3 **WHEREAS, Mrs. Fay Diana Garrido Carbullido is the daughter of Facundo**

4 **(Ding) Diego Borja Garrido and Florencia (Encha) Crisostomo Lizama Garrido; and**

1 **WHEREAS**, Fay’s interest in nursing was nurtured at an early age as she was
2 inspired by three (3) generations of nurses in her family, to include her mother; and

3 **WHEREAS**, Fay had volunteered at the Guam Memorial Hospital as a Candy
4 Striper and student trainee during her high school and summer breaks; and

5 **WHEREAS**, Fay attended the Academy of Our Lady of Guam and graduated
6 in June 1971. Upon graduation, she received a Government of Guam Professional
7 Technical Scholarship Award to begin her studies in Nursing at Seattle University in
8 Washington; and

9 **WHEREAS**, Fay completed her college undergraduate studies at Seattle
10 University and the University of Washington in 1975 with a Bachelor of Science
11 Degree in Nursing. Immediately after graduation, she launched her medical career
12 providing direct nursing care in the community and at teaching hospitals; and

13 **WHEREAS**, Fay married the love of her life, Mr. Franklin Philip Carbullido,
14 on August 21, 1976; and they will celebrate forty (40) years of marriage in 2016; and

15 **WHEREAS**, after Mr. Carbullido’s graduation with a Juris Doctorate from the
16 University of California-Davis in 1978, he and Fay returned home to Guam, where
17 she began working at the Guam Memorial Hospital Authority in the Emergency Room
18 and Critical Care Unit, the Labor and Delivery and the Medical-Surgical Wards; and

19 **WHEREAS**, Fay worked briefly at the Seventh Day Adventist Clinic, where
20 she served as a Pediatric Nurse; and

21 **WHEREAS**, Fay continued in her public service and worked as a School
22 Health Counselor for the Guam Department of Education, where she served our
23 children and youth from 1979 to 1984, from 1989 to 1995, and from 1997 to 2003.
24 Her contributions to the Department were appreciated and remembered by the

1 students of Finegayan Elementary School, Carbullido Elementary School, C.L.
2 Taitano Elementary School and Tamuning Elementary School; and

3 **WHEREAS**, from 1984 to 1989, Fay served as the School Health Program
4 Coordinator for Guam DOE where she was responsible for the administration and
5 management of the comprehensive School Health Program, providing professional
6 nursing leadership and coordinating the activities of the thirty-six (36) school
7 nurses/health counselors; and while working with the DOE, she championed the
8 initiative to have a nurse in every public school on Guam, among her other notable
9 contributions; and

10 **WHEREAS**, in 1995, Fay was instrumental in pioneering home care nursing on
11 Guam; and her work continued in her service to the public at the Guam Department of
12 Public Health and Social Services, where she was the Community Health Nurse
13 Supervisor Assistant; and she then became the Administrator for the Bureau of Family
14 Health and Nursing Services, where she directed the operations of the comprehensive
15 island-wide program of public health and nursing services; and

16 **WHEREAS**, in 2003, Fay took on the role as a Patient Safety Manager at the
17 U.S. Naval Hospital Guam (USNH), where she established and developed the Patient
18 Safety Program; she launched the first seven (7)-National Patient Safety Goals and
19 Team STEPPS; and she provided support in the two (2) successful Joint Commission
20 on Hospital Accreditation surveys, among her other notable contributions to the
21 Hospital; and

22 **WHEREAS**, in 2009, Fay took on an additional role as the Breast Health
23 Coordinator at the U.S. Naval Hospital Guam, providing excellent guidance and
24 support in the Breast Health Program, and building capacity for USNH where in just
25 two (2) months USNH recorded an increase from fiftieth (50th) percentile to ninetieth

1 (90th) percentile in July 2009 for beneficiaries and mammogram appointments, serving
2 over one thousand eight hundred (1,800) patients; and

3 **WHEREAS**, Fay continued on with her work at the U.S. Naval Hospital Guam
4 and she became the Population Health Nurse in January 2015. Her responsibilities
5 included, but were not limited to: Data Reporting and Analysis; Professional
6 Collaboration; and Preventive Health Management; and

7 **WHEREAS**, Fay has been recognized for her love of nursing with the various
8 achievement awards that have been bestowed upon her, such as: being nominated and
9 awarded with the Honorary Nursing Practice in Out-Patient/Ambulatory Care Setting
10 from the Guam Nurses Association in 2011; she was awarded Five Thousand Dollars
11 (\$5,000) for having an Outstanding Performance and/or Special Act/Service from
12 2010 to 2012; she was awarded with twelve (12) time-off hours for Outstanding
13 Performance in 2010; she was nominated for Senior Civilian of the Quarter in the 3rd
14 and 4th Quarters of Fiscal Year 2010 by the USNH; and she was also nominated for
15 Senior Civilian of the Year for Fiscal Year 2010 by the USNH; and

16 **WHEREAS**, Fay's love for her community has affected many lives and she has
17 been involved with the goals and missions of many of Guam's charitable, civic and
18 religious organizations, such as: the Guam Memorial Hospital Candy Stripers; the
19 School Health Counselors Association; the National Association of School Nurses,
20 Guam Delegate; the Guam Nurses Association; Chairperson of the Guam Board of
21 Nurse Examiners; the Guam Nurse Leaders; the University of Guam College of
22 Nursing Advisory Committee; Chairperson for the Guam Interagency Consortium for
23 Individuals with Special Needs; Program Director/Administrator of the Maternal
24 Child Health Block Grant; Founding Member, Vice Chairperson of the Board of
25 Directors, Hemophilia Foundation of Guam; Chairperson, Pediatric Evaluation and

1 Development Services; Governor's Vision 2011 Health Committee Working Group;
2 the Pacific Basin Interagency Leadership Conference, Guam Delegate; Pacific Basin
3 MCH Coordinators Conference; Charter Member of the Soroptimist International of
4 the Marianas; American Red Cross Guam Chapter, Vice Chairperson and Member of
5 the Board of Directors; the Guam Memorial Hospital Volunteers Association; the
6 American Cancer Society; the Guam Cancer Survivors Support Group; Guam Cancer
7 Care; the Medical Advisory Board of the Department of Public Health's Breast and
8 Cervical Cancer Early Detection Program; the Guam Comprehensive Cancer Control
9 Coalition; the Non-Communicable Disease Consortium; Member of the Archdiocesan
10 Governance Board of Education; Christian Mothers of the Our Lady of the
11 Assumption Parish in *Piti*; Legion of Mary Auxiliary; and the Catholic Daughters of
12 the Americas; and

13 **WHEREAS**, Fay, along with her husband of forty (40) years, F. Philip, have
14 been blessed by the love and happiness of their children: Brandon Philip, Kristina Joy
15 and Charles Rapadas, Adam Philip and Steven Philip. They also share in the joy of
16 their grandson, Kellan Philip; and

17 **WHEREAS**, Fay will enjoy the rewards of her hard work after forty-one (41)
18 years, as she will now enjoy retirement, allowing her to travel abroad, spend more
19 time with her family and provide more services as a volunteer for the GMH
20 Volunteers Association and her parish, Our Lady of the Assumption in *Piti*; now
