10 athletes from Guam, Australia and the Philippines will participate in the “First
11 Invitational Basketball Friendship Games,” to be held from July 1 to July 4, 2016, in
12 Manila, Philippines; and

13 **WHEREAS**, the “First Invitational Basketball Friendship Games” not only
14 provides a wonderful opportunity for athletes of all ages to maintain their physical
15 fitness and to strengthen their basketball skills, but the competition also promotes
16 mutual understanding and respect among the many participants who come from


