**Relative to recognizing and commending Anthony Alberto Lucero Lamorena on his successful election to the position of President of the Student Government Association for the upcoming school year at Chaminade University of Honolulu, Hawaii.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, Anthony A. Lamorena was born on Guam on February 3, 1996;  
4 and is a graduate of Harvest Christian Academy; and

5           **WHEREAS**, Anthony A. Lamorena served as a member of the 29<sup>th</sup> Guam  
6 Youth Congress, where he served as chairman of the committees overseeing the  
7 military buildup, tourism, and housing; and

1           **WHEREAS**, Anthony A. Lamorena worked as a public policy intern for the  
2 Office of Speaker Judith T. Won Pat, Ed.D., where he researched issues impacting the  
3 people of Guam; and

4           **WHEREAS**, Anthony A. Lamorena is currently a third (3<sup>rd</sup>) year student with a  
5 business administration major and a political science minor at Chaminade University  
6 in Hawaii; and

7           **WHEREAS**, in January 2015, Anthony A. Lamorena was elected to serve as a  
8 member of the Chaminade Senate, which oversaw the largest data collection project  
9 amongst Chaminade University students; and

10          **WHEREAS**, Anthony A. Lamorena also served as the Chaminade Marianas  
11 Club Vice President in 2015; and is President of the Marianas Club for 2016; and

12          **WHEREAS**, as President and former Vice President of the Chaminade  
13 Marianas Club, Anthony A. Lamorena revived the *Chamorro* culture at Chaminade  
14 University by growing its active membership and expanding programs and events for  
15 the Marianas Club; and

16          **WHEREAS**, in August 2015, Anthony A. Lamorena was appointed to be a  
17 member of the Chaminade Allocations Board, which managed the distribution of  
18 funds to over twenty (20) student organizations and clubs; and

19          **WHEREAS**, in December 2015, Anthony A. Lamorena was appointed to fill  
20 the term as the Vice-President of Internal Affairs of the Chaminade Student  
21 Government Association, which gave him a vote on the Chaminade Executive Board;  
22 and

23          **WHEREAS**, as Vice-President of Internal Affairs, Anthony A. Lamorena had a  
24 voice in the selection of the Dean of Students and the new Chaminade University  
25 President, and the ability to represent the University before dignitaries and members  
26 of the U.S. Congress; and

1           **WHEREAS**, in April 2016, Anthony A. Lamorena was elected to serve as  
2 President of the Chaminade Student Government Association, which oversees all  
3 student organizations, as well as the Executive Board, and gives a voice for the  
4 students to be represented on the Chaminade University Board of Regents; and

5           **WHEREAS**, with his *Chamorro* values, Anthony A. Lamorena has  
6 demonstrated his strong leadership, integrity and experience as a member of the  
7 student body of Chaminade University in Hawaii in the execution of his duties as the  
8 President of the Chaminade Student Government Association; now therefore, be it

9           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*  
10 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
11 of Guam, recognize and commend Anthony A. Lamorena on his election to serve as  
12 President of the Chaminade Student Government Association; and be it further

13           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules


