1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2        ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS,** the StarGazers Dance Troupe was established in June 1992 by  
4        Mark Gonzales, Director, to offer affordable dance lessons to individuals from all  
5        walks of life at a time when dance lessons were costly; and

1           **WHEREAS**, the StarGazers Dance Troupe continues to offer individuals the  
2 chance to focus and take part in music and dance, a positive and productive activity,  
3 which encourages them to build their self-esteem and self-motivation, while  
4 simultaneously discouraging them from becoming involved in potentially harmful  
5 activities; and

6           **WHEREAS**, under the leadership of Gonzales, the StarGazers Dance Troupe  
7 has dedicated countless hours to honing their craft, to perfecting their routines, and to  
8 growing as both a group and as individuals, which has culminated in their ability to  
9 compete in off-island competitions; and

10           **WHEREAS**, through hard work, dedication and determination, the StarGazers  
11 Dance Troupe was able to gather the funds, develop the skills, and forge the bond  
12 necessary to travel to Orlando, Florida, and compete in the “2016 Luv2dance  
13 Competition,” where they earned a total of nine (9) Perfectly Platinum wins, six (6)  
14 Dynamic Diamond wins, and fifteen (15) 1<sup>st</sup> Place standings; and

15           **WHEREAS**, the StarGazers Dance Troupe was able to garner the special  
16 awards, such as the Inspiring Commitment Award (Michael Cajigal for “Lost”); the  
17 Superman Award (Kobe Hall and Jonathan Abuel for “Game On”); the Rebel Heart  
18 Award (Tanna San Agustin, Eirian Gonzales, and Essence Gonzales for “Vogue”); the  
19 Precision Power Award (StarGazers Seniors for “Trippy Turtle”); the Best Grand  
20 Finale Award (StarGazers seniors for “Toros”); the National Studio Spirit Award; two  
21 (2) Best Choreography Awards (Mark Gonzales); the Most Potential Award (Michael  
22 Cajigal); the Seniors’ Convention Award (Kobe Hall); the Mini’s Convention Award  
23 (Ava Simion); and the Novice Top Score Award (“Just Dance”); and

1           **WHEREAS**, the StarGazers Dance Troupe was also able to garner individual  
2 awards, to include Second Runner-Up (Aubrey Carranza Gomez and Cristen Testa)  
3 and First Runner-Up (Tanna San Agustin, Eirian Gonzales and Essence Gonzales) in  
4 the Duo/Trio Novice Division; Second Runner-Up (Michael Cajigal) and Overall  
5 National Champion (Kobe Hall) in the Solo (Classic) Senior Division; First Runner-  
6 Up (Kobe Hall and Jonathan Abuel) in the Duo/Trio (Elite) Senior Division; First  
7 Runner-Up (Adrian Cajigal and Michael Cajigal) in the Duo/Trio (Classic) Senior  
8 Division; and Overall National Champions (Myles Macaraeg, Uwel Mendiola and  
9 Bryant Santos) in the Duo/Trio (Novice) Senior Division; and

10           **WHEREAS**, the StarGazers Dance Troupe additionally garnered several group  
11 awards, such as: Second Runner-Up, First Runner-Up, and Overall National  
12 Champions in the Group Mini Division; Second Runner-Up and Overall National  
13 Champions in the Small Group (Novice) Division; Second Runner-Up, First Runner-  
14 Up, and Overall National Champions in the Large Group Division; Second Runner-  
15 Up in the Large Group (Elite) Division; and Second Runner-Up, First Runner Up, and  
16 Overall National Champions in the Line/Extended Line Division; and

17           **WHEREAS**, as a culmination of their success at the “2016 Luv2dance  
18 Competition,” the StarGazers Dance Troupe was invited to showcase Guam’s talent to  
19 the massive Independence Day crowd at Disney World in Orlando, Florida, on July 4,  
20 2016; and

21           **WHEREAS**, participation in dance and other physical activities is beneficial to  
22 the well-being and overall health of an individual, including their mental  
23 development, as it teaches and encourages important social skills such as cooperation,  
24 team work and encouragement; and

1           **WHEREAS**, the members of the StarGazers Dance Troupe recognize the  
2 positive effects that the performing arts have had in their lives, and they value its  
3 importance in helping them to hold true to the characteristics of resilience, hard work  
4 and inspiration; and

5           **WHEREAS**, the StarGazers Dance Troupe’s accomplishments serve as an  
6 inspiration to future generations of aspiring artists, especially dancers, and reinforces  
7 the promise of the current and future state of Guam’s performing arts scene; and

8           **WHEREAS**, the StarGazers Dance Troupe have served as Guam’s  
9 ambassadors of the *Hafa Adai Spirit* everywhere they go by sharing their warm  
10 greetings, offering lasting friendships, and encouraging the best out of everyone they  
11 compete with, all of which are values the people of the island of Guam are best known  
12 for; and

13           **WHEREAS**, the StarGazers Dance Troupe’s success at the “2016 Luv2dance  
14 Competition,” their Independence Day performance at Disney World, and their warm  
15 portrayal of the *Hafa Adai Spirit* have made the people of Guam extremely proud;  
16 now therefore, be it

18 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
