1 accountancy and business advisory. Mr. Chew achieved his goals and successfully
2 completed the course as a chartered professional accountant and a fellow of the
3 chartered institute programs; and

4 **WHEREAS**, in 1989, Mr. Chew became a member of the Lions Club Subang
5 Jaya in Peninsula, Malaysia, under District 308B1 and 308B2, a non-profit
6 organization that is internationally known for its effective leaders and exceeding
7 members of men and women obligated to contributing their time and services raising
8 funds, conducting projects, and spearheading charitable donations, and other programs
9 assisting their Lions Club and the local and global communities; and

10 **WHEREAS**, in 2000-2001, at the District Level, Mr. Chew was inducted as the
