1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN*:**

3           **WHEREAS**, the late Reverend Father Patrick "*Påle*" Pat" Kenny Quitonguico  
4 Garcia was born on March 3, 1964; and is the son of the late †James Estolas and  
5 †Florentina Garcia Estolas; and

1           **WHEREAS**, *Påle*' Pat grew up in *Tamuning*, Guam, enjoying the life of his  
2 childhood and youth with family and friends; and as a youth, *Påle*' Pat spent much of  
3 his time serving as an Altar Server of the parish of Saint Anthony and Saint Victor in  
4 *Tamuning*; and

5           **WHEREAS**, *Påle*' Pat attended *Agaña* Heights Elementary School, *Dededo*  
6 Middle School, Father Dueñas Memorial School (FDMS), and John F. Kennedy High  
7 School, where he graduated in 1980; and

8           **WHEREAS**, *Påle*' Pat entered the FDMS Minor Seminary in 1977; and after  
9 graduation, he attended the University of Guam from 1980 to 1981; and

10           **WHEREAS**, in 1981, *Påle*' Pat continued his studies at St. Joseph's College,  
11 and graduated with a Bachelor of Arts in Humanities in 1985; and

12           **WHEREAS**, from 1985 to 1989, *Påle*' Pat attended St. Patrick's Seminary and  
13 University, where he earned a Masters in Divinity; and

14           **WHEREAS**, on April 22, 1989, *Påle*' Pat was ordained at the Transitional  
15 Deaconate at Saint Mary's Cathedral in San Francisco, California; and

16           **WHEREAS**, on July 16, 1989, *Påle*' Pat was assigned to serve as the  
17 Administrator of the San Isidro Catholic Church in *Malojloj*, Guam; and

18           **WHEREAS**, on September 30, 1989, *Påle*' Pat was ordained at the *Dulce*  
19 *Nombre de Maria* Cathedral-Basilica as a Priest of the Archdiocese of *Agaña*; and

20           **WHEREAS**, *Påle*' Pat's first Pastoral assignment was to the parish of San  
21 Isidro in *Malojloj*, where he served as Pastor from July 1989 to September 1996; and

22           **WHEREAS**, *Påle*' Pat was also assigned to serve as Pastor of the parish of  
23 *Nuestra Senora de Las Aguas* in *Mongmong*, from September 1996 to February 2003;  
24 at the Santa Barbara Catholic Church in *Dededo* as Parochial Vicar, from July 2005 to  
25 2009; and at Our Lady of Lourdes Catholic Church in *Yigo* as Parochial Vicar, from  
26 2009 until his passing; and

1           **WHEREAS**, *Påle'* Pat also served our brothers and sisters of the  
2 Commonwealth of the Northern Mariana Islands while he was assigned to the Saint  
3 Jude Thaddeus Parish in Koblerville, Saipan; and

4           **WHEREAS**, *Påle'* Pat served as the Director of Worship for the Archdiocese  
5 of *Agaña* for many years, assisted the Archdiocese with planning Eucharistic  
6 celebrations and other Archdiocesan events for the island community, and held  
7 discussions in the practices of the liturgy in the Archdiocese; and

8           **WHEREAS**, *Påle'* Pat had also extended his love for God in serving as a  
9 teacher at San Vicente Catholic School in *Barrigada*, Notre Dame High School in  
10 *Talofof*, Father Dueñas Memorial School in *Mangilao*, and Mount Carmel Catholic  
11 School in Saipan; and

12           **WHEREAS**, *Påle'* Pat enjoyed reading, listening to religious music, and most  
13 especially, singing during the liturgy; and he had participated in the school  
14 productions of “Oliver” at Mount Carmel School, and “Narnia” at Santa Barbara  
15 Catholic School; and

16           **WHEREAS**, *Påle'* Pat will be remembered for his enthusiastic and dramatic  
17 Mass celebrations where a weekday Mass sometimes felt like a Sunday “High” Mass  
18 because of his love of singing during the Celebration of the Eucharist, and in the  
19 pinnacle of God becoming Man; and

20           **WHEREAS**, *Påle'* Pat’s love for our Lord Jesus, especially in the Eucharist, is  
21 made evident in his passion to serve God’s people as a Priest for the Archdiocese of  
22 *Agaña*; and

23           **WHEREAS**, *Påle'* Pat will be missed by each person he has met along his  
24 life’s journey for whom he brought laughter, joy, comfort, peace and love to soothe  
25 their pains and awaken their spirit with hope; and

1           **WHEREAS**, *Påle'* Pat was called to join our Almighty God in his new home  
2 on Tuesday, August 30, 2016, in the peace of his sleep, and now joins his mother and  
3 father as they rest in God's eternal embrace; now therefore, be it

4           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*  
5 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
6 of Guam, recognize and honor the late Reverend Father Patrick Kenny Quitonguico  
7 Garcia (*Påle'* Pat) for his dedication, service and love for the people of God in the  
8 Archdiocese of *Agaña*, and extend our appreciation for his faithful service to our  
9 island and region's Roman Catholic Community and the people of Guam; and does  
10 further extend our sincerest condolences to his family and the people of God on his  
11 untimely passing; and be it further

12           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
