**Relative to recognizing and commending the Guam Kyokushinkai Karate Association on the celebration of its Fiftieth (50<sup>th</sup>) Year Anniversary of promoting and teaching the martial art of Karate to the people of Guam.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, the Guam Kyokushinkai was established in 1966, two (2) years  
4 after the International Karate Organization of Japan was established; and

1           **WHEREAS**, the Guam Kyokushinkai is the oldest and longest operating dojo on  
2 Guam, following the Karate way of building character and training the mind and body  
3 to contribute to society, basing this on Masutatsu Oyama’s Kyokushin Spirit; and

4           **WHEREAS**, the Guam Kyokushinkai was established by Mr. Jose Tedtaotao, a  
5 Guam resident, who trained under the tutelage of Masutatsu Oyama, the father of  
6 Kyokushinkai; and he was later granted a second (2<sup>nd</sup>) degree black belt, and the title of  
7 Branch Chief to open up the Guam dojo; and

8           **WHEREAS**, since the dojo’s inception, Guam representatives of the Guam  
9 Kyokushinkai Dojo have competed in major events and tournaments in Japan that are  
10 sanctioned by the International Karate Association, such as the Open World Karate  
11 Tournament, which is held every four (4) years in Tokyo, Japan; and

12           **WHEREAS**, the Guam Kyokushinkai Karate Association has a successful rate  
13 of advancing youth from white belts to junior black belts, with the first junior black  
14 belts being Jake Cabrera, Isaac Cabrera and Mika Terlaje; and with three (3) more to be  
15 promoted within the next year; and

16           **WHEREAS**, the Guam Kyokushinkai Karate Association has three (3) active  
17 black belts who have been training in Kyokushinkai for the last twenty-five (25) years:  
18 Sensei Tony Rodriguez, a fourth (4<sup>th</sup>) degree black belt; Senpai Fred Rodriguez, a  
19 second (2<sup>nd</sup>) degree black belt; and Senpai Rick Sablan, a second (2<sup>nd</sup>) degree black belt;  
20 now therefore, be it

21           **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*  
22 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people  
23 of Guam, recognize and commend the Guam Kyokushinkai Karate Association on its  
24 Fiftieth (50<sup>th</sup>) Year Anniversary of teaching and promoting the martial art of Karate to  
25 the people of Guam; and be it further

1           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
2 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of  
3 the same be thereafter transmitted to the family of Sensei Joseph Tedtaotao; to Sensei  
4 Anthony Rodriguez; and to the Honorable Edward J.B. Calvo, *I Maga'lâhen Guåhan*.
