1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, the Jose D. Leon Guerrero Commercial Port (Port) was established
4 as a public corporation and autonomous government agency by the enactment of Public
5 Law 13-87 in October 1975; and

1 **WHEREAS**, over the last four (4) decades, the Port has developed into a major
2 transshipment center for the western Pacific region, providing full services to ocean
3 passenger, cargo and fishing vessels; and

4 **WHEREAS**, in Fiscal Year 2016, the Port processed more than two million
5 eighteen thousand seven hundred ten (2,018,710) revenue tons of cargo, providing vital
6 goods to the people of Guam; and

7 **WHEREAS**, three hundred fifty (350) Port employees operate and maintain five
8 (5) cargo handling piers, a container yard, two (2) marinas, a harbor of refuge, and two
9 (2) recreational beaches; and

10 **WHEREAS**, the Port recently completed the Guam Commercial Port
11 Improvement (GCPI) Program, which improved and expanded the Port's facilities to
12 enhance its operational efficiencies, maximize its capacity, and serve the organic
13 growth of Guam's population and the increase in population due to the U.S. Department
14 of Defense plans to relocate military personnel to Guam from Okinawa; and

15 **WHEREAS**, even in the midst of undertaking improvements to modernize its
16 footprint, the Port continues to embark upon other capital improvement projects, which
17 include: (1) the implementation and integration service of its terminal operating system;
18 (2) improvements to its marinas; and (3) the rehabilitation of Hotel Wharf and other
19 facility upgrades; and

20 **WHEREAS**, the employees, management and Board of Directors of the Jose D.
21 Leon Guerrero Commercial Port continue to remain steadfastly committed to taking on
22 the challenges of modernizing the Port to meet the ever-changing needs of the island's
23 economic growth; now therefore, be it

24 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
25 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the people
26 of Guam, commend and congratulate the dedicated employees, management and Board

1 of Directors of the Jose D. Leon Guerrero Commercial Port on the occasion of its Forty-
2 First (41st) Year Anniversary, and on the observance of “Port Week,” during the week
3 of October 17 to October 21, 2016; and does further encourage the people of Guam to
4 actively participate in the activities related to the celebration of the Port’s Forty-First
5 (41st) Year Anniversary, and the observance of “Port Week”; and be it further

11 Edward J.B. Calvo, *I Maga’låhen Guåhan*.


