WHEREAS, even in the midst of undertaking improvements to modernize its 15 footprint, the Port continues to embark upon other capital improvement projects, which 16 17 include: (1) the implementation and integration service of its terminal operating system; 18 (2) improvements to its marinas; and (3) the rehabilitation of Hotel Wharf and other 19 facility upgrades; and
