4 **1936; and is the son of Jesus Dela Cruz Aquiningoc and Maria Lizama Perez Respicio**
5 **from the village of *Sumay*, and then moved to *Santa Rita* village; and**

1 **WHEREAS**, Mr. Aquiningoc has seven (7) siblings: Jesus, Antonio, Manuel,
2 Luisa, Mariano, Jose, and Kulasa; and

3 **WHEREAS**, at the age of five (5), Mr. Aquiningoc attended *Barrigada*
4 Elementary School; and went on to attend George Washington High School; and

5 **WHEREAS**, on January 18, 1976, Mr. Aquiningoc married the love of his life,
6 LaVeda Mae Fultz; and they share in the joy and love of their six (6) children: James,
7 Louise, Janet and Cheryl, who live on Guam; Glenda, who resides in Chesapeake,
8 Virginia; and Valerie, who resides in Hollywood, Maryland; and

9 **WHEREAS**, Mr. Aquiningoc is a proud grandfather of twenty-one (21)
10 grandchildren; and is also blessed with twenty-six (26) great grandchildren; and

11 **WHEREAS**, Mr. Aquiningoc was a Boatswain Mate in the U.S. Navy, where
12 he served for four (4) years aboard the USS St. Clair City based in Long Beach
13 California and traveled through Hawaii, Okinawa, the Philippines, and Hong Kong.
14 After leaving the Navy, he then started his career at the U.S. Naval Magazine, where
15 he served as an ordnance worker for four (4) years before transferring to the U.S.
16 Naval Ship Repair Facility (SRF), where he worked as a pipe fitter; and after
17 attending classes in the evenings, he was able to get his diploma from Guam
18 Vocational Technical High School in 1966. He was then promoted to Journeyman and
19 held the position through 1985; and

20 **WHEREAS**, in July 1994, Mr. Aquiningoc retired from SRF as a Lead
21 Foreman after thirty-seven (37) years of service. He is now retired and enjoys
22 spending his leisure time with his wife and admiring the fruits of his labors in
23 gardening and raising chickens. Mr. Aquiningoc is a diligent man who does not give
24 up. When he finds a fruit that he enjoys eating, he retrieves the seed, dries it, and
25 plants it; and if the plant grows well, he shares it with his family and friends. If the
26 plant did not grow well, he would be encouraged to start a new seedling again until he
