2 career working at the Judiciary of Guam as a Deputy Marshal I with the Superior  
3 Court of Guam; and

4           **WHEREAS**, through hard work and dedication, Peter continued to work his  
5 way up the ranks, and he was promoted to a Deputy Marshal II in August of 1990; in  
6 December of 1997, he transferred to the Supreme Court of Guam to serve as a Court  
7 Security Officer II; and in October of 2004, his position was changed to Deputy  
8 Marshal II, and he has since held that position; and

9           **WHEREAS**, Mr. Gutierrez had received extensive training and qualification  
10 courses throughout his years serving with the Judiciary, such as: Basic Firearms  
11 Training; Survivors Training; Fingerprinting and Report Writing; and numerous  
12 Firearms Qualification Courses; and

13           **WHEREAS**, throughout his years working at the Judiciary of Guam, Mr.  
14 Gutierrez received recognitions, to include: a Certificate of Appreciation for the  
15 opening of the Guam Judicial Center; a Certificate of Nomination for Honoring the  
16 Silent One (Unsung Hero), Fiscal Year 2006-2007; as well as a Certificate of  
17 Nomination for the Spirit of the Judiciary Award, Fiscal Year 2006-2007; and

18           **WHEREAS**, Peter D. Gutierrez's civic contributions to the community has  
19 been in giving guitar lessons to others; and in performing with a live band that has  
20 been entertaining many people at various local events; now therefore, be it
