8 during a scheduled visit to the Philippines from April 8-12, 2015; and

9 **WHEREAS**, the GMBA will share its experiences, success principles, and best
10 practices with the organizers of the PMBA so that it may provide the same
11 opportunities for playing the sport of basketball, and promoting physical fitness,
12 camaraderie and good sportsmanship; and

13 **WHEREAS**, the organizers of the PMBA have benefitted greatly from the
14 leadership of the Honorable Juanito “Jonvic” Remulla, Governor of Cavite Province;
15 the Honorable Lani Mercado-Revilla, Congresswoman, Bacoor City, Cavite; the
16 Honorable Strike Revilla, Mayor, Bacoor City, Cavite; the Honorable Alex Advincula,
17 Congressman, Imus City, Cavite; and the Honorable Manny Maliksi, Mayor, Imus
