1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** the late Robert Eugene Stahlnecker was born in Beloit,
4 Wisconsin, on August 14, 1923; and he was called to his eternal reward on June 9,
5 2013 at the age of eighty-nine (89); and

1 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker is the son of
2 †Frank Stahlnecker and †Mildred Whipple Stahlnecker; and

3 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker married Ruby
4 Kahler, his wife of sixty five (65) years, on June 27, 1948, in the town of Walla Walla,
5 Washington; and they were blessed with three (3) daughters, Carol Stahlnecker
6 Wayner, †Donna Stahlnecker Wooley, and Patricia Stahlnecker Quenga; three (3)
7 sons, †Sukhdev Veena Mathaudhu, †Larry Stahlnecker, and Leslie Stahlnecker;
8 fifteen (15) grandchildren; and sixteen (16) great grandchildren; and

9 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker grew up in
10 Wisconsin, until World War II when he joined the United States Navy in 1943;
11 distinguishing himself admirably as a member of the Sino American Cooperative
12 Association (SACO) serving “prolonged overseas extremely hazardous duty” in China
13 often behind enemy lines and in enemy territory; and

14 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker, and his wife and
15 children moved to Guam in 1969, and they resided first in *Tutujan*, then in *Piti*, and
16 finally settled in *Laguina* (Baza Gardens), where they continued to serve the people of
17 Guam as educators, as well as serving at their beloved Seventh-Day Adventist
18 Church; and had also served in community capacities, including emergency radio
19 communications, such as in 1976 when through his ham radio, immediately after
20 Supertyphoon Pamela struck the island of Guam, Bob was the first person, even
21 before the military, to make outside contact and inform the world of the destruction of
22 the island. He put in a call to the organization that is now the Adventist Disaster and
23 Relief Association (ADRA), and with information from and coordinating with the
24 Governor and Civil Defense, he was able to arrange for 17½ tons of emergency
25 supplies to be flown in to the island and distributed; and

1 **WHEREAS**, KG6ASO (“King George Six Alpha Sierra Oscar”) was his ham
2 radio call sign after moving to Guam, and it remained his call sign to the day of his
3 passing; and

4 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker loved the people
5 of Guam and, together with his wife and family, called Guam their home; and

6 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker was well-
7 respected in academia, having taught at the University of Guam and touching the lives
8 of immeasurable students interested in teaching and applying education; and

9 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker loved music, and
10 not only played, but taught music to young aspiring musicians in school and in
11 church; and he donated his time and talents freely to middle and high school bands in
12 the Marianas and Micronesia, teaching life values, which he dedicated his life to
13 doing; and

14 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker loved to extoll the
15 virtues that *Chamorros*, and those who have made Guam their home, hold so dear -
16 service to God, service to family, and service to fellow men; and

17 **WHEREAS**, even in his late years when his health was seriously failing, the
18 late Robert “Doc/Bob” Eugene Stahlnecker would extend his loving, caring sense of
19 humor, even teaching children, nieces and nephews, and those who considered him
20 family, about what Guam was like in the “good old days”; and

21 **WHEREAS**, the late Robert “Doc/Bob” Eugene Stahlnecker will always be
22 fondly remembered for his dedication to preserving and keeping alive the family and
23 neighborly customs of a God-fearing man; for his service to Guam and its people; and
24 for his humble and caring heart for the well-being of the family he loved and the
25 community he so devotedly served; now therefore, be it

1 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
2 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
3 of Guam, recognize and memorialize the late Robert “Doc/Bob” Eugene Stahlnecker
4 for his extensive and outstanding achievements, and his dedication to serving the
5 people of Guam and Micronesia; and does further extend sincere condolences to his
6 family on his passing; and be it further

7 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
8 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
9 the same be thereafter transmitted to the family of the late Robert “Doc/Bob” Eugene
10 Stahlnecker; and to the Honorable Edward J.B. Calvo, *I Maga'lahaen Guåhan*.
