1           **WHEREAS**, the Guam Memorial Hospital Volunteers Association (GMHVA)  
2 was founded in 1965 by the late Honorable Cecilia Bamba, who was the first Charter  
3 President; and

4           **WHEREAS**, the Guam Memorial Hospital Volunteers Association is a non-  
5 profit organization whose membership consists of selfless individuals, who through  
6 their gift of time, talents and personal interest, supplement the professional hospital  
7 staff in caring for the comfort and welfare of all patients, employees and visitors to the  
8 Guam Memorial Hospital; and

9           **WHEREAS**, the Guam Memorial Hospital Volunteers Association  
10 enthusiastically serves the people of Guam at the Guam Memorial Hospital Authority  
11 (GMHA), with over 150 active auxiliary volunteers generously donating their  
12 personal time in assisting at the hospital; and

13           **WHEREAS**, on this significant milestone in the history of the Guam Memorial  
14 Hospital Volunteers Association, it is right and fitting to honor all the members who,  
15 throughout the organization's fifty years of service, have selflessly given of their time  
16 and efforts in helping out at the hospital; and for the numerous fundraising activities  
17 they have conducted amounting to over Nine Million Dollars (\$9,000,000) in  
18 contributions for medical equipment, furnishings, and other needed supplies -  
19 portraying their compassion, care, love and hope for the Guam Memorial Hospital, its  
20 employees, and its patients; and

21           **WHEREAS**, the success of the Guam Memorial Hospital Volunteers  
22 Association's endeavors, past and present, is due to the generous support from the  
23 community. The continuing support and generosity of Guam's businesses, civic  
24 organizations, government, military and community leaders, the medical community,

20 embrace on a daily basis; now therefore, be it


21 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Tres Na*
