1            **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2            ***MINA'TRENTAI TRES NA LIHESLATURAN GUÅHAN:***

1           **WHEREAS**, United Airlines, Guam’s hometown airline, is proud to celebrate  
2 ten years of hosting its annual Plane Pull event - “Towing the Line to Save Lives”  
3 with its employees and community supporters working together to help save the lives  
4 of those afflicted with cancer. The entire community is affected by this disease, and  
5 this event is a wonderful opportunity to pull together and join the fight against cancer;  
6 and

7           **WHEREAS**, since 2006, the United Airlines Plane Pull event, which for the  
8 past ten years has been held at the United Airlines hangar in *Tiyan* with the support of  
9 over six thousand participants and an average of around thirty teams, has raised over  
10 Two Hundred Forty-Five Thousand Dollars for the American Cancer Society, to  
11 include a portion of the concession proceeds to also help the Guam Cancer Care. As a  
12 small island community, each of us has been touched by cancer. The Plane Pull is a  
13 fun, team-building event to raise funds in support of members of the community who  
14 are fighting cancer; and

15           **WHEREAS**, each team consists of twenty members with five alternate  
16 members. There are two divisions in which all participants can join, the all-male  
17 division and the co-ed division, in which each team must have a minimum of six  
18 female members, who pull a United Boeing 737-800 aircraft that is 129 feet long, 41  
19 feet high, and 124 feet wide, weighing a total of 145,000 pounds. The team that pulls  
20 the aircraft twelve feet in the fastest time is named as the “United Airlines Plane Pull  
21 Champion”; and

22           **WHEREAS**, while teams are pulling the aircraft, hundreds of families and  
23 friends cheer for their favorite plane-pulling team. United Airlines also provides  
24 families with kiddie bouncers, face painting, food and drink concessions, a dunking  
25 booth, performances by our local island dance groups, and other entertainment for  
26 those attending the event; and

1           **WHEREAS**, in support of the 10<sup>th</sup> Year Anniversary of the United Airlines  
2 Plane Pull 2015 - “Towing the Line to Save Lives,” and joining in the fight to help

17           **WHEREAS**, for ten consecutive years, City Hill Co. (Guam) Ltd., Dewitt  
18 Moving & Storage, Docomo Pacific, Inc., GTA Teleguam, and Tan Holdings have  
19 come together to support the United Airlines Plane Pull to bridge the gap in cancer  
20 education, awareness, and treatment for many of our island’s people who battle this  
21 deadly disease; and
