3 WHEREAS, in 2012, Antonia (Toni) Pecon started volunteering as a member

4 of the Guam Memorial Hospital Volunteers Association (GMHVA), working at the

Hospital Gift Shop as a sales clerk, cashier, and pricing the merchandise sold at the
 Gift Shop; and

WHEREAS, within a few weeks after joining the GMHVA, Toni volunteered to help the GMHVA Committee on Policies and Procedures draft a manual for the Gift Shop. She attended all the committee meetings and even brought the drafts home for further review as the manual developed; and

7 WHEREAS, in 2013, Toni volunteered to chair the annual GMHVA Charity 8 Ball, the GMHVA's biggest single fundraiser, and she quickly formed her committee. 9 There seemed to be no task too great for her and the committee as she explored all possible avenues to raise additional funds to increase the projected revenue from the 10 11 Charity Ball. Under Toni's leadership, the GMHVA also raffled a car selling hundreds of raffle tickets for \$20 a book to raise a total of \$57,000, enabling more of Guam's 12 13 people to participate in the support of GMHA; and this event was a huge success as 14 the goals were met. WHEREAS, in 2014, rather than selling raffle tickets to win a car, Toni
branched out into the sale of wedding and formal dresses when volunteer Vickie
Camacho donated gowns to GMHVA; and Toni found storage space in an *Agaña*Shopping Center store, she assembled a hard working crew, and they sold wedding
gowns and formal dresses for over two weekends allowing frugal shoppers to get
beautiful dresses at rock bottom prices, and also help GMHA in the bargain. In 2014,
GMHVA's "Charity Fund Drive" netted over \$157,000; and

WHEREAS, Toni also served as the Association's Treasurer in 2014, taking care of the Association's money. When the GMHVA President and Vice President unfortunately had to be off-island simultaneously, she served as the Acting President while in communications with the President and Vice President. Toni assisted in the procurement of three ventilators and two transport vehicles during the year for

WHEREAS, Toni's assertiveness and desire to put her business and artistic skills to work has demonstrated the meaning of being a volunteer, and she has served in the Guam Memorial Hospital Volunteers Association (GMHVA) with a kind heart. 9 WHEREAS, Toni's involvement and dedication with the Association has been 10 expressed in her sincere efforts to assisting the Association with its mission and goals, 11 and serving at the Guam Memorial Hospital as a Gift Shop cashier, Christmas tree 12 decorator extraordinaire, Tea Table Fashioner, two-time Charity Ball Chairperson and 13 leader, and Association Treasurer; and in answering the call to fulfill the needs of the 14 Guam Memorial Hospital staff, patients, their families and visitors, and our island 15 community; and

WHEREAS, Toni's love for the GMHVA and volunteerism is not to go unnoticed without the support of her husband, Mr. Bruce Pecon, and their daughter, who have also provided for the success of GMHVA through their undying support of Toni's volunteerism; now therefore, be it
