6 School, and he later received his GED from Guam Community College; and

7 **WHEREAS**, in April 1983, Thomas began his government of Guam career at  
8 the Guam Police Department, serving as a Police Officer I; and through hard work and  
9 dedication, he continued to work his way up the ranks and he was later promoted to  
10 Police Officer III in February 2007, and has since maintained this position; and

11 **WHEREAS**, throughout his years of faithful service at the Guam Police  
12 Department, Officer Thomas Manibusan has been applauded for his outstanding  
13 performance of duties; and in October of 1983, he received his first Letter of  
14 Commendation; and
