I. OVERVIEW

Bill No. 365- 31(LS) was introduced on November 3, 2011 by Senator Judith P. Guthertz, DPA, and was subsequently referred by the Committee on Rules to the Committee on Municipal Affairs, Tourism, Housing and Recreation on November 4, 2011.

The Committee on Municipal Affairs, Tourism, Housing and Recreation convened a public hearing on Bill No. 365-31(LS) on Monday, November 14, 2011 at 10:00 AM in *I Liheslatura's* Public Hearing Room.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 10:08 AM.

Senator Tina Muña Barnes: Next on the agenda is Bill 365 that is sponsored by Senator Guthertz and cosponsored by myself, Senator Tina Muña Barnes.

I do have folks from the community who wish to speak, representing the village of Yona we have Mayor Pedo Terlaje. Also from the Department of Parks and Recreation, we have Mr. Mike Cura, testimony from Mr. Peter Calvo who sent his regrets because he is at a scheduled meeting at Adelup. We will also note that for the record we have Dr. Dianne Strong who will also speak from the village of Yona. But before we do that if I may we do have the author of the legislation Senator Guthertz and I will yield the microphone to her to give her brief remarks and an introduction on the bill.

Senator Judi Guthertz: Thank you Madam Chair and my colleague Tony Ada and good morning and thank you for coming to the hearing.

Bill No. 365-31 is an act to amend sections 40113 (B) 19 and 40135 Chapter 40 Title 5 Guam Code Annotated relative to placing the Taga'chang Beach Park under the administrative authority under the office of the Mayor of Yona and including fees charged for public beach parks under the purview of the respective Mayors Municipal Planning Council Revolving Fund.

This measure does two things Madam Chair. First, it places control of Tagachang Beach Park under the purview of the Mayor of Yona. In speaking with the mayor and having learned from constituents, the area remains, a popular recreation spot however needs a lot of maintenance. Perhaps having task the mayor with its upkeep there might be renewed opportunities to rehab the area and to turn it into a true gem for Guam's eastern coast as the residence of Yona take ownership and pride in the beach park. Second, the measure expands the source of the municipal planning council's revolving funds to include village parks and beach parks but under the purview of the village mayor's. This is a potential revenue source for the mayor's to tap into to help the upkeep of their villages.

Currently mayors have authority to set charges for community centers, gymnasiums and all other sports facilities that is deposited into the municipal planning council's revolving fund. These funds are currently committed to the maintenance and upkeep of these facilities and to fund special projects identified by the municipal councils, but by expanding the potential revenue sources to include village parks and beach parks that are under the purview of village mayor's this will help add to the revenue base in maintaining these facilities.

So basically, we have a bill that addresses the serious concerns of the village of Yona, but it also provides opportunities to the other mayor's to also be involved in this similar arrangement. And to be very frank with you Madam Speaker to devolve control from the central government down to the village level and to give them all authority to our municipalities over those facilities that are within its borders. There is too much power concentrated in the central level. Unfortunately, it keeps our mayor's in a very disadvantageous where they need to go to the central government, to the governor, to the department and agencies of the executive branch to get any services for the villages.

We need to stop this arrangement and empower our municipalities, empower our mayor's. I also have the same philosophy when it comes to our school system. It is to empower the schools and to give the power to the schools communities in which they exist and empower the parents, empower the parent teacher association, empower the Mayors in where the school exists. So, I have a bill already being written which will decentralize the education, most of its functions will go down to the school level and we will see a real change in our school system.

So, I would like to start with the Mayors and later move onto the Department of Education. Thank you.

Senator Barnes: Si Yu'us Ma'ase Senator Guthertz. If I may I usually have women start but in this case because this bill is tied into the Mayor of Yona and the concerns with this bill I will have if you do not mind Dr. Strong I will yield to Mayor Pedro Terlaje to start and if you can please state your name for the record and your position.

Mayor Jose Terlaje: My name is Jose Terlaje and presently the Mayor of Yona since 2001. Mayor Terlaje reads his written testimony.

So usually the chief will call the residences of Yona and make those decisions and to decide on what progress have to be made to the community. This is why Taga'chang Beach is very sacred to us.

Work with the private contractors to resurface cracks within the pavilions. I know many people who can help me refurbish the pavilion at Taga'chang Beach. I would contract one family to stay down there and just b-b-q everyday that is what I wanted to do if given the opportunity.

I do not want to take up most of the time and listen to what Department of Parks and Recreation has to say. Thank you very much.

Dianne Strong: Madam Chair with your permission I would like to defer time to Parks and Recreation.

Senator Barnes: Thank you very much I appreciate that. Mr. Ukora.

Micheal Cura: Good morning senators and mayor Terlaje.

Senator Barnes: I apologize just please state your name for the record.

Mr. Cura: I am Micheal Cura. I am the Department of Parks and Recreation Parks Administrator. I am here to present testimony for the Director today he could not make it he had a prior appointment this morning.

Dianne Strong: Hafa Adai. Thank you Senators. I am Pedro's neighbor and a member of the Central Executive Committee of the Democratic Party of Guam along with Dr. Wyttenbach-Santos representing Yona rules the village.

I have been a resident of Yona for thirty years. I support the bill. I strongly believe the Department of Parks and Recreation is terribly over burdened. The Yona mayor's office has demonstrated great efficiency, creativity and dedication.

He has got such great support from contractors to do jobs that were never paid for by the Governor, actually the government. I have been extremely impressed with the performance of Mayor Terlaje in his three terms as Mayor. Regarding the fee schedule I believe the Mayor's office can be far more accountable and our general fund. The biggest pavilions roof is in need of painting and power washing.

On the way down to the beach the Mayor's office maintains it. It is an impossible job to keep up with it. I am sure that you remember the very active gangs volunteer Joanne Benino that where she ran she took a trash bag. I have been using that entrance to the beach for my cardio exercises and I would be glad to assist in this endeavor.

Because not only has the Del Carmen development of that building at the top cleared but it has cleared many acres below. I am sure Del Carmen's would also give great maintenance and improvement of that road and the park. In reference to the religious use of the park, on November 11th there was a sun rise ceremony there. I was not able to attend but Dr. Katherine B. Aguon's granddaughter gave a cruise and many other people were involved in that ceremony. So I appreciate our Mayor for mentioning the traditional and religious aspects of this sacred place of where we do meet the sun every morning.

I appreciate for the mayor outlining his dreams for the park and I do believe these dreams can be realized and I support this bill unequivocally. Thank you.

Senator Barnes: Thank you. I will yield to my colleague Senator Ada because Senator Guthertz is the author of the bill and have her close if there is any other questions. Senator Ada do you have any questions or comments for the panel?

Senator Tony Ada: Just for mayor Pedro. Are you sure, you want authority for the beach?

Mayor Terlaje: Well I don't really want the authority but I am the one doing all the work. And I am not assigned to it but I just do it because I feel it is my obligation to the people of Yona and also the visitors that they have a good time barbequing down there or a party.

Senator Ada: I guess one of the concerns with Parks and Receptions is whether you are going to close it off to other residence that want to use the facility?

Mayor Terlaje: Senator, they know very well that I am not going to close it off to only the Yona residence. I plan to close that at six o'clock at night and open it up at eight o'clock in the morning. But if there is a group that would like to have an overnight stay then of course all they have to do is check with me and I will let them.

Senator Ada: Mr. Cura what currently is the maintenance down there at Taga'chang and how often do you guys perform maintenance?

Mr. Okura: I would refer all the questions to my Director. We will just get the questions.

Mayor Terlaje: I can answer that. I want to say it straight forward because as public officials we got to make it known, we have to make the public know this is what we do and this is what they do not do. I do the maintenance down there. Last Saturday I had a group of people down there picking up the trash.

I did not see any of the Parks and Recreation I am sorry to say. I want them to take a look Taga'chang because there are several parks that is assigned in Yona and I have been trying to clean them since 2001. And I will continue to do that I do not care who is in charge. I will do that because it is my village.

Senator Barnes: Senator Ada in all fairness to the Department of Parks and Recreation and to the Director who is not here at the moment we will go ahead and refer all those questions to him and get those answers and we will get back to you. Also with Mayor Terlaje and his staff to go down there to augment what the Department has not done due to the lack of resources. I will get the answers to those questions because they are questions that need answers to. Also not just by Mayor Terlaje but Parks and Recreation so that will be a committed answer, back to you.

Mayor Terlaje: Well Senator do not get me wrong because Director Calvo is a very good friend of mine and I know that he is very aggressive we use to work together. All I am saying is we need a little attention to that beach. That is all we need and I can work with the Director.

Senator Barnes: Thank you very much. Senator Guthertz is there any questions.

Senator Guthertz: I have two points. I remember Taga'chang beach very well. I use to go there frequently for barbeques and parties. It was a beautiful facility for a number of years ago and very well maintained very fun place to go. As you recall Dr. Strong the University use to have a lot of picnics there for the faculty and staff and we very much enjoyed going there.

But it is a very different place today and it is shameful frankly. We recognize all the problems that Parks and Recreation is having and I think it is time for delineation really those things that Parks and Receptions should be empowered to take care of and those things that should be devolved to the Mayor's and to the Municipalities. I look at this bill as a test case and yes it is a paradigm shift turning authority of Taga'chang to the Mayor and to the purview of the Municipal Council.

But it is a good experiment. I am willing to see what the Mayor can do with his Municipal Council and with his community and with parameters that it will be opened up to the public and that it will not be exclusive just to the people of Yona. It will be open to the public and it always has been open to the general public. As far as to the general comments to the Director he has some good comments but he should be here. Now this thing about having another appointment will not allow me to be here, I have heard that from Directors since I became a Senator.

When they do not want to come to the hearing or they do not want to answer questions they do not show up and that is not the way this is suppose to work. The Director and I have been a Director, and I know what is required. An advance proper of notice is given for the scheduled Public Hearing, minimally the Director should be at that hearing. It is a matter of respect that the role the Legislature has in developing bills. Now one of the questions was, why was the Department of Parks and Recreation not notified in advance before this bill was introduced?

That is not how the process works. When the Legislature see a need or a problem, or the constituents approach it, they will introduce a bill to address the issue, and they will invite the Executive Branch, department and agencies and the public at large to come to this legislature and share their views. That is what this hearing is for and the Director should be here.

Now I know Peter Calvo very well. He was my student. He was energetic, proactive and enthusiastic. No one is saying any differently. But it is time now to devolve this government.

Governor Calvo is doing some good things in trying to introduce some worthwhile things to fix this government and this is an initiative to introduce some worthwhile things to change this government to empower our Mayors, to empower our communities to take ownership and pride in their villages, in their Municipalities and in the resources and sites and things that are unique to their village. And that is what this bill does it is a beginning and I am very happy that we have introduced this bill. I have no idea how far it will go. But for this Senator I will work as hard as I can until it becomes law. And I will ask our friend over at Parks and Recreation to understand this.

That this not to hurt you, this is not to challenge you. This is to actually help you. This bill helps Parks and Recreation, because as what was noted by our good Mayor, Parks and Recreation has

not responded to the needs of Taga'chang Beach Park probably because of the other difficulties that you would have to contend with on a daily basis. So if you cannot do it why should the Mayor and Municipal Council be able to do it.

So that is the intention of this bill and to also widen the spectrum to allow the Mayor and other Mayors to initiate a fee schedule for the use of these facilities. I think the Mayor should be commended for closing the facilities at the idea of six o'clock in order to reduce the event of vandalism and other bad things that happen to the beach area, but being able to open to later hours for specific functions and events so that accountability is laid out. So I would actually like to see this bill to be able to broaden itself to be implied to other Mayors in other Municipalities and I think it will have a chance to do that. Thank you, Madam Speaker.

Senator Barnes: Thank you Senator. I do have a question for Parks and Recreation and I am going ask if you can answer in your capacity at the Department. And then I will go ahead and have Mayor Lizama speak on behalf of the bill.

But in as far as the time lines there was a recommendation from Mayor Terlaje that if it was transferred over to him that there will be an opening time and a closing time. My question to you Mike is, out of all the beaches and parks that you have, are there any time line regulations that are set at any of them at the parks as we see it today?

Mr. Cura: Yes. There are currently 9-6 operations. It does say on the permit when they get the permit from us.

Senator Barnes: So the majority of your beaches and parks it is a majority of 9am to 6pm?

Mr. Cura: Yes.

Senator Barnes: Yes. Alright thank you. Mayor Lizama I understand it that you wish to speak on behalf of this Bill 365.

Mayor Lizama: Yes Madam Chair, I had to go to an eleven o'clock meeting and I came right back. I thank you again and I come as Mayor of Yigo to support Yona. Of course with their efforts and my wife is from Yona. We share the same opportunities perhaps with the Guam Legislature does make this happen. I commend the good Senator my former boss, Senator Judi Guthertz for sponsoring this bill and you know I have to say this that Mayor Pedro from Yona works just as hard as any other mayors that do and you know at the same time we get criticized. You know Mayor, how many times do we hear that the people of Guam go out to Taga'chang and that the Mayor is not doing his work.

But little do they know that responsibility lies with the Department of Parks and Recreation. We have no problems with the Parks and Recreation but we need to allow for the Mayor of Yona to make his name clear as to how the result of Taga'chang has been maintained. When I was with

the Guam Police as a cadre we would always run with the recruits from GCC and we will make our way up to Taga'chang. For five years we have been doing that. And even then when Parks and Recreation was in charge of Taga'chang did not do a pretty good job.

It is not about blaming a particular administration it is about what I think is the right thing to do. It is about giving the Mayor to clear his name so that if there is opportunity for the people of Guam to not blame and to be pointed at and if they continuously blame the Mayor then blame him if he is responsible. But do not blame him of the results of the condition of Taga'chang.

You know good Senators, just last week in working with the school they wanted to reach out so that they can bring the parent teacher conference closer to the community and that is exactly what happened. Upi Elementary under the leadership of Principle San Agustin had brought, and worked with the Mayor's office and Parks and Recreation, asking permission to utilize the grounds at GHURA 506 to hold this conference and they were told that they would have to pay a fee.

I did not know but when I went to take a look the grass was almost about three feet high. The basketball was not lit. Where are the parents and the kids going to go when they need the restroom? But we wanted to bring this out to the people and the parents to bring it closer. We had a portable toilet brought in, lights we had them changed and a generator so that we can accommodate the parents and children for this parent teacher conference at a Parks and Recreation responsibility area in terms of maintenance.

I would like to go on record to support my colleague the Mayor of Yona and of course the sponsor of the Bill, Senator Guthertz. Thank you.

Senator Barnes: Thank you Mayor Lizama and before I close I just want to note for the record Parks and Recreation had brought up some good concerns. When we look at the Territorial recreation facility to a Community recreational facility I would like to know the update of that status and of course as we continue to work closely with the Department of Parks and Recreation perhaps we can see how we can enhance, augment or support the Mayor of Yona and seeing where could.

Because there is an opportunity to ascertain some Federal Grant funding because definitely it is a historical site and advocate in getting some national resources if there is some available. So Mr. Cura, will you extend to Mr. Calvo the questions that have been asked here today? Some of those questions have been answered by our Mayor. So if there is additional mark up that is needed one will be committed to the agency and with that said it is 12:05 in the afternoon and I will call this Committee hearing adjourned. Saina Ma'ase and Su Yu'us Un Binidisi. Thank you.

Before I share some of my thoughts, I want to thank you, Mr. Chairman, and members of this committee not only for the opportunity in allowing me to testify on Bill 365, but also to thank you for your heartfelt understanding in acknowledging that one of our most beautiful beaches on the island is in need of considerable maintenance, protection and preservation.

To start, I want to just refresh your memory on why Tagachang Beach Park is considered one of the most significant places in Yona. The history of Tagachang Beach Park goes back before the Spanish time, even before Magellan discovered Guam. Though my testimony here today focuses on my desire to acquire custody of the Tagachang Beach Park and my support of Bill 365, I am trustful that my appearance here today will certainly prove my arguments on why we need to protect Tagachang Beach Park.

As related to me by several of our elders in Yona when I first became mayor in 2001, Tagachang Beach Park was a sacred place used by our ancestors to congregate and continue to strengthen and perpetuate our cultural livelihood. No decision can be made in regards to residential rules both on human, social or residential factors out on the premises of Tagachang Beach Park.

Though my office lacks much of the funding to uplift the Tagachang Beach Park area, I can assure the members of this committee that if the decision to have the Tagachang Beach Park fall under the custody of the Yona Mayor's Office, restoration of the water, power and restrooms, and the overall beautification of the Park itself will most certainly take place.

Understandably, I know that we are all familiar with the financial short-comings of our government and I am not here to fault the Department of Parks & Recreation for the neglect of Tagachang Beach Park, but to acknowledge that my office can at least restore the future outlook of the Tagachang Beach Park as opposed to its current condition today.

The following plans that will be undertaken upon the release of the Tagachang Beach Park to custody of the Yona Mayor's Office would entail:

1. Repair the restroom facility.
2. Work with Guam Waterworks Authority (GWA) to repair waterlines and install water faucets where needed.
3. Work with Guam Power Authority (GPA) to assess and repair all electrical outlets and put in place lighting where needed.


4. Work with private contractors to resurface cracks within the pavilions.
5. Have daily security/maintenance individuals assigned to the Tagachang Beach Park seven (7) days a week from 9 a.m. to 6 p.m.
6. Several undergrowths will be removed and clearance will be a major task.
7. Notice of restriction and regulations signs will be posted.
8. Ground leveling will be pursued.
9. Work with GPA to install streetlights.
10. The main road leading to Tagachang Beach Park from Route 4 will be maintained.

My real vision once the Tagachang Beach Park has been released to the custody of the Yona Mayor's Office would be to clear the south side of Tagachang Beach Park and construct a Cultural Center and have the Senior Citizens and the Adult residents of Yona become the caretakers of the facility. Senior Citizens and the Adult residents would be able to use the facility to entertain visitors and tourists by serving traditional menus or displaying their skills at arts and crafts. Tagachang Beach Park will most certainly become a tourist attraction.

Mr. Chairman and members of this committee, I applaud you all for introducing Bill 365.

SUBJECT: Response to Legislative Bill 365

Legislative Bill 365 proposes to transfer "administrative control" of the Taga'chang Beach Park to the Yona Mayor as a Community Recreational Facility rather than a Territorial Recreational Facility and to create "Permit Fees Rules" through the Administrative Adjudication Law (AAL) process for use by the Yona Mayor under the MPC Revolving Fund.

Chapter 77, 21 GCA authorized the creation of the Territorial Park System. The Department complied with this authorization in 1978 with a Territorial Park System list which was subsequently codified under Chapter 3, 23 GARR. Taga'chang Beach Park was placed under the Territorial Park System as a Territorial Recreation Facility and may be archeologically encumbered. Moreover, PL 22-18 also reserved the Taga'chang Beach Park under the Guam Territorial Aquarium Foundation (Chapter 76, 12 GCA).

Legislative Bill 365 is a piecemeal type of proposed legislation that creates more questions than answers.

1. Is the Legislature redesignating the Taga'chang Beach Park from a Territorial Recreational Facility to a Community Recreational Facility?
2. Will the residents of other municipalities have access to the Recreation Facility or is this asset strictly for the residents of Yona?
3. Is the Legislature abandoning the territorial long term objective of development a Territorial Aquarium?
4. Has the Guam Territorial Aquarium Foundation comment on this action?
5. What are the plans of the Yona Mayor and MPC on the use of the beach park?
6. Is the Yona Mayor planning to develop the park? If yes, how and who will conduct the archeological / historic survey?
7. Is this proposal a watershed proposal on setting precedence for Mayors in municipalities having territorial beach parks to continue with further requests for amendments to the Territorial Park System having 20 separate operations for Territorial Beach Parks; hence, 19 Mayors' Revolving Funds and 1 DPR General Fund?
8. Is this proposal only to create fund source for the Yona Mayor?
9. How does this park fit into a "community" asset when it is removed from the "community"?
10. Has a citizen survey been conducted on this action?
11. Why was this proposal not discussed with the Department prior to submission as a bill?

Hafa Adai Speaker Won Pat:

The Bureau submits the following comments on Bill 365 –“Transferring the Tagachang Beach Park Under the Administrative Authority of the Office of the Mayor of Yona; and Including Fees Charged for the Public Use of Public and Beach Parks Under the Purview of the Respective Mayors in the Municipal Planning Council Revolving Fund.”

The Bureau is very concerned that the Guam Legislature is beginning the dismantling of the Guam Territorial Parks system that is under the jurisdiction of the Department of Parks and Recreation (DPR) by introducing Bill 365. Bill 365 titled –“Transferring the Tagachang Beach Park Under the Administrative Authority of the Office of the Mayor of Yona; and Including Fees Charged for the Public Use of Public and Beach Parks Under the Purview of the Respective Mayors in the Municipal Planning Council Revolving Fund” will result in the fragmentation of the Territorial Park System which will ultimately create more problems for park management, maintenance and budgeting, and for the general public and groups wanting to utilize the various parks like Tagachang, Santos Memorial Park and the Merizo Pier Park. Additionally, as we will point out public access to our ocean shorelines may be threatened by this legislation, and result in the removal of the Governor’s direct authority over the management and administration of some of Guam’s public parks.

First of all, the Guam Territorial Parks systems is composed of major parks, especially those that lie along our ocean’s shoreline. Those parks are crucial public access points to the ocean shoreline and the coasts natural resources. As such those pathways belong to the all people of Guam and as such should be handled by the Governor, the Chief Executive of the island. The mayors are officials elected by constituents in their respective villages and therefore are not necessarily answerable to people outside their particular jurisdiction.

Second, this dismantling of the Territorial Park System which started with the transfer of the Santos Memorial Park in Piti and most recently the Merizo Pier Park takes the direct management and control of those park areas out of the hands of the Governor and puts it into the hands of various Mayors. These Mayors may also determine their own fees. Will there will be a standardized fee structure that now exists with DPR? Persons who want to make reservations for a park area also have to figure out what village that park is in, call the village Mayor and pay the fees they decide to charge. Additionally, will persons from that village have preference over others when making reservations? The Mayor of each respective village may decide to give such preference.

Third, the issue of Public Access to the Ocean shoreline is very important here. Unfortunately for the people who want to use the Santos Memorial Beach Park in Piti, after the park was transferred to the Piti Mayor, it has been closed more often than open. The park is chained shut 24 hours a day (pictures attached). People cannot just passively go to the park without making a reservation. According to the Mayor's staff, their justification for closing the park was that the people created trash in the park so they keep it closed. There is barely any space to park outside the chained entrance and the busy major Marine Corps Drive highway adjacent makes it dangerous to park along the road. Is this what we can expect to occur at other parks that are transferred to the Mayors? This is also a violation of local laws that requires public access to the ocean shoreline be provided to the maximum extent possible. At least the DPR kept most of their public and beach parks open for use any time of the day, even if they were not given adequate resources to maintain those parks.

Instead of transferring the park, as this legislation proposes, DPR and the Mayors Council should enter into a Memoranda of Agreement that will carry on the spirit and intent of this legislation. That spirit and intent I believe is to keep our parks clean, maintained and open to the public 24 hours a day or at least most of the day.

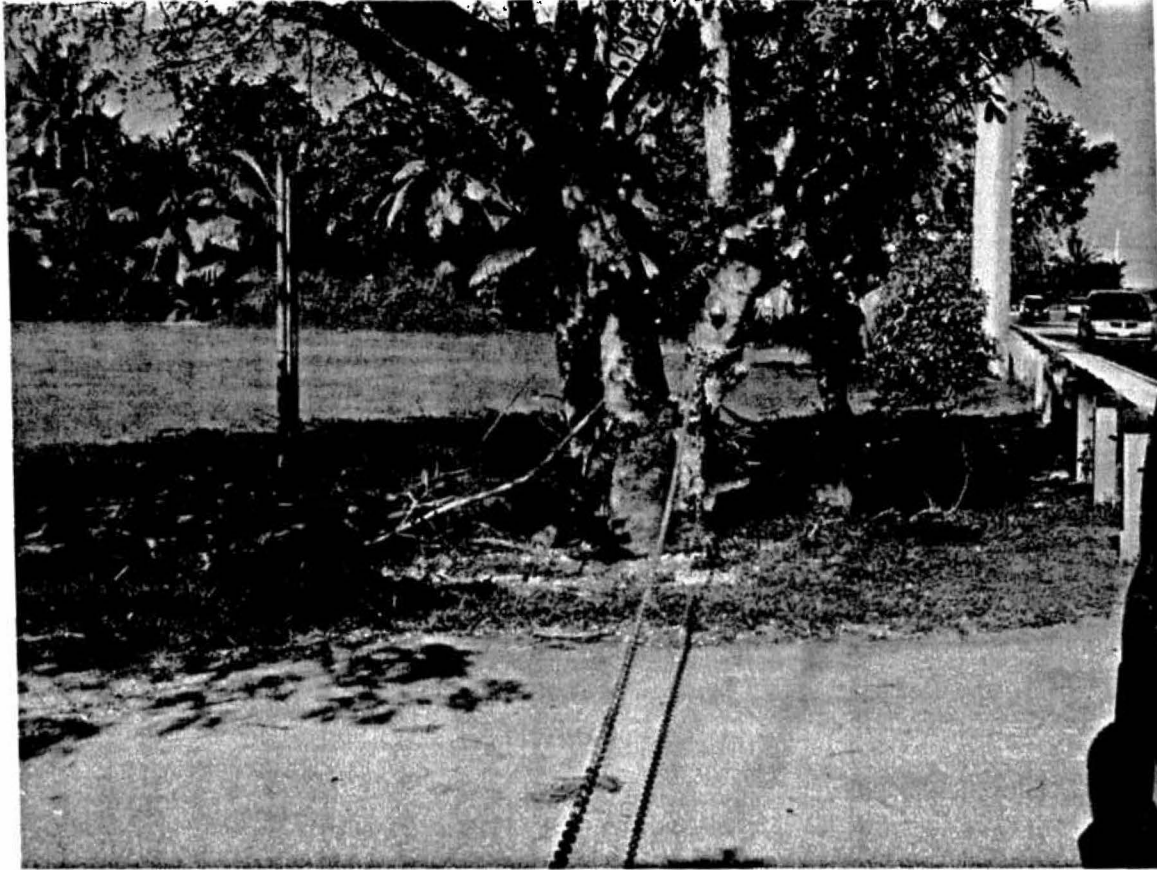

The proximity of the soil stockpile was also a concern because this a coastal park and the Marine Protected Area is immediately off its shore.

When the Bureau staff asked the Mayors staff why it was not open they said they closed the park because people made trash. At least DPR left it open. Also because of the major highway you cannot safely park outside the park's barriers and walk in.
