COMMITTEE REPORT DIGEST

Bill No. 193-32 (COR)

I. OVERVIEW: The Committee on Health & Human Services, Health Insurance Reform, Economic Development and Senior Citizens conducted a public hearing on October 4, 2013. The hearing convened at 9:04AM in I Liheslatura's Public Hearing Room. Among the items on the agenda was the consideration of BILL 193-32 (COR)-An act to amend Section 4 of Public Law 31-235 to delete the provision requiring the "Printed Materials and the "Checklist Certification" to undergo the rule making process pursuant to the Administrative Adjudication Law; Introduced by Sen. Dennis G. Rodriguez, Jr.

II. Public Notice Requirements

Notices were disseminated via hand-delivery/fax and/or email to all senators and all main media broadcasting outlets on September 27, 2013 (5-day notice), and again on October 2, 2013 (48-hour notice).

The public hearing on agenda item Bill No. 193-32 (COR) was called to order at 9:04AM.

III. SUMMARY OF TESTIMONY & DISCUSSION.

Chairman Rodriguez: I would now like to call those to testify on these bills. Mr. James Gillan, I would like to ask you to please come forward. Good morning.

Bill 193 is an act to amend Section 4 of Public Law 31-235 to delete the provisions requiring the printed materials and the checklist certification to undergo the rule making process pursuant to the Administrative Adjudication Law. What this basically is, ladies and gentlemen, is to amend existing law, to allow for these checklists and printed materials to be provided to patients and not have to go



through the Administrative Adjudication process. We received a memo from the Attorney General's office through the department indicating that these materials that the department intends to pursue are not considered any rule or regulation. Therefore, it's been an impediment for the law to move forward. And so what we are doing now is clearing those impediments and making sure that we move forward with the law. And so now we have the director, would you like to present your testimony.

Mr. James Gillan: Thank you very much. I am James Gillan, I am the Director of the Department of Public Health and Social Services. I am here to testify on 2 very closely related bills- 191 and 193. If there is only one version of the bill that I would support would be the one, I'm faced with choosing to support, your bill Mr. Chairman but thank you Senator Aguon, but the reason I don't support Sen. Aguon's bill is really technical is because it does away with the entire section because it means that effective on enactment, I would be required to publish it and distribute the materials.

We still have some considerations with the artist who's done the graphic work on licensing for those drawings and we also wanted to make these things available through electronic media and there is a license pending for that also, and so if I had to do this immediately upon enactment, I have some difficulty following the law, and I do want to follow the law. So, your version, Mr.Chairman, allows me to have some discretion of when this material will be printed and distributed and its just basically that. Thank you.

Chairman Rodriguez: Thank you very much Mr. Gillan. And we have been in communication with the author of Bill 191, Senator Aguon, and so you know, we have both on the agenda today to have it heard eventually we will have these two merge because it has the same intent in wanting to move forward with the public law.

Senator Aguon: Mr. Gillan, thank you very much for your testimony this morning and for sharing your perspective. I think its critical that we get this particular law enacted and carried out. You know, within reasonable time frame. First and foremost, both legislation were introduced on the same day. And so in this particular case it makes and amendment to a previous law that was sponsored by the Chairman. So that's a direct acknowledgement, here is a situation that needed to be addressed and being able to delete that entire section, would have allowed the department to move in the direction of implementing it and I understand your concern about the timeline. The only issue Mr. Chairman then, is if we were to proceed with his legislation because it is an amendment, and the amendment would be to add Director of Public Health and Social Services and to delete the reference to the rule making, its not every enactment so we have to be specific on our part where Section 4 would be hereby reenacted to read as follows so they provide you that additional timeline. Because based on an amendment that the timeline, although the verbage is here, it still would be effective the date the signature into law which is November 1st, 2012. So if, it sounds like semantics, but from a legal perspective, that's my understanding of what it needs to, the language that needs to be used, Mr. Chairman, is that it has to be reenacted to read as follows, so that it provides that 60day timeline and that I understand is what you're requesting.

Mr. James Gillan: That's right.



Senator Aguon: Okay. The other question is, I understand that you alluded to the fact that there are certain, I guess, copyright authorizations that you need to be able to acquire. Where are you in that process and the reason I ask that is because the law was signed on November 1st 2012? We are nine months into this law, of which 60 days thereafter, so that would have been January 1st that the materials should have been completed and within reason, that's why I am asking you if you can explain where you are in this process because if 60 days is not sufficient for you to acquire the authorizations, then we need to know, because we certainly want to make sure that we give you the flexibility, but within a constricted timeframe to bring the (inaudible) and get the authorizations that you need and then to implement the law, and so if you can explain where you are with that entire process, please?

Mr. James Gillan: Now, I don't want to (inaudible) the fine points because I am not an attorney,

Senator Aguon: That's our side, so don't worry about it.

Mr. James Gillan: I think I have 60 days from the time we determine that the materials are appropriate or the materials need to be put together, so that kind of leaves it open ended but I don't want to waste much more time with this, I think that the intent of the legislation is what it is. I'm going to follow the law as it's written. I think that the license now that there is this promulgation through the Administrative Adjudication Act could be resolved by this amendment, there'll be no need to publish it on our website, because there is this other issue whether or not the artist would allow to have it on the license to have it on electronic media, okay, that was another license issue, so I think we are pretty much almost finished with the license issue on the ability to print the high resolution copies that have to be done to do the printing. And I think that we would be within 60 days from enactment.

Senator Aguon: And so the language here, should we insert the word, rather than amendment, should reenacted then that 60 day allowance prescribed here in the proposal would be upon approval the Director of Public Health which is yourself or whose yourself. With that being the case you're saying right now that conceivably within the next 60 days, aside from the electronic version printing, that you'd be able to complete that authorization that you require?

Mr. James Gillan: Yes.

Senator Aguon: Okay, because you are absolutely right that it provides an open ended option, by chance it extends to 90 days it could extend to 120 days and it is not the intent of either legislation. The intent is to work with you to what can be done to get this law implemented.

Mr. James Gillan: Yes Sir.

Senator Aguon: Thank you very much Mr. Gillan, thank you Mr. Chair.



Chairman Rodriguez: Thank you Senator. Are there any other questions or comments? Thank you very much Mr. Gillan, and just before, since both bills are very similar, we'll hear both bills now, Bill 191, so if there's any other individual who wishes to testify, I would ask you to please come forward, on either 193 or 191.

Mr. Tim Rohr: Good morning, Tim Rohr, citizen. Just a couple of points relative to that, what Mr. Gillan said, the Esperanza Project is undertaken the responsibility to procure the copyright and to assemble the printed materials as per the provisions of the law and to pay for them. There's no requirement for it to be electronically published, we'd like to see that at one point and if the department would like to see that, they are welcome to purchase the copyright and that would allow that, but the copyright that we have allows us to go forward with the printed materials and we quickly assumed that responsibility. We support Bill 193 simply because we still believe it is right and good for the department, the director of the department to have control over the printed materials to prove them. Whereas Bill 191 would eliminate that requirement. We want the public to have confidence and assurance that the Department of Public Health which is responsible over the implementation of all rules, matters related to public health are the ones who give the final approval. So just relative to that copyright situation, you're Bill 193 would eliminate the whole rule making process which would require electronic publication, so that's no longer an issue, and I hope I clarified that. So I speak in support of Bill 193, and urge you to pass it promptly.

Chairman Rodriguez: Thank you very much Mr. Rohr. The committee has received numerous testimonies which were provided by email, so we will continue to do that with both bills.

Senator Aguon: Mr. Rohr, just a quick question. I take it that the Esperanza Project is working in conjunction with the Department of Public Health and Social Services to acquire the copyright, is that what you are saying?

Mr. Tim Rohr: The Esperanza Project acquired the copyright independently.

Senator Aguon: So you are not going to share that copyright authorization, they still have to pursue theirs?

Mr. Tim Rohr: Once we give the printed materials to the Department of Public Health with all the information about the copyrights and everything, they have basically the license, we turn it over to the Department of Public Health and they can print to their hearts content. After, we are going to the original printing of 5,000 but essentially we owe the copyright, we procured it, we paid for it. But if the department actually wants to sign, if they actually want control in the future, its fine with us. At this point we just want to get the 5,000 copies printed immediately, and what we want is to work with the Department of Public Health after that.

Senator Aguon: I just want to make sure, I don't know, the Vice Speaker is here knows of the legal perspective or approach to this and now having a non-profit organization who has collectively (inaudible) issue like this that is extremely sensitive. I just want to make sure that this relationship and extending your copyright authority to a public entity would keep within the confines of what is authorized by law, because we certainly don't want to come into a situation where we are



questioned. And that's the only concern I have, and I'll leave it to legal counsel from the legislature , and vice speaker Cruz...

Mr. Tim Rohr: That's why we did that because the last time we tried to pass this bill and we presented, I think the budget, I think it was going to cost \$7,000, we were told by you guys that we don't have the money. We'll give you the copyright...

Senator Aguon: It's extremely commendable on your part...

Mr. Tim Rohr: We are not looking for any kudos, we did what we needed to do, and I understand your part. Whatever we need to do with the Department of Public Health we'll provide it.

Senator Aguon: I just want to make sure that legally, there are not potential challenges along the road.

Chairman Rodriguez: Thank you Senator. Are there any other individuals who wish to testify?

Rev. Mr. Frank Tenorio: Senators, manelu-hu, my brothers and sister. Every time we come to this session, we have one objective, we have to understand that we are here to serve the community. And to be able to serve our community, we must identify also that there is God and his commandments for all of us. I also, all the time that (inaudible) of this understanding of the commandment of God, love God, love your neighbor. You're here because of your neighbors, because of the poor, the rich, the handsome, the sick people, we're all here for that. I am blessed because today we're celebrating St. Francis of Assisi. I guess most of us, I can say, can identify who St. Francis of Assisi is. He was one person and continued to exist that his name all over the world and a lover of God and a lover of mankind. And this is why God brought us into this world so that we can have harmony with one accord, directed by God to fulfill his wishes and his desire and his will in loving one another. Life is the ultimate, the greatest, there is no other greater than any other created beings, human life is the greatest of all. Jesus came into this world suffered and died for you and me. He is telling us to love him and follow his commandments and everything will come forward with his blessings. I want to share with you, I hope you don't mind, but I have a very special prayer. It is a very special prayer because it is St. Francis of Assisi's feastday. Brother and sisters, I beg you through the mercy of God to offer your bodies as a living sacrifice wholly and acceptable to God. Your spiritual worship, do not conform yourself to this age but be transformed in mind, so that you may judge with what is God's will, what is good, pleasing and perfect to almighty God. I thank you for allowing me to speak for our Lord, Jesus Christ. I never look at each of you as little less than a human being, because we are all human beings. No matter how sinful you may be, you are all human beings, and for a fact, Jesus came not for righteous people but for sinful people. He goes and tells us to sin no more. Abortion is a sin against humanity against society. Same sex marriage is no difference in that it contradicts the law of God, the law of nature. May St. Francis intercede for each and every one of us. May St. Francis help to direct your decision in bringing justice, truth and love of God for humanity. Humanity is essential to understand first that we don't have description to say that he is less because he is a very sinful man, no, that person may be a very sinful man, but that he may be one day the greatest of all man like St. Agustine. I can say there were many saints that were very sinful people, but they changed because of the grace of God, and that's



my prayer for all of you, for all of us. And I can say that I served for more than 20 years, the poor and the babies in the womb and all of those. Thank you for allowing me to talk to you, Si Yu'os Ma'ase' Senators.

Chairman Rodriguez: Thank you very much, God bless you. That will conclude the public hearing on Bills 191 and 193.

There being no other testimony, or comments by Senators, Chairman Rodriguez declared the bill as having been heard, and concluded the public hearing on Bill No. 205-32 (COR).



"THE WOMEN'S REPRODUCTIVE HEALTH INFORMATION ACT OF 2012"

Dear Mr. Chairman:

My name is James W. Gillan and I am the Director of Public Health and Social Services. I am here to testify on two very closely related bills, 191 and 193.

I want to express my thanks to you and to Senator Aguon for addressing the matter of the Administrative Adjudication Act requirements as stipulated in Section 4. of PL 31-235.

If there were only one version of the bill I would have supported it. I am faced with choosing from the two and I support your Bill Mr. Chairman. It has somewhat the same effect as Senator Aguon's bill, but I feel that by deleting the whole of Section 4 of PL 31-325, my reading of it, or my understanding of it would then make the Law effective immediately. The Department is still awaiting the licensing permission from the graphic artist whose drawings are contained in the information booklet. When we obtain that permission, we will have deemed the printed materials and checklist approved. We would then have them printed and distributed as required. Your bill allows for my approval discretion which is important at this time. Eliminating the entire Section 4 would in effect require me to print and distribute materials for which there is currently no license to do so. For that reason alone, I support Bill 193-32.

Dear Senator:

I write to oppose Bills 191-32 and 193-32.

P.L. 31-235 was passed by the Guam Legislature to provide for women's informed consent in order to obtain an abortion. Section 4 of the law requires the Department of Public Health and Social Services (DPHSS) to follow the rule-making process of the Administrative Adjudication Law (AAL) for the information pamphlets ("printed materials") and "checklist certification" before the law can take effect. Bills 191-32 and 193-32, which would delete section 4, undermine the purpose and intent of the law.

The intent of P.L. 31-235 is clearly stated in the preamble in section 1: The Guam legislature finds "it is essential to the psychological and physical well-being of a woman considering an abortion that she receives complete and accurate information material to her decision of whether to undergo an abortion including information concerning abortion alternatives." (Emphasis added) Further, the law requires that DPHSS shall produce the printed materials and present them "in an objective, unbiased manner designed to convey only accurate scientific information." P.L. 31-235, section 2(b) (emphasis added). By deleting section 4 of P.L. 31-235, Bills 191-32 and 193-32 eliminate the submission of full and accurate information, particularly by doctors and other medical professionals who will be subject to liability under the law, to be considered by DPHSS in producing the printed materials and checklist certification. Instead, as was clear at the public hearing on these bills on October 4, 2013, only one side of the issue - the materials produced by Tim Rohr - will be considered and utilized. Whatever happened to democracy and a full and fair hearing on this issue? How can women receive "complete and accurate information" "in an objective, unbiased manner" when they are given only a one-sided view of information and are not provided information by doctors and medical professionals trained to know the type of information they should receive? Most important, since when does the Guam Legislature delegate the determination of public policy to a private individual, Tim Rohr, who has a well-known religious bias on the issue of informed consent?

Page

Bills 191-32 and 193-32 were ostensibly introduced because they would save DPHSS some money. Yet no information was provided at the public hearing to show that the costs of complying with the AAL would be so prohibitive that DPHSS could not effectively produce the printed materials and checklist certification. The AAL, (5 G.C.A. § 9301(a)), provides that at least 10 days before the date set for hearing, notice is to be published in a newspaper scheduling a hearing. At the hearing parties are afforded an adequate opportunity to participate in the formulation of the proposed rules through argument or submission of writing. 5 G.C.A. § 9301(b). The DPHSS director is then tasked with producing a report of the proposed rules. The AAA process is straightforward and would not be costly. By contrast, the detriment to women who are not given complete and accurate information in an objective, unbiased manner, is incalculable.

I enclose a draft checklist certification as an alternative to the one produced by Rohr. If the Legislature is concerned about cost, it should be concerned about the 17 pages produced by Rohr which must be made available to all physicians in Guam and must also be translated in other languages as required by P.L. 31-235, Section 2(c) (at a minimum, Chamorro, Japanese and Korean).

It was clearly the intent of the Legislature in enacting P.L. 31-235 to allow for public participation in the development of printed materials and the checklist certification required to provide informed consent for women. Bills 191-32 and 193-32 undermine that intent and allow a one-sided, biased version of materials to be forced upon the women of Guam.

The final determination will be made by the doctor upon ultrasound examination. If you are between 4 - 14 weeks, the common procedure is Vacuum Aspiration. Medication Abortion is available for pregnancy termination between 4 - 9 weeks. If you are between 15 - 22 weeks the most common procedure is Dilation and Evacuation.

3. Types of Abortion Procedures (10 G.C.A. § 3218.1(b)(1)(ii)(a)):

First Trimester (4-13 wks LMP) Vacuum Aspiration- This abortion procedure begins with a local anesthetic given to numb the cervix. The cervix is then widened using dilators, which are tapered rods that gradually increase in size. The physician inserts a small tube (cannula), which is attached to an aspiration device. The device's suction empties the contents of the uterus through the tube. The physician may check the walls of the uterus with a curette. The entire procedure takes less than 10 minutes. Sensations will vary, but they are mostly described as cramping or discomfort, which generally subsides within a few minutes after the procedure is over.

Early Non-surgical/Medication Abortion (4-9 weeks LMP or up to 63 days) – While in the clinic, a drug, Mifepristone, is given to stop the development of the pregnancy. One to two days later, at home, a second drug (Misoprostol) is taken, causing the uterus to contract and expel the embryo and placenta. During this process cramping and bleeding will occur.

Second Trimester (14-22 wks LMP) Dilation and Evacuation- During the initial appointment, the osmotic dilators are inserted into the patient's cervix to begin the process of slow and gentle dilation of the cervix. The abortion procedure occurs several hours later, or in some cases one or two days later and involves removal of the pregnancy with forceps. A suction instrument is used to clean the uterus, and a curette is used to check the uterine walls. Patients are then monitored in recovery for at least 2 hours following the procedure.

Complications of Abortion- Possible complications include: blood clots accumulating in the uterus, requiring another suction procedure; infections, most of which are easily identified and treated if the woman carefully observes follow-up instructions; a tear in the cervix, which may be repaired with stitches; perforation of the wall of the uterus and/or other organs, which may heal themselves or may require surgical repair or, rarely, hysterectomy; and abortion that is not complete or that does not end the pregnancy may require the procedure to be repeated; excessive bleeding due to failure of the uterus to contract, which may require a blood transfusion; death. In the second trimester, risks increase with every week of gestation. 10 G.C.A. § 3218.1(b)(1)(ii)(b), 3218.1(c)(4).

- 4. Risks with terminating a pregnancy vs. carrying a pregnancy to term-Health risks are low with either decision. There is approximately 1 death for every 167,000 women who have legal abortions and these rare deaths are usually of adverse reactions to anesthesia, heart attacks, or uncontrollable bleeding. The death rate for a woman carrying to term is about 10 times greater. 10 G.C.A. § 3218.1(b)(1)(ii)(a), 3218.1(b)(1)(v).
- 5. Your blood type will be determined the day of your appointment. Approximately 15% of the population is Rh negative. All Rh-negative women will receive an injection of Rhogam to prevent problems with future pregnancies such as miscarriage, severe fetal anemia or permanent fetal damage. The cost of the Rhogam is \$75 \$125 depending upon fetal age. 10 G.C.A. § 3218.1(b)(1)(vi).
 - 6. As required by Guam Law, the following information is provided to you:

- Medical assistance benefits may be available for prenatal care, childbirth, and neonatal care. Public assistance may be available to provide medical insurance and other support for her child while he or she is a dependent. To learn more about the medical care and support that you may qualify for, visit http://www.dphss.guam.gov or call (671) 735-7270. 10 G.C.A. § 3218.1(b)(2)(i) and (ii).
- Alternatives to abortion include adoption. The law permits adoptive parents to pay costs of prenatal care, childbirth, and neonatal care. To learn more about adoption services available at Child Protective Services, visit http://www.dphss.gouam.gov/content/child-protective-services-section or call (671) 475-2653. 10 G.C.A. § 3218.1(b)(2)(iii), 3218.1(c)(1).
- The father of a child is liable to assist in the child's support, including child support payments and health insurance, even in instances where he has offered to pay for the abortion. Paternity may be established by written declaration of paternity or by court action. To learn more about child support services and paternity, contact the Office of the Attorney General of Guam, Child Support Enforcement Division at (671) 475-3360) or visit www.guamese.net. 10 G.C.A. § 3218.1(b)(v).
- You are free to withhold or withdraw your consent to the abortion at any time without affecting your right to future care or treatment and without the loss of any locally or federally funded benefits to which you might otherwise be entitled. 10 G.C.A. § 3218.1(b)(vi).
- 7. It is unlawful for any individual to coerce a woman to undergo an abortion. Any physician who performs an abortion upon a woman without her informed consent may be liable to her for damages in a civil action. 10 G.C.A. § 3218.1(c)(1).
- 8. The Territory of Guam strongly urges you to contact the resources provided in this booklet before making a final decision about abortion. The law requires that your physician or his or her agent give you the opportunity to call agencies and service providers like these before you undergo an abortion. 10 G.C.A. § 3218.1(c)(1).
 - 9. I received this information at least twenty-four (24) hours prior to my procedure.
