





I. <u>OVERVIEW</u>

Bill No. 242-32 (COR) was introduced on December 17, 2013, by Senator B.T. McCreadie, and was subsequently referred by the Committee on Rules to the Committee on Guam US Military Relocation, Veterans' Affairs, Homeland Security and Judiciary on December 17, 2013.

Public Notice Requirements

Public Hearing notices were disseminated via e-mail to all senators and all main media broadcasting outlets for the January 14, 2014 hearing on January 06, 2014 (5-Day Notice), and again on January 9, 2014 (48-Hour Notice). Notices were also published in the Marianas Variety Newspaper for the January 14, 2014 hearing on January 06, 2014 and January 09, 2014.

II. TRANSCRIPTION OF TESTIMONY & DISCUSSION

Senator Frank B. Aguon, Jr.

"Good morning ladies and gentlemen. This public hearing sponsored by the committee on Guam us military relocation, veterans' affairs, homeland security and judiciary is hereby called to convene today Tuesday January fourteen at nine am. Just for information the public items on the agenda are bill number 242-32 an act relative to amending the Guam code annotated in reference to the crime of indecent exposure and bill number 247-32(COR) relative to expanding the Guam slayers statute the will prohibit inheritance by persons who murders someone from whom he or she tends to inherit. For the information for the public, information went out to all the stakeholders and to all the senators on January 3rd that was the initial publication and notices were sent out and then subsequent to that in compliance with the open government law.

On January 9th, Second public hearing notice was forwarded to all stake holders inclusive of all the senators and the printing was published on January 6th Monday, the initial printing and subsequent on January 9th. So those are in compliance with the requirements. Other than that just a caveat to our discussion today because traditionally we would provide a timeline of 10 days for the public to provide written testimony subsequent to the public hearing but because there's an anticipation for session to be scheduled to commence as of the week of the 27th of January. I would like to request that should the sponsors of either of the two proposals want to have the bill placed on the agenda that all written testimonies be submitted no later than 12 noon on Tuesday January 21st. That would give the committee ample time to be able to finalize the report and to submit it within the timeline required by the committee in rules. So without any further adieu', I would like to invite Mr. Jacob Cruz and also Mr. Phil Tydingco from the AG's office to the table and prior to receiving testimony, I would like to recognize my colleagues, Senator Brant McCreadie for joining us today and also if you would like to say a few words with regards to the first legislation in reference the crime of indecent exposure, Senator McCreadie as a sponsor."

Senator Brant McCreadle

"Thank you Mr. Chairman. Thank you for allowing me to speak and holding a public hearing for the bill, bill 242-32 which was introduced after hearing concerns from the Guam Police Department. Under the current statute, Police officers can arrest cannot arrest individuals for indecent exposure only if themselves witness the crime. Under this bill, the penalties for indecent exposure increases from a petty misdemeanor to a misdemeanor and it makes it a felony if the individual exposes himself to a minor or has prior sex crime convictions. Now based on the statistics I have received from the GPD, there are 26 arrests cases totaled from 2012 to 2013. So it is my goal to not just curb this indecent exposure problem but to end it from ever happening again. Indecent exposure is not a big problem but none the less it is a problem. The intent of this bill is to increase the penalties so that GPD can better perform its jobs. This bill will help this small problem from growing into a big problem and with that I would like to thank you again Mr. Chairman and I look for a positive response for our Attorney General's Office."

"Thank you very much Senator McCreadie and to begin with these those individuals that have signed in the order of the sign in, we are going to have now Mr. Jacob Cruz to provide oral testimony then we'll share the podium with Mr. Tydingco, Mr. Cruz."

"I apologize Chief or Deputy Attorney General but let me just go ahead and recognize the presence of one of my other colleagues, Senator Chris Dueñas. Thank you very much senator for joining us this morning. Please proceed."


"Good morning and I always defer to my fellow parishioner t here Chris Duenas. So and also good morning to the author of this bill, Brant, Senator Brant McCredie. On behalf of Attorney General Leonardo Rapadas and myself Chief Deputy Phil Tydingco, we support bill 243-32 which looks to strengthen the indecent exposure statute increasing the penalty from a petty misdemeanor to a misdemeanor. I also noticed that you're also increasing the penalty if convicted for up to a 3rd degree felony if this person does this to a person under the age of 16 or if they do it for purposes of gratification or they have a prior conviction or convicted of any prior sex offense. Again, would in its phase I know the intent of the bill it was meant to curb the act conduct or behavior which is offensive and alarming to the public and to folks. Although I would submit that there would be challenges. I anticipate and we support the bill and its intent. But the 21st century I have to share this observation. There are social morays that are a lot more looser and with technology this will present some challenges when some folks decide to press charges against other people because they have text or you know we have sex texting stature already but as you know there are a lot more going on there and increasing it into a felony will find ourselves being more challenge. But......sounds like there is a need for it. So we support it. Thank you very much."

Senator Frank B. Aguon Jr.

"Thank you very much Mr. Tydingco. Just one particular question I guess, in regards to this I think it's always noble to move in the direction to making sure that crimes are stiffened up in terms of trying to discourage any illegal activities out there. My biggest concern is looking at the resources that have been provided to you by this legislature. I know that in the last 3-4 years that every single year you've seen a modest increment to the adjustment in the overall allocation to the Attorney General's office. But this really should not impact your resources because it is more or less increasing the penalties rather than imposing additional job or work responsibilities. Is that almost a correct assessment?"

Chief Deputy AG Phil Tydingco

"Well, at least based the reported numbers and it shouldn't and I'm not putting that testimony before this body. I'm just anticipating based on whenever you increased penalties you have to expect pushback. When you look the hierarchy of what the criminal justice system faces and the criminal justice system is not just simply the police and the prosecutors. It's not like Law and Order just those two groups. There's actually other group like DOC. There's pressures there and the courts

are another body of organization that are in the criminal justice system and so in the hierarchy of prioritizing who should be getting jailed and who should be locked up longer and all of that. I'm just simply pointing out that this will complicate matters and when you deal with stiffer penalties you should expect stiffer push back especially with courts and defense attorneys are saying, "well you know that's indecent exposure I really want to put the I understand the prosecutors are pushing for more jail for the rapist, but why you pushing for felony on something like this?" especially for example when it happens in the content of boyfriend girlfriend break up. And again those are things the courts are going to have to sort out. Again I know that the intent here is for those folks that are less controlling of their impulses and so forth so and decent folks not to be offended by that. I'm just simply pointing that out factor. It's great to strengthen our laws but at the same time there's there are potential consequences and that's all I'm raising. I'm not trying to claim and impact issue even though there will be impact just not probably in a magnitude so I would agree with you senator."

Senator Frank B. Aguon Jr.

"I think Mr. Tydingco, I believe you're right in terms of not just an issue affecting GPD but also the Attorney General's Office or the Judicial system. It's really a community issue. And many times I would move in the direction of trying to stiffen up the laws. We always need to look at the implications and if we stiffen up the Laws on one end but does it resolve the discouraging any criminal activities because how stiff the laws are because it all goes back to providing the resources from the ground level. That whether it be the mayor so they can provide opportunities and activities within the village and then moving on to GPD providing the additional resources, providing your office and likewise the judicial system. So you're absolutely right in terms of looking at it from a community perspective because it is a public safety issue."


"And I think I was also hinting at and I feel like I'm sound like my parents when we were young we were all indecent too. But the promiscuity and exposure of peoples self to each other and many venues and events is a lot more different in this century than it was in the late 20th century. So I'm saying that we have to factor that in that comes into play."

"Thank you very Mr. Tydingco. I would like to welcome speaker Pangelinan. Thank you very much Mr. Speaker for joining us this morning...Senator McCreadie."

Senator Brant McCreadie

"Thank you Mr. Chairman and you're right on the nose there. It's not a huge problem. This is a problem that when I spoke to some of the stakeholders at GPD they were in agreement that not a huge problem, but a problem that if we kind of catch it early like we're doing now and increase these penalties to allow them to arrest somebody because right now, as it stands, they have to witness it themselves to be able to arrest these individuals. And I think in 2012 there were 16 cases and in 2013 it went down by 10 so my whole intent of this bill is not just to curb it but to eliminate it. So if we can go from 16 to 10 to 5 and then maybe in 2015 to zero then I've think we've done what the intent of the bill was. So I'm happy that you support it the good senator to my right the chairman of the committee brought it up the revenue and how it's going to cost the department and I'm happy that it's not going to be a huge burden on you guys and so thank you for your testimony."

"Thank you very much senator McCredie. Senator Dueñas, any comments?"

Senator Chris Dueñas

"Thank you Mr. Chairman and deputy general, back at you in terms of our Sunday rituals, nice to see you every Sunday. I don't think or presume that this is something that the Attorney General's office or any other you know group that would look at how the law is charged. Is their intent... doesn't legislation such as this when you move the bar up especially with the possible emerging issue give you more of a tool, initial tool in the tool box, if you will in terms of working on your case load to maybe plead down whereas, there was nowhere to go in the past if this becomes an emerging issue as sometimes we see in the media and something that you know that could be offensive, particularly since senator McCredie is also working on issues with regards to our visitor industry. I know this type of activity and this type of lewd behavior has been noted several times even against tourists like a Micronesia mall. I know there was a case, a couple of cases where this has happened. It's an image issue for us right and so if the message is out there that there's a much larger penalty, and more flexibility with the office does that help?"

"Yes, it does."

Senator Chris Dueñas

"Thank you Mr. Chairman, I just want to kind of bring that up knowing that the resources and other resources are stretched at times. However, I think sometimes when we set the bar higher we set ourselves up the ability to able to create a deterrent and also add other options and opportunities. so I thank you for the chance to speak on this issue."

"Thank you very much Senator Dueñas. Speaker Pangelinan, any comments?"

Senator V.T.Pangelinan


"I'm just curious if you've been invited to this and if we can get a statement from them."

Senator Brant McCreadie

"They've actually said their statements already."

"Okay, do we have any reason why we reduced it without any addition to the law? Why it's been reduced from 12 to 10. I know senator McCredie had mentioned. You said in 2012 there were 16 cases and without any amendment to the law it was

reduced to 10. Is it accurate to say that in order the charge this crime or to make an arrest the police officer has to witness it, Mr. attorney general?"

Chief Deputy AG Phil Tydingco

"You know I believe the good senator reported that was GPD information that they provided and I don't think the officer has to. If it was exposed to me and I report it.

Senator V. T. Pangelinan

"You just have to be careful."

Chief Deputy AG Phil Tydingco

"Can the officer decide if I'm credible and make that arrest? I was sort of hinting at, so there could be circumstances where it would make sense of it police officer witness it because the person or tourist describes it in such a vague or neutral way ambiguous way then you would want to probably witness it because what is it? Is he dropping his pants and all we see is his underwear and you're offended versus actually exposing his genitals, dropping his pants and his underwear or flasher so it depends on the facts. I don't what GPD's experience is on this so we have to ask them. So I would say that this only helps because you as I understand these circumstances are probably still going on. It may be in a way it is described or reported to the police. I don't know, I can't really help you there senator, but I would say now if I say your genitals and you offended me or alarmed me...that should be sufficient to cause an arrest. I don't know why GPD would say that."

Senator V.T. Pangelinan

"Maybe we can get some clarification. If in fact this is a deterrent, would it be more deterrent if we made it a first degree felony?

Chief Deputy AG Phil Tydingco

"Yes and no that's extremely high for this type of conduct. I mean if you try to look at the hierarchy of offensive, I'm going to call it offensive sexual conduct. I would say we have other more offensive sexual conduct that's not even first degree so and I would submit that these folks who are engaged may have, may be likely candidates for the mental health court. So whether it's first degree or third degree I would say is not as importantful, so I would say that third degree is probably sufficient. I think that first degree would be, no pun intended, but by over exposure of the penalty."

"Okay, I'll stop there then."

"By the way, I'm turning my orange juice around."

AN ACT TO AMEND §28.65 OF CHAPTER 28, TITLE 9, GUAM CODE ANNOTATED, RELATIVE TO THE CRIME OF INDECENT EXPOSURE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that the crime of indecent exposure is currently classified as a petty misdemeanor in Guam's criminal code. Because of this, the Guam Police Department has had difficulty in arresting individuals who have been accused of committing indecent exposure. In order to ensure that those accused of indecent exposure are properly arrested, it is necessary to increase the penalty for the offense. Therefore, it is the intent of I Liheslaturan Guåhan to increase the penalty for indecent exposure by amending §28.65 of Chapter 28, Title 9 Guam Code Annotated.

Section 2. §28.65 of Chapter 28, Title 9 Guam Code Annotated, is hereby *amended* to read:

"§ 28.65. Indecent Exposure; Defined & Punished.

A person commits a petty misdemeanor the crime of indecent exposure if he or she exposes his their genitals or performs any other lewd act under circumstances in which his their conduct is likely to be observed by any person who would be offended or alarmed.

Except as provided below, indecent exposure is a misdemeanor.

Indecent exposure is a felony in the third degree if:

1	1) a person exposes their genitals or performs any other lewd act to
2	a person under the age of sixteen (16) years; or
3	2) a person exposes their genitals or performs any other lewd act
4	for the purpose of sexual gratification; or
5	3) a person has previously been convicted under this section; or
6	4) a person has been convicted of any other sex offense as defined
7	in a provision of the Guam Code Annotated."
8	Section 3. Effective Date. This Act shall be effective upon enactment.
9	Section 4. Severability. If any provision of this Law or its application to any
10	person or circumstance is found to be invalid or contrary to law, such invalidity shall
11	not affect other provisions or applications of this Law which can be given effect

Buenas Yan Hafa Adai! The Guam Police Department has reviewed and supports the enactment of Bill No. 242-32, which seeks to increase the penalty for the crime of indecent exposure by amending §28.65 of Chapter 28, Title 9, Guam Code Annotated.

The current penalty as a petty misdemeanor for violation of the subject statute poses an enforcement challenge for the Guam Police Department in that in order for a police officer to effectuate an arrest for violation of the statute, the commission of the crime must be in the presence of an officer. Therefore, in a situation where the requisite officer's direct observation of the crime is absent, the Department's recourse is to record the citizen's complaint and forward the complaint to the Attorney General's Office for their disposition. Unless the crime of indecent exposure is accompanied with the commission of a crime with higher penalty or compelling circumstances exist to cause the officer to detain the perpetrator after the fact, the officer will annotate the perpetrator's personal and other pertinent information and release the perpetrator without further police action.

The enactment of this Bill into law not only empowers GPD officers to arrest perpetrators of the crime, but it also provides for higher penalty of felony under the circumstances included in the Bill, which are absent in the current statute.

Currently, indeceat exposure is a petty misdemeanor. The intent of this bill is to amend the offense as a misdemeanor and a felony in the third degree if four (4) conditions are met. The fiscal impact will cesult in new guidelines in the length of possible imprisonment if convicted. Currently, a petty misdeamenor sets a term not to exceed 60 days. A misdemenor requires a maximum term not to exceed one (1) year; and a seiony in the third degree, the courts may impose a sentence of not more than three (3) years. The additional sentencing requirements for the proposed bill will have a fiscal impact on the services provided by the government. These imprisonment requirements will have an effect on a potential increase in operational costs to all law enforcement departments/agencies.

Bills to be discussed at public hearing

Several bills that would address school facility issues are up for a public hearing today at the Legisla-

Guam Department of Education Superintendent Jon, Fernandez recently asked Gov. Eddie Calvo in a letter to support Bill 225 and Bill 226, which would provide funding for school facilities.

"We must consider the needs of all of our schools and not just a couple of them," wrote Fernandez. "We have 40 public schools in GDOF that serve 31,000 students and I want all students to have school environments that not only meet their health and safety needs but are also conducive to learning in this century."

The bills would provide funding for Smon Sanchez High School and dedicate a revenue source for renovations and improvements at other schools.

The Yigo high school faced a possible shutdown in November after students raised concerns about the school's aging facilities.

Arrother bill also would provide funding for the Yigo high school. Sens Dennis Rodriguez, D Dededo, and Brant McCreadie, R Againa Heights, introduced Bill 218, which missives the lease back mechanism used to build John F Kennedy High School and several other schools.

Guam - Individuals caught in lewd acts could face higher penalties if Bill 242 passes into law. Introduced by Senator Brant McCreadie today, the legislation amends Guam law relative to crimes for those who expose their genitals or perform any lewd acts to a person under the age of 16.

"It's a bill that ups the penalty for lewdness from a petty misdemeanor to a misdemeanor," he explained. "And if you do any lewd acts in front of children under the age of 16 then it becomes a felony, my intention is to not just curb these kind of acts, which we recently just had one, but to eliminate it completely from this community."

McCreadie notes that smaller crimes should be handled early on to prevent more serious crimes, like the recent rape of two young girls in Dededo over the weekend.

Currently, indecent exposure is a petty misdemeanor. The intent of this bill is to amend the offense as a misdemeanor and a felony in the third degree if four (4) conditions are met. The fiscal impact will result in new guidelines in the length of possible imprisonment if convicted. Currently, a petty misdeamenor sets a term not to exceed 60 days. A misdemenor requires a maximum term not to exceed one (1) year; and a felony in the third degree, the courts may impose a sentence of not more than three (3) years. The additional sentencing requirements for the proposed bill will have a fiscal impact on the services provided by the government. These imprisonment requirements will have an effect on a potential increase in operational costs to all law enforcement departments/agencies.

AN ACT TO AMEND §28.65 OF CHAPTER 28, TITLE 9, GUAM CODE ANNOTATED, RELATIVE TO THE CRIME OF INDECENT EXPOSURE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds that the crime of indecent exposure is currently classified as a petty misdemeanor in Guam's criminal code. Because of this, the Guam Police Department has had difficulty in arresting individuals who have been accused of committing indecent exposure. In order to ensure that those accused of indecent exposure are properly arrested, it is necessary to increase the penalty for the offense. Therefore, it is the intent of I Liheslaturan Guåhan to increase the penalty for indecent exposure by amending §28.65 of Chapter 28, Title 9 Guam Code Annotated.

Section 2. §28.65 of Chapter 28, Title 9 Guam Code Annotated, is hereby *amended* to read:

"§ 28.65. Indecent Exposure; Defined & Punished.

A person commits a petty misdemeanor the crime of indecent exposure if he or she exposes his their genitals or performs any other lewd act under circumstances in which his their conduct is likely to be observed by any person who would be offended or alarmed.

Except as provided below, indecent exposure is a misdemeanor.

Indecent exposure is a felony in the third degree if:

1	1) a person exposes their genitals or performs any other lewd act to
2	a person under the age of sixteen (16) years; or
3	2) a person exposes their genitals or performs any other lewd act
4	for the purpose of sexual gratification; or
5	3) a person has previously been convicted under this section; or
6	4) a person has been convicted of any other sex offense as defined
7	in a provision of the Guam Code Annotated."
8	Section 3. Effective Date. This Act shall be effective upon enactment.
9	Section 4. Severability. If any provision of this Law or its application to any
10	person or circumstance is found to be invalid or contrary to law, such invalidity shall
11	not affect other provisions or applications of this Law which can be given effect
12	without the invalid provisions or application, and to this end the provisions of this
13	Law are severable.
