COMMITTEE REPORT DIGEST

I. OVERVIEW

Bill No. 391-32 (LS) was introduced on August 19, 2014 by Senator V. Anthony Ada. The bill was subsequently referred by the Committee on Rules to the Committee on Aviation, Ground Transportation, Regulatory Concerns, and Future Generations on August 19, 2014.

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations convened a public hearing on November 18, 2014 at 9:33 a.m. in *I Liheslatura*'s Public Hearing Room. Among the items on the hearing agenda was Bill 391-32 (LS). The hearing was adjourned at 11:50 a.m.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas convened a public hearing on Bill 391-32 and yielded to the main author, Senator Tony Ada, to offer an opening statement.

Senator Tony Ada explained the intent of the bill. He mentioned that the bill would mandate that motorcycle license examinations be taken using a moped, scooter, or motorcycle which possesses an engine size that meets a specific size.

Dave Neilsen stated that engine limitations caused several problems for motorcycle operators. He mentioned that current law required the operators to use a different license each time they wanted to operate a larger motorbike. The situation becomes burdensome to the users because they have to make changes more often. Mr. Neilsen explained that the current

test uses impractical maneuvering which would make the test more difficult for test takers. He said that if a person receives proper rider education and possesses practical riding experience, they should have an easier time to receive certification.

Chairman San Nicolas asked Mr. Neilsen if engine size mattered when a motorcycle follows the speed limit with regards to road safety.

Mr. Neilsen stated that a variety of factors need to be considered including the type of motorcycle being used, rider experience, and road conditions.

Carl Dominguez provided written testimony (see attached). He further mentioned that Utah had a tiered system for testing which restricted different licenses to different size motorcycles and motorbikes.

John Camacho mentioned that the bill makes it more convenient for the individuals who take tests. He indicated the support of the Department.

Senator Tommy Morrison thanked the panel for their testimony. He asked for clarification on the type of the test process that is in place for operators of a 50cc motorcycle or motorbike.

Mr. Camacho stated that he was unsure and that he would inquire with Department staff.

Senator Morrison stated that regardless of engine size, operators should all be required to go through the same process for licensing.

Mr. Neilsen stated that there may be problems for businesses that provide scooter rentals because a large part of the businesses' customer base is tourists and many countries do not issue separate licenses for vehicles and motorcycles. He said that requiring a specialized license for scooters may adversely affect these types of businesses.

Senator Tom Ada asked for clarification on the different engine sizes.

Mr. Dominguez stated that Utah provides a breakdown of engine size versus licensing: 90cc, 249cc, and 649cc, and 650cc and above.

Mr. Neilsen stated that there are many modifications that can be made which affect the motorbike.

Senator Tom Ada expressed concern that the Department of Revenue and Taxation may get overburdened with individuals who have to apply for a new license each time they want to begin riding a motorbike with a larger engine.

Mr. Neilsen stated that the ability of properly operate a motorbike varies among individuals. He stated his belief that the engine size proposed in the bill is a good measure of an individual's ability to get an operator's license. He also mentioned that mandating a larger engine size increases the cost to the prospective licensee.

Senator Michael Limtiaco asked Mr. Neilsen if he was aware of any other major motorcycle business which sold models with an engine size below 150cc.

Mr. Neilsen stated that there may be another manufacturer that does but he wasn't entirely sure.

Senator Limitaco stated that the proposed legislation was trying to differentiate between motorcycles and scooters. He asked if it would be more sensible to have language that reflects the engine sizes most commonly offered by major manufacturers.

Mr. Neilsen stated that the dynamics of operating a scooter or motorcycle are similar. He again reiterated that the cost of a motorcycle with a larger engine may drive people away from the market and to require that size of an engine to obtain a license will negatively affect businesses that sell smaller engine sizes.

Mr. Camacho clarified that an operator's license is required for a scooter, motorbike, or motorcycle with an engine size larger than 50cc.

Chairman San Nicolas thanked the panel and adjourned the hearing.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Aviation, Ground Transportation, Regulatory Concerns, and Future Generations hereby reports out Bill No. 391-32 (LS), as amended by the Committee, with the recommendation To REPORT ONLY.

Section 1. Paragraph (14) of §3101(f) of Chapter 3 of 16GCA is *amended* to read:

(14) License Limitation on Engine Size. A licensee is prohibited 5 from operating a motorcycle/motorbike on public roads with an engine 6 7 larger than the engine in the motorcycle/motorbike for which he/she used to take the road exam. Licensees may qualify to operate larger 8 motorcycles/motorbikes by passing a qualifying road exam. This provision 9 shall be effective for licenses issued to first-time licensees after January 1, 10 11 2015. No person may use a moped, scooter or a motorcycle/motorbike with an engine size of One Hundred Fifty cubic centimeters (150 cc) or smaller to 12 take a qualifying road exam. A driver may operate a motorized two or three 13 wheeled vehicle on public roads, with an engine size of one hundred forty-14 nine cubic centimeters (149 cc) or smaller provided that (1) the vehicle 15

meets or exceeds U.S. Department of Transportation safety specifications for street operation *and* (2) that the driver possesses a valid Class A operator's license or higher *or* a valid motorcycle operator's license.

Dear Mr. Chairman and Members of the Committee:

The Department of Public Works and its Office of Highway Safety (OHS) support Bill 391-32, which amends paragraph 14 of §3101, Chapter 3 of 16 GCA, i.e., in order to obtain a motorbike operators license, an applicant must not use a moped, scooter or a motorcycle/motorbike with an engine size of One Hundred Fifty cubic centimeters (150 cc) or smaller to take a qualifying road exam.

Guam's 16 GCA Vehicle Chapter 3, §3108 (h) states in part, "the applicant shall be required to give an actual demonstration of his ability to exercise ordinary and reasonable control in operating a motor vehicle by driving the same under the supervision of an examining officer." Bill 391-32 stipulates testing on an actual motorbike with greater than 150cc engine size will determine ability and licensing for the applicant to operate any size motorbike. To do a road test with a moped, scooter or motorcycle with an engine of 150cc or smaller allows the applicant to demonstrate a minimal degree of ability and presents a potential risk should the applicant operate motorbikes with larger engines on our roadways.

The OHS did some research into this subject and found that Guam does not have a tiered licensing system matching privilege with demonstrated skills as the state of Utah has, while Wyoming and Illinois require motorcycles of 150cc or above be used for testing, as would be required through Bill 391-32.

Bill 391-32 will establish yet another step towards greater safety and responsibility while operating or riding a motorcycle on Guam's roadways. Thank you for the opportunity to testify in support of this bill.


