COMMITTEE REPORT DIGEST

Bill No. 48-32 (LS)

I. OVERVIEW: The Committee on Health & Human Services, Health Insurance Reform, Economic Development and Senior Citizens conducted a public hearing on May 20, 2013. The hearing convened at 5:00 p.m. in I Liheslatura's Public Hearing Room. Among the items on the agenda was the consideration of **Bill No. 48-32 (LS)**, An act to define the educational and professional requirements for a licensed Professional Counselors.

II. Public Notice Requirements

Notices were disseminated via hand-delivery/fax and/or email to all senators and all main media broadcasting outlets on May 13, 2013 (5-day notice), and again on May 16, 2013 (48-hour notice).

The public hearing on agenda item Bill No. 48-32 (LS) was called to order at 5:00 p.m.

II. SUMMARY OF TESTIMONY & DISCUSSION.

Chairman Rodriguez: Thank you everyone for being here at the Public Hearing. I would like to ask the author if he wishes to provide remarks opening remarks regarding the bills.

Senator Respicio: [Please see written testimony]

About a month ago, we had a round table meeting, which you facilitated and required that they go back to their colleagues and determine whether or not these are acceptable to us or any changes are needed to be made. During the last several weeks, I am pleased to report that they have reached consensus, particularly the area to which Senator Yamashita had concerns on cultural diversity. This is about a ten year struggle and they have shed blood, sweat and tears because you have those in the same profession that do not want to change at all. They wanted to maintain their current licence and did not want to reflect what is required on the national level. So, you have the up and coming ones who want to be recognized up to the national standard.

What we decided to do, which I hope your committee agrees to, is we provide a grandfather clause. Those who want to maintain status quo, they can do that, those who want to be recognized with national standards can do that as well in these three bills. I would also like to thank the co-sponsors of these bills. The message they are trying to get is basically if this is what we want, this is what we are going to give them. They are a little bit worried that the legislature will make changes that they did not want. But those are their concerns.

Chairman Rodriguez: Thank you very much for joining us here and the round table we had recently. I hope that we can move this forward and we will work with him to get this done right away.

Rosemarie Camacho: [Please see written testimony]

Wayne Butler: I think Rosemarie said it very well. We really did our best to include everyone in every possible way. We believe we've addressed every concern and reached out to everyone. What we have right now is based on the current practices and reflect what is happening in the other states. We do expect reciprocity. Thank you for this opportunity and all your help.

Maresa Aguon: I come to the table as a student. I am currently seeking my Masters Degree in Clinical Psychology through the University of Guam. I am currently finishing up my course and hope to graduate by this December. When I started my program in 2010, one of the first things we did is looked at the licensure. At that time, there haven't been any major actions for change. During the development of these three licensures, we wanted to make sure that these courses are required through all the three levels of licensure and programs. We can say with confidence that through the Clinical Psychology program, all of the requirements can be met. During the round table discussion, there had been various concerns and we had an in depth meeting with Dr. Patricia Taimanglo at the Guam Behavioral Health and Wellness Center. Her primary concerns were to have course work available on Guam as well as requirements to be a supervisor.

During the round table, Senator Aline Yamashita mentioned the cultural competency. So what we did is sat with Dr. Taimanglo and made revisions for all three bills.

Nadine Cepeda: I am here because of some of the concerns of the group and other psychologists in the other disciplines, and more importantly, because of the need. Currently, we only have 6 psychologists at Mental Health, 3 are licensed and 3 are still working on their licensure. There is a need and the demand just keeps getting grater and we still can't meet those needs. Currently, we have to contract out because there is not enough. I know this group has worked very hard to standardized and specialize in training, classes and so forth. This really holds us accountable in what we can and cannot do. Again, we are all invested in the community and this is the best that we have come up with and the people who have worked on this have really done an awesome job. In the last ten years, this is definitely the standards that we are trying to move forward with.

This will determine that you do know, understand, and competent to do the type of work for people who are very vulnerable. I really ask that we can move forward with this fast and hastily. Thank you again.

Senator Respicio: During the round table, it was Nadine who said that her colleagues at the Department. Now, I see that we are all in agreement.

Nadine Cepeda: Yes, Senator. These people have met with Dr. Taimanglo and pother psychologists in the Department. Annie Unpingco's concerns were also addressed. All the concerns in the round table have been addressed.

Senator Respicio: Again, I thank you and Rosemarie for you leadership in this effort in moving this legislation forward.

Senator Yamashita: I thank each of you for actually caring and making a difference. The whole change issue is sometimes scary but then when you made time to speak and listen, that makes a difference. This is what I suggest, by the time we are done, everyone in the world is going to want you because of your diversity background and your openness to culture competency. This is a global community now, and more and more people are looking for you because the people today are going through more and more struggles. The idea is you will be competitive because of the knowledge and experience you will gain. Thank you for your leadership and your time.

Chairman Rodriguez: During the round table, we discussed about moving you out of the Allied Health Board because you are the largest discipline in the board. I know you said that perhaps we should take care of this issue first and we can do that later on down the road. I still would like to pursue that idea.

Rosemarie Camacho: Just to add on Nadine's points, we also have federal jobs where our locally trained counselors have not been qualified for. There are these lucrative opportunities that we have to watch them pass us by because we are not up to standards. So, we are also helping our people fill the positions available here locally as well.

Chairman Rodriguez: I know the Chairman's intent is to include this in the session we are in now. I would like to announce that we will work on this diligently and will put out a committee report together. Usually, we have a 10 day window to provide in testimonies, unfortunately that will not be done for these three bills.

Senator Respicio: Also, Senator you agree to concise these three bills into one?

Senator Rodriguez: Yes. Thank you very much.

There being no other testimony, or comments by Senators, Chairman Rodriguez declared the bill as having been heard, and concluded the public hearing on Bill No. 48-32 (LS).

AN ACT TO DEFINE THE EDUCATIONAL

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 SECTION 1. Legislative Findings and Intent. *I Liheslatura*

3 finds that based on the representations of the Association of

4 Individual, Marriage, Family Therapists, the current Allied Health

5 regulations should be refined, updated, and reformed to incorporate

6 more specialized educational and professional provisions with

7 respect to licensed therapists. *I Liheslatura* further recognizes that

8 ultimately any alterations to the current statutory and regulatory

9 structure governing the practice of professional therapists must be

10 done in concert with all the stakeholders involved, including the

11 Guam Board of Allied Health Examiners, local professional therapists

12 and counselors, public and private mental health providers, the

13 elected leadership, and the general public.

1 To commence this dialogue among all stakeholders, *I*
2 *Liheslatura* finds that the framework for new regulations in this field
3 should be introduced in the legislative process in order to construct a
4 final set of statutory and regulatory changes that will move this
5 reform process forward.

6 **SECTION 2. Definitions.** In this Article:

7 (a) *Accredited educational institution* shall mean any educational
8 institution which grants a doctoral or master's degree and is
9 accredited by a regional accrediting body in the United States or by
10 another accrediting or recognized approval agency recognized by the
11 Board including state, national or foreign approving agencies.

12 (b) *Clinical supervision* shall mean the supervision of no more
13 than six (6) persons at the same time who are acquiring and
14 completing clinical experience in accordance with Guam law. Clinical
15 supervision is that aspect of instructional supervision which draws
16 upon data from direct firsthand observation of actual teaching, or
17 other professional events, and involves face-to-face and other
18 associated interactions between the observer(s) and the person(s)
19 observed in the course of analyzing the observed professional
20 behaviors and activities and seeking to define and/or develop next

1 steps toward improved performance. This includes, but is not limited
2 to the following: case consultation, the assessment and diagnosis of
3 presenting problems, development and implementation of treatment
4 plans and the evaluation of the course of treatment.

5 (c) *Consultant* shall mean a credentialed professional who
6 provides expert service, advice, or makes recommendations for a fee
7 or pro bono, by phone, internet, in person, or by other means to an
8 individual licensed on Guam as a Licensed Professional Counselor
9 for the purposes of maximizing therapeutic benefit for a client.

10 (d) *Licensed Professional Counselor* shall mean a person licensed
11 in Guam to practice Professional Counseling as defined in these rules
12 and regulations.

13 (e) *National Counselor Examination for Licensure and Certification*
14 *(NCE)* shall mean the examination compiled by the National Board
15 for Certified Counselors (NBCC).

16 (f) *Professional Counseling* shall mean the use of
17 psychotherapeutic techniques in the delivery of services to
18 individuals and groups in order to diagnose and treat mental,
19 emotional and nervous disorders, whether these are behavioral,
20 cognitive or affective. Professional Counseling includes, but is not

1 limited to:

- 2 i. Assessment and diagnosis of presenting problems
3 through inquiry, observation, evaluation and integration
4 of diagnostic information;
- 5 ii. Designing and developing treatment plans by
6 incorporating and integrating recognized
7 psychotherapeutic theories in establishing treatment
8 goals and interventions collaboratively with clients; and
- 9 iii. Implementing and evaluating the course of treatment by
10 incorporating psychotherapeutic theories to assist
11 individuals and groups.

12 (g) *Counseling* shall mean a specialized, formal interaction
13 between a Licensed Professional Counselor or other Mental Health
14 Professional and a client in which a therapeutic relationship is
15 established to help resolve symptoms of mental disorders,
16 psychosocial stress, family problems or other difficulties which is
17 designed to enhance problem solving skills and coping abilities as
18 identified in a treatment plan.

19 (h) *Individual Counseling* shall mean planned interventions to
20 assist a client to enlarge competencies, increase problem solving

1 skills and coping abilities according to identified treatment goals.

2 (i) *Group Counseling* shall mean the gathering together of
3 unrelated individuals at the direction of a group facilitator or
4 counselor for a therapeutic purpose.

5 **SECTION 3. Qualifications for Licensure.**

6 (a) The provisions in this bill shall take effect two (2) years after
7 enactment. At that time, the Board shall issue a license as a *Licensed*
8 *Professional Counselor* to an applicant who:

9 i. Has a doctorate or master's degree from an accredited
10 educational institution with a program in psychology,
11 counseling, marriage and family therapy, clinical social
12 work or other psycho-therapeutic discipline.

13 ii. Must be able to show documentation of a minimum of
14 seventy-two (72) quarter hours or forty-eight (48)
15 semester hours of graduate studies (as suggested by the
16 Counsel for Accreditation of Counseling and Related
17 Educational Programs [CACREP]) that:

18 A. Includes course content in the following areas:

19 1. Human Growth and Development

20 2. Social/Cultural Foundations

- 1 3. Counseling Theories and Techniques
- 2 4. Group Work
- 3 5. Career and Lifestyle Development.
- 4 6. Appraisal (test and measurements for
- 5 individuals and groups)
- 6 7. Research and Program Evaluation
- 7 8. Professional Orientation (to counseling)
- 8 9. Professional Ethics; and
- 9 B. Includes a practicum, consisting of a minimum of
- 10 one hundred (100) hours; and
- 11 C. Includes an internship, consisting of a minimum
- 12 of six hundred (600) hours and;
- 13 D. Has completed a minimum of three thousand
- 14 (3,000) hours of documented post-graduate
- 15 clinical experience and one hundred (100)
- 16 hours of supervision by a licensed Individual,
- 17 Marriage and Family Therapist (IMFT),
- 18 Certified Professional Counselor (CPC),
- 19 Licensed Clinical Social Worker (LCSW),
- 20 Licensed Mental Health Counselor (LMHC),

1 Licensed Professional Counselor (LPC),
2 Marriage and Family Therapist (MFT),
3 psychologist, psychiatrist or other license
4 deemed by the Board to be substantially
5 equivalent to these professions, who is licensed
6 and authorized to provide such supervision in
7 the United States, its territories or a foreign
8 country determined to be acceptable on a case
9 by case basis by the Board. The three thousand
10 (3,000) hours of post graduate clinical
11 experience may include, but is not limited to:
12 face-to-face treatment of clients, keeping
13 clinical notes, supervision, treatment team
14 meetings, consultation, education, treatment
15 planning, observation and other activities
16 generally recognized to be part of clinical
17 practice. A minimum of one thousand five
18 hundred (1,500) hours of the three thousand
19 (3,000) hours of post-graduate clinical
20 experience must be in the face-to-face treatment

1 of individuals or groups, and;

2 E. Has successfully passed the National
3 Counselor Examination for Licensure and
4 Certification (NCE) which has been conducted
5 in a manner approved by the National Board
6 for Certified Counselors (NBCC).

7 (b) For an individual who has not engaged in post-graduate
8 experience or cannot document a minimum of three thousand
9 (3,000) hours of post-graduate clinical experience under the
10 supervision of a licensed IMFT, CPC, LCSW, LMHC, LPC, MFT,
11 psychologist, psychiatrist or other license deemed by the Board to
12 be substantially equivalent to these professions, who is licensed
13 and authorized to provide such supervision in the United States,
14 its territories or a foreign country determined to be acceptable on a
15 case by case basis by the Board; such individual may practice
16 under an internship program approved by the Board prior to
17 engagement in that program in order to gain that supervision on
18 Guam. To provide such supervision on Guam, a person must be a
19 licensed Individual Marriage and Family Therapist, Licensed
20 Professional Counselor, Marriage and Family Therapist, Licensed

1 Clinical Social Worker, Clinical Psychologist or Psychiatrist
2 licensed on Guam who has held a license for a minimum of five (5)
3 years.

4 (c) Individuals who hold a current, valid license issued by a
5 state of the United States, its territories or foreign country
6 approved by the Board on a case-by-case basis as a Certified
7 Professional Counselor, Licensed Clinical Counselor of Mental
8 Health, Licensed Clinical Mental Health Counselor, Licensed
9 Mental Health Counselor, Licensed Mental Health Practitioner,
10 Licensed Professional Counselor of Mental Health, Professional
11 Counselor, Marriage and Family Therapist or other license
12 deemed by the Board to be substantially equivalent to the Guam
13 License for Licensed Professional Counselor, shall be eligible for
14 the Guam license for Licensed Professional Counselor.

15 **SECTION 4. Exceptions to licensure.**

16 1. No person may practice Professional Counseling on Guam who
17 is *not* licensed as a Licensed Professional Counselor by the Board,
18 *unless* such practice is approved by the Board or other Guam
19 licensing Board. *However*, this Article does not prohibit:

20 a. An employee of the Federal government from performing

1 official duties on federal property;

2 b. An LCSW, PC, LPC, CPC, LMHC, MFT, Psychologist or
3 Psychiatrist, currently licensed in another jurisdiction of the
4 United States from consulting with or advising a Licensed
5 Professional Counselor on Guam. However, the consultant,
6 if not licensed on Guam may not provide services to a client
7 directly;

8 c. An active student in good standing as a requirement of a
9 university program for completion of a degree or a person
10 who is engaged in the completion of the requirement of
11 three thousand (3,000) hours of post-graduate clinical
12 experience to become licensed as an LPC, under the
13 supervision of a Guam licensed IMFT, LPC, LMHC, MFT,
14 LCSW, clinical psychologist or psychiatrist from performing
15 assigned duties.

16 d. Nothing herein prohibits qualified members of other
17 professional groups, such as clinical psychologists, school
18 psychologists, counseling psychologists, social workers or
19 ordained clergy from doing work of a counseling nature
20 consistent with the training and code of ethics for their

1 respective professions; *provided*, that they do not hold
2 themselves out to the public as a Professional Counselor.

3 **SECTION 5. Scope of Practice.** Licensed Professional
4 Counselors use psychotherapeutic techniques to prevent, assess,
5 evaluate, diagnose, develop treatment goals, plans and objectives,
6 treat and evaluate outcomes for mental, emotional or behavioral
7 disorders and associated distresses that interfere with mental health.

8 **SECTION 6. Client Confidentiality.** Client Confidentiality
9 is defined and regulated as set forth in the Health Insurance
10 Portability and Accountability Act (HIPAA), the ethical rules of the
11 American Counseling Association (ACA), Guam law, and revisions
12 thereof. Breach of client confidentiality except as provided for by
13 HIPAA, the ACA, or Guam law shall be considered unprofessional
14 conduct and may be grounds for revocation or suspension of the
15 license.

16 **SECTION 7. Continuing Education Requirements.** A
17 licensee shall complete a total of 40 contact hours or 4.0 Continuing
18 Education Units directly related to the practice of Professional
19 Counseling within each two (2) year licensure period to qualify for
20 renewal of licensure.

1 **SECTION 8. Grandfather Provision.** All licensees who hold
2 a current, valid, license as an Individual, Marriage, and Family
3 Therapist issued by the Guam Board of Allied Health Examiners at
4 the time this section becomes law shall be deemed to hold a current,
5 valid license as a Licensed Professional Counselor.

12 individual licensed in Guam as a Licensed Professional Counselor for
13 the purposes of maximizing therapeutic benefit for a client.

14 (4) *Licensed Professional Counselor* shall mean a person licensed
15 in Guam to practice Professional Counseling as defined in these rules
16 and regulations.

17 (5) *National Counselor Examination for Licensure and Certification*
18 (*NCE*) shall mean the examination compiled by the National Board
19 for Certified Counselors (NBCC).

20 (6) *Professional Counseling* shall mean the use of

1 psychotherapeutic techniques in the delivery of services to
2 individuals and groups in order to diagnose and treat mental,
3 emotional and nervous disorders, whether these are behavioral,
4 cognitive or affective. Professional Counseling includes, but is not
5 limited to:

6 a. Assessment and diagnosis of presenting problems
7 through inquiry, observation, evaluation and integration of
8 diagnostic information;

9 b. Designing and developing treatment plans by
10 incorporating and integrating recognized psychotherapeutic
11 theories in establishing treatment goals and interventions
12 collaboratively with clients; and

13 c. Implementing and evaluating the course of treatment
14 by incorporating psychotherapeutic theories to assist
15 individuals and groups.

16 (7) *Counseling* shall mean a specialized, formal interaction
17 between a Licensed Professional Counselor or other Mental Health
18 Professional and a client in which a therapeutic relationship is
19 established to help resolve symptoms of mental disorders,
20 psychosocial stress, family problems or other difficulties which is

1 designed to enhance problem solving skills and coping abilities as
2 identified in a treatment plan.

3 (8) *Individual Counseling* shall mean planned interventions to
4 assist a client to enlarge competencies, increase problem solving
5 skills and coping abilities according to identified treatment goals.

6 (9) *Group Counseling* shall mean the gathering together of
7 unrelated individuals at the direction of a group facilitator or
8 counselor for a therapeutic purpose.

9 **SECTION 3. Qualifications for Licensure.**

10 (1) The provisions in this bill shall take effect two years after
11 enactment. At that time, the Board shall issue a license as a *Licensed*
12 *Professional Counselor* to an applicant who:

13 a. Has a doctorate or master's degree from an accredited
14 educational institution with a program in psychology,
15 counseling, marriage and family therapy, clinical social
16 work or other psycho-therapeutic discipline. The
17 applicant must be able to show documentation of:

18 i. a minimum of seventy-two (72) quarter hours or
19 forty-eight (48) semester hours of graduate studies (as
20 suggested by the Counsel for Accreditation of

1 Counseling and Related Educational Programs
2 [CACREP]) that:

3 ii. Includes course content in the following areas:

4 1. Human Growth and Development

5 2. Social/Cultural Foundations

6 3. Counseling Theories and Techniques

7 4. Group Work

8 5. Career and Lifestyle Development

9 6. Appraisal (test and measurements for
10 individuals and groups)

11 7. Research and Program Evaluation

12 8. Professional Orientation (to counseling)

13 9. Professional Ethics; and

14 iii. Includes a practicum, consisting of a minimum
15 of one hundred (100) hours; and

16 iv. Includes an internship, consisting of a
17 minimum of six hundred (600) hours and;

18 b. Has completed a minimum of three thousand (3,000)
19 hours of documented post-graduate clinical experience
20 and one hundred (100) hours of supervision by a licensed

1 Individual, Marriage and Family Therapist (IMFT),
2 Certified Professional Counselor (CPC), Licensed Clinical
3 Social Worker (LCSW), Licensed Mental Health
4 Counselor (LMHC), Licensed Professional Counselor
5 (LPC), Marriage and Family Therapist (MFT), Clinical
6 Psychologist, Psychiatrist or other license deemed by the
7 Board to be substantially equivalent to these professions,
8 who is licensed and authorized to provide such
9 supervision in the United States, its territories or a foreign
10 country determined to be acceptable on a case by case
11 basis by the Board. The three thousand (3,000) hours of
12 post graduate clinical experience may include, but is not
13 limited to: face-to-face treatment of clients, keeping
14 clinical notes, supervision, treatment team meetings,
15 consultation, education, treatment planning, observation
16 and other activities generally recognized to be part of
17 clinical practice. A minimum of one thousand five
18 hundred (1,500) hours of the three thousand (3,000) hours
19 of post-graduate clinical experience must be in the face-
20 to-face treatment of individuals or groups, and;

1 c. has successfully passed the National Counselor
2 Examination for Licensure and Certification (NCE) which
3 has been conducted in a manner approved by the
4 National Board for Certified Counselors (NBCC), and
5 d. has documented completion of training by a professional
6 association or educational institution and approved by
7 the Board that consists of at least six (6) hours of
8 professional ethics, three (3) hours of culturally
9 competent counseling practices with Micronesian
10 communities in Guam and one (1) hour of mandated
11 reporting.

12 (2) For an individual who has not engaged in post-graduate
13 experience or cannot document a minimum of three thousand (3,000)
14 hours of post-graduate clinical experience under the supervision of a
15 licensed IMFT, CPC, LCSW, LMHC, LPC, MFT, Clinical Psychologist,
16 Psychiatrist or other license deemed by the Board to be substantially
17 equivalent to these professions, who is licensed and authorized to
18 provide such supervision in the United States, its territories or a
19 foreign country determined to be acceptable on a case by case basis
20 by the Board; such individual may practice under an internship

1 program approved by the Board prior to engagement in that program
2 in order to gain that supervision in Guam. The three thousand (3,000)
3 hour internship program may include, but is not limited to: face-to-
4 face treatment of clients, keeping clinical notes, supervision,
5 treatment team meetings, consultation, education, treatment
6 planning, observation and other activities generally recognized to be
7 part of clinical practice. A minimum of one thousand five hundred
8 (1,500) hours of the three thousand (3,000) hours must be in the face-
9 to-face treatment of individuals and groups, and a minimum of one
10 hundred (100) hours must be supervision. To provide such
11 supervision in Guam, a person must be a licensed Individual
12 Marriage and Family Therapist, Licensed Professional Counselor,
13 Marriage and Family Therapist or Licensed Clinical Social Worker
14 licensed in Guam who has held a license for a minimum of five (5)
15 years; or a Clinical Psychologist or Psychiatrist licensed in Guam who
16 has held a license for a minimum of three (3) years.

17 (3) Individuals who hold a current, valid license issued by a state
18 of the United States, its territories or foreign country approved by the
19 Board on a case-by-case basis as a Certified Professional Counselor,
20 Licensed Clinical Counselor of Mental Health, Licensed Clinical

1 Mental Health Counselor, Licensed Mental Health Counselor,
2 Licensed Mental Health Practitioner, Licensed Professional
3 Counselor of Mental Health, Professional Counselor, Marriage and
4 Family Therapist or other license deemed by the Board to be
5 substantially equivalent to the Guam License for Licensed
6 Professional Counselor, shall be eligible for the Guam license for
7 Licensed Professional Counselor.

8 **SECTION 4. Exceptions to licensure.**

9 1. No person may practice Professional Counseling in Guam who
10 is *not* licensed as a Licensed Professional Counselor by the Board,
11 *unless* such practice is approved by the Board or other Guam
12 licensing Board. *However*, this Article does not prohibit:

- 13 a. An employee of the Federal government from performing
14 official duties on federal property;
- 15 b. An LCSW, PC, LPC, CPC, LMHC, MFT, Psychologist or
16 Psychiatrist, currently licensed in another jurisdiction of the
17 United States from consulting with or advising a Licensed
18 Professional Counselor in Guam. *However*, the consultant, if
19 not licensed in Guam may not provide services to a client
20 directly;

1 c. An active student in good standing as a requirement of a
2 university program for completion of a degree, or a person
3 who is engaged in the completion of the requirement of
4 three thousand (3,000) hours of post-graduate clinical
5 experience to become licensed as an LPC, under the
6 supervision of a Guam licensed IMFT, LPC, LMHC, MFT,
7 LCSW, clinical psychologist or psychiatrist, from performing
8 assigned duties.

9 d. Nothing herein prohibits qualified members of other
10 professional groups, such as clinical psychologists, school
11 psychologists, counseling psychologists, social workers or
12 ordained clergy from doing work of a counseling nature
13 consistent with the training and code of ethics for their
14 respective professions; *provided*, that they do not hold
15 themselves out to the public as a Professional Counselor.

16 **SECTION 5. Scope of Practice.** Licensed Professional
17 Counselors use psychotherapeutic techniques to prevent, assess,
18 evaluate, diagnose, develop treatment goals, plans and objectives,
19 treat and evaluate outcomes for mental, emotional or behavioral
20 disorders and associated distresses that interfere with mental health.

1 **Definitions.** In this Article:

2 **(1)** *Accredited educational institution* shall mean any
3 educational institution which grants a doctoral or master's degree
4 and is accredited by a regional accrediting body in the United States
5 or by another accrediting or recognized approval agency recognized
6 by the Board including state, national or foreign approving agencies.

7 **(2)** *Clinical supervision* shall mean the supervision of no more
8 than six (6) persons at the same time who are acquiring and
9 completing clinical experience in accordance with Guam law.
10 Clinical supervision is that aspect of instructional supervision which
11 draws upon data from direct firsthand observation of actual teaching,
12 or other professional events, and involves face-to-face and other
13 associated interactions between the observer(s) and the person(s)
14 observed in the course of analyzing the observed professional
15 behaviors and activities and seeking to define and/or develop next
16 steps toward improved performance. This includes, but is not limited
17 to the following: case consultation, the assessment and diagnosis of
18 presenting problems, development and implementation of treatment
19 plans and the evaluation of the course of treatment.

20 **(3)** *Consultant* shall mean a credentialed professional who

1 provides expert service, advice, or makes recommendations for a fee
2 or pro bono, by phone, internet, in person, or by other means to an
3 individual licensed in Guam as a Licensed Mental Health Counselor
4 for the purposes of maximizing therapeutic benefit for a client.

5 (4) *Licensed Mental Health Counselor* shall mean a person
6 licensed in Guam to practice Mental Health Counseling as defined in
7 these rules and regulations.

8 (5) *National Clinical Mental Health Counselor Examination*
9 (NCMHCE) shall mean the examination of that name compiled by
10 the National Board for Certified Counselors (NBCC).

11 (6) *National Counselor Examination for Licensure and*
12 *Certification* (NCE) shall mean the examination of that name compiled
13 by the National Board for Certified Counselors (NBCC).

14 (7) *Mental Health Counseling* shall mean the provision of
15 services to individuals, couples, families, and groups. This includes
16 the application of theories, principles, and methods of counseling and
17 psychotherapy to define goals and develop plans of action aimed
18 toward the prevention, treatment, and resolution of mental and
19 emotional dysfunction and intra- or interpersonal difficulties. The
20 practice of mental health counseling includes, but is not limited to,

1 the assessment, diagnosis, and non-medical treatment of mental and
2 emotional disorders, the application of psycho-educational
3 techniques and measures aimed at the prevention of such disorders,
4 and consultation to individuals, couples, families, groups,
5 organizations, and communities.

6 (8) *Counseling* shall mean a specialized, formal interaction
7 between a Licensed Mental Health Counselor or other Mental Health
8 Professional and a client in which a therapeutic relationship is
9 established to help resolve symptoms of mental disorders,
10 psychosocial stress, family problems or other difficulties which is
11 designed to enhance problem solving skills and coping abilities as
12 identified in a treatment plan.

13 (9) *Individual Counseling* shall mean planned interventions to
14 assist a client to enlarge competencies, increase problem solving skills
15 and coping abilities according to identified treatment goals.

16 (10) *Couples therapy* shall mean therapeutic interventions
17 with married or unmarried couples to resolve problems and conflicts
18 in their relationship.

19 (11) *Family therapy* shall mean systematic interventions for
20 the purpose of enabling family members to understand the behavior

1 of individuals in relation to the ongoing operations of the family
2 group.

3 (12) *Group Counseling* shall mean the gathering together of
4 unrelated individuals at the direction of a group facilitator or
5 counselor for a therapeutic purpose.

6 **Section 10. Qualifications for Licensure.**

7 (1) The provisions in this bill shall take effect two years after
8 enactment. At that time, the Board shall issue a license as a Licensed
9 Mental Health Counselor to an applicant who:

10 a. Has a doctorate or master's degree from an
11 accredited educational institution with a program in
12 psychology, counseling, marriage and family therapy,
13 clinical social work or other psycho-therapeutic discipline.

14 The applicant must be able to show documentation of:

15 i. A minimum of ninety (90) quarter hours or
16 sixty (60) semester hours of graduate studies (as
17 recommended by the Counsel for Accreditation of
18 Counseling and Related Educational Programs
19 [CACREP]) that:

20 ii. includes course content in the following areas:

b. Has completed a minimum of three thousand (3,000) hours of documented post-graduate clinical experience and one hundred (100) hours of supervision by a licensed Individual, Marriage and Family Therapist (IMFT), Certified Professional Counselor (CPC), Licensed Clinical Social Worker (LCSW), Licensed Mental Health Counselor (LMHC), Licensed Professional Counselor (LPC), Marriage and Family Therapist (MFT), Clinical Psychologist, Psychiatrist or other license deemed by the Board to be substantially equivalent to these professions, who is licensed

1 and authorized to provide such supervision in the United
2 States, its territories or a foreign country determined to be
3 acceptable on a case by case basis by the Board. The three
4 thousand (3,000) hours of post-graduate clinical experience
5 may include, but is not limited to; face-to-face treatment of
6 clients, keeping clinical notes, supervision, treatment team
7 meetings, consultation, education, treatment planning,
8 observation and other activities generally recognized to be
9 part of clinical practice. A minimum of one thousand five
10 hundred (1,500) hours of the three thousand (3,000) hours of
11 post-graduate clinical experience must be in face-to-face
12 treatment of individuals or groups; and

13 c. Has successfully passed the National Counselor
14 Examination for Licensure and Certification (NCE) and the
15 National Clinical Mental Health Counselor Exam
16 (NCMHCE) which have been conducted in a manner
17 approved by the National Board for Certified Counselors
18 (NBCC); and

19 d. Has documented completion of training by a
20 professional association or educational institution and

1 approved by the Board that consists of at least six (6) hours
2 of professional ethics, three (3) hours of culturally competent
3 counseling practices with Micronesian communities in
4 Guam and one (1) hour of mandated reporting.

5 **(2)** For an individual who has not engaged in post-graduate
6 experience or cannot document a minimum of three thousand (3,000)
7 hours of post-graduate clinical experience under the supervision of a
8 licensed IMFT, CPC, LCSW, LMHC, LPC, MFT, Clinical Psychologist,
9 Psychiatrist or other license deemed by the Board to be substantially
10 equivalent to these professions, who is licensed and authorized to
11 provide such supervision in the United States, its territories or a
12 foreign country determined to be acceptable on a case by case basis
13 by the Board; such individual may practice under an internship
14 program approved by the Board prior to engagement in that program
15 in order to gain that supervision in Guam. The three thousand (3,000)
16 hour internship program may include, but is not limited to: face-to-
17 face treatment of clients, keeping clinical notes, supervision,
18 treatment team meetings, consultation, education, treatment
19 planning, observation and other activities generally recognized to be
20 part of clinical practice. A minimum of one thousand five hundred

1 (1,500) hours of the three thousand (3,000) hours must be in face-to-
2 face treatment of individuals and groups, and a minimum of one
3 hundred (100) hours must be supervision. To provide such
4 supervision in Guam, a person must be a licensed Individual
5 Marriage and Family Therapist, Licensed Professional Counselor,
6 Marriage and Family Therapist or Licensed Clinical Social Worker
7 licensed in Guam who has held a license for a minimum of five (5)
8 years with experience in clinical work which requires diagnosis and
9 treatment planning; or a Clinical Psychologist or Psychiatrist licensed
10 in Guam who has held a license for a minimum of three (3) years
11 with experience in clinical work which requires diagnosis and
12 treatment planning.

13 (3) Individuals who hold a current, valid license in a state of
14 the United States, its territories or a foreign country approved by the
15 Board on a case-by-case basis as a Licensed Clinical Counselor of
16 Mental Health, Licensed Clinical Mental Health Counselor, Licensed
17 Mental Health Counselor, Licensed Mental Health Practitioner,
18 Licensed Professional Counselor of Mental Health, or other license
19 deemed by the Board to be substantially equivalent to the Guam
20 License for Licensed Mental Health Counselor, and who has passed

1 both the NCE and the NCMHCE in a manner approved by the NBCC
2 shall be eligible for the Guam license for Licensed Mental Health
3 Counselor.

4 **Section 11. Exceptions to licensure.**

5 **(1)** No person may practice Mental Health Counseling in
6 Guam who is not licensed as a Licensed Mental Health Counselor by
7 the Board, unless such practice is approved by the Board or other
8 Guam licensing Board. However, this Article does not prohibit:

9 a. an employee of the Federal government from
10 performing official duties on federal property;

11 b. an LCSW, PC, LPC, CPC, LMHC, MFT,
12 Psychologist or Psychiatrist, currently licensed in another
13 jurisdiction of the United States from consulting with or
14 advising a Licensed Mental Health Counselor in Guam.
15 However, the consultant, if not licensed in Guam may not
16 provide services to a client directly;

17 c. an active student in good standing, as a
18 requirement of a university program for completion of a
19 degree or a person who is engaged in the completion of the
20 requirement of three thousand (3,000) hours of post-

1 graduate clinical experience to become licensed as an
2 LMHC, under the supervision of a Guam licensed IMFT,
3 LPC, LMHC, MFT, LCSW, clinical psychologist or
4 psychiatrist from performing assigned duties.

5 d. Nothing herein prohibits qualified members of
6 other professional groups, such as clinical psychologists,
7 school psychologists, counseling psychologists, social
8 workers or ordained clergy from doing work of a counseling
9 nature consistent with their training and code of ethics for
10 their respective professions; *provided*, that they do not hold
11 themselves out to the public as a:

12 i. Mental Health Counselor

13 **Section 12. Scope of Practice.**

14 Licensed Mental Health Counselors are qualified to provide
15 services to individuals, couples, families, and groups. They apply
16 theories, principles, and methods of counseling and psychotherapy to
17 define goals and develop plans of action aimed toward the
18 prevention, treatment, and resolution of mental and emotional
19 dysfunction and intra- or interpersonal difficulties. The practice of
20 mental health counseling includes, but is not limited to, the

1 assessment, diagnosis, and non-medical treatment of mental and
2 emotional disorders, the application of psychoeducational techniques
3 and measures aimed at the prevention of such disorders, and
4 consultation to individuals, couples, families, groups, organizations,
5 and communities.

6 **Section 13. Client Confidentiality.**

7 Client Confidentiality is defined and regulated as set forth in
8 the Health Insurance Portability and Accountability Act (HIPAA), the
9 ethical rules of the American Counseling Association (ACA), Guam
10 law, and revisions thereof. Breach of client confidentiality except as
11 provided for by HIPAA, the ACA, or Guam law shall be considered
12 unprofessional conduct and may be grounds for revocation or
13 suspension of the license.

14 **Section 14. Continuing Education Requirements.**

15 A licensee shall complete a total of 40 contact hours or 4.0
16 Continuing Education Units directly related to the practice of Mental
17 Health Counseling within each two (2) year licensure period to
18 qualify for renewal of licensure.

19 **Section 15. Grandfather Provision.**

20 All licensees who hold a current, valid, license as an

1 Individual, Marriage, and Family Therapist issued by the Guam
2 Board of Allied Health Examiners or as a Licensed Professional
3 Counselor issued by a Guam Board, at the time this article is enacted
4 into law, shall be eligible to apply for a license as a Licensed Mental
5 Health Counselor. They may be granted a license as a Licensed
6 Mental Health Counselor if:

7 1. They can pass the NCMHCE developed by the NBCC
8 (they shall be deemed eligible by the board to take the test),
9 or

10 2. They can document 1,000 hours of post Masters
11 clinical work which requires diagnosis and treatment
12 planning, or

13 3. They have held a license as an Individual, Marriage
14 and Family Therapist in Guam, a Licensed Professional
15 Counselor in Guam, or any combination of the two (2) for a
16 minimum of six (6) years.

17 **SECTION 16.**

18 **MARRIAGE AND FAMILY THERAPIST**

19 **Definitions.** In this Article:

20 **(1)** *Accredited educational institution* shall mean any educational

1 institution which grants a doctoral or master's degree and is
2 accredited by a regional accrediting body in the United States or by
3 another accrediting or recognized approval agency recognized by the
4 Board including state, national or foreign approving agencies.

5 (2) *Clinical supervision* shall mean the supervision of no more
6 than six (6) persons at the same time who are acquiring and
7 completing clinical experience in accordance with Guam law. Clinical
8 supervision is that aspect of instructional supervision which draws
9 upon data from direct firsthand observation of actual teaching, or
10 other professional events, and involves face-to-face and other
11 associated interactions between the observer(s) and the person(s)
12 observed in the course of analyzing the observed professional
13 behaviors and activities and seeking to define and/or develop next
14 steps toward improved performance. This includes, but is not limited
15 to the following: case consultation, the assessment and diagnosis of
16 presenting problems, development and implementation of treatment
17 plans and the evaluation of the course of treatment.

18 (3) *Consultant* shall mean a credentialed professional who
19 provides expert service, advice, or makes recommendations for a fee
20 or pro bono, by phone, internet, in person, or by other means to an

1 individual licensed on Guam as a Marriage and Family Therapist for
2 the purposes of maximizing therapeutic benefit for a client.

3 (4) *Family* shall mean all forms of households that consist of
4 members with emotional bonds and mutual obligations that define
5 themselves as families. "Family" as used here includes, but is not
6 limited to, nuclear families, once married couples with children, a
7 single parent with children, non-married couples with children,
8 blended families, remarried couples, and couples without children.

9 (5) *Marriage and Family Therapy* shall mean the application of
10 psychotherapeutic techniques in the delivery of services to
11 individuals, couples, families, or groups in order to diagnose and
12 treat mental, emotional, and nervous disorders, whether these are
13 behavioral, cognitive, or affective, within the context of the
14 individual's relationships. Marriage and Family Therapy includes,
15 but is not limited to:

- 16 a. Assessment and diagnosis of presenting problems through
17 inquiry, observation, evaluation, and integration of
18 diagnostic information;
- 19 b. Designing and developing treatment plans by incorporating
20 and integrating recognized psychotherapeutic theories, in

1 establishing treatment goals and interventions
2 collaboratively with clients;

3 c. Implementing and evaluating the course of treatment by
4 incorporating psychotherapeutic theories to assist
5 individuals, couples, families and groups.

6 **(6) *Marriage and Family Therapist*** (herein referred to as MFT)
7 shall mean a person licensed on Guam to practice Marriage and
8 Family Therapy as defined in these rules and regulations.

9 **(7) *Psychotherapy*** shall mean a specialized, formal interaction
10 between an MFT or other Mental Health Professional, and a client (an
11 individual, couple, family, or group) in which a therapeutic
12 relationship is established to help resolve symptoms of a mental
13 disorder, psychosocial stressor, family problem, or other difficulty,
14 which is designed to enhance problem solving skills and coping
15 abilities. Therapy can be used interchangeably with counseling and
16 psychotherapy.

17 a. *Family therapy* shall mean systematic interventions for the
18 purpose of enabling family members to understand the
19 behavior of individuals in relation to the ongoing operations of
20 the family group. This approach enables family members to

1 generate a wider range of options for coping with problems,
2 and to learn problem solving skills.

3 b. *Individual therapy* shall mean planned interventions to help
4 a client enlarge competencies and increase problem solving
5 skills and coping abilities.

6 c. *Group therapy* shall mean the gathering together of
7 unrelated individuals at the direction of a group facilitator or
8 therapist for a therapeutic purpose.

9 d. *Couples therapy* shall mean therapeutic interventions with
10 married or unmarried couples to resolve problems and conflicts
11 in their relationship.

12 **Section 17. Qualifications for Licensure.**

13 1. The provisions in this bill shall take effect two years after
14 enactment. At that time, the Board shall issue a license as a
15 Marriage and Family Therapist to an applicant who:

16 a. has a doctorate or master's degree from an accredited
17 educational institution with a program in psychology,
18 counseling, marriage and family therapy, or other psycho-
19 therapeutic discipline. The applicant must be able to show
20 documentation of:

- 1 i. a minimum of ninety (90) quarter hours or sixty (60)
2 semester hours of graduate studies (as suggested by the
3 Counsel for Accreditation of Counseling and Related
4 Educational Programs [CACREP]) that:

6 **Section 19. Client Confidentiality.**

7 Client Confidentiality is defined and regulated by the
8 standards set forth in the Health Insurance Portability and
9 Accountability Act (HIPAA), the ethical rules of the American
10 Counseling Association (ACA), Guam law, and revisions thereof.
11 Breach of client confidentiality except as provided for by HIPAA
12 the ACA, or Guam law shall be considered unprofessional
13 conduct and may be grounds for revocation or suspension of the
14 license.

15 **Section 20. Continuing Education Requirements.**

16 A licensee shall complete a total of 40 contact hours or 4.0
17 Continuing Education Units directly related to the practice of
18 Marriage and Family Therapy within each two (2) year licensure
19 period to qualify for renewal of licensure.

20 **Section 21. Grandfather Provision.**

1 All licensees who hold a current, valid, license as an
2 Individual, Marriage, and Family Therapist issued by the Guam
3 Board of Allied Health Examiners or as a Licensed Professional
4 Counselor issued by a Guam Board, at the time this article
5 becomes law, shall be eligible to apply for a license as a Marriage
6 and Family Therapist. They may be granted a license as a
7 Marriage and Family Therapist if:

- 8 1. They can pass the Marital and Family Therapy
9 examination developed by the Association of Marital
10 and Family Therapy Regulatory Boards (AMFTRB)
11 (they shall be deemed eligible to take the test by the

14 clinical work with couples and families, or
- 15 3. They have held a license as an Individual, Marriage
16 and Family Therapist on Guam, a Licensed
17 Professional Counselor on Guam, or any combination
18 of the two (2) for a minimum of six (6) years.

Section #####1. Definitions. In this Article:

1. *Accredited educational institution* shall mean any educational institution which grants a doctoral or master's degree and is accredited by a regional accrediting body in the United States or by another accrediting or recognized approval agency recognized by the Board including state, national or foreign approving agencies.
2. *Clinical supervision* shall mean the supervision of no more than six (6) persons at the same time who are acquiring and completing clinical experience in accordance with Guam law. Clinical supervision is that aspect of instructional supervision which draws upon data from direct firsthand observation of actual teaching, or other professional events, and involves face-to-face and other associated interactions between the observer(s) and the person(s) observed in the course of analyzing the observed professional behaviors and activities and seeking to define and/or develop next steps toward improved performance. This includes, but is not limited to the following: case consultation, the assessment and diagnosis of presenting problems, development and implementation of treatment plans and the evaluation of the course of treatment.
3. *Consultant* shall mean a credentialed professional who provides expert service, advice, or makes recommendations for a fee or pro bono, by phone, internet, in person, or by other means to an individual licensed on Guam as a Licensed Professional Counselor for the purposes of maximizing therapeutic benefit for a client.
4. *Licensed Professional Counselor* shall mean a person licensed on Guam to practice Professional Counseling as defined in these rules and regulations.
5. *National Counselor Examination for Licensure and Certification (NCE)* shall mean the examination compiled by the National Board for Certified Counselors (NBCC).
6. *Professional Counseling* shall mean the use of psychotherapeutic techniques in the delivery of services to individuals and groups in order to diagnose and treat mental, emotional and nervous disorders, whether these are behavioral, cognitive or affective. Professional Counseling includes, but is not limited to:
 - a. Assessment and diagnosis of presenting problems through inquiry, observation, evaluation and integration of diagnostic information;
 - b. Designing and developing treatment plans by incorporating and integrating recognized psychotherapeutic theories in establishing treatment goals and interventions collaboratively with clients; and

- c. Implementing and evaluating the course of treatment by incorporating psychotherapeutic theories to assist individuals and groups.
- 7. *Counseling* shall mean a specialized, formal interaction between a Licensed Professional Counselor or other Mental Health Professional and a client in which a therapeutic relationship is established to help resolve symptoms of mental disorders, psychosocial stress, family problems or other difficulties which is designed to enhance problem solving skills and coping abilities as identified in a treatment plan.
- 8. *Individual Counseling* shall mean planned interventions to assist a client to enlarge competencies, increase problem solving skills and coping abilities according to identified treatment goals.
- 9. *Group Counseling* shall mean the gathering together of unrelated individuals at the direction of a group facilitator or counselor for a therapeutic purpose.

Section #####2. Qualifications for Licensure.

- 1. The provisions in this bill shall take effect two years after this bill is passed. At that time, the Board shall issue a license as a Licensed Professional Counselor to an applicant who:
 - a. has a doctorate or master's degree from an accredited educational institution with a program in psychology, counseling, marriage and family therapy, clinical social work or other psycho-therapeutic discipline. The applicant must be able to show documentation of:
 - i. a minimum of seventy-two (72) quarter hours or forty-eight (48) semester hours of graduate studies (as suggested by the Counsel for Accreditation of Counseling and Related Educational Programs [CACREP]) that:

 - 7. Research and Program Evaluation
 - 8. Professional Orientation (to counseling)
 - 9. Professional Ethics; and
 - iii. includes a practicum, consisting of a minimum of one hundred (100) hours; and
 - iv. includes an internship, consisting of a minimum of six hundred (600) hours and;
 - b. has completed a minimum of three thousand (3,000) hours of documented post-graduate clinical experience and one hundred (100) hours of supervision by a licensed Individual, Marriage and Family Therapist (IMFT), Certified Professional Counselor (CPC), Licensed Clinical Social Worker (LCSW), Licensed Mental Health Counselor (LMHC), Licensed Professional Counselor (LPC), Marriage and Family Therapist (MFT), Clinical Psychologist, Psychiatrist or other license deemed by the Board to be substantially equivalent to these professions, who is licensed and authorized to provide such supervision in the United States, its territories or a foreign country determined to be acceptable on a case by case basis by the Board. - c. has successfully passed the National Counselor Examination for Licensure and Certification (NCE) which has been conducted in a manner approved by the National Board for Certified Counselors (NBCC), and;
 - d. has documented completion of training by a professional association or educational institution and approved by the Board that consists of at least six (6) hours of professional ethics, three (3) hours of culturally competent counseling practices with Micronesian communities on Guam and one (1) hour of mandated reporting
2. For an individual who has not engaged in post-graduate experience or cannot document a minimum of three thousand (3,000) hours of post-graduate clinical experience under the supervision of a licensed IMFT, CPC, LCSW, LMHC, LPC, MFT, Clinical Psychologist, Psychiatrist or other license deemed by the Board to be substantially equivalent to these professions, who is licensed and authorized to provide such supervision in the United States, its territories or a foreign country determined to be acceptable on a case by case basis by the Board; such individual may practice under an internship program approved by the Board prior to engagement in that program in order to gain that supervision on Guam. The three thousand (3,000) hour internship program may include, but is not limited to: face-to-face treatment of clients, keeping clinical notes, supervision, treatment team meetings, consultation, education, treatment planning, observation and other activities generally recognized to be part of clinical practice. A minimum of one thousand five hundred (1,500) hours of the three thousand (3,000) hours must be in the face-to-face treatment of individuals and groups, and a minimum of one hundred (100) hours must be supervision. To provide such supervision on Guam, a person must be a licensed Individual Marriage and Family Therapist, Licensed Professional Counselor, Marriage and Family Therapist or Licensed Clinical Social Worker licensed on Guam who has held a license for a minimum of five (5) years; or a Clinical Psychologist or Psychiatrist licensed on Guam who has held a license for a minimum of three (3) years.
3. Individuals who hold a current, valid license issued by a state of the United States, its territories or foreign country approved by the Board on a case-by-case basis as a Certified Professional Counselor, Licensed Clinical Counselor of Mental Health, Licensed Clinical Mental Health Counselor, Licensed Mental Health Counselor, Licensed Mental Health Practitioner, Licensed Professional Counselor of Mental Health, Professional Counselor, Marriage and Family Therapist or other license deemed by the Board to be substantially equivalent to the Guam License for Licensed Professional Counselor, shall be eligible for the Guam license for Licensed Professional Counselor.

Section #####3. Exceptions to licensure.

1. No person may practice Professional Counseling on Guam who is *not* licensed as a Licensed Professional Counselor by the Board, *unless* such practice is approved by the Board or other Guam licensing Board. *However*, this Article does not prohibit:
 - a. an employee of the Federal government from performing official duties on federal property;

- b. an LCSW, PC, LPC, CPC, LMHC, MFT, Psychologist or Psychiatrist, currently licensed in another jurisdiction of the United States from consulting with or advising a Licensed Professional Counselor on Guam. However, the consultant, if not licensed on Guam may not provide services to a client directly;
- c. an active student in good standing as a requirement of a university program for completion of a degree or a person who is engaged in the completion of the requirement of three thousand (3,000) hours of post-graduate clinical experience to become licensed as an LPC, under the supervision of a Guam licensed IMFT, LPC, LMHC, MFT, LCSW, clinical psychologist or psychiatrist from performing assigned duties.
- d. Nothing herein prohibits qualified members of other professional groups, such as clinical psychologists, school psychologists, counseling psychologists, social workers or ordained clergy from doing work of a counseling nature consistent with the training and code of ethics for their respective professions; *provided*, that they do not hold themselves out to the public as a:
 - i. Professional Counselor

Section #####4. Scope of Practice.

Licensed Professional Counselors use psychotherapeutic techniques to prevent, assess, evaluate, diagnose, develop treatment goals, plans and objectives, treat and evaluate outcomes for mental, emotional or behavioral disorders and associated distresses that interfere with mental health.

Section #####5. Client Confidentiality.

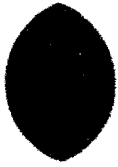
Client Confidentiality is defined and regulated as set forth in the Health Insurance Portability and Accountability Act (HIPAA), the ethical rules of the American Counseling Association (ACA), Guam law, and revisions thereof. Breach of client confidentiality except as provided for by HIPAA, the ACA, or Guam law shall be considered unprofessional conduct and may be grounds for revocation or suspension of the license.

Section #####6. Continuing Education Requirements.

A licensee shall complete a total of 40 contact hours or 4.0 Continuing Education Units directly related to the practice of Professional Counseling within each two (2) year licensure period to qualify for renewal of licensure.

Section #####7. Grandfather Provision.

All licensees who hold a current, valid, license as an Individual, Marriage, and Family Therapist issued by the Guam Board of Allied Health Examiners at the time this section becomes law shall be deemed to hold a current, valid license as a Licensed Professional Counselor.

The intent of the proposed measure is to define the educational and professional requirements for a licensed professional counselor. 
