COMMITTEE REPORT DIGEST

I. OVERVIEW

Bill No. 88-32 (COR) was introduced on April 12, 2013 by Vice Speaker Benjamin J. Cruz and Senator Thomas C. Ada. The bill was subsequently referred by the Committee on Rules to the Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations on April 12, 2013.

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations convened a public hearing on Bill No. 88-32 (COR) on April 19, 2013 at 11:06 a.m. in *I Liheslatura's* Public Hearing Room. The hearing was adjourned at 11:41 a.m.

II. TESTIMONY & DISCUSSION

Chairman San Nicolas convened the public hearing of Bill No. 88-32 (COR) at 11:06 a.m., invited Mr. Craig Thompson, Mr. John Ilao and Director John Camacho to the panel to testify. The Chairman discussed the contents of the bill. He stated that the bill intends to strike a balance between allowing businesses to continue to open, while mitigating the impacts of establishments. Chairman San Nicolas recited Resolution 2-32 (COR). He stated that the establishment ratio needs to be addressed immediately.

Mr. Craig Thompson deferred to Mr. John Ilao to begin comment. Mr. John Ilao stated that the Alcoholic Beverage Control Board discussed the main points of agreement among the ABC Board's discussion of the bill via email. Their consensus was that there should be a grandfather clause for licensees to continue paying the \$1,000 rate and that new licensees should not pay more than \$2,500 per year for their license fees.

Mr. Thompson said that the Board agrees that the license fee can be increased and suggested that Hagatna and Tamuning municipalities should be exempted from the establishment ratio. He believes that the funds raised from the increase should go to Guam Police Department and be given authority to enforce liquor laws.

Mr. Ilaos said that neighborhood bars are good because there is a shorter driving time between an establishment and a patron's home.

Mr. Thompson discussed possibility of establishing of an adult entertainment district in Harmon, as per the suggestion of the Guam Hotel and Restaurant Association.

Chairman San Nicolas discussed the concerns of the ABC Board, including that there be a grandfather clause for existing licensees to continue paying \$1,000 per year, that the fee not exceed \$2,500, that the funds raised by the increased fee not go to the mayors, but instead be applied to intervention by the Department of Youth Affairs and the Guam Police Department, and that all of Tamuning should be included in lifting the establishment-population ratio.

Director John Camacho said that he believes that the Director of the Department of Revenue and Taxation should be allowed to approve temporary liquor licenses, pending action of the Alcoholic Beverage Control Board.

Senator Vicente C. Pangelinan asked what the position of the Governor was with his suggestion. Director Camacho said that Governor's position is that the law prevents the Director from issuing a temporary liquor license. Senator Pangelinan asked what the reaction of the Governor was to this suggestion and asked whether he advocated the Governor appoint more board members. Director Camacho said that he is concerned with the issue and hopes it will be addressed.

Chairman San Nicolas said that he has urged the Governor to make appointments to the ABC Board and other boards under his oversight. He said that he does not believe the answer is to provide the Director with temporary authority and that the subject is not germane to the public hearing.

Mr. John Ilaos said that he was a member of ABC Board in a previous administration, as well. He said that a previous practice was that the ABC Board retained the right for issuing temporary licenses, but that the Director of DRT signed for permanent licenses.

Chairman San Nicolas brought attention to the draft substitute of the Bill. He said that he was displeased with the initial draft of the bill. The Chairman pointed out that existing licensees would be grandfathered in at \$1,000 per year, but new licensees would have to pay \$2,000 per year. It is designed to be revenue neutral with respect to the General Fund and the remainder is earmarked to mitigate impacts to the community. He said that the draft bill would lift the ratio for the whole island. He asked for any comments and whether it addresses their concerns. Chairman San Nicolas provided an opportunity for the Senators present to discuss any issues.

Senator Pangelinan questioned whether there would be an issue with regard to equal protection.

Director Camacho said that he is concerned that there may be an equal protection issue. Chairman San Nicolas said that there will be extra review on this issue. Director Camacho pointed out that there would not be much extra revenue. Chairman San Nicolas stated that he understands that would be the case, but that the impact will gradually increase and that the point of the bill is not to raise revenue, but to fix a problem with the existing law. He points out that over time the new establishments will become a larger portion of the market.


Chairman San Nicolas requested that members of the community provide testimony and concluded the public hearing.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations hereby reports out Bill No. 88-32(COR), as substituted by the Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations, with the recommendation TO DO PASS.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 **Section 1. Short Title.** This Act *shall* be cited as the “Responsible
3 Alcoholic Beverage Control Act”.

4 **Section 2. Legislative Intent.** *I Liheslaturan Guahãn* finds that Section
5 3309 of Chapter 3 Title 11 Guam Code Annotated, which limits the number of on-
6 sale and off-sale general licenses allowed in a municipality, was enacted by the *I*
7 *Mina'Dosse Na Liheslaturan Guahãn* to protect the interests of the community.

8 *I Liheslaturan Guahãn* finds that the village of Tumon has grown into a
9 center for tourism with numerous hotels and a large population of visitors. In
10 addition, the capital village of Hagåtña has become a center for business and
11 government offices with a large population of professionals that work in the
12 village.

13 Therefore, *I Liheslaturan Guahãn* finds that the economy and the
14 community will be best served by finding a balance between establishments in
15 excess of the amounts prescribed by the *I Mina'Dosse Na Liheslaturan Guahãn*
16 and the resources to protect the general welfare. In order to properly regulate the

1 concentrated number of liquor licenses in Tumon and Hagåtña, fees shall be
2 increased for on-sale general liquor licenses in these areas to provide for increased
3 Alcoholic Beverage Control enforcement, police presence, mass transit availability
4 and other programs to be administered by the village mayor.

5 It will allow the accommodation of our increased tourism numbers and
6 provide enforcement resources for Alcoholic Beverage Control and the Guam
7 Police Department and provide needed funding for village programs in the affected
8 villages.

9 **Section 3. General License Fee for Hagåtña and Tumon.** § 3207 of
10 Chapter 3 Title 11 of the Guam Code Annotated is hereby *amended*, to read:

11 **“§ 3207. Licenses: Classes and Fees.**

12 The Board is authorized to issue the following classes and kinds of licenses at the
13 following fees:

14 Class 1. Manufacturer’s license \$ 100.00 per year

15 Class 2. Agent’s license \$ 250.00 per year

16 Class 3. Wholesale dealer’s license \$1,000.00 per year

16 **Section 4. Exemption of Hagåtña and Tumon.** §3309 of Chapter 3 Title

18 **“§3309. Same: Same: Number, Cancellation, Issuance of Licenses in**
 19 **Excess of Authorized Ratio: Application: Hearing.**

20 (a) The number of premises for which a class four on-sale general license or
 21 a class five off-sale general license is issued shall be limited to one (1) for each
 22 two hundred (200) or fraction thereof, inhabitants of the municipality in which the
 23 premises are situated for each respective class. The following establishments shall
 24 not be included in the number of premises allowed for each respective class;
 25 ~~provided, however, that without regard to such population limitation, a~~
 26 ~~nontransferable, on-sale, general license may be issued for~~

1 (1) Any hotel of not less than twenty (20) rooms; or

2 (2) Any premises designed to provide restaurant facilities for the

14 GCA Ch. 40 exercises jurisdiction, ~~while inhabitants shall exclude those residing~~
15 ~~on military contractors' reservations. Nothing in this section shall authorize the~~
16 ~~cancellation of any license which may be outstanding~~ Current licenses in any
17 municipality in excess of the number authorized by the ratio established in this
18 section shall not be cancelled nor shall anything in this Article require the issuance
19 of any license in any municipality because the number of the licenses does not
20 equal the authorized ration. Any licenses issued after the July 1st 2013 that do not
21 comply with the provisions of this section shall be held invalid.

22 (d) Whenever it is made to appear to the Board by satisfactory evidence that
23 the population in any municipality has increased by more than two hundred (200)
24 or multiples of two hundred (200) inhabitants since the latest census recognized by
25 the government of Guam, ~~and it appears to the Board that by reason thereof the~~
26 ~~inhabitants of the municipality are unjustly and unfairly discriminated against, and~~

1 if the total number of licenses in such municipality does not exceed the maximum
2 specified, the Board may issue not to exceed one on-sale general license and one
3 off-sale general license for each additional two hundred (200) inhabitants in the
4 municipality since the effective date, hereof, any person applying for an off-sale
5 general license on the ground of increased population shall set forth in his
6 application and shall affirmatively show all of the following:

7 (1)(a) That he is a qualified applicant and that his premises qualify
8 under the law and rules of the Board.

9 (2)(b) That the issuance of the license applied for would serve the
10 public convenience or necessity.

11 (3)(c) That the issuance of the license applied for would not be
12 contrary to the public welfare and morals.

13 (4)(d) That inequality in the ratio of licenses exists between the
14 municipality in which the applicant's premises are located, and other
15 municipalities in the territory.

16 (5)(e) That the population in the municipality for which the license is
17 applied has increased to the extent and under the conditions mentioned in this
18 section.

19 (e) When an application is filed with the Board pursuant to the provision of
20 the section regarding the increase in population, it shall be referred to the
21 Administrator who shall cause a full investigation to be made of all matters stated
22 in and relating to the application and report his findings to the Board with the
23 recommendations. If a protest against the issuance of the license is filed with the
24 Board, the hearing thereon shall be had and conducted accordingly, as provided in
25 this Title.”

1 **Section 5. Distribution of Class 4 On-Sale General License Revenue**
2 **for Hagåtña and Tumon.** A new § 3207.1 is hereby *added* to Chapter 3 Title 11
3 of the Guam Code Annotated, to read:

4 “**§3207.1. Same: Same: Distribution of Class 4 On-Sale General**
5 **License Revenue for Hagåtña and Tumon.**

6 The license fees collected for class 4 on-sale general licenses in Hagåtña and
7 Tumon *shall* be distributed as follows:

8 50% to the General Fund;

9 20% to the Police Services Fund for the procurement and service of patrol

Hata Adai Senator San Nicolas,

Regarding your scheduled Public Hearing for **Bill 88-32 (COR)**, on **Friday, April 19th**, I have prepared the following comments based on the fact that I may NOT have time to attend this scheduled hearing. My review and comments focus primarily on enforcement and the equity of this draft bill.

- **Legislative Intent:** That, this bill finds that the economy and the Hagatna & Tumon community will best be served by finding a "balance" between establishments that sell, serve, and consume alcohol on their premises versus protecting the general welfare of the Hagatna and Tumon communities. And, to achieve this balance, this bill proposes a higher licensing fee for a **Class 4 (Dealer's on-sale license)** for the Hagatna and Tumon areas.
- Additionally, that the increased licensing fees for establishments selling and serving alcohol in Hagatna & Tumon, for consumption on their premises, will be used for the benefit of the Hagatna and Tumon areas. In particular, that these additional funds would be used to obtain additional resources needed to enforce these laws and to protect the general welfare of the residents living within these communities.
- Accordingly, I would recommend that there also be a similar distinction for a **Class 9 (Club license) & Class 11 (Microbrewery-pub restaurant license)** for the Hagatna and Tumon (Village of Tamuning) districts. In this manner, there would be equity towards **ALL** "licensed" establishments serving alcohol that is "sold" and consumed on their premises to a clientele which may include persons NOT residing within the Hagatna and Tumon areas.
- That, **1 GCA Ch.4, § 403 (q)**, defines the "Village of Tamuning" (a.k.a. District/Municipality of Tamuning-Tumon-Harmon or "TaTuHa") which is inclusive of Tumon. That, outside of this legal definition for the Tumon area, there appears to be no separate "legal" definition of a "Tumon" only district. Accordingly, difficulty may arise in the enforcement of this proposed law. It is possible that businesses may contest paying the higher fee. That, by legal definition, they are within the Village of Tamuning and NOT "Tumon". This can be resolved by legally defining what areas will be considered a "Tumon" only district or further expanding this draft bill to encompass the currently defined Village of Tamuning (a.k.a. Municipality/District for Tamuning-Tumon-Harmon) as defined in 1 GCA Ch.4.
- That, there may be a question regarding the application of this law to the Adelup, Anigua, and East Hagatna areas since the Municipality of Hagatna is also defined by **1 GCA Ch.4, § 403 (b)**. That, my


comments regarding a "Tumon-Only" district similarly applies to a "Hagatna-Only" District.

- Depending on the objective of this bill: Was it your intent to include the businesses currently operating in the Adelup, Anigua, and East Hagatna areas? For clarity, this bill should reference 1 GCA Ch.4, § 403 as the applicable areas for enforcement, **or**
- If a smaller subset of these Districts/Municipalities is desired and for the purposes of enforcing this bill, a clear definition of the boundaries of the Hagatna and the Tumon-only areas that will pay these higher licensing fees should be included (defined) within this bill.
- **§ 3207.1** indicates that 15% of the license fees collected would go to the respective municipality's Municipal Planning Council Revolving fund. Since this revolving fund is managed directly by the District Mayors "versus" the Department of Administration, history reflects that similar bills passed into law that allowed for the disbursement of government funds in to a District's Municipal Planning Council Revolving fund were ultimately amended by subsequent legislation. That these amendments were made to "legally" clarify the "mechanism" as to how the expenditure of these government funds would be accomplished and to ensure that the expenditure of these funds were in keeping with current appropriations and procurement laws. It is my recommendation that this "clarification" be included in this draft bill as opposed to having to draft a future amendment that further delays the Mayor of Hagatna and the Mayor of "TaTuHa" in the use of these funds.
- As a member of the Mayors' Council of Guam, it is heartwarming to see that our Legislature continues to understand the challenges our Island Mayors face in having enough funds for our community programs. And, that the government's investments to "build-up" the attractiveness in operating a business in the Hagatna and the Tumon areas is worthy of levying an higher fee to conduct business that taxes the "public safety" resources available to these areas.
- Finally, **§ 3207.2** creates a "**Regulatory Enforcement Fund**" which, in theory, I fully support. However, I've attached a listing of legislated funds (not a complete listing), similar to this, which I have always questioned as to whether or not there is any "real" enforcement or oversight being done to ensure compliance in the allocation of these funds. If there had been "compliance and enforcement" over these "Special Funds", then I contend that the Government would have always been capable of repaying "Tax Refunds" per 11 GCA Ch. 50 & 11 GCA Ch. 51. Accordingly, somehow we must ensure that greater transparency is afforded to the amounts collected as outlined in these bills and that this information is readily available to the recipients of these funds which would include: the "Police Services Fund" administrator, the Tamuning and Hagatna Mayor, and the DRT who would administer the "Regulatory Enforcement Fund".
