### COMMITTEE REPORT DIGEST

### I. OVERVIEW

The appointment of **April L. Flores** to serve as Member of the KGTF/PBS Board of Trustees was executed by Governor Edward J.B. Calvo on September 15, 2014. The appointment packet was received by the Office of Speaker Judith T. Won Pat on September 16, 2014, and the appointment was subsequently referred to the Committee on General Government Operations and Cultural Affairs on September 17, 2014.

The Committee on General Government Operations and Cultural Affairs convened a Public Hearing on Thursday, November 20, 2014, beginning at 3:30PM in the Guam Legislature Public Hearing Room, with the appointment of April L. Flores to serve as Member of the KGTF/PBS Board of Trustees as an item on the agenda.

The Confirmation Hearing for the appointment of April L. Flores began at 4:56PM and ended at 5:00PM.

### II. TESTIMONY & DISCUSSION

Chairperson Benjamin J.F. Cruz began the Confirmation Hearing by recognizing the appointee and asking her to proceed with her statement.

### April L. Flores proceeded to provide her statement:

"Hi. Hafa Adai, honorable senators. Thank you for the opportunity to be here and to present myself as an [appointee] for the KGTF/PBS Board. I believe I would make a great addition to the PBS Board because the PBS Channel has been an integral part of my childhood. So I would love the opportunity to give back to the island through service and to continue PBS's mission to educate, inform and inspire. If you review my resume, you'll see that my experience in product development and telecommunications has helped hone my skills to learn and adapt quickly, make informative and objective decisions, and carry a positive and resourceful attitude. So I just wanted to thank you for the opportunity to be here."

**Chairperson Cruz** thanked Ms. Flores for her willingness to serve and invited other Committee members to speak.

**Vice Chairperson Tina R. Muña Barnes** thanked Chairperson Cruz and provided the following comments:

"I just want to say congratulations, April, for stepping up to the plate. And I acknowledge the fact that you are an [alumna] of Academy [of Our Lady of Guam] and I would like to say that for the record, you've got my vote. Thank you."

Chairperson Cruz apologized for the delayed commencement of Ms. Flores' hearing and opined that it should have been conducted at the beginning of the public hearing session for the afternoon.

**Ms. Flores** stated that she found the legislative discussion informative and thought having sat through the hearings was a good experience.

**Chairman Cruz** thanked Ms. Flores and, on the account that there were no others present to testify on behalf of Ms. Flores, considered the her executive appointment as heard.






