COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of Belinda C. Mejia to serve as a member of the Alcoholic Beverage Control Board was made by Governor Edward J.B. Calvo on October 13, 2014. The nomination packet was received by the Office of Speaker Judith T. Won Pat, Ed.D., on October 14, 2014. The nomination of Belinda C. Mejia was subsequently referred by the Committee on Rules to the Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations on October 16, 2014.

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations convened a legislative hearing on November 18, 2014 at 2:23 p.m. in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was the nomination of Belinda C. Mejia. The hearing was adjourned at 3:02 p.m.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas convened the hearing on the nomination of Belinda Mejia to serve as a member of the Alcoholic Beverage Control Board. He invited members of the public who wished to provide testimony on the nomination.

Narci Dimaoala spoke in support of Ms. Mejia's nomination. She spoke about their relationship as members of the National Association of Women in Construction. Ms. Dimaoala stated that Ms. Mejia would be a valuable asset to the Board.

Franklin Leon Guerrero spoke in support of Ms. Mejia's nomination. He stated the Board requires so much commitment from its members. He mentioned that Ms. Mejia's experience on the Board is invaluable as she possesses the knowledge of the laws and the process. Mr. Leon Guerrero stated that Ms. Mejia has been an integral part of the Board and reaffirmed his support for her nomination.

Chairman San Nicolas stated that the Committee was in possession of several written testimonies in favor of the nomination.

Belinda Mejia stated that the Board has been aggressively enforcing the village quota law with regards to alcoholic beverage licensing. She further mentioned that the Board is working on properly implementing the mandated alcohol server training. She spoke about several other legislative measures that the Board would have to take up if passed. Ms. Mejia expressed hope that the Department of Revenue and Taxation inspectors be better equipped to carry out their responsibilities. She reaffirmed her commitment to serve on the Board.

Chairman San Nicolas thanked Ms. Mejia for accepting the nomination. He commended the Board for their work in reducing the number of alcoholic licenses that are above the village quota. He asked for an update on the implementation of the alcohol server training program.

Ms. Mejia stated that the Board has met with several relevant stakeholders. She further stated that the Board would like to conduct a roundtable discussion with those stakeholders to discuss the program.

Chairman San Nicolas stated that he will work with the author of the alcohol server training program legislation to facilitate that roundtable discussion. He thanked Ms. Mejia for her service.

Senator Aguon thanked Ms. Mejia for her service. He asked for an explanation on what may have caused the decrease in alcoholic beverage licenses with regards to the village quota.

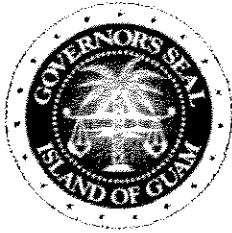
Ms. Mejia stated that several businesses had already closed and it was just a matter of updating the list of licensees.

Mr. Leon Guerrero stated that establishments may have changed its license categories with some becoming restaurants thus falling under a different status.

Chairman San Nicolas clarified that the reduction in the quota is based on the natural occurrence of the business market and not any overly drastic actions taken by the Board. He thanked Ms. Mejia for her attendance and participation and adjourned the hearing.

III. FINDINGS AND RECOMMENDATIONS

The Committee on Aviation, Ground Transportation, Regulatory Concerns, and Future Generations hereby reports out the nomination of Belinda C. Mejia to serve as a member of the Alcoholic Beverage Control Board, for a term of two (2) years, with the recommendation TO CONFIRM.


