COMMITTEE REPORT DIGEST

I. OVERVIEW

The appointment of **Darryl A. Taggerty** to serve as Station Manager of the Guam Educational Telecommunications Corporation (KGTF/PBS) was executed by Governor Edward J.B. Calvo on November 8, 2013. The appointment packet was received by the Office of Speaker Judith T. Won Pat on November 8, 2013, and the appointment was subsequently referred to the Committee on General Government Operations and Cultural Affairs on November 11, 2013.

The Committee on General Government Operations and Cultural Affairs convened a Confirmation Hearing on Thursday, March 6, 2014, at 9:30AM in the Guam Legislature Public Hearing Room. Among the items on the agenda was the appointment of Darryl A. Taggerty to serve as Station Manager of the Guam Educational Telecommunications Corporation (KGTF/PBS).

The Confirmation Hearing for the appointment of Darryl A. Taggerty began at 9:30AM and ended at 10:18AM.

II. TESTIMONY & DISCUSSION

Chairman Benjamin J.F. Cruz: *Hafa Adai* and good morning. Today we have one confirmation and a bill has been tabled by the author. The confirmation for today is the appointment of Darryl A. Taggerty as station manager for Guam education Telecommunications Corporation (KGTF/PBS). We have Mr. Taggerty here, and we will invite him to present his testimony.

Darryl A. Taggerty: Thank you very much, Mr. Chairman for hearing the governor's nomination for me to serve as the station manager for PBS Guam. I would like to summarize my written statement for the hearing today and ask that it be submitted in record in its written form.

I first became aware of radio broadcasting when I first moved to the Washington area with my family in January 1971. These were new networks and I was not only impressed and taken by them, but by the noncommercial forms of electronic media. I was very familiar with ETA television, which was the Washington anchor for the PBS network and WAMU at American University, which was the studio for National Public Radio News. I listened to both the news and entertainment on WAMU avidly. I attended Georgetown University and it had one of the best independent commercial radio stations in the country. I followed the fortunes of that station as it rose and failed. Ten years later in 1981, I was fortunate to become a volunteer at a similar station at John Hopkins University. After a year as a volunteer, I was asked to be the acting general manager. Since I was not a student at John Hopkins University, I was asked to be in charge for only that summer. At the end of the summer, they asked me to be the general manager and to make me eligible; they offered me a scholarship, guaranteed matriculation, and classes of my choice. I turned it down because I was making my way back to Guam. Later when public radio started here on Guam, the founding general manager was stepping aside and asked me to apply for the position in 1996. I left the governor's office to take that position at KPRG. That was a dream come true.

I served five years as the General Manager and one year as executive producer at KPRG. The last five years I worked for Robert Kelly, a telecommunications consultant. He's been my friend for 25 years and my partner as a founding member of the non-profit, Marianas Educational Media Services incorporated that I am the president of. We have three noncommercial FM stations in Saipan. We rebroadcast Public Radio Guam and provide EWTN services. Until they have a bishop and although we are giving the station to the diocese, they cannot

accept the station. When they do accept it, we will provide all equipment to the church and provide training. We have already pledged to them in writing. We also carry melodies of prayer, which is heard here on Guam on 106.9 and 107.9. The producer of that program leases the station in Saipan for the edification of its people.

I currently serve the people of Guam in an executive appointment. When I became available, the station manager position at PBS Guam was vacated. Here I am today, offering myself to the legislature for your consideration as the next station manager for PBS Guam. At this point I will be very happy to entertain your questions and hear your concerns.

Chairman Cruz: I have not a chance to read your written testimony, but I was hoping that you might like to expand on the plans and visions that you want to implement for the future of PBS so everyone can understand, look forward to the future. There's no question that you have the credentials, the issue now is do you have the mission and the vision to take this over. What are your plans specifically for PBS and is there any conflict between your nonprofit and your position at PBS?

Mr. Taggerty: I would like to answer the second question first. I do not think there is a conflict. The three stations are operated at a remote studio by [Federal Communications Commission] (FCC) permission at Sunny Plaza here on Guam. They are all remote stations and they pass through the audio that is sent to them via [Internet Protocol] (IP). The operations are not time intensive and costly. Mostly, they are not in conflict with the mission of PBS Guam. In fact, my experience and connections I have through having those stations in Saipan will assist in a strategic plan that has been in place with my predecessors. I do not see any other conflict and if there is a conflict, I will step away from my government job. That is my primary job. I do not see any reason to do that. If one raises the question, I will certainly step back. I am on the board and I am not paid by the nonprofit—I never was. This is strictly [on a volunteer basis]. The ones who get compensation are the ones who are under written agreements.

On the vision for PBS Guam, what I found for the facility was the crying need for updating the equipment. I have a great staff that knows what they want to do. However, using five-year-old editing suites, 10-year-old cameras, and 20-year-old devices makes it very slow and inefficient to produce. My staff can do three times more with better equipment. First off, for production I would like better equipment such as [high definition] (HD) cameras and HD editors. The studio

was given to us in the 1970s. It was once the industrial arts area for George Washington High School (GW). There's a wooden wall that separates us from regular classes. Since the census for GW is expected to decline next year, I am asking [the Guam Department of Education] (GDOE) to allow us to use the remaining space. I do not consider the facility to be safe so I am considering that we include a backdoor. We cannot expect people to produce work; however we use it as a studio. The door is substandard and there is an electrical subpanel, which should have not been there. I would put a door through the wall, but it was not recommended by [the Department of] Public Works due to the way the wall was built. So, I am stuck with what I have.

As far as programming, we have a digital transmitter and a digital conversion of all TV programs in the United States. Digital programming allows four programs to be transmitted at the same time. My idea for this is to include the legislative channel and the Guamanian channel as broadcast channels not dependent on cable, since this is a public service. There are some areas shadowed by terrain, so some of our broadcasting cannot be reached in Agat, Malesso, Umatac, and Inarajan—places [where] I would like to install transmitters. A transmitter in Malesso was destroyed and never replaced. I would like to secure transmitters in Rote' point, in Malesso, and hopefully in Inarajan. These are large populations and they deserve to be served equally.

We are not using all of the programs that we have paid for because we do not have enough space on the channel. I am working on getting those on channel 12.2. [This channel] was supposed to be a completely local channel, but we cannot fill it with only local material. We also need independent producers to suggest material to broadcast, such as films, shorts, and productions. We have a sister station held by Hurao Inc. We provided assistance to make sure they did not lose their license in 2013. We can provide them technical guidance so that they can provide a robust production facility to fulfill their mission.

Educational television and radio has a broad mandate to do what commercial radio cannot do, that leaves all educational effort to PBS Guam. PBS is a network that we pay \$100,000 for the rights to carry their programming, but KGTF's grants are all predicated on local production. We have the PBS programming; now we need local production that should include the Northern Mariana Islands. The law restricts Guam educational telecommunications to television and I would like that law to be broadened to radio, so that there is no problem in assisting Hurao and even in setting up a Micronesian Channel.

We can serve Micronesians in the region and here on Guam with them speaking in their language to other Micronesians in their home islands. This not in connection with PBS, but I propose that we bring one of the FM stations from Saipan to put on Guam and assisting each of the FM stations Micronesian centers where run AM stations. It will be more economical to turn their AM stations into low-power FM stations. We can send out one short wave from Guam and one FM wave corresponding via IP to Micronesia. This will fulfill a need in the Micronesian community, not just on Guam but around the world.

This will improve the quality of communications and community. This was an idea that I presented to the Micronesian Chiefs Executive Conference in 2011. It was endorsed, but we will need to follow through with that. The fact that I am a holder of a license that may be a partner of this and standing before you as a potential Station Manager for PBS Guam is not a conflict. If it was a conflict, I would pass on my license to another group and commit to my plan for PBS Guam.

Chairman Cruz: It is a very great vision. I am a little concerned about the radio being done immediately, but I am more concerned with your plan in the next year and two years. I want to thank you for visiting me. I want to discuss now, for the month of March, the issue of Chamorro immersion and expanding Chamorro television shows on PBS. What do you think of these ideas possibilities and is there any chance of these becoming public programming?

Mr. Taggerty: That was one of the highest priorities, but due to the highly detailed strategic plan, the plan became something we had to organize. That was a great idea that you had—to have news in Chamorro. Whether it be daily or weekly news, real ideas and concepts that we encounter every day should be spoken in Chamorro so that it is not a social language. The language can be of important matters and this can really expand our understanding and ability of the Janguage.

I brought this up to the staff and the focus of getting Chamorro month off the ground; I have not spoken to the other folks that you have mentioned. If we can do it by the end of this month, this plan can be so much the better. This should be done and I will find time on the schedule to do it on the main Channel 12. This is what Hurao intended to do, 24 hours [a day], seven days a week. I have been discussing this, making a production facility, and training volunteers with Anne Marie at Hurao for the past five years. We want to set a procedure so they can have spoken Chamorro in various locations being fed into a central facility,

rather than having people come to a facility to operate a station with a satellite. This is what should be done and is five years overdue. This is why I am happy that I am now in a position to change this. Anne Marie and I have been communicating about this plan in writing and she is well aware of it.

Senator Christopher M. Duenas: Thank you Mr. Chairman and I would like to congratulate the Governor's office for what I consider as a very excellent consideration of appointment and your willingness to serve as well. I did not know your background, but I did know you in social circles. I must say that I am extremely impressed in listening to you.

I have two questions for you. I want to see what additional expansion you would have in working the Department of Education. This can bring a lot of excitement with DOE with bringing the broadcast in. I remember going to grade school in the States and a lot of public broadcasting integrated with audiovisual (AV). Do you see this as a possibility?

You mentioned that you presented to the Micronesian Chiefs. I encourage approaching me and the Speaker, who is now currently the President of [Association of Pacific Island Legislatures] (APIL). One of the major concerns of these conferences is connecting the blue continent. We look for private enterprises, as you well know, because connectivity is expensive but needed. The efforts you were talking about for programming, I was thinking that you may be a catalyst for early endeavors. I encourage you to work with APIL. I just wanted to get your thoughts. Thank you, Mr. Chairman.

Mr. Taggerty: These are both excellent concerns. The first one with GDOE, the audiovisual is something I am not sure that they are doing currently. There is an NPR and PBS restriction on having actual classes over the airwaves. However, we can integrate audiovisual and productions in school clubs. Afterwards, we can send it to PBS to broadcast. This is something that should be done. We should have communication clubs to have these opportunities. I would like to look into this.

When you mentioned GDOE, Chamorro promotion came to mind. This is a personal perspective, but we could use some of the Chamorro Education can be used effectively and efficiently in broadcasting. Some of the teachers could be part of the group to provide material. I will look into tying the schools with broadcasting. I am looking for interns. I have reached out to the University of Guam (UOG) communications department and I will reach agreements with the interns next week. I would like to give you my proposal to the Chief Executives

with regional broadcasting. It was based on nation building to help them see each other as a unified group. This will be all time share with the languages. Now that broadcasting is happening in Micronesia, there is no reason for this to not happen. Our idea of bringing radio content from each of the state centers via IP, real time was to assail the restrictions on getting large amounts of contents. Thank you.

- **Senator Duenas:** Thank you for your responses and you certainly have my support. Thank you, Mr. Chairman.
- Senator V. Anthony Ada: Thank you, Mr. Chairman. I am related to Darryl and we grew up together since our families are very close. Thank you, Darryl, for accepting the Governor's appointment to PBS and I look forward to seeing many good things. A lot of shows came out with PBS, like Sesame Street, and there was one show with a bill sitting on the steps on Capitol Hill explaining how a bill becomes a law. I went to PBS and many of your concerns were also concerns of the previous director. Do you think PBS will get a new facility or expand on the old facility?
- **Mr. Taggerty:** The current facility is adequate except for the studio space. The studio suffers from safety issues. It would not sustain an inspection so we need to have a rear exit to the studio. Since the George Washington High School is expected to have a smaller census next year, this is our first attempt in 40 years to work with the space given to us. Just last week I was given that GDOE was expected to cut GW's census in half. This allows us to move forward.
- **Senator V. Ada:** Thank you. I am glad to hear that and I hope that you are successful in expanding your studio. I am glad that you are there and I look forward to voting on your confirmation in the future. Thank you, Mr. Chairman.
- **Chairman Cruz:** I have a few more questions, Darryl. Yesterday, the OPA and Deloitte issued an audit on KGTF/PBS. Have you had any chance to review it?
- **Mr. Taggerty:** One of the preoccupations I have been in was making sure that this audit was finalized. Yes, I was actively involved with the audit.
- **Chairman Cruz:** Are there any recommendations that the auditor has for you to financially address? You have mentioned that PBS is in a financial state.
- **Mr. Taggerty:** Well, the financial state has to do with falling revenue over the past years. Some areas include production and donations. We need to resolve that separately, but we have a reserve that is needed to bridge the time between the

approval of a grant and the disbursement. We have to carry our employee paychecks in the fall before the allotments are released. The community service grant is not received until December and then the balance is provided in April. For the past 10 years, Congress has been threatening to defund the National Endowment of the Arts. There is a two-year commitment by Congress for funding. Due to the financial difficulty that we have had of maintaining the pace of fundraising, we have been using our reserve and that has been a concern of the auditor. There were a few things they wanted us to do like changing some numbers and definitions. There was no material concerning the financials. In fact, the OPA was very happy that we completed the audit on time. We met those deadlines and that is why it appeared on the OPA website.

Chairman Cruz: There is one other thing I would like to ask. Concerning your plans with the Micronesian Chiefs and wanting to broadcast out to the blue continent, but I would like the focus to be more Guam centered. There was a story of Guam Micronesians that want to promote a positive image of the Micronesian community.

Mr. Taggerty: I must have missed it.

Chairman Cruz: It was a very good story. I have been pushing the issue of deportation in my letters, but the important thing is how unfortunate it is with these students who are alumni of UOG and have become presidents and governors of their islands in the region, are shadowed by the criminals in the media. I think that it is imperative that along with the Chamorro immersion idea—it is important to include these young people and maybe ministers to deliver positive news and make good role models for some of these kids because unfortunately, many of these kids are lacking positive role models. There just is not enough time in a 30-second [ad] to properly deliver these issues. Since this group includes a large portion of our community, it is imperative to promote positive role models and then to reach out. Devote some time to Channel 12 before you get to 12.2. This community is not going to move forward unless we turn the tide with this community.

I would like to get your feedback, since you have been thinking about this for five years; how we can do this because it is important help them understand laws in our community. We can find someone to reach out and provide good role model to the kids in schools. There is too much negativity with the media and you can do something to change that.

Mr. Taggerty: I think this is why I am so happy to be appointed to this position. As I mentioned early, how public broadcasting has a mandate to do the things commercial radio is lacking, this is a good opportunity to get this in the airwaves. The articulate sub communities, when they realize that they can have their expressions and passions represented fairly in long form and in a positive fashion, then we have succeeded that is the purpose of public broadcasting.

I am so happy to not only have [Channel] 12.2 ready to go, but also to be able to shoot material to put on the Guamanian channel. We can put things on there now. The broadcast capability is able to send it to homes that are not connected to Docomo or GTA. I also want to incorporate antenna installments. People will watch the programs with our broadcasting capability. I want to thank you for your encouragement. This was part of the back details of what I propose with radio and television. This can happen with the next several months.

Chairman Cruz: I agree. I remember that there used to be a Filipino show on KGTF and that created a sense of community within that group. It included all of the positive role models and it provided them that pride to help them move forward.

Mr. Taggerty: It is similar to the Chamorro experience, in that there is an editorial bias. We do not see the positive role models because we read and accept what we read on print. It takes effort to build a mirror for the community see themselves as the way they are. This is what we can start with right away.

Senator Duenas: Just a quick follow up on the financial state audit, I would encourage now that you have made it clear on your goals, that you make connections with GVB. I think the hotel industry would be very interested and seeing what they can invest in that is tax deductible for them. There can be real results in terms of outreach with the community. I think that can help you bridge that gap in financing. If you had that proposal and GVB can set up meetings with you, I believe that the hotel industry would be interested in investing in that. It is good for everyone. Thank you, Mr. Chairman.

Mr. Taggerty: Thank you. That is a great idea.

Chairman Cruz: Thank you, Darryl. I am excited about your confirmation and it will be on the agenda for the week of the [March 24th] (session was rescheduled and moved to April 7th to 17th). You can expect my support.

Mr. Taggerty: Thank you, Mr. Chairman. Thank you, Senators, for today.

Chairman Cruz, on the account that there was no one else present to provide oral testimony, adjourned the Confirmation Hearing for Mr. Darryl A. Taggerty.

III. FINDINGS AND RECOMMENDATIONS

The Committee on General Government Operations and Cultural Affairs hereby reports out the nomination of Darryl A. Taggerty to serve as Station Manager of the Guam Educational Telecommunications Corporation (KGTF/PBS) for a term of four years, beginning on the date of her confirmation by *I Liheslaturan Guåhan*, with the recommendation TO DO CONFIRM.

Dear Mr. Chairman and Members of the Committee:

Thank you for considering Governor Calvo's nomination for me to serve the government and people of Guam as Station Manager of PBS Guam, a public corporation. I am confident that you will find me to be qualified and suitable for this responsibility.

My interest in publicly-supported, non-commercial television and radio broadcasting started during the fledgeling years of Public Broadcasting Service (PBS) and National Public Radio. My family moved to the Washington, D.C. area when I was 16 years old in January, 1971. I regularly watched local noncommercial television station WETA, a leading PBS network production and live studio news center, and listened avidly to news and alternative music programming on WAMU-FM at American University, the NPR network news center. I preferred programming on college radio and free-format commercial stations to the popular fare of the day. I closely followed the institutional development and programming ethos of my favorite station, WGTB-FM, at Georgetown University. By June of 1981, I was a volunteer program host on WJHU-FM, a student-operated broadcast arm of the Johns Hopkins University in Baltimore, where I was appointed acting general manager for the summer of 1982.

As manager of a volunteer cadre of over 40 students and community producers, I became familiar with responsible stewardship of the public airwaves and public trust. My duties included training and supervising program producers and announcers for both entertainment and news programs; orienting novice volunteers; maintaining studios, an office and music library; enforcing FCC and University rules; producing University audio programs for national syndication; and providing city residents with an alternative radio service which was consistent with the excellence of the University as a whole. When the Fall semester started, I declined the university President's offer of graduate matriculation with scholarship and stipend that would

have made me fully eligible for the General Manager position as a student, choosing instead to return home to Guam as I had planned.

For the next 14 years I was appointed to a number of technical research, writing and service positions within the government of Guam Executive and Legislative branches, and with the Guam Delegate's office. Each one required me to be a quick study and to display understanding of the context of topics under consideration. Directly relevant to my qualifications for the PBS Guam station manager position were: Acting Director of Tiyan Reuse Authority in 1995, organizing a staff of 57 to take possession of NAS Agana and facilitate relocation of government of Guam offices into vacant buildings, while maintaining strict compliance with federal procedures; Director of the Guam Disaster Recovery Office in 1995 and 1996 to complete FEMA reimbursement claims for public facility damages following typhoons Yuri and Omar; and acting Director of Civil Defense for six months in 1999, when my office managed a military chemical dumpsite evacuation and completed a major dump fire well within budget. I am very proud of the fine work that was done by the government staff in these offices I managed, when I served in the ultimate support role as their advocate, to make sure they had the tools, direction, and protection when necessary, to get their daily jobs done right.

In May of 1996, however, I left government service to become General Manager of KPRG-FM, Public Radio for Guam, operated by the non-profit Guam Educational Radio Foundation. The KPRG opening was an unexpected second opportunity, after walking away from the WJHU offer. There, I became familiar with Corporation for Public Broadcasting grant guidelines, annual audits, working with a governing Board of Trustees, and satisfying the public trust in partnership with donor members, the University of Guam, Legislature and the Governor's Office. I truly enjoyed my 30 months as station manager. I returned in June 2000 as Executive Producer under General Manager Chuck Crisostomo, and succeeded him in that position the following year. The Guam Humanities Council recognized KPRG in late 2002 for its exemplary contribution to the arts on Guam. Over the years, I have remained a loyal advocate and volunteer at KPRG; I moved my program "Jazz on the Seventh Day" from K-57 when KPRG started on the air in January 1994, and have been a devoted Sunday evening volunteer since.

Perhaps I should also mention at this point that I am the Chairman of Marianas Educational Media Services, Inc., a non-profit corporation formed in 2001 that holds three FM licenses on Saipan. With the expert technical and regulatory assistance of co-founder Mr. Robert F. Kelley, Jr., we afford the residents of Saipan and Tinian with a simulcast of KPRG programming from Guam, "Melodies of Prayer" also originating on Guam, and EWTN Catholic Radio service. As you can see, promoting non-commercial broadcasting service has been my alternate career passion, competing only with public policy analysis and project management.

In the past six weeks, I have come to be acquainted with the work 26 fine people perform at PBS Guam. We have discussed their workplace challenges, and aspirations. They feel strongly about the importance of their individual contributions, to provide Guam residents with a high-quality, educational television information and entertainment service. They understand the statutory purpose of PBS Guam, its annual appropriations and terms of eligibility for Corporation for Public Broadcasting's annual Community Service Grant. I see my role as Station Manager as one of support and direction. Without executive support and direction, staff will repeat the same tasks month after month, as their equipment ages and their creative juices dry up. I am only the latest in a string of managers at KGTF. If confirmed, I plan to upgrade production equipment and the studio facility, provide momentum for PBS Guam to compete favorably with other media, protect and digitize station tape and film archives, and help to faithfully document the contemporary lives of island residents.

I wish to thank Governor Calvo for having confidence in me to perform the duties required of the PBS Guam Station Manager, and for the PBS Guam Board of Trustee's enthusiastic support for my nomination. I would thank you for sharing their perspectives and voting in Committee and in Session to confirm my appointment, once your concerns, if any, are satisfied. I certainly welcome your questions, and look forward to addressing your concerns and aspirations today, and over the coming years.
