Senators Present

Vice Speaker BJ Cruz, Acting Chairman

The public hearing was called-to-order at 11:00 AM.

Vice Speaker Cruz. This committee on appropriations, public debt and legal affairs, retirement, public parks, recreation, and historic preservation of land will now reconvene. I apologize for my delay. For the listening audience that were not aware, the chairman of this committee, Senator Vicente Ben Pangelinan, passed away this morning. We just had the rosary at the hospital. Before his passing, he instructed me to hold these hearings and I intend on fulfilling the instructions that were given to me. I know that with the long title of his committee is that he had taken probably the most important functions of government in every single one under his purview. The board of equalizations is a very important board so I thought that it

was imperative that we have this hearing. The reassessments and reappraisals will be coming out in August, I believe the hearings on the equalizations will be in September and the board of equalizations will announce the new tax rules in November so in his honor, I believe it is imperative that we continue with this hearing. I would like to that that there is only one name that has been sent down, and that is Mr. David Jimenez. Are there any individuals that wish to speak on his behalf? Mr. Jimenez going to be the only testifying? No? Okay, thank you.

II. SUMMARY OF TESTIMONY & DISCUSSION

Mr. David Jimenez. Good morning, Hafa adai, my name is David Jimenez. I am here to testify and answer any questions in regards too what I can do, and bring from my past experience to help fulfill the missions to the board of equalizations

Vice Speaker Cruz. You will forgive me if I seem like I am trying to figure out from your resume what experience in this resume makes you qualified to be a member of this board of equalization.

Mr. David Jimenez. Correct, and that was probably one of the first questions that I had when the discussions were initially had as far as nominated myself to be apart of the board. I forgot who it was I spoke with within the legal office I believe it was, asking them specifically what was it about my resume or my past experience that would help or fulfill the mission of the board. Basically what I do on a day-to-day basis is solving problems as it relates to not just technical issues, but also the finances and the cash flow of operating our business locally. Quite often what that involves with is making decisions without having all of the variables readily at hand so what it requires me to do, with the help of my co-workers and colleagues is coming up with the best conclusion for the situation that we have with he information that is available and so I think quite often what I see whenever committees like this are formed there entrusted to make the right decision based on the information that is available when sometimes that is not always the case. We know every single piece. The experience that I bring is being able to identify or provide my angle from a private sector on how we can make rulings based on decisions when information is not always there.

Vice Speaker Cruz. I note that you have a degree from the University of South Florida. Could you just elucidate on what this degree is in? BSME? What that means?

Mr. David Jimenez. Sure. The BSME is a Bachelor of Science and Mechanical Engineering. That was a program that I completed from 2000-2005. I took a little bit longer than the standard 4 years, so I did internships throughout my summer and winter periods and completed that degree.

Vice Speaker Cruz. How would a degree in mechanical engineering assist in reviewing and making determinations on whether or not, the appeals before the Board of Equalization are to be approved or disapproved? Maybe if you told us more about what you are currently doing at Johnson Control? It might help me understand exactly since you did not have a prepared testimony, I'm going to have to be pulling teeth to try and get some information on the record to justify this appointment.

Mr. David Jimenez. Yes, I guess breaking that down into two pieces, from my experience, it is part of the degree, the mechanical engineering background or discipline you can from an engineering standpoint. It touches on not just all the aspects from all of the different fields of engineering from civil and electrical, but also there is a certain business aspect to that as well. Part of your curriculum is economics and engineering finance. Part of those things play into heavily in what I do on a day-to-day basis. When I think about what I do at Johnston controls, probably about 5% of what I have learned from a tactical standpoint at the University of South Florida is really applied in my day-to-day work. When look at the economics and finance side of it that is heavily used on day-to-day basis on what I do at Johnston controls. So taken that aside and looking specifically more at what's done at Johnston Controls -----(In Audible)---- We were tasked with trying to figure out the best solution from a monastery standpoint, whether or not the budgets we currently have set aside were going to be fulfilled in our floor logs for securing the work. Part of that, we have to make certain tough decisions as far as not only from an equipment standpoint, but these are also decisions that affect peoples lives. It is something we do not take lightly. We take it very seriously. Especially when we are trying to forecast who we have to---- (In Audible)-----Part of our team locally here for Johnson Controls----- (In Audible)-----has to do a lot with the economic side as well as the people side and how top affect the two together.

Vice Speaker Cruz. What exactly is your job their?

Mr. David Jimenez. I am account executive for Johnson Controls. I am charged with the profit and lost success for the local branch.

Vice Speaker Cruz. How long has Johnson Control been here?

Mr. David Jimenez. Locally, we have been on Guam, the official bona fide branch has been here since 2008, I believe. 2008 or 2009 is when they first started out here for the first phase of the naval efficiency project, but as far a broader standpoint, we have been doing business with the local Navy for shipyard repairs long before that. I would say, conservatively speaking, two or three decades prior, but an actual bona fide branch since 2008 or 2009.

Vice Speaker Cruz. And besides working with the Navy, you mentioned the electrical. Did

you guys have the new contract for all of the new lights that went up?

Mr. David Jimenez. We were initially rewarded a partnership with the Guam Power Authority to provide energy efficiency programs for public and private sectors. Part of that was included in the streetlights. I think in 2010 or 2011 there was a grant awarded and because the street lights were under our chunk of the contract, another part of the contract was awarded to another part of the country, but the street light were also part of our contract as well, so we performed the change out of those lights.

Vice Speaker Cruz. Are there any other projects that you guys are involved in locally?

Mr. David Jimenez. Yes. The major projects that we have so far are the Guam Airport. If you have been through there and have seen the signs that say "Pardon our dust for the air conditioning improvements." We did the whole entire expansions from A-Z in the HVAC upgrade for the airport. There was also like I mentioned before, the navy project, which is of equal size if I recall. The other projects are the line agency improvements, also done through GPA. We have had a large track record of large projects being executed through Guam and there are a number of other small projects we do from time to time in servicing our customers.

Vice Speaker Cruz. Have you taken the time to review the statutes that relate to the Board of Equalization and familiarize yourself with what you might have to be doing as a member of that board?

Mr. David Jimenez. That was one of the questions I was going to pose to the committee as far as where to go for that information. I was attempting to look up that information on my own online as far what I could find out. The best information that I could see the minutes that were posted on the Guam Rev and Tax website. I read through those to get an idea as far as what kind of discussions are had at these meetings, what kind of deliberations go on, and what kind of indicates to the decisions of the board members already.

Vice Speaker Cruz. What is your understanding of the responsibility or the mission of the board of equalization?

Mr. David Jimenez. Primarily as it was told to me, it was the main charter in the immediate future is like what you mentioned before that after the re-evaluation is done, there would more than likely be a number of protest or appeals as far as determining the appeals should be upheld or if they should be overturned.

Vice Speaker Cruz. Have you discussed your responsibilities with the director of revenue

and taxation?

Mr. David Jimenez. No I haven't had any discussions with anybody from Rev and Tax.

Vice Speaker Cruz. So besides the minutes you saw online....?

Mr. David. Jimenez. Yes that is correct. It has been a relatively short period of time from when the application process was done to where it is right now. I mean as far as preparing myself, I mean no doubt, I would have liked to been able to have found more information online, getting more involved with the Rev and Tax are certainly things that I can take on.

Vice Speaker Cruz. Alright. Do you have anything else you would like to add as it relates to your participation or nomination to this board?

Mr. David Jimenez-. No, but thank you for hearing me this morning.

Vice Speaker- The committee will stand adjourned.
