COMMITTEE REPORT DIGEST

I. OVERVIEW

The Committee on Education, Public Library and Women's Affairs convened a public hearing on July 25, 2013 at 9:00 am in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Ms. Debra Duenas to serve as a Member of the Guam Public Library System Board, and whose appointment history is as follows:

- Appointed by the Governor of Guam on June 12, 2013, for a term of Three (3) years;
- Appointment packet forwarded to *I Liheslatura* on June 12, 2013;
- Appointment packet forwarded to the Committee for public consideration on June 13, 2013.

Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on July 17, 2013, (5-Day Notice) and July 22, 2013 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

II. SUMMARY OF TESTIMONY AND DISCUSSION

- Speaker Won Pat, Ed.D. called Ms. Storie and Ms. Gogue to testify.

- Ms. Storie testified in support of Ms. Duenas. Her testimony is appended to the committee report.
- Ms. Gogue testified in support of Ms. Duenas. Her testimony is appended to the committee report.
- There being no questions or comments for Ms. Storie and Ms. Gogue from the senators, Speaker Won Pat, Ed.D. thanked them for their testimonies.
- Ms. Duenas' written testimony is appended to the committee report.
- Speaker Won Pat, Ed.D. asked Ms. Duenas, if her statement in her testimony was accurate "The libraries in the schools are an integral part of that process, but they are adequate in themselves." The Speaker asked if the nominee meant to insert the word "not" before the word adequate.
- Ms Duenas replied that she meant to type "inadequate", but the auto correct may have changed it to adequate. She stated that the school libraries do a good job, but they need the public support.
- Speaker Won Pat, Ed.D asked the nominee her opinion concerning expanding the libraries' role after school hours.
- Ms. Duenas suggested after school tutoring programs and more hands on technology for school age students at the branch libraries and the Hagatna library. She explained that students are assigned technology homework such as power point or word processing for their papers, but many students do not have the technology at their homes and the students need access to the technology to accomplish their homework.
- -Speaker Won Pat, Ed.D. spoke about DOE offering their teachers laptops or computers, but there are teachers who are hesitating accepting because they will be liable if the equipment is damaged or stolen. Speaker asked the nominee her opinion about the library system acquiring the laptops for the patrons to utilize with the claim that the libraries are an extension of the schools.
- Ms. Duenas replied that she would like to see DOE and the Public Library System collaborate regarding the usage of the computer system.
- Speaker Won Pat, Ed.D. spoke about blue ribbon schools in the mainland and how their school libraries are available to the general public after school hours. The Speaker asked the nominee her opinion about this practice.
- Ms. Duenas replied the idea is good one and it will take a lot of administrative finesse. She commented at this time the schools do not have separate entrances for the libraries and they will be a need for security and personnel to implement this idea. She stated the idea is worth looking at with a different mindset.
- Speaker Won Pat, Ed.D. asked the nominee her vision of how the library system should address the changing of the times.
- Ms. Duenas responded that technology and access to online research data bases are important tools to meet the changing times. She spoke about providing library patrons the usage of kindles, ipads and ereaders. She further stated that the library should be more comfortable place for the patrons to utilized and provide strong wi-fi internet connection.

- Speaker Won Pat, Ed.D recognized that the library system has not received the financial support and the attention it truly needs and she expressed the library system has been coasting with the limited resources it receives.
- Vice Chairperson, Yamashita Ph.d. thanked the nominee for accepting the appointment. The Vice Chairperson asked the nominee if she would support a model system where the mayors, schools and the libraries work collaborative to ensure the technology is robust at the libraries, the doors remain open during the evening hours for families to access.
- Ms. Duenas replied the public libraries belong to the community and the more community members involved in keeping the libraries open and bringing awareness of the services available are the best moves library system. She stated the key to making the libraries successful is having librarians at the helm. She expressed that several years ago there were concerns about what was going on with the village libraries and the transferring of the village libraries to Mayors, she stated the concerns could have been addressed by hiring librarians, they are professionals and have the skills to manage a library.
- Vice Chairperson Yamashita, Ph.d. commented that she appreciated the nominee's remarks. The Vice Chairperson stated for the record that the employees of the library system are doing a good job with the limited resources and this must be emphasized over and over. The Vice Chairperson asked the nominee her role as an advisory board member for the developmentally disabled.
- Ms. Duenas replied that she is part of the Guam Legal Services Advisory Board. She stated the role of the advisory board is to assist with the marketing, promotion and community education programs for the developmentally disabled.
- Vice Chairperson Yamashita, Ph.d. thanked Ms. Duenas for her service on the advisory board. The Vice Chairperson stated that she hopes the nominee would ensure the policies, practices and programs for the developmentally disabled in our libraries are carried out. The Vice Chairperson stated for the record that the public library system has always opened their doors for us. The Vice Chairperson expressed that the library system has taught her son extremely well. The Vice Chairperson recommended that awareness needs to be raised that all people are welcome to the library. The Vice Chairperson thanked the nominee for her willingness to serve and she looks forward working with her.
- Senator Duenas complimented the nominee's background and testimony. The Senator asked how the library system can assist the FSM community.
- Ms. Duenas stated that her school (JQ San Miguel Elementary School) has a large number of Micronesian students. She stated that she was awarded a grant which provides free books to students for the past five years. She stated the free books provide students reading materials to practice with and gain the love for literacy. She pointed out it is important for them to have access to technology and reading materials, it is the goal to have them fluent, because they will be the leaders and economic workers in the future.
- Senator Duenas stated during his tenure as Director of the Department of Youth Affairs that the third of the population at DYA where from FSM decent. The Senator voiced that the greatest opportunity to rehabilitation is with the opening of the minds and education. The Senator stressed that after school programs at the libraries should be available now to help students with their homework and hopefully the long term goal of the library system being open during the evening hours will realize. The Senator thanked the nominee for her willingness to serve and he would be voting in the affirmative on her appointment.

- Senator Limitaco stated the nominee has a strong packet with impressive requisites in education and work experience. The Senator asked the nominee to share with the committee her business experience.
- Ms. Duenas stated that the job of a librarian is highly administrative which involves planning, budgeting, procurement, inventory and other business related skills. She stated that she owned several business on Guam, the Guam pet shop which provided government quarantine services and a collection agency.
- Senator Limitaco stated that the nominee having a business background would help the public library system operate efficiently. The Senator expressed it is refreshing to see in her testimony that she has a set of goals that she desires to accomplish. The Senator pointed out that appointees normally don't mention their goals they wish to accomplish when they testify before the legislature. The Senator asked what would be the main items she would be focusing on to accomplish these goals.
- -Ms. Duenas replied that she will focus on hiring librarian administrators. She explained that librarians are professionals and they have a set skills and knowledge. She stated the library employees are doing a fantastic job, but you don't want your accountant's secretary doing your taxes. She stated having librarians will be a huge step to accomplishing your goals. She also stated that marketing and promotion will be the next thing to look at, through that you can accomplish almost anything else. She stated that with limited funding the libraries have to be creative and partner up with local business and obtain grants.
- Senator Limitaco stated the nominee has the requisites and he is looking forward in supporting her nomination.
- Speaker Won Pat, Ed.D. noted for the record that letters of support were submitted. The Speaker asked the nominee with her experience in grant writing would she in writing grants for the library system.
- Ms. Duenas responded yes and she explained that there is a wealth of grants available.
- Speaker Won Pat, Ed. thanked the nominee for accepting the post as a member of the board.

There being no further questions or comments from the senators, Speaker Won Pat, Ed.D. concluded the public hearing for Ms. Debra Duenas to serve as a Member of the Guam Public Library System Board.

I arrived on Guam active duty Navy when I was only nineteen years old. I have spent my entire adult life here. I spent my wild youth here. I tried my hand at work and play here. I married and had children here, and they have now had children. My heart belongs to Guam.

I started with Business classes at UOG, but found Education classes more attractive after a few semesters. I tried it out as a substitute teacher and a school aide, before committing to the Yamashita Education Corp and becoming a secondary English teacher. While I love working with teenagers and have taught summers at the high school level for several years, circumstance landed me in the library early on in my career. It had originally been the backup plan, but I quickly found that I loved it. I have now been with J.Q. San Miguel Elementary School in Toto for twelve years.

Creating quality educational experiences that grow the future leaders of our community is our goal at GDOE. We encourage them to explore on their own, taking on that role of lifelong learner that makes a well-rounded and productive member of society. The libraries in the schools are an integral part of that process, but they are adequate in themselves. The Public Library System is a vital part of a productive community. For the children these learning experiences need to continue after school and on the weekends. And the rest of our community needs both enrichment and information as well. This is the role of the Public Library.

In addition to my work with J.Q. San Miguel, I have also taken on a leadership role within the school librarian's cohort, serving as the district wide school library coordinator for two years, as well as two years as a summer programs coordinator. I have had the opportunity to teach graduate level library science classes through PIP at UOG. I feel that giving back beyond your employment is important so I serve on an advisory board for the developmentally disabled and as a Girl Scout leader.

It is in this spirit that I applied to be on the Public Library System Board. It is the perfect combination of my education and expertise and my strong belief that we all need to work together to better the community. In this role I would like to see our public libraries grow and change with the times. So many good things seemed to have happened in this area lately and I would like to see them continue. In my role as a member of this Board there are some things I would like to address:

- The hiring of a Territorial Librarian and branch librarians for all of our facilities. These people should be qualified degreed people properly prepared to function in this capacity. While the staff currently working at the public libraries has done a great job, even they have expressed to me the desire to have a strong leader for their department.
- The expansion of literacy and public service programs. Current staff have several children's programs in place and have begun computer training for older patrons. It would be beneficial to have programs for teens and adults as well.
- Coordination with the expansion project to ensure the most beneficial outcome, for all stakeholders.
- Continuing to integrate new technologies. Once again, we have projects already
  developing that need to be nurtured, but new innovations are coming available rapidly.
  Not only understanding of current technology but its constructive use is a critical skill for
  our young people. Access to technology and instruction in technology should be
  available at the public library.
- Reinstatement of the McNaughton Lending Program.
- A greater focus on marketing and promotion. If you build it they will come is not always
  true. Like any goods or services we have to let the people know what is available.
  Libraries have wonderful cross promotional characteristics. They are also great venues
  for things that are not quite library activities or services but highly library related. All
  you need is a little creativity.
- Continued searching for grants and partnerships to help sustain this important resource in difficult economic times.

There is a lot of work to be done. These are just a few ideas. I am sure other candidates have further ideas and we can meld them together and create new and interesting things @The Library.




