

COMMITTEE REPORT DIGEST

I. OVERVIEW

The Committee on Public Safety, Infrastructure and Maritime Transportation convened a public hearing on June 6, 2014 at 4:00 pm in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Mr. James M. Casallo to serve as a Construction Industry Representative to the Guam Contractors License Board, whose appointment history is as follows:

- Appointed by Eddie Baza Calvo, Governor, on April 29, 2014;
- Appointment packet forwarded to *I Liheslatura* on May 1, 2014;
- Appointment packet forwarded to this committee for public consideration on May 1, 2014.

Public Notice Requirements

Notices were disseminated via email to all senators and all main media broadcasting outlets on Friday, May 30, 2014 (5-Day Notice), and again on Wednesday, June 2, 2014 (48-Hour Notice).

II. SUMMARY OF TESTIMONY AND DISCUSSION

Chairperson Ada called the hearing to order at 4pm.

*Note: Chairperson Ada heard the Executive Appointments of Mr. James Casallo and Ms. Adelia Custodio to the GCLB Board simultaneously. This summarized transcript reflects the hearing in its entirety as opposed to if the transcription reflected the appointments being heard separately.

Mr. Riley Ridgell

Contractors License Board Member

Oral Testimony

Mr. Ridgell stated that he cannot speak on behalf of the nominees as he just met them today. He then stated that the Board is in dire need of members, as they have not had a meeting in almost one year. He closed by stating that he is present to support the process and that he is hopeful that the individuals make it through the process and get confirmed.

Mr. Ed Ordonez
Executive Director
Oral Testimony

Mr. Ordonez stated that Mr. James Casallo was a civil engineer for public works and he now works in the private sector as a licensed electrician. He further stated that he thinks Mr. Casallo can do a very good job on the Board as he knows the construction industry and that he can also stand up for the consumer.

Mr. Ordonez then stated that Ms. Custodio served on the Board during the Camacho Administration as the Vice-Chairwoman. He further stated that she can support the agency for both consumers and contractors. He stated that there has been a time without a quorum and there are cases that need to be presented to the Board and he would appreciate the nominees being given the chance to join the Board.

Chairperson Ada asked that if the Board had not had a meeting for a year without a quorum, how many active members were on the Board.

Mr. Ridgell responded that during the previous year before the Board's hiatus, they would usually make a quorum with four or five. He further stated that Public Works always showed up because they were right there. At the time, there were three appointed members to the Board. Mr. Richard Quimbao was the Chairman and Mirian Pizzaro was the Vice-Chairwoman and they usually showed up along with Mr. Riley. He then stated that when there was a quorum, it was normally four people.

Chairperson Ada clarified that it took four votes for Board Action.

Mr. Ridgell responded in the affirmative and added that when it was four, it [the Board] had to be unanimous on anything.

Chairperson Ada asked that if the Board had not had a quorum in the last six months at least, then one of powers and duties of the Board was to grant licenses to Contractors, he asked if the Board granted the licenses.

Mr. Ridgell responded that they do not physically grant the licenses, he stated that when Senator Morrison was the executive officer, they shifted that to him.

Chairperson Ada stated that he is trying to get a sense of the urgency of the appointments given the Board is without Quorum.

Mr. Ridgell responded that he does not know what the backlog that requires Board action is. He stated that the current practice is the CLB will impose a fine or suspend a license and if it is challenged, then it goes to the Board and he does not know what that backlog is.

Chairperson Ada then asked Mr. Ordonez if he could comment to a backlog existing for Board action.

Mr. Ordonez stated that there are about three backlogs waiting for Board action. He further stated that they are minor contests for the Board and reiterated that there are three cases waiting for Board action.

Chairperson Ada asked to clarify, are they minor issues?

Mr. Ordonez stated, yes, they are minor and are not big issues.

Mr. Leo Macareg

Oral Testimony

Mr. Macareg stated that he was invited by Ms. Custodio to testify on her appointment to the Board. He stated the work of the Board is important to make sure that contractors are doing their work right. He then stated that he has known Ms. Custodio for over 40 years as a very responsible person and successful businesswoman. He then stated that although she does not have an engineering background, he would highly supports her appointment. He thanks the Chair for allowing him to testify and then stated that this is his first time testifying on any appointment in his many years on Guam. He closed by stating the he is in support of both Mr. Casallo and Ms. Custodio's appointment.

Mr. Armondo Dominguez

Resident

Oral Testimony

Mr. Dominguez stated that he is in support of Ms. Custodio. He stated that her appointment is important so the Board can function. He added that Ms. Custodio would be a qualified member of the Board and that she is qualified from her time under Governor Ada and personally as well as he does not know of any civil litigation or criminal action ever brought against her. He then urged the body to confirm her so she could add to the Board and continue in its duty to the people of Guam.

Chairperson Ada thanked Mr. Macareg and Mr. Dominguez for their testimony and invited Ms. Custodio and Mr. Casallo to provide opening statements.

Ms. Custodio thanked the Chairman and stated that in 2003 she served as Vice-Chairwoman for the Board and they invited her back.

Mr. Casallo stated that he was asked by Mr. Ordonez to be part of the Board because of the lack of quorum. He further stated that he agreed to help the Board and will be tasked to be part of the Construction Industry as a Board Member as he's been with the construction industry. He stated he worked for the Government of Guam for 17 years with GTA and then seven years with DPW. He clarified that he is a certified electrical engineer and that he also has a master's electrician license (he stated this to correct earlier statements made by Mr. Ordonez that he is a civil

engineer). He further stated that the purpose for him accepting is that he wants to help, as he knows what it is to be a consumer and what it is to be a contractor. He then stated that at the moment he is doing design work for contractors and regular citizens. He stated that he also knows how it is to work for the Government because he has been there. He closed by thanking the Chair and stated that he is hopeful that the body will support both he and Ms. Custodio's appointment to the Board.

Chairperson Ada asked Mr. Casallo if he is still a Registered Professional Engineer and a registered RME.

Mr. Casallo responded in the affirmative.

Chairperson Ada then asked if the two are current?

Mr. Casallo responded that as a professional electrical engineer, he is current. He then stated that as a professional RME, he used to be with a company out of Hawaii and was registered as an RME out of that company. He left the company in December 2013 and no longer has that license as he is doing home business with several clients at the moment.

Chairperson Ada asked what Mr. Casallo would do if a client of his comes before the Board because of some complaints or disciplinary action that may have to be adjudicated.

Mr. Casallo stated that he can't be biased, because he is part of the Board. He then stated that he is part of the Board and they would have to weigh what is happening and get clear evidence of who and what is right under the Rules, Regulations and Laws and that they would have abide by them accordingly.

Chairperson Ada stated that his question was more so toward whether or not Mr. Casallo felt he would have to recuse himself if the contractor before the Board was in some way a client of his? He asked if Mr. Casallo would consider recusing himself from that particular discussion and voting.

Mr. Casallo stated that would be the best thing and more than likely that would have to happen and he would let the Board know. He stated that he would let the Board decide whether or not he should be apart of that discussion and thus it would be dependent on the rest of the Board's decision on those particular cases.

Chairperson Ada clarified then that at the very minimum, for Mr. Casallo, full disclosure would be appropriate.

Mr. Casallo responded in the affirmative.

Chairperson Ada then asked Ms. Custodio if, having served on the Board before, because she is still active in the community, whether or not she has the time to serve on the Board?

Ms. Custodio stated that she is retired and that she can serve anytime.

Chairperson Ada stated that this is a four-year term appointment and luckily there is not much backlog so they do not anticipate too many long hours or many meetings so that is good to know.

Ms. Custodio added in closing that she is a Doctor in the Philippines, but she is not practicing on Guam.

Chairperson Ada stated he noted that in her packet and then closed the hearing stating that the Committee would try to get the appointments reported out for the next Session so the Board could have a quorum and go about its business.

With no further testimony, Chairperson Ada adjourned the Public Hearing at 4:25pm.
