I. OVERVIEW

The Committee on Municipal Affairs, Tourism, Housing and Hagåtña Restoration & Redevelopment Authority convened a public hearing on Tuesday, July 30, 2013 at 10:00 a.m. in I Liheslatura's Public Hearing Room in Hagåtña. Among the items on the Agenda was the consideration of the Appointment of Mr. John Ilao to serve as a Member of the Guam Housing and Urban Renewal Authority Board of Directors, and whose Appointment History is as follows:

- Appointed by I Maga'låhen Guåhan on June 6, 2013, to serve the unexpired term of Commissioner Ricardo Calvo from March 31, 2011 to March 30, 2016;
- Appointment packet forwarded to I Liheslaturan Guåhan on June 10, 2013;
- Appointment packet forwarded to this committee for public consideration on June 12, 2013.

II. INTRODUCTION, SUMMARY OF TESTIMONY & DISCUSSION

Vice Speaker Cruz: The Committee on Municipal Affairs, Tourism, Housing and Hagåtña Restoration and Redevelopment Authority is now called to order... it is now 10:00 a.m. Joining me here this morning are Senator Aline Yamashita, Senator Tommy Morrison, Senator Frank Aguon, Jr., and Senator Brant McCreadie. For the record and accordance to statutes all notices were sent out on Tuesday, July 23, 2013, which is five (5) working days prior and a second notice was sent out on Friday, July 26, 2013 which is forty-eight (48) hours prior. On the agenda this morning, we have three (3) items: The appointment of Mr. John Ilao, Member, Guam Housing & Urban Renewal Authority, Board of Directors for the unexpired term of Commissioner Ricardo Calvo from March 31, 2011 to March 30, 2016; Bill No. 145-32 (LS) introduced by Senator Aguon – "An act relative to naming the Malesso Pier Park; and Resolution No. 189-32 (COR). Let's begin with the appointment of Mr. Ilao. Mr. Chairman Sablan, please come forward.

Mr. David Sablan: Thank you very much Vice Speaker Cruz and Acting Committee Chair, as well as Senators Aguon, Morrison, Yamashita. Nice to see you all. I appreciate this opportunity to speak on behalf for the nominee of our board. As you all know, our former Vice Chairman passed away last December and we have been operating less than full capacity. So there has been times that we don't make the quorum, so the addition of Mr. Ilao to our Board, who is a prominent business man and a man of integrity, would certainly fill that void. We provide good discussion and debate that face GHURA. As you all know we have a major mission ahead of us and we have been tracking the number of housing units that we are building to make sure that as many qualified residents and people on our island to have qualified homes. I am here to support the nomination of Mr. Ilao to join our Board and provide that leadership and we look forward for his confirmation by this body. Thank you!

Vice Speaker Cruz: Thank you! Mr. Selvidge.

Mr. Roland Selvidge: Thank you Vice Speaker Cruz. For the record, my name is Roland Selvidge and I am the resident Commissioner for GHURA and I am here this morning to stand in support of Mr. Ilao's appointment and confirmation. I'd like to echo the words of our Chairman in terms of meeting a quorum. Hopefully this honorable body's speedy confirmation of Mr. Ilao, we won't have to worry about a silver bullet is coming our way and not meeting a quorum and therefore not meeting our obligations to the people of Guam. Although I do not know Mr. Ilao personally but I know of his professional accomplishments and I welcome that and I welcome him as our newest member to the Board and I look forward to working with him. Thank you Vice Speaker and we look forward to having Mr. Ilao on our Board hopefully when we start working on the budget.

Vice Speaker Cruz: Thank you Mr. Selvidge. Mr. Cameron.

Mr. Joseph Cameron: I do know the parents of John and I have a personal knowledge through my Auntie Madeleine Bordallo, back in 1987, as a matter of fact I think he was still in diapers at

the time. But nonetheless, he's grown up to be a fine gentleman. He has a long history of dedication to the people of Guam. He and his family have provided services to the people of Guam. I've seen his work ethics and I think that's very important. I think it's also important to not accept just any appointment to any board, but to have the tenacity to not miss any of them. I want to say for the record, that he's a fine man and I know him personally. So I can bring to the table a fine man that I can support for a speedy confirmation.

Vice Speaker Cruz: Thank you very much Mr. Cameron. Mr. Ilao.

Mr. John Ilao: Good morning Mr. Chairman and Senators. My name is John Ilao and for the record, I am no longer wearing pampers. On a serious note, my day job, I am the current Vice President of JMI Edison and Aeronet Solutions and CEO of MR Imaging Group and current Vice President of ER Ilao and Associates because my brother decided to give me 1% of his engineering company. My education: I graduated from FD in 1985, bachelors from UOG and MBA from Loina Linda University. Govguam experience I was with Joseph on the DISID Board, which was back during former Governor Gutierrez. A member of Department of Labor Board as well as the ABC Board, which was famous for the past eight years. I feel it's time for me to move on. My day job is actually on health care. Health care and housing really mesh well. I was actually elated that the Governor appointed me to the GHURA board. That's the short and sweet summary of my education and govguam experience. Please let me know if you have any questions.

Vice Speaker Cruz: You left one part out and we'd like to thank you for your service in the military.

Mr. John Ilao: Oh, thank you!

Senator Yamashita: Thank you Mr. Vice Speaker and welcome everyone to your legislature. Mr. Ilao, thank you very much for your continuous willingness to serve the community. Folks like you that are willing to step up and carve out time from your busy schedule it really does make a difference. I appreciate your statement about health care being a critical component of a housing community. I hope that as you determine policy, deliberate decisions and as you carry out decisions, that you always ensure the communities are as integrated as possible. Which means that all families are given the opportunity to realize their potential and to specially give those with disabilities, those of us who are older, those of us who might need a hand up, are always reflected in what decisions that you are rendering. GHURA has always been a champion for many of us that need than hand up. I hope that those policies will continue to reflect those of us in the community who need that. Furthermore, I hope that we look towards programming in the communities, as you deliberate and improve programming that would

help these young families know how to parent. I really believe that the social fray that we are experiencing in our island is a direct correlation of lack early childhood education on our island. I want you to know that I support you and look forward to working with you. Thank you Mr. Vice Speaker.

Vice Speaker Cruz: Thank you Dr. Yamashita. Senator Morrison.

Senator Tommy Morrison: Thank you Vice Speaker. Congratulations Mr. Ilao, I don't know you personally, but I really appreciate about a year ago when you took some time out to discuss some ideas to discuss your ideas for the island. I'd like to thank you for all your past contributions as well as your military service too. You have my full support. I appreciate the quality members coming before us to continue the fine work at GHURA. Thank you to the panel for providing testimony in support of Mr. Ilao. Thank you Mr. Chairman.

Senator Frank Aguon, Jr.: Thank you Mr. Chairman and good morning Mr. llao. Thank you to everyone that provided testimony in support of Mr. Ilao. When I look at candidates who are nominated for a particular position, it's obviously looking at the level of expertise and what they can bring to the table. Your resume is certainly apropos for a position such as this because not only is the Guam Housing & Urban Renewal Authority providing housing to the community they provide support. One of the things that I was very pleased with recently, especially with the result of sequestration, was that the board had made decisions that would have minimized any negative implications on people who are presently benefitting from the program. I wanted to publicly make that statement because I think that was a very good move on your part to try to minimize any hit on our families that benefit from your services that you provide. Mr. Ilao, also in conjunction with what qualities that individuals bring to the table is the attendance and time commitment. There's one aspect that always sticks with me is that I've always seen you as a family man. When I come across you, you're always with a family member or with your loved one. This also extends to personal life and then to your professional life. I look forward to working with you and being active on this board with active attendance. Let me just close with this, about 3 years ago, GHURA provided vouchers for our veterans in the number of about 9. That has certainly increased to about 30. And we are in the process of pursuing an additional 30 because of the recent survey, it shows that there are 30 plus homeless veterans on our island. I ask you as a member that will be sitting that on this board that you consider that and push forward to try to increase the number of accommodations for our veterans. Hopefully we could address the homelessness of our veterans which is critical to our island community. You have my support and you have my vote and I wish you the best. Thank you Mr. Chair.

Vice Speaker Cruz: Thank you. Senator McCreadie.

Senator Brant McCreadie: Thank you Mr. Chairman. I guess going last you can't really say much more, but I absolutely agree with what was said here. I congratulate you on your appointment through 2016 and you have a very strong and capable Board of Directors. I thank you for your service to our country and our island. I agree with Senator Morrison's comments that the people that have been coming before us have been proactive and intelligent individuals in this community. I congratulate you! I echo Senator Aguon's sentiments with reference to our veterans. Hopefully we can bridge that gap for our veterans. Congratulations again and you have my full support and what has been said this morning is pretty much what needs to be said. Congratulations again and I look forward to your appointment and you serving the island.

Vice Speaker Cruz: That was an early eulogy for your state funeral, I thought it was over. (laughing) It is important and I really am glad that you have this health background. As Dr. Yamashita mentioned there is a need to make sure that the homeless have behavioral and physical illnesses addressed. At some point, I invite your entire board to come to our building in the evening, because the number of homeless people that hang out in the back is really just disconcerting. Senator Muna Barnes last week, ran into a homeless person and was concerned about all the sores he had on his body and he showed her the medication that he had for his leprosy. We really need to do more about trying to address our homeless population and most especially our homeless population that suffer from physical illnesses and behavioral issues. The men and women who serve our country are now out there homeless. You have quite a challenge and fortunately with the many hats that you've had since you came out of your diapers ten years ago. You have a lot of work ahead of you and you have an excellent board and a great department. You have a good group that you're working for. I wish you could have on this and the ABC so that we could have a quorum there too, but I guess they decided to remove you there. I will talk to the Chairman to make sure that this confirmation is attended to before we go back into session in a couple of weeks. The appointment of Mr. John Ilao has been duly heard by this committee with the recommendation to confirm. Thank you!




