

## COMMITTEE REPORT DIGEST

### I. OVERVIEW

The Committee on Education, Public Library and Women's Affairs convened a public hearing on April 1, 2014 at 5:30 pm in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Mr. Kenneth P. Chargualaf to serve as a Member to the Guam Education Board, Retired School Administrator, the appointment history as follows:

- Appointed by the Governor of Guam on March 10, 2014, term to expire for a term of Three (3) years
- Appointment packet forwarded to *I Liheslatura* on March 10, 2014; and
- Appointment packet forwarded to the Committee for public consideration on March 11, 2014.

### Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on March 25, 2014, (5-Day Notice) and March 29 and 30, 2014 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

## **II. SUMMARY AND TESTIMONY**

- **Speaker Won Pat, Ed.D.** announced the agenda of the public hearing – one of which was the nomination of the appointment of Mr. Kenneth P. Chargualaf, as member of the Guam Education Board
- **Speaker Won Pat, Ed.D.** asked the following individuals to come forward to testify: Beverly San Agustin, Ray S. Topasna, Jim Reyes and Dexter Fullo
- **Beverly San Agustin** endorsed the nomination of Kenneth P. Chargualaf. Her written testimony is appended to the committee report.
- **Mr. Topasna**, special assistant to Gov. Calvo, and vouching as a personal. His written testimony is appended to the committee report.
- **Mr. Reyes**, in support of the nominee. His written testimony is appended to the committee report.
- **Mr. Fullo**; Principal, Benavente Middle School testified in favor of Kenneth P. Chagualaf’s nomination. His written testimony is appended to the committee report.
- **Senator Respicio** inquired about the account in which Kenneth P. Chagualaf will provide as a member of the board, and to what faction of stakeholders; is he to serve the perspective of the educational administrators, as a member of the Board of Education, or serve in the capacity and perspective as a representative of the Governor.
- **Ms. San Agustin** expressed that as an educator, Kenneth P. Chargualaf represents all the stakeholders, and can indeed serve as the intermediary between the different functions/board representatives, as a diplomatic, who is dedicated above all to the students.
- **Mr. Topasna** stated that he is confident that Chargualaf’s appointment to the board is not to serve as a puppet to the Governor.
- **Senator Respicio** asserts, he was not suggesting that.
- **Mr. Topasna** explained there was a vetting process, through which Chargualaf was chosen out of a couple of candidates; he was chosen based on his background and expertise.
- **Senator Respicio** asked if the vetting process included a survey of the school administrators.
- **Mr. Topasna**, stated he was not privy and referred the Senator’s question to special assistant for education, Vince Leon Guerrero.
- **Mr. Reyes**, stated he doesn’t think that Mr. Chargualaf would put administrators before teachers, even before children. He’s always put in mind children if it doesn’t benefit children than it’s not worth considering.

- **Mr. Fullo** expressed that Mr. Chargualaf has always been about the students and making sure we, as educators, meet our mission; where, in the case that we don't, have a critical reflection of what we need to do to improve.

- **Senator Respicio** made it clear that is trying to generate discussion because for those who ran for the board of education, in their elected capacity, they bring with them what they would like to see in support of the department of education system. He refers that we are about to hear from the parents, Parent Teacher Organization (PTO). He is interested to see if they were consulted or who their nominees might have been, as it is important to have a Parent advocate on the board and who ultimately share the same mission, for the children. Senator Respicio ends by expressing: he wants to know why the administrators and PTO were not consulted.

- **Vice Chairperson Yamashita, Ph.D.** thanked Mr. Chargualaf for the many different ways that he has given.

- **Speaker Won Pat, Ed.D.** calls the next set of individuals to testify : Lourdes San Nicholas, Mr. Peter Ada, Elizabeth Diego, and Dr. Jose Cruz.

- **Ms. San Nicholas** stated that she has known the nominee for 35 years and she supports Mr. Chargualaf's new role as a policy maker. She begins by certifying that Mr. Chargualaf has served in various capacities within the education system; he was teacher for Agueda Johnston, then a principal. She confirms that they served in many different committees together, in which they were asked or appointed. As acting associate superintendent secondary, she tells of how she witnessed his passion as a leader. She continues to mention that Chargualaf demands and sets high expectations, while still remaining accessible to provide help and support. She furthers this comment by expressing that his drive and expectation of principals – however rigid – motivated a high standard and produced progress. She also tells of Mr. Chargualaf as an advocate to implement the freshman academy – a research program and national association of school principals – as well as an Advocate for a program for high school senior advanced placement enrollment, which prove to be a great partnership between UOG and DOE. San Nicholas ends by reaffirming Mr. Chargualaf's commitment to education and students , and that he will continue to do what is best for the students of Guam even in this new role..

- **Mr. Ada** stated he supports both Charlene Conception and Mr. Chargualaf. He stated when he was a former teacher; George Washington H.S. he witnessed Chargualaf's leadership as Principal and Superintendent of Education. He conveyed that Chargualaf was very accessible whenever issues arose, especially regarding secondary education. He affirmed that Chargualaf is experienced and passionate; rather than a man who will represent one sole perspective, or entity, he is a man or himself and is committed to the well-being and success of the student. He ends with attesting that Charlene Conception's nomination in conjunction; elaborating the significance and voice of the parents.

-**Ms. Diego** testified in support of Chargualaf's appointment. Her written testimony is appended to the committee report.

- **Dr. Cruz**, chair of the board of education testified that the Chargualaf is one who gets involved, and completes assignments well, He stated that Chargualaf with the description that he challenges. Dr. Cruz gave an example how Chargualaf challenged the accreditation team of Inarahan Middle School, having



disagreed with their judgment of the school. Thus, he challenges; both locally and nationally. On the theme of challenges, Dr. Cruz asked Chargualaf – to unify, collaborate and cooperate – in this new potential capacity as GBE member. Furthermore, Dr. Cruz challenges Chargualaf to work with everyone, sensitively viewing everyone’s input as significant.

- **Speaker Won Pat, Ed.D.** calls Darlene Stremmelaer and Debbie Quinata to testify

- **Ms. Stremmelaer**, Teacher; Southern High School testified in support of the nominee. Her written testimony is appended to the committee report.

- **Mrs. Quinata** stated that she is a mother of six – who’s eldest underwent the guidance of the nominee, Chargualaf, and two of which are educators – testified in support of the nominee. She attested to Chargualaf’s many contributions to our youth community. She also attested to Charlene Conception’s nomination, who is an utmost extraordinary mother who can serve to represent this niche as well. Quinata ends by articulating that we would all be lucky, and benefit, to have both serve on the Board for a better system of Education.

- **Speaker Won Pat, Ed.D.** announced that written testimonies were submitted by Gregorio C. Sablan and Asherde Duenas Rosete. The Speaker asked the nominee to testify before the committee.

- **Mr. Chargualaf** testified before the committee. His written testimony is appended to the committee report.

- **Speaker Won Pat, Ed.D.** opens the discussion to the committee.

- **Vice Chairperson Yamashita, Ph.D.** conveyed that Mr. Chargualaf’s perspective shall drive policy to get our system to where it needs to get. Senator Yamashita asked to always consider those students with disabilities, who need help, and whose consideration and accommodation lies in teacher evaluation and professional development. She ended by expressing, she hopes that everyone will be included in what needs to happen in order to realize collective and individual potential. And comments, it was great to have teacher’s testify, as Mr. Chargualaf’s reputation and often doesn’t include favorable teacher impressions.

- **Senator Ada** stated that he looks forward to voting on Mr. Chargualaf’s confirmation, and that is says a lot that Mr. Chargualaf would like to put more time into the educational system after years of continual service.

- **Senator Respecio** asked, how did the vetting processed occur, and if administrators had any input. He makes the point that the make-up of the Board is a particular, significant dynamic. He further recognizes how hard the superintendant works and what he has inherited within the position. Lastly, Senator Respecio inquires about Chargualaf’s mention GEB’s role in the grand scheme of GDOE management. He asks if this means that Chargualaf has essentially resolved the policy versus operations dichotomy, as the board has fundamentally created some tension between staff, management and board members.

- **Mr. Chargualaf** replied that he has a copy of the statute that governs the Guam department of education, that has read his roll and the roll of the superintendent; day to day operations fall under the Superintendent while his role is categorically listed in his job function and as member of the board.

- **Senator Respicio** asked if the board should get involved in personnel issues and grievance procedures.
- **Mr. Chargualaf** replied no.
- **Senator Respicio** asked if the board should can get involved in federal grants
- **Mr. Chargualaf** replied; the Board is involved in the federal grants.
- **Senator Respicio** inquired, to what extent, then, if the Board is involved in federal grants.
- **Mr. Chargualaf** replied that he isn't quite sure but according to statute, the Board has governance over federal programs.
- **Senator Respicio** explained that if the situation exists where the federal grants administrator has judiciary responsibility, as well as the superintendent, then, Senator Respicio asked, how are judiciary responsibilities to be defined, or reconciled.
- **Mr. Chargualaf** replied that he'd like to consult the other board members about this and, of course, ask the superintendent to brief him on this subject.
- **Senator Respicio** asked, should the board get involved on how and who these grants are being awarded to.
- **Mr. Chargualaf** countered that he doesn't know.
- **Senator Respicio** stated that these are the kinds of circumstances involving amid Guam Department of Education administrations versus the individual role which each board of education member plays. The Senator further elaborted, with so many variations within the Guam education board to respond to the needs of the system.
- **Mr. Chargualaf** assured that he is working very closely on federal programs while at the district office, with the board, which is his understanding and extent, to review the provisions noted but in consultation with superintendent and school principal. In response to Senator Respicio's inquiry on federal programs, Chargualaf replies that he needs to consult: how to best approach specific issues.
- **Senator Respicio** asked Chargualaf how he feels going into the public school system as a potential board member rather than, as he was, an administrator.
- **Mr. Chargualaf** replied that the students will always be who his mission is centered upon, and that is where he is going to continue to provide.
- **Senator Respicio** responded that if it means taking position to release the allotment reserve in order for DOE to make pay roll or reconcile how much is being owed to DOE, how can Chargualaf now capacitate and advocate for such things. He concludes, Chargualaf has been a part of the ever-changing system, and the importance of responding to the give structure.
- **Senator Aguon** asked "tao tao manu hao," or where he is from.
- **Mr. Chargualaf** replied tao tao Yona... Inalahan.

- **Senator Aguon** thanked Chargualaf for remaining in the education arena. The Senator stated that the nominee is an educator by heart, Chargualaf is the sort of character needed on the Board, professed by Senator Agoun, and that he has his vote.

- **Speaker Won Pat, Ed.D** professed that Chargualaf has a strong personality as an educator and an administrator and thus must work with himself to be able to work with the Board. The Speaker stated the Board is designed to be a policy board, though rendered operational, she expresses that she would like to see it still as a policy board. The Speaker stated that the question of federal programs posed by Senator Respicio was one that essentially caused a change in Board policy and expresses that she is glad that he will seek legal council, and clarification on this subject. Speaker refers to Chargualaf's commitment to work with the board to improve student achievement (referencing page two of his testimony), and asks, if there are any policies that the board needs to consider to ensure student success.

- **Mr. Chargualaf** responded that the focus is student achievement. And, as far as policy, refers to the statute regarding bullying and other measures that seek to provide clear guidance and a safe school environment. He expresses that he would like to continue to support policies such as this and work closely with schools, as a board member.

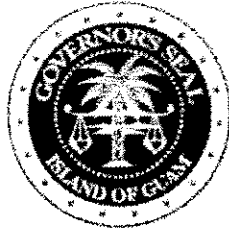
- **Speaker Won Pat, Ed.D** inquired of Chargualaf's position on the principal performance contract.

- **Mr. Chargualaf** responded that he is a strong believer and advocate.

- **Speaker Won Pat, Ed.D.** stated that there is no further questions for the nominee. The Speaker concluded the public hearing of the nomination of Mr. Kenneth Chargualaf.

To the Honorable Judith T. Won Pat, Ed. D.,

My name is Dexter Fullo and I'm currently the Principal of Benavente Middle School in Dededo. I have been a principal at the school for the last four years, and prior to that I was an assistant Principal for six years at Both Benavente Middle School and Untalan Middle School dealing in the areas of both student personnel and curriculum. I have a background and direct connection with Learning Forward because my school was selected, participated, and completed the Learning School Alliance. One of their tenets is the belief that student learning is possible only if adult learning happens in the school/organization. Because of my experience from Learning Forward, I am one of the principals charged with designing the administrator leadership academy that builds that capacity of our school leaders so we may empower our teachers and positively impact student achievement.

I have known Mr. Chargualaf when I first became an Assistant Principal in 2004, serving under his leadership as the Associate Supt of Secondary schools. I then worked with him as a secondary school Principal colleague from 2010-2013. During that time, Mr. Chargualaf was a member of the design team, and his advice and guidance was invaluable in ensuring we move the Department forward. I come before you to testify in favor of his appointment specifically for the following reasons:

- 1) To act as a liaison between educators and the board
- 2) To initiate or support policies and practices that will ensure the successful full implementation of the Common Core standards, adherence to the standards, and flexibility and autonomy for teachers to do what they must to achieve to the standards. This will include support for autonomy within school communities on how best to teach and what should be done within school and classroom settings

Currently, the Department of Education is at an exciting moment with the implementation of the Common Core State Standards. Unlike prior implementation of the standards, the district office has done an exemplary job of being intentional and deliberate with both the awareness and the implementation of the CCSS. Teacher cadres from every DOE school has been given trainings with the standards as well as the process needed in an effort to ensure the trainings make its way where it matters most-the classrooms.

As educators, we all know common core success will depend, first and foremost, on the instructional shift that is required by our classroom teachers. With a higher student expectation than ever before due to the rigor, it is important that our leaders understand, at a very deep level, the change process. It must not only be limited to the structural level, such as providing time for collaboration and using technology, but more importantly, at a cultural level. For example, providing more time to collaborate will not necessarily lead to increasing student scores unless the team members value interdependence, use student data they developed as a team, and believe that all their students can succeed if exposed to a variety of instructional strategies and provided additional support. As Robert Marzano and Rick Dufour, two great educators of our time state, "School Improvement equals People Improvement." We must change the mindset (cultural) of our educators if there is any chance of ensuring we meet our vision of preparing ALL students for life. This is where adult learning, at its deepest level, comes into play.

The difference between structural change and cultural change may seem minute to non-educators, but those of us who have the privilege of shaping our island's future know intuitively this makes all the difference in our students' lives. We have all known certain teachers who can turn around any student, regardless of the issues they encounter. Parents and students line up at the Principal's office to try and get their students into this class because they know that by the end of the day, their child will a better child and will leave the school year prepared and ready to learn. All our schools have



these superstar teachers. I have encountered many of these teachers and what I find they all share in common is the belief that their students can learn, their self-efficacy as a skillful teacher and perseverance to impact their students, and the unwavering commitment to life-long learning for both adults and students. Unfortunately, many leaders settle for these teachers to be the exception in the school setting rather than the rule. The success of the students is based on the lottery of who their teachers are. A school leader will set the right conditions so ALL adult learning and improvement is the norm and expectation.

This is where Mr. Chargualaf excels. Whether you "love him or hate him," one cannot deny his ability as a leader to impact students by challenging the cultural values and mores of the school. He has both the craft knowledge of how to ensure effective operations of the school (structural) and also the instructional leadership to have educators examine their values and ensure it is in the best interest of the student (cultural). I experienced this first hand when I transfer to UMS as an Assistant Principal and I noticed how teachers in the same content taught the same skills. Although that may seem minute, it's not the norm, as many educators use the idea of academic freedom to teach whatever they want, or use the textbook as their curriculum. At the end of the quarter, each teacher completes a skills assessment and accountability form that identifies student strength and weaknesses. It took many school a decade later to implement these concepts that we know works.

I have engaged in challenging and, often times, realistically painful, conversations about the reality of my school and my successes and failures as a leader. Fierce conversations, although avoided by many leaders but totally necessary for student improvements, become the norm when in the presence of Mr. Chargualaf. Although we both agreed that funding is an issue and our educators are highly underpaid, he does not use that as an excuse for our current reality. He understands that there are many areas of improvement in our department. However, he knows that our focus must be on areas that will have the biggest impact on student achievement: Ensuring a guaranteed and viable curriculum, Improving instructional quality in the classrooms, the frequent and strategic use of common formative assessments, a change in our dispositions regarding student learning, using data in our collaborative process (professional learning communities) to improve our skills as educators, and our passion to do whatever it takes to ensure all kids learn. Many of these do not require extra funding, but they do require a fundamental shift in how we do things. These cultural changes are what will help with our educational system and ultimately improve the quality of life in our island.


Mr. Chargualaf has the credibility from our colleagues because he knows and understands our culture at schools and as a department-both its strength and the areas where we need improvement. Moreover, he not only speaks from logic and common sense, he speaks from best practices and research from the latest literature. As a board member, he will ensure the focus is on supporting the schools and doing the things that matter. He has proven himself as a school leader and any school leader today can testify how he has transformed cultures. Good Evening, my name is Elizabeth Paulino Diego, a former educator with the Guam Public System and currently an administrator with the Guam Community College.

I can only speak of my professional experience with Kenneth Chargualaf many years ago when he was first assigned at the school I spent eleven years at. Egotistical, Unreasonable, and a Slave-driver were the most common descriptions I heard that summer prior to his start about him. I was disheartened because my school had lacked the kind of leadership necessary for many years and I immediately concluded, Ken was going to be another mediocre administrator with the usual controlling and authoritative style. As a consequence of this initial perception of him, I had decided I was going to be a minimalist confining myself to the classroom and not volunteering for additional roles in the school. It took Ken two months to convince me otherwise.

If I were to share all the experiences of what Ken has taught me as an educator, we would be here for a number of hours. It would have to suffice in this encapsulation of what I call the three ps of which has become the foundation of my leadership philosophy to illustrate what I learned of the difference between management and leadership as I experienced it directly with Ken. Each serves as a very important developmental point for the other and require the active practice of the other for you to be an effective leader.

The first is personhood. Each of us is born with unique talents and abilities and the propensity to develop what we have been given. It is up to each of us to build ourselves to the greatest capacity not for self-serving interests but for the benefit of others. Initially I learned much about Ken through my observations of him in his interactions with others. Ken was driven, concentrated his attention on improving the school physically, academically, and socially and he did so with unsurpassed passion and energy. Ken had high expectations of himself and he modeled this in so many aspects and more importantly was consistent in doing so. Some simple examples: He wanted us to look professional in our appearance and bring the respect to the profession by doing so. He modeled this. He expected us to be prompt to work and he modeled this by being one of the earliest employees arriving after the custodian responsible for unlocking the gates. Ken moreover was informed by the latest research and applied his education and training in his leadership role. He was industrious so naturally he expected everyone else to be that way. He expected quality work and didn't settle for second best. He was a perfectionist and it showed in ways such as an exceptionally clean and well-kept campus to pointing out the slightest errors on a report. He was extremely adept at recognizing and utilizing the abilities of others for the benefit of the school.

The second is purpose. Ken inherited an organization that didn't have direction, a staff with low morale, and a culture of apathy. Our school was perceived as the dumping ground and a step child in the school system. Most administrators in the past accepted the status quo and were unsuccessful in transforming the school to a level that it deserved to be. Ken provided the vision and a clear sense of direction and ultimately, people began to buy into the purpose of why our organization existed. He did so by having us focus on the primary task at hand which was to examine the quality of the teaching and learning that took place within the walls of our school. You would be hard pressed to ignore all the activity going on at the school. We began to have more conversations, professional development, and

initiatives that encouraged us to focus on the greater purpose. You could feel the energy and the renewed sense of hope and excitement on campus. Cynicism began to fall away and more and more people were coming out of the woodwork and participating in committees, volunteering to stay after school and coming in during the weekends. The most interesting aspect of this, was that Ken was collaborative and inclusive.

The last of the ps is people. For our school, this was perhaps the best work that he did. People were intimidated by Ken first because of the horror stories they had heard of him irrespective of the accuracy of the information. It didn't take people long to conclude this was a gross misperception on him. Through his actions and behavior Ken showed his heart was in the right place and that he cared about people. First, he cared about the students and the kind of education students were receiving. We learned to utilize research to inform us about the improvements that were necessary. He had us focusing on the teaching and learning and how great teaching would translate into great learning. He was out in the hallways on a regular basis talking with students, the staff, and he regularly visited classrooms and made his presence known. He invited and encouraged input from everyone and respected the institutional experience of individuals. He empowered others by giving them opportunities to innovate, experiment with ideas, and to assume leadership roles.

In the two short years at that school, Ken proved to be an exceptional leader and gained my utmost respect and admiration for the kind of leader he was. I can say this was the case with a vast majority of the former colleagues I worked with whether they were custodians, fellow teachers, or school aides.

I had the opportunity during my doctoral studies to analyze many models of leadership and their impact on organizations. I wrote about Ken in a number of my papers simply because he stood out as a leader. As I learned about formal names and terms associated with various leadership styles, I discovered that Ken had already been applying many of the qualities and practicing the kind of leadership style organizations are in dire need of today.

In one of my papers, I wrote about those first descriptions of him as egotistical, unreasonable, and a slave-driver and in my reflection and exposure to leadership concepts how those words took on a completely different meaning for me. I concluded that he is egotistical but in the sense that he had uncompromising confidence that he was going to succeed in the task at hand and expected everyone within the organization felt the same. He was unreasonable in the sense that he expected everyone to be on their toes and to put out full effort in providing quality education and the best support system for the students whom we served. And yes, he was a slave-driver. He demanded you put in the work required. Those who were lazy and mediocre in their performance suffered because he put fire under their feet and it was quite obvious if you weren't a team player because he demanded this of everyone. No one escaped the high expectations he set for the organization.

I was away from the island for almost a dozen years and recently came home. But while away, I still kept in touch and learned Ken remained the same. Schools he had been assigned to became achieving schools. I still hear the passion in his voice, he is still driven, he is still a slave-driver, he still has the leadership skills and experience and energy that are needed to transform an organization. But more

importantly, he has proven himself. I am elated about his appointment because there is still much work to be done and I can't think of a better person more qualified. It is quite an honor to come before you for an individual for whom it was a privilege to work with. I hope my testimony will be considered in your confirmation of him as a member of the Education Board. Thank you for the opportunity.

DALLENE

I can't remember a time when Mr. Kenneth Chargualaf has not been a part of my educational life and my professional life.

I graduated from Oceanview High School in 1990. I remember like it was yesterday going to all the essay contests I could join. The sports activities always had 100 or more kids in attendance but at the essay contests, the crowd usually consisted of my Mom and Dad, 3 or 4 contestants, the judges and Mr. Ken Chargualaf. As a young student you remember the people that inspired you to do more for yourself. He is one of those people. I'll never forget him, following me to the parking lot after an essay contest, I thought to myself, why is the Principal following me, the contest is over, but he came after me just to tell me that I did great and he was going to let the whole school know how great I did. That meant so much to me and to this day, I make it a point to always find something true and great to say to my students on an individual basis so that they understand just how unique they are to me and to the world.

When it came to college I attended the University of Guam with a Bachelor's in Secondary Education with an emphasis in English. I had the opportunity to teach at JFK, GW or Sanchez High School because there were plenty of openings at the time I graduated from college. I received a call at least a month before the opening of the new school year from Mr. Chargualaf, congratulating me and letting me know that he has not forgotten me and if I could go to Inarajan High School to teach English. It was a tough decision because I had my mind set on teaching at GW.

Mr. Chargualaf convinced me to teach at Inarajan because he said that he would support me and be there for me and that I could always go to him for whatever reason. There were two other graduates from Oceanview that followed me. He told all of us the same thing. As a new teacher I was struggling to learn the ropes because as all educators know, going to school to learn how to teach is something different than actually having your own class to teach. I thought I was going to quit my first week of school but Mr. Chargualaf kept his promise, he was there for me, he introduced me to people who I could learn from because he knew what I needed. The other two teachers who started with me are also still thriving teaching professionals. From that point on I realized that I was not just one



teacher trying to make a difference, but I was part of a team that could make a difference. What a gift Mr. Chargualaf gave to me.

There he was again further into my adult professional life, still making a difference, still inspiring me to do more. Even when we parted ways because Inarajan High School closed and Southern High was born, I was still in touch with Mr. Chargualaf and several times asked for his advice. I went ahead and got my Master's in Educational Leadership from University of Portland. He was one of the people that wrote me a recommendation letter. It wasn't just a recommendation letter, it was a testimony to who I was. I was a person who loved to teach and learn. He understood this. He understood what it meant to support the students and to support the teachers and he understood what it meant to ensure that everyone worked together. When he was Principal of Inarajan High School I saw what he did to make us work together. It wasn't leadership from the top down, it was leadership from the whole school. Even the janitors were part of the accreditation process. It was a remarkable time. He is a remarkable leader and a remarkable role model.

I don't know what is on his resume list but I do know that this moment is not on his resume. Southern was going through rough patches when it first opened from all of the rioting and kids adjusting to each other, I remember a riot broke out and Mr. Chargualaf was there on campus to help supervise. One student got so crazy he was going to hit Mr. Chargualaf with a piece of wood and Mr. Chargualaf looked at him and without yelling, he just said, "Boy look at what you are doing, put it down, help me stop this, help me to stop someone from getting hurt." The boy stopped and things calmed down through the help of other school staff. If I recall correctly the boy even apologized. I thought to myself, this is the kind of leader I want my kids to have on their side. This is the kind of person that I want to go to when I need help.

I am now a parent of two beautiful children. I want there to be a leader who will cheer my kids on, who will be part of the governing body that makes policies that make things better for my children. I want this person to represent me and listen to me and my colleagues. We need someone who has worked with teachers and understands what it means to be a teacher. He has been around long enough to know that you don't stop learning and you don't stop sharing your talents and

skills. I am so proud and honored to be here today and to say that I have been an educator for 16 years and I'm still in it because I have had great leaders in my life who have inspired me to keep going because we love what we do and we love the people we do it for.

To be able to call Mr. Ken Chargualaf my Principal, my Boss, my Mentor and my friend is something so special because he is still going strong. Shouldn't we get someone on the Board of Education who has been there, who has been a part of all aspects of educational life to work with the existing members and to share his knowledge, his talent and to work for all of us. I think for the sake of education on Guam, for the sake of our children and for the sake of the teaching profession he should be on the board of education. Thank you for your time.

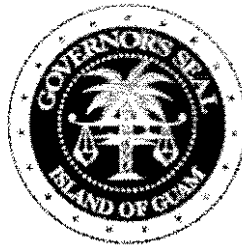

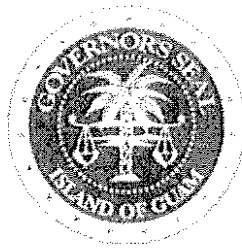


