COMMITTEE REPORT DIGEST

I. OVERVIEW

The appointment of **Kristal K. Koga** to serve as Member of the Guam Council on the Arts and Humanities Agency was executed by Governor Edward J.B. Calvo on May 22, 2014. The appointment packet was received by the Office of Speaker Judith T. Won Pat on May 22, 2014, and the appointment was subsequently referred to the Committee on General Government Operations and Cultural Affairs on May 23, 2014.

The Committee on General Government Operations and Cultural Affairs convened a Confirmation Hearing on Tuesday, June 3, 2014, at 6:00PM in the Guam Legislature Public Hearing Room. The single item on the agenda was the appointment of Kristal K. Koga to serve as Member of the Guam Council on the Arts and Humanities Agency.

The Confirmation Hearing for the appointment of Kristal K. Koga began at 6:01PM and ended at 6:14PM.

II. TESTIMONY & DISCUSSION

Vice Speaker Benjamin J.F. Cruz: This evening we have one executive appointment of Kristal K. Koga to serve as Member of the Guam Council on the Arts and Humanities Agency (CAHA). I think I know you quite well. I received at least a dozen emails of testimonies in supports of your confirmation. So why don't we just start and have a fellow going-to-be board member go ahead and introduce you and hear your testimony.

Donna Kloppenburg: Okay, good evening senators. I'm Donna Kloppenburg and I'm also a current member of the Guam CAHA Board. I'm the most recent member and I'm very happy to be here this evening to support Kristal Koga's nomination to serve on the board of CAHA. I've known Kristal for probably about almost twenty (20) years now. We worked together on many different fundraising activities through the Guam Council of Women's Club, Soroptimist, worked on some things for the American Cancer Society. And I know her to be a very hard worker, very talented, and she will be a wonderful addition to our CAHA Board as we move forward in helping to plan our Festival of Pacific Arts (FestPac), which is coming up soon, and we really need her help.

Chairman Cruz: Please, We need a fundraising chair.

Mrs. Kloppenburg: Yes, I heard that. I did hear that. She's an excellent fundraiser. So I'm very happy to be here on behalf of the CAHA Board and say that we hope she gets to work quickly on the Board. I know she'll be a wonderful addition.

Chairman Cruz: Yes, after reading all the glowing letters of recommendation that I've received through e-mail over the last week and a half, I'm sure she will. Ms. Koga, if you would just introduce yourself and read your testimony.

Kristal Koga: Well, my name is Kristal Koga. I'm born and raised in Honolulu, Hawaii. And I graduated from Kalani High School. I then received my B.S. in Liberal Studies, Cum Laude, from Oregon State University. I have been on Guam for over two decades,

have run my business called Kristal Kollection, which retails women's contemporary wear, unique accessories, men's exclusive printed island wear shirts, and specialized uniforms. We do many benefit fashion shows for the non-profits and large entities, such as the hospital in Palau — we were flown there and we did a fundraiser for them — as well as in Honolulu for the Kuakini Geriatric Hospital. I have been involved with nonprofits since 1997 when I was inducted into the Soroptimist International of the Marianas (SIM), [of] which I still am a member. I have served as a president of SIM and president of Guam Council of Women's Clubs, which is the umbrella organization for the non-profit women's clubs on Guam, and was the 2010-2012 Federation of Asia-Pacific Women's Association International (FAWA) president. I was elected as president [of FAWA] in Taiwan in 2010, and our installation dinner was officiated by Taiwan Vice President [Vincent] Siew and the opening ceremony was conducted by Taiwan President Ma [Ying-jeou]. And we did present them with a Guam painting as an official gift, which was done by Ron Castro. Thereafter, Guam hosted the international convention of FAWA in 2012 and we welcomed delegations from all over the Asia-Pacific.

Ron Castro—once again, very generous and very involved with CAHA—created much of the local artwork for our convention, such as [this] front cover (scan of artwork appended to report) here. So he did the latte stone and the puti tai nobiu or the bougainvillea and the lavender color scheme, which was FAWA's colors, as well as this hand-painted original item that we gave to each delegate from off island as well as the local committee members and sponsors. So you see the Guam theme throughout his painting. This was exactly what we gave them.

And President Barack Obama, Secretary of State Hillary Clinton, and the late Senator Danny Noah also received these pieces of art, both items, as they supported FAWA Guam in our endeavors. And you will see their letters in our program here and the President's will be actually in the proceedings, which will come out later this month because his letter came very late. Apparently there's a one-month—he can't give a letter prior to one month before an event, and we had to put this to bed and print this longer than a month before the event so we couldn't include his letter.

I have attended many off-island conventions and conferences and [more] often than not, I ask Ron [Castro] for paintings I can bring as gifts, so I have been promoting Guam art and the artists here for many years. And I'm proud to do so. So I can leave these if you want to look through, they can be samples. And I just wanted to say that I read through CAHA's bylaws and all their mission statements. I'm familiarizing myself with them. It's a lot to go over. And as Donna [Kloppenburg] said, FestPac is coming up in 2016 as well as the Prevention and Early Intervention Advisory Community

Empowerment (PEACE) Person for the Arts, one of CAHA's initiatives, I read through that. So I'm familiarizing myself with the Council. And I just want to thank you for your time and [that of] everybody here that supported me. Thank you very much.

Chairman Cruz: Well you promoted everybody but you didn't bring any of your artwork. I would have loved to see that.

Ms. Koga: My skirt [has my artwork design] (*referring to her outfit*). And I have a calendar with some of our designs. So I could leave one as well.

Chairman Cruz: Mr. Kloppenburg in the back, maybe you can get him to commission you a new shirt for us at Guam Visitors Bureau (GVB). We just came back from Seoul, Korea, and we got the Best Design for the booth and the dancers got Best Entertainment so maybe we'll get the Best Costume if you would design one for us for our next one.

Ms. Koga: In fact, FAWA will be held in Seoul in October 2014, so Guam will be sending a big delegation. Donna is the president of the Guam Council of Women's Club. They're going to be our head of delegation, so it should be a really nice representation.

Chairman Cruz: Okay, well, you're both on CAHA and that's before we do FestPac. We have lots of meetings and I know Donna's been very active with co-chairing one of the subcommittees. So I'm very excited by the fact that you're willing to go on. And I know we had a recent resignation on the board, right? Is that why we're filling? I thought there was a resignation.

Mrs. Kloppenburg: Oh no, maybe one of the committees.

Chairman Cruz: So I'm hoping we'll have a full board. If you guys continue to operate, and especially since CAHA has undertaken the responsibility of co-chairing all the subcommittees in FestPac, you'll have a very busy next two years. And with everything you've been describing about what you've done over the last two decades since you moved to Guam, you should make an excellent addition to the co-chairmanship. Your confirmation should be done within two weeks. So you'll be at work and we expect you to attend board meeting more frequently than some other people. Because there's lots and lots of work with FestPac and we look forward to maybe you heading up the group that does co-chairing, the textiles. That would be exciting and interesting to have done. Because I know there will be a whole display on that. I know there's a fashion show that's being planned with your background and clothing designs that may be your area to take up. I really have no questions; I mean, you're obviously very involved in the

community with non-profits and I'm very happy that the Governor and CAHA Board has decided to ask you to come on board. Senator Ada, do you have any comments?

Senator Tony Ada: Thank you, Mr. Chairman. I think the Chairman said it the best: it's a fresh new face to the CAHA Board. I think you'll make a great fit into there. I'd like to thank you for taking the Governor's call and stepping onto the Board, be a part of it, helping the community and the island. You will have my full support and vote for your confirmation. Thank you, Mr. Chairman.

Chairman Cruz: (to Nadine Cepeda) Did you want to testify? Please come on up. We have your written comment, but it would be nice to be read [it] into the record.

Nadine Cepeda read her written testimony (appended to the report) into the record.

Chairman Cruz: (to Ms. Cepeda) Thank you very much for that well-written testimony. If we don't have anything else, like what Senator Ada said, (to Ms. Koga) thank you very much for accepting the Governor's invitation to serve the community. You obviously have done a lot in the community in the past, anyway, so this should be nothing new. The next two years are going to be very, very, very busy, so put aside a lot of time because it's going to be a lot of meetings, a lot of preparations for FestPac and it should be a very exciting time. With your help, I'm sure Guam will shine again in 2016 when we host FestPac. On behalf of the Legislature, I want to thank you for offering yourself, and we should have your confirmation out within two weeks so you can get to work. Thank you, and this hearing is adjourned.

III. FINDINGS AND RECOMMENDATIONS

The Committee on General Government Operations and Cultural Affairs hereby reports out the nomination of Kristal K. Koga to serve as Member of the Guam Council on the Arts and Humanities Agency for a term of four years, beginning on the date of her confirmation by *I Lilteslaturan Guåhan*, with the recommendation TO DONTIRM
