


II. SUMMARY OF TESTIMONY AND DISCUSSION

- **Speaker Won Pat Ed.D** announced that the Committee will hear the nomination of Mr. Kyle Mandapat for the Guam Public Library System Board. Speaker asked the appointee to tell the public about him and why he wants to serve on the board.

- **Kyle R. Mandapat** the appointee mentioned that he is a personality host with Sorensen Media Group. He mentioned that his current line goes back 2 years, where he brought his children to the Dededo Library, to explore the books. He thanked the government for keeping the library open. The appointee is also working on a book where he is donating all 100% of the proceeds to be donated to the Library. He also mentioned that everybody is interested in keeping the library open.

Senator Yamashita mentioned the notion of intergenerational activities and programs that the library can get back to. Senator Yamashita lastly thanked the appointee for making the time and giving back to Guam.
- **Senator San Nicolas** fully supports the appointment of Mr. Mandapat. Senator San Nicolas mentioned the technology aspect of searching for books and for library users who are on the go.
- **Speaker Won Pat Ed.D** acknowledged the appointee receiving the voice of the year award and hopes the appointee be the voice for the library system and welcomes the nomination of the appointee.
