COMMITTEE REPORT DIGEST

I. OVERVIEW

The nomination of Marcel G. Camacho to serve as a member of the Real Estate Commission was made by Governor Edward J.B. Calvo on September 30, 2014. The nomination packet was received by the Office of Speaker Judith T. Won Pat, Ed.D., on October 1, 2014. The nomination of Marcel G. Camacho was subsequently referred by the Committee on Rules to the Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations on October 2, 2014.

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations convened a legislative hearing on November 18, 2014 at 2:23 p.m. in *I Liheslatura's* Public Hearing Room. Among the items on the hearing agenda was the nomination of Marcel G. Camacho. The hearing was adjourned at 3:02 p.m.

Public Hearing notices were disseminated via electronic mail to all senators and all main media broadcasting outlets on November 10, 2014, and November 14, 2014. Notice was also posted on *I Liheslaturan Guåhan's* website beginning on November 10, 2014.

II. TESTIMONY & DISCUSSION

Chairman Michael San Nicolas convened the hearing on the nomination of Marcel Camacho to serve as a member of the Real Estate Commission. He introduced the nominee and opened the floor to any members of the public wishing to provide testimony.

Former Senator Marcel Camacho expressed his gratitude for the nomination. He mentioned his experience as a former senator. He stated that he always possessed great interest in real estate, development, and other land issues. Former Senator Camacho mentioned that he previously worked on developing a land use master plan for the government of Guam. He stated that his experience as a public servant helped him to learn more about various issues including land and environmental issues. He stated that he believes that he would bring a unique perspective to the Commission. He asked for favorable consideration of his nomination.

Chairman San Nicolas thanked Former Senator Camacho for accepting his nomination. He stated his belief that with Senator Camacho, and the other individuals nominated to the Commission, the Commission looks to be off on the right foot and sees great potential in the work they will do.

Senator Frank Aguon thanked the nominee for his service. He asked if Former Senator Camacho could foresee any potential conflicts of interest between his membership on the Committee and his family's role in the real estate industry.

Former Senator Camacho stated that his participation on the Board will allow him to share his knowledge and experience in helping shape rules and regulations and does not foresee any conflicts.

Senator Aguon expressed his support for Former Senator Camacho's nomination. He stated that he looks forward to the work the Commission will do. He mentioned that he hoped that the Commission will work to ensure that the interests of the people of Guam will be priority.

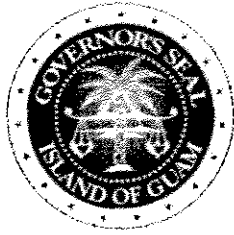


