#### II. SUMMARY OF TESTIMONY & DISCUSSION

- 2. Mr. Eric Palacios, Administrator of the Guam Environmental Protection Agency, Provided Oral Testimony In Support of the Appointment.

Senator Rory J. Respicio called the public hearing for the reappointment of Mr. William T. Detry to serve as a Member of the Guam Environmental Protection Agency Board (GEPA) to order at 10:00 A.M. and invited the panel to testify.

#### Mr. Eric Palacios:

Thank you for the opportunity to speak in support of Mr. Detry's nomination to the GEPA Board of Directors. I have limited background information on Mr. Detry's background but it's enough to comfortably speak on his qualifications and what I believe to be his commitment and the value he will bring to this Board.
