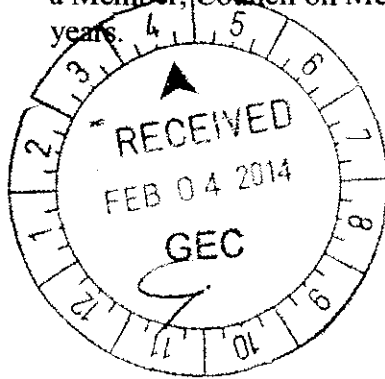



II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 12:00 pm.

Chairman Rodriguez: Confirmation Hearing called to order at **12:03 pm Friday, January 31, 2014**

We now have the appointee here. If there is anyone here who wishes to provide written or oral testimony I ask you to please sign in to the table on my left. All right? Mr. Espaldon.

Ernesto V. Espaldon, Jr.: Provided oral testimony, and submitted written testimony [Please see written testimony]

Chairman Rodriguez: Thank you very much, Mr. Espaldon. Before I recognize any of my colleagues here who wish to make any comments or ask a question. I want to thank your family, your wife, Mrs. Espaldon, for being here and your brother, Carl. Family support is always very important, so we appreciate them being here. Majority Leader?

Senator Respicio: Thank you Mr. Chairman, just very quickly. I know we have another hearing after this, but I certainly want to thank you June for accepting the governor's appointment to GEDA. Governor Calvo certainly made a wise decision in tapping your business acumen. You're very successful and established businessman and I know this because he is my brother's brother in law. His wife Submico is my sister in law's twin sister and so I, I want to lend my personal support also to this confirmation process and again, thank you for your service.

Ernesto V. Espaldon, Jr.: Thank you very much.

Senator Ruspicio: And your brother is our colleague and your other brother, we go back a very long time. Your reputation certainly precedes you and this is an excellent appointment. Thank you.

Ernesto V. Espaldon, Jr.: Thank you.

Chairman Rodriguez: Thank you Senator, Senator Morrison?

Senator Morrison: Thank you Mr. Chair. Thank you June for your testimony, outlining the wonderful service your family, your father, your mother, and of course, family--former Senator Jimmy Espaldon is here, brothers, your wife, note the service that your family is contribute to our island. I just took a glance through your packet and I appreciate some of the other civic involvement that you also outline aside from your testimony and I also want to thank you for all these services that you provided to our community, of course you're now no stranger sitting on the boards and understanding the dynamics of serving on a board and working with others to find solutions to serve our community. Very encouraged, and I thank the governor for the nomination

and I look forward to your service working with you and working with the committee, thank you Mr. Chair. Thank you.

Ernesto V. Espaldon, Jr.: Thank you Senator Morrison.

Chairman Rodriguez: Thank you Senator, Senator Duenas?

Senator Duenas: Thank you very much Mr. Chairman and Ernesto thank you also. As many have mentioned your esteemed family members here to support you and the contents of your background that you provided now for us to, certainly I hope a majority—hopefully a clean sweep of colleague's support you and your nomination. I want to thank you for your willingness to serve. I know that in your business capacity I frequent your businesses. I know that the attention to detail and service that you provide and you know, to your employees and your employees provide to the community that is a testament of your ability to serve on this board and I'm certain that you're going to make a great contribution. I also think you're not only history of your family's involvement and community service and your business acumen I think you're going to bring a much needed and new dynamic to our pretty dynamic board already and I'm happy and I appreciate this appointment because I think that you're going to bring some additional perspective and I think it is an excellent choice and you certainly have my support. Thank you once again for your willingness to serve

Ernesto V. Espaldon, Jr.: Thank you very much, Senator Duenas.

Chairman Rodriguez: Thank you Senator, Senator Yamashita?

Senator Yamashita: Thank you very much Mr. Chair. Well my goodness gracious this sure takes me back a long way. I am honored and humbled that you're in front of us. I am honored and humbled that you are a success in our community and that you're willing to do even more for us. And as you sit on the GEDA Board, once you are confirmed, I would ask two things, one is that you help GEDA multiply what you have been able to do as far as how do we motivate and inspire our younger generations to work as hard as you have to succeed—what does that look like and how do we do and all the conversations, the dialogues, the businesses that you invite to Guam, welcome to Guam, and try to retain on Guam—how do we build local capacity, so that we can hand that torch over and we are handing the torch over and that is why my heart is smiling right now because my gosh, I was with Viv and Arlene, so I can be your mom, I think I'm much older than you. And so, I'm just feeling very good and then the second component is as you discuss partnerships and contracts and how to grow Guam not only growing it in local capacity, but also ensuring that there's always a component that will strengthen diversity. We

need to do more in our island to ensure all of us that are different who are blessed with the different language, with the different skill set, with the different ability that they are given opportunity and not a handout, but a hand up, an opportunity to prosper. We have a really big problem with public assistance on our island and GEDA's economic development and that has to be for all of us. So we can always say okay, so then how do we also make sure that there is opportunity for these segments to integrate to infiltrate and to succeed as well. I wasn't able to study the e-mail this morning, but I got an e-mail this morning from a Japanese entrepreneur, he is going to be visiting Guam and I'm sure my colleagues got it as well, but they are interested in having a farming industry out here and employing those of us with disabilities and anybody like me, who has a disability or has a son—for good workers. We want to go to work and when we get to work, we really work, and we insist on working. And so that kind of—how do we multiply that so as you sit on the board, and you do your work I hope those two things always come to mind: how do we grow it and then how do we expand it and welcome everybody. I am certainly very proud to have you. I'm sure your brothers are extremely proud, your two brothers, my goodness what a loving family and we are very proud that you and your dad—your dad was my doctor made Guam your home. You're giving back right now, he's smiling big time, so thank you. Thank you very much and congratulations. Thank you, Mr. Chair.

Ernesto V. Espaldon, Jr.: Thank you.

Chairman Rodriguez: Thank you for your wonderful comments, Senator Yamashita. Thank you very much Senator and of course, I want to congratulate you again. For this nomination, I think you'll be a very good asset to our people of Guam, to GEDA most especially. I committed to you to make sure that after this hearing we'll get the committee report prepared and hopefully we can get it on the agenda during this session, so we can vote on it. There are people who signed up Mr. Tallege and Mr. Kyle Espaldon, signing up in favor of your testimony and we did also receive a written testimony from Mr. Boe Baba. If anyone else wishes to submit any testimony they may do so through e-mail or they may drop it here in the building. Did you want to do an oral? Okay, please if you could, I'm just going to ask that if we could keep it short, we have another hearing at 12:30pm and we also want to be able to give the committee report, so we have less to transcribe. Okay, so keep it short. Mr. Tallege.

Mr. Tallege: Hafa Adai and good afternoon, Senators. You know, my daughter, when we heard about Ernesto being for GEDA Board, me and my daughter you know, she's nine and I'm trying to stick as much politics into her head as much as possible, but anyways, we were talking and we live right behind Chuck E Cheese, so Coldstone and Wendys that's her breakfast, that's her thing. If this guy can run a place like that in a very expensive real estate here on Guam as far as

rental and stuff and doing business, he must have a very good head on his shoulders for business economics. I just wanted to say that and umm, I really believe—I was just reading this thing here from the governor, endorsing him to be in the GEDA board and he the governor himself comes from a very successful business as well, so from one business man to the governor offering him to be on GEDA, I think Guam needs that and the only thing that I am going to ask is Mr. Espaldon, I know his whole family and they are well, very good people. I just want them to know that when you are on that board, which I almost 100% feel, they will vote you in find money to fix our roads. I'm asking you that put some efforts in there because Guam really needs it. Okay? With all that being said, everybody should smile. The million dollar question is asked already. Thank you.

Chairman Rodriguez: Thank you very much sir. I would also like to recognize the other brother, Jimmy Espaldon for being here as well, so thank you. This concludes your public hearing and we'll now move on to the next one on the agenda: the appointment of Mr. Lawrence J. Alcairo.

Ernesto V. Espaldon, Jr.: Thank you Mr. Chair

Chairman Rodriguez: Thank you. Do we have people who signed up? If I can call on Mr. Jermaine Alerta first, he signed up to give an oral testimony. Same requirements, just keep it short.

Jermaine Alerta: Yes sir, thank you Senator. My name is Jermaine Alerta, I work for the Guam Legislature, but I am also a former speaker of the Guam Youth Congress. I am going to testify in favor of the nomination of Lawrence Alcairo for the Council. I first met Lawrence in a church trip in 19—2008 very—he was—what grade were you 10th grade? 10th grade at FD very, what can I say charismatic person so when we took over our office took over future generations in the Youth Congress, Lawrence was always expressing a desire to be a member of the Youth Congress and when we made our office available for him to come in and work out of it. One of the first things I remember him asking was “What board can I be on? What board does Youth Congress have a seat for law in the government. He was very anxious, we went to so many different boards “how should I write my letter, requesting if I can be placed on this board” I think the one thing that he is going to bring is his willingness and his eagerness to not only learn the laws that effect different parts of our community but his willingness and his eagerness to learn. I think he will be a great asset. He is one of the more active members of the Guam Youth Congress. His mind is constantly moving, so I think that can only be beneficial to any board especially this board that he is going to be on, so I hope that you vote in favor of his nomination. Thank you very much.

Chairman Rodriguez: Thank you very much Germaine. Lawrence?

Lawrence Alcairo: Thank you Senator Rodriguez, Senator Morrison, Senator Duenas, Senator Yamashita, and Senator Respecio I believed stepped out for a second. I like to take the time to first again introduce myself. My name is Lawrence Alcairo. I recently graduated from high school, Father Duenas 2011, so you can see I am pretty young. I am currently enrolled at both the University of Guam and the Guam Community College, pursuing a degree in health science. I am both honored and humbled to be appointed to this board as a youth member. The Council on Mental Health and Substance Abuse, growing up on this island, family has always been the staple of our community, we make decisions as a family, we make decisions as a whole, and the youth should never be excluded from that. In fact, the youth are what we make these decisions for. I want to thank all of you for hearing me out and providing this opportunity for the island to take into consideration the voice of our youth on a Council that touches on matters which greatly affect our youth: mental health, suicide, substance abuse. The strongest driver of youth is peer pressure and I hope that by being on this council, I will be able to install positive peer pressure in our youth and drive our island into a better future. Thank you.

Chairman Rodriguez: Thank you very much, Mr. Alcairo. Senator Respecio?

Senator Respecio: Thank you Mr. Chairman and keeping in line with your edict. I just want to say thank you so much Lawrence, I have always been impressed by your kind of energy and your willingness to be the great representative you are for our young adults and so, you have my support.

Lawrence: Thank you.

Chairman Rodriguez: Thank you very much, Senator. Senator Morrison?

Senator Morrison: Thank you Mr. Chair. Thank you Lawrence for your testimony I want to thank Jermaine as well for sharing his understanding and seeing your work and providing it clearly to us and I just want to thank you for sharing some of the information and tailoring it to the perspective from the youth and working with my colleagues here are some of the issues that I clearly focus on within this legislature and youth issues that will help prevent our youth from getting caught up in the negative influences in our community and some of it preventive measures we can put in through specific youth programs that will guide them in a more positive light and deter them from engaging in any type of negative activities out there, so I thank you for sharing that perspective and I thank you for wanting to serve our island, serve in our community,

specifically in this board and I look forward to supporting you and hopefully we can get it done Mr. Chairman, we'll try to do that, but I look forward to supporting your nomination, thank you.

Lawrence: Thank you.

Chairman Rodriguez: Thank you very much, Senator. Senator Duenas then Senator Yamashita.

Senator Duenas: Thank you Mr. Chairman just being really quick here. Lawrence, once again, my appreciation to you and your willingness to serve the youth membership that you describe on certain boards cannot be overstated as of my good friend and colleague Senator Rory Respicio and I presented over at Department of Youth Affairs and the Youth Membership on that board as well was always critical in knowing and understanding the current affairs that youth are facing and that voice that you spoke to, so I look forward to your participation and also in voting on your confirmation and I want to just ask you personally, reach out to us, you know, when your board meetings are conducted, I would like to hear back from you personally on how you feel things are going and how your participation how you feel your participation has affected change or in terms of your understanding of youth issues. I just want to reach out to you personally and I hope you reach back to your office after you sat in on meetings and I want to see your perspective Thank you very much Mr. Chairman.

Senator Yamashita: Thank you very much Mr. Chair. Sir, thank you for your willingness as you're going to UOG and GCC to carve out the time to do this. Have you received any training of systems of care I'Famagunta with Project Karinu?

Lawrence: I have done some training with the Behavioral of Wellness Center back in 2011 right out of high school I did the suicide prevention training and I was also a part of the PEACE Conference that they are currently undergoing to create that 5 year plan to address mental health and substance abuse in our island so I was a part of the initial conference, the 2 day conference I believe that carved out that plan for our community and I hope to continue to be active in caring on that plan.

Senator Yamashita: Okay, but you haven't had actually got actual training in systems of care. Rather than the strategic planning (interrupted by Lawrence)

Lawrence: Just the suicide prevention (interrupted by Senator Yamashita)

Senator Yamashita: What I would recommend is that upon your confirmation that you do connect with Annie Unpinco and Terry Aguon. Terry is with Project Karinu and Annie is with I'Famagunta. They always have training. They are still on their federal money; it will be really

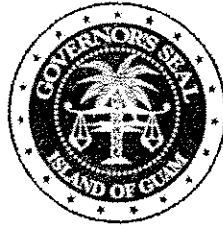
good for you to see how the pieces come together for behavioral wellness. The suicide prevention, yes, is important and the PEACE efforts are important, but the behavioral wellness really kicks in on the mental health part. We have huge, huge challenges in our island huge, huge challenges that start with our babies. I would hope that you would do that and then also, last term, with Senator Palacios and this legislature, we push to ensure that our first responders get continuous training in mental health and we know that the general orders have been educated and we're very pleased with that but perhaps what you can do as a council ensure that they are continuously being trained because as you would know, one training doesn't do it. It has to be continuous and first responders have to be well aware of what it's going to be like when they come across a child with autism—how do you deal with that person, how you deal with the family—the day of shooting them dead has to come to an end. We can't do that anymore and we have done that, but it does take awareness and it does take training and I think this is the Council that will ensure that the training is had. We had all the laws and policies in place but now it's the actual implementation of it, so with that again, thank you for your willingness it's great to see our younger generation stepping up and receiving the torches so the best of luck and thank you. Thank you, Mr. Chair.

Chairman Rodriguez: Thank you very much Senator Yamashita. Lawrence congratulations again, thank you for taking the time off to come and see me before we have this public hearing and just like the previous appointee make sure that your report is prepared and submitted in this session, so we can confirm you. I look forward to working with you, congratulations again.

This concludes the public hearing on the two nominations, and the time now is 12:25 pm. Thank you.
