

Chairman Rodriguez: Thank you very much Ma'am. Are there any other questions for the panel we have in front of us here? Senator Barnes, thank you for joining us. If there's no questions, that'll be all. Thank you for being here. We will now call the nominee, Mr. Babauta, to please come forward. Just for the record I just want to read off on those who signed in favor: Ms. Barbara Bernardo, Lynn San Nicolas, Jenae Chimp, Antoinette Marie Babauta, Hope Pangelinan Cortez, Tricia Taitague, Warren Lampa, thank you very much.

Mr. Babauta, thank you for being here and congratulations on your appointment. I want to recognize your wife and your lovely children, (indaudible) and Maya. Thank you for being here.

Thomas Babauta: Please read nominee's written and emotional testimony, attached.

Chairman Rodriguez: Thank you very much for your testimony. And now may I ask any of my colleagues, Mr. Vice Chairman.

Vice Chairman Ada: Thank you Mr. Chair. Mr. Babauta, thank you for your service to our island, our community and now stepping up to the place to be a member of the Social Worker Board. As I'm looking at your packet, it's just unbelievable, your accomplishments and where you've been. It's just unbelievable that you have enough time to also put into the social work board.

Mr. Babauta: I don't but I will make the time. It's a priority.

Vice Chairman Ada: So then I have to ask, is it okay for your daddy to come unto the board? (Addressing children) Yes, it's okay? So they fully support you, you have my full support and my vote to the board. Thank you Mr. Chairman.

Senator Respicio: Thank you Mr. Chairman. You also have my support Tom. I'm just looking at the back of the room and Maya is very emotional because you mentioned her grandpa. But I want



to let her know, that everybody knows that not only listening to your testimony, but the work over the years, your dad is very proud. So thank you for your service and thank you for accepting the governors nomination and you have my support.

Senator Aguon: Thank you Mr. Chairman and thank you for also scheduling this confirmation hearing today, because I know that you expedited it. Mr. Babauta, just a couple of items. You know when I first sat down, my good colleague to my immediate right, reminded me that you graduated from Father Duenas. And apparently, one of my caveats is that if you are from the south, or you graduated from Father Duenas, you automatically have my support. So I wanted to open up with that particular statement.

Just a couple items of your overall presentation, thank you for leaning over forward and offering yourself to the people of Guam and offering your expertise, not only do you have a lovely family to take care of, but you are also working in the Dept of Education in the Special Education Division. And we know that in itself is time consuming and it takes a strong heart, so to speak, to provide our students in our schools as well as the department. But looking at this and looking at how you are able to manage your office. You still have your office?

Mr. Babauta: Yes.

Senator Aguon: And you are operating off of that, and then serving in the National Guard and extending yourself beyond our island community to the entire nation speaks volumes in terms of not only your commitment to your family, your commitment to your job, your commitment to our island community and our nation, so I thank you for offering yourself and I look forward to your contributions to the board. Thank you, FDMS Class of 88, you have my support. Thank you Tom.

Senator Duenas: Thank you. You know Tom, in my days as Director of the Department of Youth Affairs and the many social work engagements that you have been a part of in working with Dr. Rapadas and so many other folks, you are certainly not only suited, but very well suited for this board so you certainly have my support. I know how it feels, in your explanation of your father, I just lost my dad a few months ago. One thing my family always tells me, and I can see it in you Tom, is that one of the things we have to do when we lose a loved one is that they still live in us. So that all the lessons that your pop taught you and everything else, in your testimony, your service not only, what you do now, but on this board, will be a reflection of everything you were taught and who you are. So, stepping up to the plate and doing another thing for our community simply just embodies that spirit that lives within you. So I ask you to do it with vigor and conviction and you



certainly have my vote. I hope we can move this forward in a session soon, if not today. Thank you Mr. Chairman.

Senator Muna Barnes: Mr. Babauta I want to thank you for your support to the island of Guam and your family who are here and also (inaudible remainder of Senator's comments).

Senator Morrison: Thank you Mr. Babauta for your passionate testimony. I also want to thank all those who came before you in testimony in support of you. I'm just very encouraged with the administration in working and sorting and finding the cream of the crop who really meet the quality that you bring. So I just want to thank you for stepping up and wanting to serve our community and you have my full support.

Senator McCreadie: Senator Muna Barnes hit it right on the head. That was the best testimony ive seen in my two years here, my first term. I learn something new every day. And what I learned today is that we need more people like you to step forward and serve. Whether it's on this side of the aisle or where you choose right now for your path in life. You know, you are exactly what this island needs. And with that you have my full support. I just had a question because it was asked to me yesterday at a debate and we're not the experts, although sometimes we pass ourselves off as experts, we're not the experts, you guys are the experts. No disrespect to anyone on the panel, but speaking of myself as well. I going to ask the question because it was asked to me and I answered it. The question was, how can you as a leader, improve the state of our public health social services? And my answer was that I thought we could do a better job of specifically finding the problems that we need to solve and addressing it that manner. Whether it's hiring new or specific health care providers or people like yourself. Do you see a one size fits all for our island or do you see a lot of different pockets of social work that is needed out there, and if you do, what is the foundation because of these problems?

Mr. Babauta: I'll try to answer, that's a pretty loaded question. One of the things, one of the reasons I fell in love with the social work profession, I initially was going to be a nurse. I was enrolled up at UOG for 2 years in the nursing program. My dad kept pushing me, he was like you know, you should be a nurse because everyone is going into business and there's not that many nurses, there is longevity and job security and my heart wasn't in it, but I got into the nursing program, I was up there and I wanted to go to school off island and to get off island, I didn't realize how competitive the nursing field is, so there were 800 applicants at the University of Utah for 80 slots. It was really competitive. So I took on these classes thinking, what if I don't get in and I stumbled on a social work class and I found there were social workers in almost every professional setting including industrial social workers who look a productivity, look at morale, they look at work load, they look at how can we have a better work ethic. You have social workers in family



advocacy, in schools, mental health social workers, so I was thinking if I ever got tired in one area, I could slide over. Now, when I look back on it, the first job you have, typically, you get a lot of experience in there and you kind of lock yourself in. I intend to look at, because there is so many different ways to look at it, so many different areas, there wouldn't be one kind of thing. But NASW outlines our basic tenets, our basic foundations and if you apply those, like I mentioned before about the core values, if you apply that and look at what's in the best interest of the client you have you are always going to come out on top. A few years ago, we were looking at transformational change and the public health model, I remember reading a book about having some issues in underdeveloped country and they were finding that some kids were not nourished, so they were trying to figure out how can we get these education out there, how can we teach these families, how can we get these families to adopt these changes that we know are important. And they kept failing. So they looked at it from a different angle. Who is doing what? Who is getting fed? Who is thriving? And when they looked at that and they studied and saw what was going on there, they said let's see if we can get them to teach the others. I'm a firm believer that if we look from different angles, we'll find a solution one way or another. And what we found in that case is, once you have the people with the buy-in and they know what they are doing, they infected the people in their community. So you got to start where the client is, figure out what their perspective is, because our perception is our reality. If you are in the social work field, then the school system or mental health, you got to look at it from that angle you got to get down, like I work with kids, I get down on their level because I want to connect with them and understand what they are feeling and from there I want to come in with these basic values, you can meet their needs. I hope that answered you.

Senator McCreadie: That last part answered my entire question. That was very (inaudibles from panelists). Thank you, I just want to say you have my full support and I can officially now say that you have a beautiful family. My first tour was with your two kids, I took them into the session hall. Thank you, you have my full support.

Chairman Rodriguez: Tom thank you for taking up the call and congratulations on your appointment. We move quickly to have this hearing and as soon as we get all that is needed, we will get the committee report ready and ensure that it is placed on the next session agenda that is called. I want to also thank the chair of the Guam Social Work Board Gaudencia for being here for the work her and the other members and all the social workers have been putting into really getting this law moving forward. And so our commitment is still, we affirm that we will stay committed that we get this on track and we get everything moving forward. So, thank you very much. This hearing is adjourned at 3:49pm.



we are trained to assess and treat not just the individual and her symptoms, as a psychologist or medical doctor, but also the bio-psychosocial and spiritual environments that affect our clients, whether they be individuals, families, communities, or the entirety of Guam. We know and are trained to realize how the disparate variables affect the individual, and vice-versa, and we are called by our Code of Ethics to advocate for this.

It is with this perspective in mind that I again express my strong support for the appointment of Mr. Thomas C. Babauta to the Guam Social Work Licensing Board.

Hafa Adai, my name is Thomas Babauta and I am a social worker. I am seeking support of my nomination to the Guam Board of Social Work. The NASW code of ethics and practice guidelines provide practice parameters in the field of social work. The primary mission of the social work profession is to enhance human well-being and help meet the basic human needs of all people. The mission of the social work profession is rooted in a set of core values: service, social justice, dignity and worth of the person, importance of human relationships, integrity, and competence.

The licensure process provides the checks and balances to ensure that social workers adhere to the NASW code of ethics. Should a practitioner operate outside the guidelines set forth, a process is not in place to ensure compliance to include sanctions if warranted. As the last entity in the country to move towards the licensure process, social workers on Guam are now held to national standards.

I would like to give you a quick overview of my professional experience.

In September 1994 I returned to Guam after being off-island completing my BSW and MSW programs. Although I was offered a position at the Psychiatric Hospital where I did my internship, my desire was always to return home to begin my career.

In my 20 year career I have been licensed in 3 states as a social worker. Until recently, any social worker seeking certification/licensure had to acquire it via an off-island mechanism. In my attempt to meet national standards I pursued the Academy of Certified Social Workers (ACSW), Qualified Clinical Social Worker (QCSW), and Licensed Clinical Social Worker (LCSW). This required testing that was only accessible off-island and at a great expense.

During my tenure as NASW Guam Chapter President over a decade ago, I participated in discussions regarding increasing standards for social workers locally. Dr. Vivian Dames and Dr. Gerhard Shwab were instrumental in promoting the implementation of licensure on Guam. I want to ensure that they are credited for their work.

I often tell my clients, that we are like pieces of clay and every experience that we have molds and shape us into the person that we are today. I have had many experiences both personal and professional, which have shaped me into the individual I am today. The foundation of respect, perseverance, a strong work ethic, dedication, flexibility and compassion was instilled early in my life by my parents. I often think of my dad repeating to respect everyone, he would say "son, I want you to respect everyone older than you, younger than you, those who have more than you, and those who have nothing, etc...." and also taught me not only to give respect, but to command it. Those lessons have resonated throughout my life and paid dividends. Those characteristics are the cornerstone

of my career. If I can sum my life up into one quote it would be Reba Mc Entire's quote, "to succeed in life, you need three things: a wishbone, a backbone, and a funny bone."

In addition to my direct practice experience as a social worker, as a clinical social worker, as a school-based social worker, and as a supervisor of social workers, I have a long history of community involvement.

I have served as the Chairman of the Developmental Disabilities Council, Vice President of the Guam Association of Social Workers, President and Vice President of the NASW Guam Chapter, NASW Delegate to National Assembly, member of the System of Care Council, and member of the Mental Health Planning Council. I was the 2006 NASW Guam Chapter Social Worker of the Year. At the age of 39, I commissioned as the first Behavioral Health Officer for the Guam Army National Guard and volunteered to deploy to Afghanistan in support of Operation Enduring Freedom with Task Force Guam in 2013.

The combination of professional experiences coupled with my knowledge base, value base, and skill base make me a prime candidate for the Board. I continually strive to improve my craft borrowing from the Army AAR (After Action Review). I constantly evaluate what I do well and modify areas that need improvements.
