

#### COMMITTEE REPORT DIGEST

#### I. OVERVIEW

The Committee on Education, Public Library and Women's Affairs convened a public hearing on July 25, 2013 at 9:00 am in *I Liheslatura*'s Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Mr. John T. Benito to serve as a Member of the Guam Public Library System Board, and whose appointment history is as follows:

- Appointed by the Governor of Guam on June 3, 2013, for a term of Three (5) years;
- Appointment packet forwarded to I Liheslatura on June 5, 2013;
- Appointment packet forwarded to the Committee for public consideration on June 6, 2013.

#### Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on July 17, 2013, (5-Day Notice) and July 22, 2013 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

#### II. SUMMARY OF TESTIMONY AND DISCUSSION

- Speaker Won Pat, Ed.D. called Ms. Santos, Ms. Belanger and Mr. Sablan to testify.

- Ms. Santos testified in support of Mr. Benito on behalf of President Mary Okada. President Okada's written testimony is appended to the committee report.
- Ms. Belanger testified in support of Mr. Benito. Her written testimony is appended to the committee report.
- Mr. Sablan testified in support of Mr. John Benito. His written testimony is appended to the committee report.
- There being no questions or comments for Ms. Santos, Ms. Belanger and Mr. Sablan from the senators, Speaker Won Pat, Ed.D. thanked them for their testimonies.
- Speaker Won Pat called the nominee Mr. Benito to testify before the committee.
- Mr. Benito's written testimony is appended to the committee report.
- Speaker Won Pat, Ed.D. expressed that Mr. Benito's background in financing will be an asset for GCC, especially when President Okada searches for financial resources to build GCC's infrastructure and develop its programs. The Speaker asked the nominee if he has attended any board meetings.
- Mr. Benito replied no.
- Speaker Won Pat, Ed.D asked the nominee if he has reviewed the enabling legislation that pertains to the board of trustees and GCC.
- Mr. Benito replied that he has reviewed the duties and responsibilities of the board.
- Speaker Won Pat, Ed.D. asked the nominee what improvements would like see happen at the college.
- Mr. Benito responded he would like to evaluate the existing programs and see what new job skills are needed for Guam's job market.
- Speaker Won Pat, Ed.D. asked why he accepted to serve on the board.
- Mr. Benito shared his experience when he was asked to speak at an economics class at GCC and from that experience he felt it was a good moment for him sharing his knowledge with the students.
- Speaker Won Pat, Ed.D. thanked the nominee for taking the time to serve on the board.
- Vice Chairperson Yamashita, Ph.d. thanked the nominee for carving his time to be a member of the board. The Vice Chairperson expressed about the good works at GCC and how the trustees are working collaborative with the administration. The Vice Chairperson provided advice to the nominee about early childhood education and how investing a little bit more in early childhood would reap great benefits in life. The Vice Chairperson expressed it is an awful shame that there is discussion to build more prison cells. The Vice Chairperson went on to speak about the relationship with GCC and UOG and the 2 plus 2 plus 2 model as a good model for our students. The Vice Chairperson asked the nominee to further expand the model. The Vice Chairperson asked the nominee why he has invested so much of his time with Big Brothers Big Sisters of Guam.

- Mr. Benito replied that he felt it is important to properly mentor our youth and seeing the "little" (a description of the youths participating in the Big Brother and Big Sisters program) to grow and develop into good students and good adults is very important to him.
- Vice Chairperson Yamashita Ph.d. responded the worth of all human beings.
- Mr. Benito replied yes.
- Vice Chairperson Yamashita Ph.d. stated that she is thankful that GCC is welcoming students with disabilities, but she believes that more work needs to done. The Vice Chairperson stated when students with disabilities leave GDOE their rights are curtailed and many parents do not want to see their children in the living rooms until they die and unfortunately this is happening right now. The Vice Chairperson suggested that the nominee assist GCC in showing the community that it is succeeding in helping people with disabilities.
- Senator Duenas expressed he has seen the great works of the nominee being part of the boxing federation and Big Brothers Big Sisters. The Senator stated the integrity, commitment and financing background of the nominee will bring an added dimension to the trustee. The Senator expressed his support of the nominee.

Senator Limitaco stated that the nominee will make a great addition to already stack team with great board members and management team. The Senator stated that he fully supports the nominee and he looks forward seeing better things coming out of GCC.

There being no further questions or comments from the senators, Speaker Won Pat, Ed.D. concluded the public hearing for Mr. John T. Benito to serve as a Member of the Board of Trustees, Guam Community College.
