**I. SUMMARY OF TESTIMONY & DISCUSSION**

**Acting Chairman Benjamin Cruz.** The next item on the agenda is the nomination of Mr. Tony Blaz as Director of the Bureau of Budget and Management Research. We have here to testify on Mr. Blaz' behalf is (former) Senator Tony Lamorena, (former) Senator Bamba, (former) Senator Carlotta Leon Guerrero, Mr. Illagan and (former) Senator Joann Brown.

We will start with (former) Senator Leon Guerrero.

**Testimonies & Discussion**

**(former) Senator Carlotta Leon Guerrero.** Thank you very much, Mr. Chairman and senators. It is a great honor to be here to stand in support of (former) Senator Tony Blaz. I think that in all of the years working with him and working with many of you here, as well as with many of the top financial people within the government, there is an understanding that there are some people that are essential because of their years of experience and their understanding of the flow of government finances. (former) Senator Blaz has that ability. I come from a perspective of being in the legislature, as well as having spent some time in the executive branch. I was able to work with him on finding the funds, having creative ideas and solutions. George is here, Art is here and we were all part of the fiscal team that contained Tony Blaz. I stand in support of his abilities, his grasp of government budgets and continuity. These long time understandings of government budgets is very important. I stand in support of him.

**Acting Chairman Benjamin Cruz.** Thank you very much. (former) Senator Brown?

**(former) Senator Joann Brown.** Thank you very much, Mr. Chairman. I also am here to testify in favor of Tony Blaz' appointment to BBMR. I started working with Tony about 26 years ago. I was assigned the task of being in charge of the Legislative Review Committee and he was probably the one director that I had the challenge of keeping up with. If anyone knows Tony Blaz, you know how active he can be and sometimes how energetic he can be. The challenge is always trying to keep up with him. Tony went on to take over PUAG, at the time. He has continued his work in government for many years; at GEDA also. He is very well rounded. He is knowledgeable. He has done the implementation of budgets. He has been in charge of the very committee that you sit on that oversees budgets for the entire government of Guam.

In terms of the expertise that he brings, there are not too many people that have all those capabilities in the government right now. We are very supportive of his initiative and his desire to want to continue to work. It is a challenging position because anyone who has to deal with budgets, generate budgets, approve budgets, knowing that the demands are greater sometimes than what the finances are and then trying to balance that and then trying to take care of all the immense needs that are out there and all the things we see as a priority. It's a tough job. The fact that he is willing to come forth - not just to be nominated but to say, yes I am willing to take that challenge and willing to continue to serve the people of Guam. That is very admirable. Certainly, the five of us that are here who have worked with Tony over the years are very supportive of him. We know he is quite capable of doing the task that has been put before him.

I am here, along with my former colleagues – I think this was the first time we all hung out in the old session hall – probably a good 14+ years to be here to support him today. I certainly stand in support of his nomination. Thank you.

**Acting Chairman Benjamin Cruz.** Thank you very much. (former) Senator Lamorena.

**(former) Senator Tony Lamorena.** I will yield to (former) Senator George Bamba.

**(former) Senator George Bamba.** Thank you, Mr. Chairman and Vice Speaker. First of all, I have known Tony for – actually our relationship goes all the way back to his father. I worked for his father while we were in the Paul Calvo administration. When Tony was going to the University of Notre Dame, every time he would come back, he would of course express a very strong interest in the activities of the executive branch and of course his background is in finance. When he graduated, I asked him to consider going into public service because he had gone abroad, got a great education and we need leaders that have that capacity. That was one decision I made to support him in his endeavors that I will never regret. Since then, not only did we serve together in the legislature, but he was a key part of the fiscal committee during the previous administration, of which I was chairman. Tony, as well as Art and John Camacho, Lou Perez and Bertha (Duenas) were very essential in crafting and working with the legislature in reaching a consensus on a lot of challenges that we faced. I think if it was not for the support of the legislature at that time, even with the late Senator Ben

Pangelinan – he was very candid, we were very open and we wanted to reach as much of a consensus as possible.

Tony was critical in the subsequent bond issues that were floated, which took care of the landfill, the COLA, as well as the EITC and the refunds. He was essential on that part. His agency was critical to develop a strategy not only to get higher ratings for our bonds, but also putting on a road show to get investors interested. As a result of that, and as I was telling the late Senator Ben, we were blessed that day. We spent a week in New York in the dead of cold and in less than half an hour a total of \$460M that this legislature authorized to be floated, was sold. At that point, the window closed. New York could not sell their bonds. California couldn't. Puerto Rico couldn't. I think it was due in large to the preparation that occurred and the determination that we all had, especially Tony in seeing this thing through.

For that, I sincerely hope that this legislature does confirm him as Director. I think he is entirely deserving of it and I think he is extremely capable of performing the job. Thank you.

**Acting Chairman Benjamin Cruz.** Thank you very much. (former) Senator Lamorena.

**(former) Senator Tony Lamorena.** Thank you Vice Speaker, senators. I am Tony Lamorena and here in support of (former) Senator Tony Blaz. I have known Tony for almost 30 years. Tony brings with him a wealth of knowledge. The first time I met Tony, he was Director of PUAG. He moved to the legislature and has now served in various capacities within the government of Guam. What you need in BBMR is someone who does, in fact have that institutional knowledge, who knows government functions, who understands government finance. I am proud to sit here and support and endorse my good friend and colleague, (former) Senator Tony Blaz.

**Acting Chairman Benjamin Cruz.** Thank you very much. Mr. Illagan.

**Mr. Artemio Illagan.** Thank you, Senators. My name is Artemio Illagan and I have known Tony since high school. I was an outgoing senior and he was an incoming freshman. Of course, we abused him. We initiated him into Father Duenas at the time. When I first got to know Tony, he came up to me and said, I know your parents and your grandparents and your great-grandparents. He studies genealogy. I think he knows almost all your grandparents. I respected Tony for that.

As a professional, I knew Tony when he worked for Peat Marwick Mitchell. He was a Senator, and he was a director for PUAG. I really got to know Tony when he was the administrator for GEDA. He really did a lot – our rating started to increase. We got bonds and money to help the government. But I mostly know Tony for his faith, his belief in God. I know Tony, his upbringing by his parents making the Lord's Day – every Sunday. I see him at mass, we talk about God, especially in hard times. That's why I am close to Tony. That's why I am here to ask for your support in confirming Tony. Thank you.

**Acting Chairman Benjamin Cruz.** Thank you very much, Mr. Illagan. Any questions for this panel?

**Senator Aline Yamashita.** I just want to thank each of you for all that you have done and for you to continue to really care. You still are very active and your leadership speaks for itself. For you to come and speak on behalf of another leader, for me is one of the things that Guam is really good about – we continue to care about one another. It matters to us who is in place. It really matters. I thank you for that. Thank you, Mr. Vice Speaker.

**Acting Chairman Benjamin Cruz.** Thank you. Do we have any others who would like to testify? Mr. Pangelinan?

**Mr. John Pangelinan.** My name is John Pangelinan and I am here in support of Tony Blaz. The only thing I want to say is that when I see Tony, he does his work, he completes his work, finishes his work – he makes me tired because he does it real fast and correctly. Tony is goal oriented, he is mission-related and completes his vision. I have known of Tony for 30 years, but got to know him in the last couple of years. He is a worker and he cares for people. I wouldn't be here if it wasn't for his attributes; not only his experience but caring for his staff. I am in favor of supporting Tony Blaz. I hope he gets this directorship because he can do it. Thank you.

**Acting Chairman Benjamin Cruz.** Thank you, Mr. Pangelinan and we did receive your written testimony and will be included in the record.

**Ms. Kimberly Blaz.** My name is Kimberly Blaz and I am Tony Blaz' eldest daughter. I am here with my sister, Maria Blaz, second eldest and the youngest, Tina Blaz.

All I have to say is that my Dad is a hard worker. He is the smartest man I know. He really believes in Guam and anything to help Guam. Even if this job is director of BBMR, or being a Senator or working on a radio station, he does the best at everything he does. That's all I have to say.

**Ms. Maria Blaz.** My Dad has shown us the best guidance by facing every challenge that has come our way. That shows his character and speaks for himself. He will be the best person for anything, and especially this.

**Ms. Tina Blaz.** My name is Tina, I am his youngest daughter. Like my sisters said, we faced a lot of challenges growing up. I believe that my Dad as a single parent raising us all alone, has proven the morals and values and he has instilled the best he could in all of us. I have never met anyone like him. He forced us – he does not force us anymore, but we all go to church on our own now. He raised us to love each other, our family, love the people around us no matter how bad they wronged us. I think his hard work and dedication has shown me to do the same in my every day life. I wouldn't be where I am today if it wasn't for him. Thank you.

**Acting Chairman Benjamin Cruz.** Thank you. Any questions?

**Senator Dennis Rodriguez.** Thank you, Mr. Vice Speaker. Kimi, I want you to know you have a real good Dad. Yesterday when he called me, I hold him I would support him because of you.

Really, he is a good man and he has my full support. Thank you and congratulations.

**Acting Chairman Benjamin Cruz.** Thank you very much. Mr. Blaz.

**Mr. Tony Blaz.** Hafa adai, manâna si Yu'os. Honorable Vice Speaker, Senator Tommy Morrison, my prima Senator Tina Muna Barnes, my good friend Senator Dennis Rodriguez, Senator Rory Respicio, my long time colleague Senator Tom Ada, Senator Mike San Nicolas, Senator Brant McCreadie, Senator Aline Yamashita.

[Read written statement verbatim. See attached]

I want to honor my father, Mr. Joaquin Blaz. I want to thank him for being here today along with my siblings, my friends and supporters to support my nomination. Thank you Senators for giving me this opportunity to work with you. I have worked with you for many years and we want the collaborative relationship. We can agree to disagree. I think in the end, the whole mission for all of us is to help the people of Guam.

Dangkulu Na Si Yu'os Ma'ase.

**Acting Chairman Benjamin Cruz.** Thank you very much. In all the positions that you have had – and there should be a letter to the Governor either today or tomorrow from me – did you serve on the Governor's Performance Based Budgeting Committee? He established it by executive order about two years ago and I am just wondering ...

**Mr. Tony Blaz.** Performance Based Management Systems? Yes. I want to also remind you, Vice Speaker I was the Chairman of Ways and Means and we worked together with DOI at the time on the Performance Based Management. We did some examples to try and proceed with Performance Based Management and we are committed to do that at BBMR.

**Acting Chairman Benjamin Cruz.** Which is the reason I brought it up. I am glad that you are here today because the letter that is going to the Governor and cc'd you is to suggest that in the coming months, now that he signed the budget that we start planning on the next budget. Select a few government agencies; my suggestion would be two or three of the agencies with over 200 employees, two or three employees with over 50 and two or three agencies with employees under 50 and require that those line agencies start the evolution towards Program Based Budgeting by having that done by the time you submit the budget the end of this calendar year.

**Mr. Tony Blaz.** You have given us a new challenge. Of course, we will do our part. Thank you Mr. Chair.

**Acting Chairman Benjamin Cruz.** I really do think it's important. We worked on the budget this last time, but they were just numbers without being able to say, this program really needs to be saved, this one can go. The letter should be arriving in the next day, but I thought I would premiere it today and asking you... I know that you supported it in the past and I am hoping that as a new confirmed director that you will push it in the future and make it happen. It is not just a DOI pipedream, but actually something we can all be proud of.

Any other questions?

**Senator Tommy Morrison.** Good afternoon and thank you, Mr. Chairman. First, I want to thank all those who came before you and testified in support of you. I am going to miss you at DOA and I want to thank you for recognizing the effort that we put into the Office of Technology, understanding and assumed a lot of the responsibilities going forward. Your belief in the office that would eventually transform this government and its customer service. I thank you for that. I want to also acknowledge your efforts. I have watched you in the past, working with the fiscal team and have seen how instrumental you have been contributing to that wonderful team that has done great things for our island and working with the legislature.

Thank you for your public service for many, many years. Thank you for your family for being here. You have my full support.

**Mr. Tony Blaz.** Si Yu'os Ma'ase, Senator Tommy. Thank you so much.

**Senator Tina Muna Barnes.** Si Yu'os Ma'ase, Mr. Vice Speaker. To (former) Senator Tony, thank you for acknowledging our relationship and disclosing that for the record. Thank you for truly believing in working together and noting that sometimes we can agree to disagree. The bigger picture is what is best for the island of Guam. If there is anything that you have touched near and dear to my heart is believing that anything and everything is possible with God. Having your beautiful children to come up and testify on your behalf and seeing Uncle Kin, I just want to say, thank you. You have got a lot of support here. You have been in government service for a long time; over three decades. I know the work that you will continue to provide for the government will be for the best for the island. Thank you for being a part of that; stepping up to the challenge and working with all the different financial agencies, DRT, BBMR and DOA. Thank you. You have my support. I noted that to you when you called me personally. I also want to thank your family for being here. Saina Ma'ase.

**Mr. Tony Blaz.** Dangkulu Na Si Yu'os Ma'ase, Prima.

**Senator Rory Respicio.** Thank you very much, Mr. Chairman. I also want to say for the record that you have my full support. (former) Senator Lamorena said something that reminded me of something that is very characteristic of you and I want to take the opportunity to thank you for always honoring the memory of my grandmother – Tan Beck Rivera Respicio. To this very day you always tell me what a beautiful woman she

was. You remind me that she was the patriarch of the republican party of Guam indirectly asking me why I am a democrat.

I am happy to certainly vote for you and I want to recognize you for all your years of public service and having that strong family unit is something that gets people like us, in our position to – like you say – wake up every day and want to do the best job that we can. Thank you for accepting the appointment and thank you for your hard work.

**Mr. Tony Blaz.** Dangkulu Na Si Yu'os Ma'ase and thank you so much.

**Senator Tom Ada.** Tony, I first met you when we were back in Indiana; that was about 40 years ago. Also had the opportunity to serve with you in the legislature. I have seen your work. But for today, probably the best compliment that any father can have is when his daughters step up to the plate and say, my Dad's the best. I am definitely going to support your nomination.

**Mr. Tony Blaz.** Thank you Senator Tom.

**Senator Brant McCreadie.** Thank you Mr. Chairman. It always seems to amaze me that the best comments come from people who not trying to get elected. With all due respect, it's so raw; there is no script. It's so true and from the heart. To me, commitment is something you do when nobody is watching you. I know you talked about the budget and we all get the credit for the budget, but you were one of those guys that were behind the scenes and nobody knew that. I thank you for that. Maybe they just found that out now – that you were behind the scenes. But still, it was a budget that was a one and done and we balanced the budget for the fourth consecutive time. I remember the last budget process we had seven vetoes. This time with your help and our collaboration we finished the first shot. I thank you for that.

This is a no-brainer. I think this is a 14-0 yes vote for you. I really appreciate and thank you for your public service. I look forward to working with you, at least for the next couple of months.

**Mr. Tony Blaz.** Thank you and Dangkulu Na Si Yu'os Ma'ase.

**Senator Aline Yamashita.** Thank you very much Mr. Vice Speaker. It's always been a pleasure working with you. It is no surprise to me that your girls are here. I think it was such an honor to have them speak on your behalf. What they said was such a true testament to your success as a family. To have your Dad in the room is also very wonderful. I hope you feel really good about that. I know your challenges and I appreciate your courage. I truly appreciate your courage. You get it, you walk in the shoes, you know what concerns the families on this island, you know the struggles of the agencies, and you know how to pull it together. I think you are the perfect person to help us all work together. You answer phone calls, you answer text messages, you open your door and you help me understand how come or why not.

I would like to echo the Vice Speaker's issue or challenge about performance based (management). I would ask that you include the Department of Education in this initiative. They already have performance standards for our teachers that the Board adopted. There is already a process for professional development and how to hold them accountable. That is our biggest agency. We have not been holding them accountable and in this last budget process it really showed to me how we give out this money, but we don't see the real outcomes or how it is being realized, what is going toward. Those deliverables and those outcomes really need to be in front of us.

A huge part of our budget we all know is people. It's the human capital. Until we hold everybody accountable and give them opportunity to get better we are not investing as best as we can. Then what happens is all the smartness that you all do on bond markets, investments and finances, we don't use that as well as we can. For me, where does all this input go and what do we deliver? I would really like to see a start with DOE. I know some might think it's just too huge, but I don't think so at all. Understanding that this is our biggest investment and maybe our most important investment. Although I would say that school of education is really way up there because they prepare the teachers. I would say that we would see a wiser deliverable. This is what we gave and this is what we got in return. That's why this is a wise investment and that's why this needs more money because they weren't able, then this is why.

We would really be able to understand that better. The outputs are really not there. How are the people helped to get there - the whole professional development key. You've got some good people at DOE who already got this and know it but it is not on the table. I think it needs to be or else we would continue to give them hundreds of millions of dollars and not being held accountable. That's my personal and professional opinion. That's not a popular opinion and politically right now I probably shouldn't be talking like this but this is a serious conversation.

Your confirmation process is a very serious process. You being in this position is going to help all of us understand where the investments need to be if we are really going to be serious about doing what is right for our island. I thank you for wanting to do this. I thank you for your energy. I thank you for your attitude. I really do. When I see you coming down the hallway or wherever it is, I never turn the other way. We all do that. We see certain people and we just go the other way because we don't always have the energy. When I see you, my heart smiles. I go up to you and we greet each other. It doesn't have to be a long interaction. A lot of times it's just that short spurt of energy - it's a good day and Guam is good. Guam can be better, but right now Guam is good. I think with you as a director in this agency, it's in good hands.

Thank you for willing to serve and thank you for being here.

**Mr. Tony Blaz.** Si Yu'os Ma'ase, Senator. I will do my part and work with the chairman.

**Senator Chris Duenas.** Thank you Mr. Chairman. The challenge always of being last - I know you've been through this before - is everybody said everything. I ran out of a



meeting to get here because of my commitment to support you and to show my public support for you. I don't have to go over all the conversations that we've had in the last several weeks, several months and years, but especially in the last several weeks as you worked up to this confirmation.

I also see a lot of the wonderful staff here, present to support you. I know it means a lot to you, but it means a lot to me, as well. It means they are supportive of you being the head of the ship and the captain now. I know that you are going to do a fine job. I just wanted to stand to my commitment and I look forward to voting affirmative on your confirmation.

One last thing before I close, we've all had challenges in our life and I am not going to over that, but one thing that has always impressed me about you is your resiliency. You've never let anybody hold you down, put you down and that is a true testament of your character and that's the reason why I have no problems supporting you. I have had my challenges in life, as well. You are a testament for being tough, taking on the challenges and moving forward. That's why you are more than qualified for this job. You've got my support.

**Mr. Tony Blaz.** Thank you Senators. I am very humbled by these comments. Dangkulu Na Si Yu'os Ma'ase.

**Acting Chairman Benjamin Cruz.** Thank you very much. Were there any other people that signed up? Mr. Blaz (Tony's Dad), thank you for honoring us today.

This hearing is adjourned.



Honorable Chairman, Members of the Committee and all Honorable Senators:

I wish to thank you for allowing me the opportunity to appear before you today to speak on my nomination to serve as the Director of the Bureau of Budget and Management Research. I also wish to thank our Governor Eddie Baza Calvo for nominating me for this position.

The consideration of my nomination for this position comes at a critical time now that our budget has been signed into law as we move forward in fulfilling the mandates and promises to our people. Thank you senators, for the bipartisan collaborative relationship that you have all displayed in working with the Administration in order to deliver a budget that takes care of major priorities such as health, education, and public safety. BBMR is currently working with all stakeholders in preparing for the execution phase of our budget beginning October 1<sup>st</sup>.

the manner of extracting remains could assure that there are ashes of some non-Japanese in Yasukuni Shrine in Tokyo.

Locating the remains of U.S. servicemen from World War II is always a challenge because they are located in the Pacific where there are jurisdictional concerns and

bureaucratic hoops to clear. And, to be fair, these hurdles are the same even on U.S. soil. However, I can understand how Petty and his associates feel because they think that their purpose is merit enough to be given permission, and it is. But as we have learned from his writings, the frustrations have resulted from lack of communication.

The honest intentions of purpose or efforts are not

enough to persuade authorities to approve projects like the KUENTA-USA's. And as I write this article I wonder how many of the remains could also be the remains of native men and women who were killed by shrapnel and explosions during the bombardment of Saipan.

Mymother, Frederica Flores Santos, was born on Saipan and survived the war there. In her oral history accounts,

Mom said they would come out of the bokungo' during ceasefire, and although they were brief, it allowed them to get out from the cramped underground shelters to get fresh air, stretch their legs and relieve themselves. In one instance, the bombardment started and they all scattered to get back into the bokungo' when one of the young women they were sharing the shelter with was killed instantly and her father was shocked by the effects of her death that he refused to get back inside with them. He wandered off and was never seen again. I wonder how many of the local residents died in the same way, and if in the recovery process their remains were bulldozed into the mass burials done in the interest of time.

Many Japanese nationals who lived on Saipan, Tinian and Luta arrived in the islands for commercial opportunities. Even some people from Guam, were in Saipan at that time for the same reasons.

Petty's book, "Saipan: Oral Histories of the Pacific War" is the first compos-

ite work of its kind in these parts. He has encouraged me to publish the oral histories that I've collected and we will one day. But for now, we are focusing on the final editing of the Manengon March and Concentration Camp video. We will announce the premiere date and time in this column.

Petty and his family now live in New Zealand. When the Pettys lived on Saipan, his wife Danielle was a physician at the Commonwealth Health Center and Bruce was house-husband before the position became a coined phrase to identify a man who is not employed in the traditional corporate way. So the Pettys left remains were bulldozed into the mass burials done in the interest of time. And, that is what Bruce and Danielle have done several times. This past summer was the most recent visit for them.


