**I. OVERVIEW**

The Committee on Education, Public Library and Women's Affairs convened a public hearing on October 7, 2014 at 4:00 p.m. in *I Liheslatura's* Public Hearing Room. On the agenda was the consideration of the appointment of Mr. Elvin Y. Chiang, to serve as a Member of the University of Guam Board of Regents for a term of six (6) years and whose appointment history is as follows:

- Appointed by the Governor of Guam on July 24, 2014 for a term of six (6) years;
- Appointment packet forwarded to *I Liheslatura* on July 24, 2014;
- Appointment packet forwarded to the Committee on Education, Public Library and Women's Affairs for public consideration on July 28, 2014.

**Public Notice Requirements**

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on July 30, 2014 (5-Day Notice) and August 4, 2014 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

## II. SUMMARY OF TESTIMONY AND DISCUSSION

- **Speaker Won Pat, Ed.D.** commenced the public hearing on the nomination of Mr. Elvin Y. Chiang stated for the record that the public hearing notices were transmitted to the media as required by law and written testimonies will be accepted up to 10 days after the adjournment of the public hearing. The Speaker acknowledged that Mr. Shen, Mrs. Leon Guerrero, Mrs. Sanford, Mr. Kosanke and Mr. Miyashita submitted written testimonies supporting the nominee.

- **President Underwood** testified in support of the nominee. His written testimony is appended to the committee report.

- **Mr. Felix** a member of the Board of Regent testified in support of the nominee. He recognized the nominee as a friend and neighbor whose expertise, intelligence and personality will be a perfect fit as a member of the regent family.

- **Justice Carbullido** testified in support of the nominee. His written testimony is appended to the committee report.

- **Mr. Onedera, CPA** testified in support of the nominee. His written testimony is appended to the committee report.

- **Ms. Nace, CPA** testified in support of the nominee. She stated that the nominee is a long time supporter of school of business in the discipline of accounting at the university. She pointed out that the nominee is a strong advocate of accountability, transparency and professional ethics and it would be an honor to work with him in capacity as a member of the board of regents.

- **Mr. Kasperbauer** testified in support of the nominee. He shared his experience with the nominee as members of the college of business advisory committee in securing matching funds for the construction of the college of business building. He expressed there were challenges but under the leadership of the nominee the university was able to secure funding with USDA. He expressed that the nominee is low key in taking personal credit, but emphasized that it was a team effort. Lastly, He wished to state that on behalf of his parents former Vice Speaker Larry Kasperbauer and former senator Carmen Kasperbauer that they both support the appointment of the nominee.

- **Speaker Won Pat, Ed.D.** asked the Mr. Chiang to testify before the committee.

- **Mr. Chiang** expressed that is an honor to be appointed to the board of regents. He spoke about Guam being his home since 1974. He stated that he is a licensed certified public accountant and he is also

active in community services, including various educational organizations. He stated that he would like to contribute to his services to the board because the university is the highest educational institution in the region and it builds our future leaders.

- **Speaker Won Pat, Ed.D.** stated that with the overwhelming endorsements from the President of the University, Justice Carbullido, fellow certified public accountants and from community members the nominee is more than qualified to be a regent.

- **Vice Chair Yamashita, Ph.D.** thanked the nominee for carving out time to be a regent. The Vice Chair asked the nominee to remain in mind it is about human capital.

- **Mr. Chiang** replied yes I shall remember.

- **Vice Chair Yamashita, Ph.D.** stressed to the nominee that the School of Education needs support, to strengthen teaching and to include early childhood education.

- **Mr. Chiang** replied points well taken.

- **Senator San Nicolas** expressed about one of his hopes is that the university will graduate students that would attract industry to our island rather than graduates that meet the demands of our island. The Senator stated that meeting demands is important but the higher institutions have to take another step such supply side. The Senator expressed concerned about tuition increase, he want the nominee to keep in mind that the higher tuition will affect individuals from attending the university.

- **Mr. Chiang** expressed that he will keep in mind the overall mission of the university.

- **Speaker Won Pat** expressed that the nominee will help move the university from good to great.

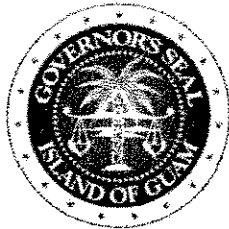
- **Mr. Chiang** stressed that he will not disappointment the committee, friends and the community in serving the university.
