The Committee on Education, Public Library and Women's Affairs convened a public hearing on April 1, 2014 at 5:30 pm in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Mrs. Charlene D. Concepcion to serve as a Member of the Guam Education Board, Parent Representative, the appointment history as follows:

- Appointed by the Governor of Guam on March 7, 2014, for a term of Three (3) years.
- Appointment packet forwarded to I Liheslatura on March 10, 2014; and
- Appointment packet forwarded to the Committee for public consideration on March 10 2014.

#### **Public Notice Requirements**

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on March 25, 2014, (5-Day Notice) and March 29 and 30, 2014 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

#### II. SUMMARY OF TESITMONY AND DISCUSSION


- Speaker Won Pat, Ed.D announced that the Committee will hear the nomination of Mrs. Charlene Concepcion as the parent representative to the Guam Education Board. The Speaker asked Mary Mantanane, Mary Gutierrez, Jim Reyes, and Peter Ada to come forward and testify before the committee.
- Ms. Mantanane testified in support of the nominee. She stated that Charlene will be an asset to the board. She believes that values that she has instilled in her children that she will carry it over to the board as parent representative. She believes that the nominee will work diligently to serve the community.
- Ms. Gutierrez stated that she supports the concept of a parent representative to serve on the board and the board member should reach out to the parent teacher organizations. She stated that she supports the nomination of Ms. Concepcion.
- Mr. Reyes testified in support of the nominee. He stated that she brings a positive demeanor to in addressing any problem or issue.
- Mr. Ada testified in support of the nominee. (Please note that his remarks were made during the confirmation of Mr. Kenneth Chargulaf to the Guam Education Board.)
- Speaker Won Pat, Ed.D. stated that the committee is in receipt of written testimonies in support of the nominee by Raquel Flores, Veronica M. Reyes, Eulgio S. Gumataotao, Governor Felix P. Camacho, Frank S. Blaz, and Karl Pangelinan. The written testimonies are appended to the Committee Report.
- Ms. Concepcion stated that she was very grateful to Governor Calvo for appointing her to the Guam Education Board. She stated that there is no greater calling than to serve your island, whatever the capacity you may be ask to serve. She acknowledged that she has over 21 years of government service, and 11 years with the legislature. She stated that she moved to the executive branch and worked with former Governor Camacho and GEDA for a couple of years. She stated that she decided to leave government service to pursue a military career. She pointed out that she has 7 kids, but this is not my only qualification to be on this board. She believes as a parent, education starts at home. She stated that she has instilled her children that importance of education and that you must pursue a college degree. She stated that she has shown her children the importance of community service. She stated that when things go wrong you cannot focus on the bad you have to move forward, you have to press ahead. She stated that her military background has made her mission oriented. She stressed that missions always come first and that we have look at all the aspects with everyone involved to accomplish the missions. She stated as a board member that she will be accountable to the children, she will be accountable to the senators because they confirmed her, she will be accountable to the Governor because he appointed her. She stated that she wants to bridge the gap between the Parent Teacher Association, the school, and the board. She shared her experiences as a parent trying to understand the school policies and how they affect my children's education. She stated that parents are not made aware of the changes of the school policies by GDOE and that they learn of it from the media. She stated that she wants the parent teacher congress and Superintendent to have an open dialogue and discuss what are the issues, what are the priorities, how can we address them. She noted that she has financial background that she can bring to the board. She concluded by stating that she is open to a collaborative effort with the other board members and the stakeholders in accomplishing what needs to be done for the children.

- Speaker Won Pat, Ed.D. asked the members of the committee if they had questions or statements for the nominee.
- Vice Chairperson Yamashita, Ph.D. thanked Ms. Concepcion for her willingness to serve. The Vice Chairperson appreciated the notion that we need to better in our communication and collaboration of our families. The Vice Chairperson appreciated also stated that policies need to be friendly, accessible, and understood by all of us. The Vice Chairperson appreciated the idea that sometimes all the compliance gets so muddled up that we forget about the kid, particularly in special-ed. The Vice Chairperson noted that she has a real problem that we do all this work to be in compliance that we forget that the kid has a soul, and that is just forgotten. The Vice Chairperson wished the nominee the best, and the way she is raising her children is holistic and that is something we need in our schools.
- -Senator Ada stated that he fully supports the appointment of Charlene Concepcion. The Senator thanked Charlene for stepping up to the plate to answer the Governor's call to serve in the board. The Senator expressed with all those years of service to the government, the years in at the Air Guard, the years as a mother, and now you want to be on the board, that is so admirable. The Senator thanked the nominee for still wanting to serve back in to the government but in a different capacity and ensuring that again all our children are well educated, well informed, the parents are well informed, and bridging that gap with communication. The Senator noted where the military discipline comes in because she always want to make sure that chain of command, or that information is free flowing both up and down and that everyone stays informed. The Senator further expressed that a well informed soldier or well informed air man is a trooper they take their orders and try to drive on. The Senator thanked the nominee for her service to our country as a veteran, and thank you for your service to the government.
- -Senator Respicio stated that he fully endorses the appointment of Charlene Concepcion. The Senator thanked the nominee for her service to our country and serving our community. The Senator acknowledged that the nominee stated that there is no greater calling or the highest form of public service is actual public service. The Senator stated these are different times and parents need to know what are the policies are and that the leadership of GDOE is addressing this by moving into social media, getting announcements through face book and through emails. The Senator appreciated that the nominee mentioned the Parent Teacher Association and how she will reach out and be their voice and that is the spirit of the law. The Senator noted that is the nominee's mission to reach out to those parents, because you are the voice. The Senator thanked her and that he fully supports her
- -Senator Aguon stated that he is in full support of the appointment of Charlene Concepcion. The Senator stated that the nominee had said everything correctly.
