

Senator Cruz and the members of the panel agreed to hear the testimony and have the committee report for Mr. Duenas completed for session. Senator Cruz noted that the Guam Parole Board currently does not have enough members for quorum.

Michelle Taitano, Guam Parole Board, stated that Mr. Duenas is courageous. Ms. Taitano stated that Mr. Duenas is willing to work on the parole board, that he is a good listener, reader of body language, and that he has the background as a counselor, which will help him make decisions.

Joana Margaret Blas, Mayor of Asan, stated that she has known Mr. Duenas since they were in school 45 years ago. Mayor Blas stated that Mr. Duenas is a compassionate and patient man that will make a strong addition to the parole board.
