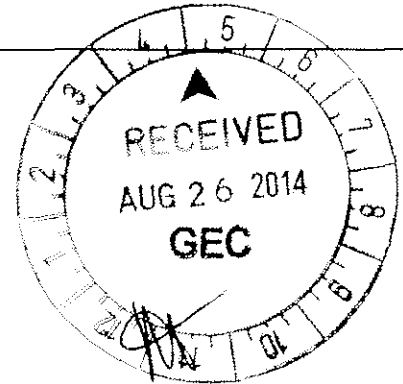



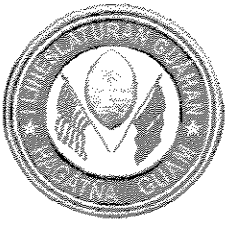

Limtiaco**, to serve as a Member of Hagåtña Restoration and Redevelopment Authority, Board of Commissioners, and whose appointment history is as follows:

- Appointed by I Maga'lahen Guåhan on May 12, 2014, for Five (5) years;
- Appointment packet forwarded to I Liheslatura on May 14, 2014;
- Appointment packet forwarded to this committee for public consideration on Friday, July 11, 2014.

II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 9:30 am.

Senator Barnes

Next ladies and gentlemen is the nomination for Mr. Rob S. Limtiaco, member to the Hagåtña Restoration and Redevelopment Authority. If there is anyone else wishing to speak on behalf of

Mr. Limtiaco they're more than welcome to sign in with the staff here to my right and if not they can send written testimonies to our office at 155 Hesler Place Hagåtña, Guam. Here to speak this morning to present oral testimony, we have from the Hagåtña Restoration and Redevelopment Authority and also the President of Department of Chamorro Affairs, Mr. Joseph Cameron and is there a Joseph Santos? Mr. Santos is here to say that he is just here to support and will not give testimony so I will go ahead and start with Mr. Cameron. Please state your name for the record and if you're here in support or not in support of the nominee

Mr. Cameron

(Speaks Chamorro) on the behalf of the Department of Chamorro Affairs and Hagåtña Restoration for which I have been Executive Director for the past going on 5 years. My name is Joseph Artero Cameron and I'm here in full support for the confirmation hearing of Mr. Rob S. Limtiaco to the Guam Restoration and Redevelopment Authority Board of Commissioners. The HRRRA as we use the acronym for, fully heartily supports Mr. Limtiaco. As the capital of Guam, Hagåtña is rich in culture steep in traditions and with the Pacific as part of its character and playground, having an individual such as Mr. Limtiaco with skill sets as a Commissioner will emphasize the sea faring, the recreation, and the Chamorro artesian concept. Mr. Limtiaco, we believe, would benefit to the Board of Commissioners of Hagåtña Restoration and Redevelopment Authority and his skill sets and for the name sake of the word Restoration again. On the behalf of the board of the Hagåtña Restoration and Redevelopment Authority, it supports the confirmation, all the members, support the confirmation of Rob Limtiaco to the Board of Commissioners. Si Yu'os Ma'ase!

Senator Barnes

Thank you! Also joining us this morning ladies and gentleman is my colleague, Senator Aline Yamashita. Thank you for joining us this morning and if there's no one else to speak on the behalf of Mr Limtiaco, I present Mr. Rob Limtiaco to speak on his appointment.

Mr. Limtiaco

Morning Senators, thank you! It's nice to be here. I was appointed by the Governor, as well as Mr. Cameron, and I am willing to help in any way that I can. I am still getting up to speed on

what many of the issues are but I think I can attend the meetings and learn a lot before giving my input.

Senator Barnes

I'm going to yield over to the Vice Speaker.

Vice Speaker Cruz

Thank you very much Madam Chair! I thought maybe you were going to come out to one of the cultural groups Mr. Limtiaco?

Mr. Limtiaco

Si Sigundo Blas, he was my first teacher in 1983.

Vice Speaker Cruz

We won't tell how long ago that was.

Mr. Limtiaco

It was a long, long, long time ago in a land far away. In fact Hagåtña was quite different at that time.

Vice Speaker Cruz

But I'm very happy to see that Rob is coming on to the Board. You guys still own quite a bit of property in Agana don't you?

Mr. Limtiaco

Our family, yes.

Vice Speaker Cruz

It'd be great to see that we properly rebuild the city and turn it in to something that we all can be proud of and so I think it's great to have someone who has an interest in this village. Sitting on that Board opposed to someone from the outside. I'm very happy to see Mr. Limtiaco on the Board. I have no other questions.

Senator Barnes

Si Yu'os Ma'ase, Mr. Vice Speaker. Senator Chris Duenas?

Senator Duenas

Si Yu'os Madam Chair. (speaks Chamorro) Mr. Limtiaco, you know I was looking through your packet, because I don't know you personally. I was looking through your packet and one thing jumped out at me because we had a hearing the other day with Pale' Eric and others for historical preservation. One of the things we spoke about was of course all of the current, I would call it a revival if you would, of restoration on the Lujan house. It's really moving throughout the island Inetnon Gef Pago down in Inalahan and all the other strong movements. I spoke about the fact that a lot of cultural groups have come before us because of the military buildup and brought concerns forward on historical locations. Mr. Perez, Kin Perez, really moved me with his testimony and how it pains him today whenever he drives through Agat and Santa Rita. You know, remembering and knowing the cultural significance of his family's property on navy base but what jumped at me was that you have been a cultural presenter at all local schools from 1983 to present and that's what really made me feel so good. One of the discussions we had while we are going to always prevail on the federal government and the department of defense to understand the cultural significance and the value of the lands that they occupy we also should lead by example and have our locations outside of the fence in pristine and preserved conditions for the education and the perpetuity of our culture for our children for generations to come. And so while you will be assuming the responsibilities under the sea faring portion as Joseph Cameron the director had mentioned, I would implore on you and ask your ideas. Do you see the same vision that many of us do? That when the museum is completed, because imbedded in its name is the educational portion of its design and what its designed to do I would ask you to commit yourself to that being the emphasis where everything would emulate out from there at the museum. So I would just ask for your thought on that and see if that was in line also with your vision.

Mr. Limtiaco

Thank you for that question. I couldn't agree with you more. I have done a lot of speaking at the schools and I just wanted to interject one thing, there's a difference between when I started to do that 32 years ago and to date. Thirty (30) years ago I could go in to a school and ask the kids do you know for example what the dukduk is and they all knew and recently I started to do presentation in the high schools none of the kids knew what that is. You know

and I know you know, in our culture, our children know God first from my perspective, but nothing is more important than our children. And if we are to revive our cultural practices it has to begin with them. So I think when you talk about the museum that is a static display which is wonderful. It can present a picture, an accurate picture if it's done well of our culture, but you have to combine that with a dynamic practice. I have got two special projects going on right now.. I'm finishing a small sailing canoe to teach younger kids and I'm talking about kids that are around 10 and below in age. If this practice is revived, we have to continue it and it has to begin with them and we have to have programs that encourage that and it has to be a long term. I know our culture tends to do a lot things all at once, but the real true test of any program is, does it last. I'm 53 years old Senators and if I'm lucky I have maybe 20 years left, 30 or 40 hopefully but I'm still strong now. I want to tell you something that my teacher Kunsegundo Blas he told me, "you know boy, knowledge never dies only people." You know we have to take some times the hard path in order to achieve something that is worthwhile and what I see is the children have an innocence and they're like sponges and they take it in and and so that has to be done carefully and that has to be done over time and it needs support. I'm looking forward to the opening of the museum. I would like to work closely with Siñot Cameron and I think there are a lot of ideas on things that have yet to be done.

Senator Duenas

That's the answer I was looking for. So I've met you now and just in closing madam Chair you know the Vice Speaker always dates himself, he's such a strong good looking man even though he always talks about his years. I graduated in 1985 and I'm sad that I missed one of your presentations given the fact that you've been doing them since 1983. I look forward to your confirmation. My final question for Joseph is would this complete the board? Thank you madam Chair.

Mr. Cameron

We have two vacancies and we're working on that. We actually wanted to work on looking at other residents that are still residents of Hagåtña and often times when folks are working and they can't pull away so we're still prodding along asking. But we definitely have a healthy quorum now to effectuate our meetings and we're very happy for that. I want to say Rob has more than generous to the Guam Museum. He has recently, earlier this year, donated phenomenal amount of photographs that shows the work he's done over the years and of course they're a natural to have in prosper but more importantly to put it to life. I'm very happy

that you used the word living because right now most museums are closing down because they're not living museums. Rob hit the nail right on its head when he says it has to be living. I was speaking to him earlier and he stated that he realized that if I don't see something that I don't really care for that's going to happen to Agana. I'm going to be outspoken I said then you'll have three actually it'll be you, me and especially Joe Santos who's behind me. We're pretty radical in the meetings. There are going to be some stuff that we're going to be doing that are not too popular for those who have encroached in Marine Drive who built their businesses near the ocean and its strictly Gov. Guam property. Some of them have gone through the zero lot line and there's going to be some moving and shaking to either have people start paying lease for properties that don't belong to them or they have to give up that property so that we can use it for things that Rob is talking about. If we're going to make Hagåtña living and he's going to be practicing that tradition in Hagåtña where it was very rich at one time, then things have to start rolling. I will leave that to Rob to speak on behalf as a practitioner because I'm not a practitioner. I can speak read and write Chamorro and I know the thoughts and the feelings but Rob is a wonderful addition to the Commissioners. Thank you!

Senator Barnes

Thank you Mr. Cameron and thank you Senator Duenas. Senator Yamashita for a comment or question?

Senator Yamashita

Thank you very much madam Chair and I apologize for being late, I thought we started at 9:30. Thank you Sir for your willingness to serve. I too don't know you but just listening to what you've said you've made my heart smile. It all does begin at the beginning. I truly hope that as you build in the support for our younger children, I know you said 10 and younger, I hope we start at birth that the expectation and the policies and the practices that you will be shaping and reformulating as a Commissioner will ensure that our families are welcome with their infants and toddlers and preschoolers because that's really the way to motivate and captivate. Every time somebody comes up in front of us this particular Board of Commissioners, I stress two things the accessibility issues need to be ensured that the ramps and the sidewalks have to be there. The answer can no longer be we can't afford it and we're at a point where we can't afford it and secondly surely the museum is a living entity will be brought to life especially with

Joseph at the table but we want to make sure that the arts are well and alive and that's all arts and so we have lots of laws and lots of rules and regulations and I look forward to you being at the table and sparking the conversations. Of course we have people like Monica Guzman there and it's like you have all kinds of allies and partners. I look forward to the good things and I am glad that you have one at the schools so that means that you do know our kids and you do see what needs to happen and then when appropriate times I hope that your voice can be heard at teacher preparation. I have great concerns about our teacher preparation programs today. How we are failing our students because our teachers are not being prepared in this millennium and that doesn't include our culture and our families, where we've been, where we are and where we need to get, that was a really long winded comment but I was very sincere in saying welcome and thank you! I do appreciate what you said, what you stand for and I look forward to supporting you. Thank you Madam Chair!

Senator Barnes

Thank you Senator Yamashita. Rob as I look at your resume here and as I look at your education that you have received from a man who loved his island and loved to teach and love to share and you wanting to give that same talent education that you have received from Kunsugundo Blas. I want to say Thank You, it really hurt my heart to hear you just say that thirty years ago if you asked a student what a dukduk was they'd say yes they knew what it was but today you talked to the students and their minds are well what is it? I don't know and you being here saying you're 53 years young and saying you want to teach and you want to continue to give, I want to say thank you! Not a very easy thing to do because like i said earlier it's a labor of love that you're going to have to give. I know that just hearing you speak and hearing what you're going to do and what you are going to work with, I hope full corporation of tradition about sea faring and incorporating what we need to continue to teach our children from what was taught to our elders and to folks like you, I just want to say that I'm hoping that our curriculum on the presentations that you give to the schools that maybe a special curriculum somewhere here in Hagåtña. Mr. Cameron, I want to thank you for sharing with us that you're still going to get the two members to the Hagåtña restoration board but more importantly that the prerequisite is having to be a resident of Hagåtña or a family business in Hagåtña would be best. I know it's not going to be an easy journey making some big changes but I do know that it will truly be a blessing for what you're going to bring to the table. I'm hoping that the children will engage and the families will engage because Hagåtña even before World War II was the main congregation for all our island residence. We always had a vision of

bringing it back to its original glory and with the support of this august body we're going to see that realization sooner than later. I want to say thank you! You've got my support. I will try my very best to get it on the next session agenda and if there's any comments that you would like to add please share it at this time.

Mr. Limtiaco

Oh no, I was just going to say that I'm not in this arena but I watch you guys a lot and I know your job is not easy. I'm looking forward to learning as well as. Kunsegundo, one of the things about him was he never stopped learning and I think that's really the success of anyone. Just keep learning!

Senator Barnes

Thank you very much! With that being said, again for all those who couldn't make it today if anyone would like to send us written testimonies to support Mr. Rob S.
