

COMMITTEE REPORT DIGEST

I. OVERVIEW

The appointment of **Athena C.G. Meno** to serve as Member of the Guam Educational Telecommunications Corporation (KGTF/PBS) Board of Trustees was executed by Governor Edward J.B. Calvo on July 2, 2014. The appointment packet was received by the Office of Speaker Judith T. Won Pat on July 7, 2014, and the appointment was subsequently referred to the Committee on General Government Operations and Cultural Affairs on the same day.

The Committee on General Government Operations and Cultural Affairs convened a Confirmation Hearing on Tuesday, July 22, 2014, at 6:00PM in the Guam Legislature Public Hearing Room. The hearing for the appointment of Athena C.G. Meno began at 6:01PM and ended at 6:14PM.

Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on July 14, 2014, and July 20, 2014, via email. Copies of the hearing notices are appended to the report.

II. TESTIMONY & DISCUSSION

Vice Speaker Benjamin J.F. Cruz stated public notification information for the public hearing and recognized individuals present before the Committee.

Mr. Darryl A. Taggerty, Station Manager for KGTF/PBS, read his written testimony (appended to the report) into the record.

Chairperson Cruz thanked Mr. Taggerty and motioned for the appointee to speak.

Athena C.G. Meno, Appointee, greeted the Committee and provided a brief narrative:

"As many of you know, I've served on the KGTF/PBS Board [of Trustees] for over a year and I served not only as a board member but also as the board treasurer. And [in my capacity as treasurer], I've had to serve obligations such as coming in on a biweekly basis to sign checks. Outside of [my] obligations [...] to the PBS Board, I have also assisted as a judge for the PBS writing competition and also volunteered to work during the PBS wine event. Although I've only served a year for [the] KGTF/PBS [Board], I still feel that there is much more that I can do to help out PBS and through that, help the community."

Chairperson Cruz stated that he recalls more individuals attending Ms. Meno first confirmation hearing last year and that he is pleased that she has been elected treasurer in the short year that she has been on the KGTF/PBS Board. He commented that Ms. Meno does not "fall too far from the tree with being very responsible fiscally," and inquired about her involvement with the University of Guam theater group.

Ms. Meno informed Chairperson Cruz that she is double majoring in English Literature and Theater and minoring in Women and Gender Studies.

Chairperson Cruz asked if Ms. Meno participated with recent theater productions.

Ms. Meno said that she was involved in the production of the play "Pagat".

Chairperson Cruz asked Mr. Taggerty when the play will air on PBS.

Mr. Taggerty replied that the play will air on Channel 12.2, the station's second channel, "within a month or so". He added that the station is "just trying to work out the cable and GTA/DOCOMO rights and equipment installation."

Chairperson Cruz asked why Ms. Meno why she did not give Mr. Taggerty adequate notice to arrange for the filming of the play.

Ms. Meno replied, "As far as I knew, we had planning underway."

Chairperson Cruz stated that the play was a "phenomenal production" and regrets that it had such a short run. He added that he has emailed Mr. Taggerty, insisting that PBS should broadcast the production and that he hopes the play is sufficiently promoted before it airs to get the widest possible coverage, to which **Mr. Taggerty** agreed.

Chairperson Cruz recognized his colleagues, Committee Vice Chairperson Senator Tina Muña Barnes, Senator Thomas C. Ada and Senator Frank B. Aguon, Jr.

Senator Tina Muña Barnes thanked Chairperson Cruz, and thanked Ms. Meno for her willingness to serve and lauded her membership on the board as a "great asset to KGTF". She mentioned that her advocacy and support for KGTF stems from her many years of volunteering with KGTF, and stated that individuals like Ms. Meno "who really make a difference." She added that she would like to see Ms. Meno continue her work with the Guam Environmental Protection Agency/iRecycle Program for which she interned in 2012, the UOG English department's tutoring program for which she is currently a tutor, and the UOG theater. She concluded that she is pleased that Ms. Meno is eager to serve and that she supports her appointment.

Senator Thomas C. Ada stated that he is really impressed with Ms. Meno's self-confidence and her involvement in the community, and that she would be a good addition to the KGTF/PBS Board of Trustees. He concluded his remarks, addressing Ms. Meno, by saying:

"I can understand now why [Chairperson Cruz] was saying that he was impressed during your first public hearing, but I want to commend you for that self-confidence that you have, and you're very articulate, and you have qualities that I wish I had. You certainly have my support."

Senator Frank B. Aguon, Jr. thanked Chairperson Cruz and extended his congratulations to Ms. Meno for her acceptance of her appointment. He stated that volunteerism and public service do not come without challenges, and Ms. Meno, as board treasurer, is familiar with financial challenges, such as "being able to go out there and pursue some private sector donation and contributions that you can keep the program as aggressive as it is today." He noted Ms. Meno's pursuit of higher learning and her volunteer work with Relay for Life, Coastal Clean-up, and the Micronesian History Conference, and commended her for not only striving to improve herself but also her community. He continued:

"On behalf of recognizing your generation for stepping up and extending yourself as [a] public servant in this capacity, I commend you for doing that, and you certainly have my support and endorsement."

Chairperson Cruz thanked his colleagues and stated that Ms. Meno's appointment will be on the next legislative session.

III. FINDINGS AND RECOMMENDATIONS

The Committee on General Government Operations and Cultural Affairs hereby reports out the nomination of Athena C.G. Meno to serve as Member of the Guam Educational Telecommunications Corporation (KGTF/PBS) Board of Trustees for a term of four years, beginning on July 1, 2014, to June 30, 2018, with the recommendation TO TO CONFIDM.






