

and the plethora of both your experiences and expertise that you both have are quite interesting. I'm glad that you take time out of both your busy schedules to volunteer your time to work closely with the Guam Housing Corporation and I'm really humbled by the fact that you continue to want to work to try to find new opportunities for our working class families to make their dream come true. So, to the both of you, thank you very much. Now, let me yield to my colleague, Senator Duenas.

Senator Chris Duenas: I only have one question, but first of all congratulations for all the work that you've been doing throughout the years and to Mr. Benavente as well. The synergies that have been created are really impressive to me, having come from that area for only a year and a half. A lot of these are the dreams that a lot of the staff and board members have thought about and dreamed about for years. A lot of action has been happening under Mr. Benavente's term. With you Commissioners supporting that effort, I'm sure that is what's been able to carry it through. Since both of you have extensive financial background, I just wanted to tap on some of the visions you may see in furthering these synergies. Particularly with Chamorro Land Trust, Department of Land Management and GHURA, in terms of future prospects of projects for affordable housing and maybe just in the financing area, just some of your thoughts. Other than that, great job to date and I look forward to be able to vote for you now sitting in this Legislature, but just wanted to throw that out as a general question. Thank you Madam Chair.

Sandra F. Santos: Well, I'm a social worker, so my passion, as the folks at Guam Housing know, is availability of funds and is geared towards the working poor or the middle income class folks. They don't make enough to walk into a bank and get the dream house that they want and can afford for their family and then you've got the lower end where they are just barely, here or there. I want to be able to work with these folks and see how we can fix that. When you have land with Chamorro Land Trust and they end up building substandard homes, so we want to be able to assist them in this area. Especially if it's not developed properly... I was there, so I want to be able to help families like these.

Glenn A. Meno: I appreciate your encouragement to myself and Sandra. To answer your question as best as I can, in as far as the vision is to increase and more so the availability and just spread the word even more on Guam Housing Corporation basically as a last resort for a financing mechanism. That's really crucial, and I don't wanna rock the boat or anything, but it's really bothersome to me as one of the board members to read in the print media or see on TV for some of the folks not having a high value of Guam Housing Corporation and its mission. Its primary mandate is to provide affordable financing mechanism because it is a last resort. It's gotta be clearly understood that when you go to a bank or a credit union, and there's an adverse

action letter, we are the last resort. So, it's very bothersome for me to hear that folks are being critical of that. So I think they need to be clear, that we are their last resort to provide that last resort. It's not like the mainland where you have other financing options. So, this is a non-traditional but it's very crucial. Especially as a local, as a Chamorro, it's something that I wanna keep in the forefront. As a board member, I'm gonna be very steadfast in keeping that intact. I'm learning a lot everyday from these sharp folks and one of the things that I've learned that we have properties that have been sitting there for a long time and turning that into a source to increase the availability for affordable housing. I'm pleased to hear that they are working on this. The big thing now is the physical challenge, not only here, but everywhere including the U.S. It's nice to hear that there are things on the operational side that are being done to enhance the revenue to continue their mandate to provide affordable housing.

Senator Chris Duenas: I'm even more pleased with voting on your nominations. That vision is the core and I agree with you. Criticism is unfounded... you've done so many wonderful things as to those who fall through the cracks and also really carrying the key initiative. Keeping Guam special that way because we all know, that's the biggest problem we have here, but it's that middle road that need this assistance. Thank you, Madam Chair.

Senator Muna Barnes: You're welcome! Speaker Ben, do you have any comments or questions?

Speaker Ben Pangelinan: Just a couple of things, but first of all, congratulations on your appointment and reappointment to Guam Housing. I certainly believe in the mission of the corporation and certainly support efforts to find programs and opportunities to meet the mission of the GHC. I just wanted to ask, is there anything you would like to see expand in regards to what the corporation, you would like to see them be able to see them do and do more of or do new things within its core mission that's not being pursued that you would like to push?

Glenn A. Meno: While Sandra is contemplating, I can tell you right now that based on the meetings, and again as a board member, one that is very self conscious of getting into the micro managing aspect, and I say that with all due respect, but to answer your question Senator Pangelinan, I can tell you that there is a number of items that are in process ok, now one of my, the things that I brought to the table which they are addressing is the dissemination of information on who, you know, the function of the Guam Housing Corporation, ok, and they are doing what they can, Guam housing Corporation can only do what they are dealt with so I'm sure that there'd be more efficacy in getting the word out. So to answer your question, a lot

of stuff is in process, they have addressed the marketing, they've done some for lack of a better word, an outreach with realtors for example to make them aware, that's still not any fault of theirs, it's just the function of the resources that they have, it's not like they have a full marketing group that can address the print media, radio and TV. They are doing what they can. That would help if it's a collective effort within government overall that they have some sort of link or if there is an interest if you will with Guam Housing Corporation, in other words what they do has an effect on who we are and our function. But I think just getting the word out even more. I know I am still hearing some questions about who and what Guam Housing Corporation but again I get back to the core of Guam Housing Corporation so if the word isn't going out enough, not saying that they're not doing enough, I see that they are and remember they have resources to work with, limited. But the more the word is out, then people are going to again, be more aware of an option, a last resort option, that they have realizing that if they go through the traditional real estate financing route that it isn't a dead end street.

Speaker Ben Pangelinan: Sandra?

Sandra F. Santos: Gosh... um, I had to take a moment to think about that but they're already doing such a great job that when I do attend the meetings and we discuss different opportunities for to explore different areas Mr. Benavente and his crew already take care of that so, with me I know we're not here to do the commercial, we aren't here to compete with commercial banks, we are not here to cross over into GHURA's lane, they can certainly use more monies to fund the different homeowners or applicants that come through their doors. That's always the biggest hurdle is we don't have any funding right now, we don't enough monies to although you are approved, it does happen eventually that homeowner or that applicant is going to own a home that he or she wants to purchase but it's all about we don't have enough funds to loan out. The probability of increasing their funds or borrowing more from the different banks off-island. That is what I'd like to see for Guam Housing.

Speaker Ben Pangelinan: Again I certainly agree with you that in this particular case, the old adage of it takes money to make money, can be no, can not be truer than any other situation. You have to the capital to lend, to be able to generate your margins in order to fund your operations. In that respect, are you satisfied with the direction that the Corporation has taken or is taking to ensure that the allocation of the money towards operation based upon, is as tight as it can be or is as frugal as it can be to ensure that more money is made available for borrowing versus operational cost.

Sandra F. Santos: Yes and I smile because I always look back at the staff. But during the meetings I would argue do we need this, do you need to do this, do you need to do that. They've actually went from 60-70 some employees down to I think 40 or 26, 20, wow, so they have really tightened down the hatches and they've, they're operating and they're working it and when we are in those meetings, we look at the financial report ever month and they are doing a great job.

Martin C. Benavente: We have a lot of single positions. We don't have duplicates. Each person carries either 1 or 2 responsibilities or sometimes 3 responsibilities. We have what we call the one man but in our case a lot of one woman operations.

Speaker Ben Pangelinan: No wonder why you can function that well with 26 employees. If you had 26 men you'd be shut down.

Martin C. Benavente: I'm glad you said that sir.

Sandra F. Santos: And I look back at these folks because when I'm in the meetings, I give them grief. If I get a call from an applicant who knows I'm on the board and I have to get a call from them, if I have to hear it they're going to hear it and I'm like you know, they are right on it. I had a mali's sister call me and says you're on and says look, let them do what they need to do but at the same time, I'm making that call to say what's going on with this applicant, and then so and so and so is not here but they're working it. So it just goes to show that although it's hard times, it's tough time economically, it doesn't mean we're not, or they're not going to ask for additional staffing, they're going to continue to do that because as our community grows so does the work. So eventually they're going to have to start asking for more people and I'd certainly like to support that because I wouldn't want to be doing the job of 10 different positions. It's tough. You don't want them to burn out but they're doing a great job right now.

Speaker Ben Pangelinan: Thank you madam chair and si Yu'os ma'ase for your responses.

Martin C. Benavente: Madam Chair can I just add on one thing before we get too far from it? Caesar is GHURA's loss and Guam Housing's gain so he's with us now.

Senator Chris Duenas: Congratulations Caesar. That was GHURA's loss.

Martin C. Benavente: Yes it was and he's fantastic. The other thing is that I wanted to say that since I started at Guam Housing we only missed one board meeting and that was just because

there was just one person, lack of quorum. But we've had you know before I came in, not to criticize anybody but we had 2 board meetings in a year, since we've been in and these people are part of this, it's almost like perfect attendance in board of directors meetings. So, they're good.

Senator Muna Barnes: Thank you Mr. Benavente. Senator Ada.

Senator Tony Ada: Thank you Madam Chair. I don't have any questions but I'd just like to thank the both of you for your past service to Guam Housing and also for your willingness to continue being on the board with Guam Housing and to work with the staff and management there. I think that with all of you guys working together you guys would be able to bring good things to the people of Guam especially those that are in need that turn to you guys as their last resort looking for every single way that you can to be able to help them in realize that dream of homeownership. Hopefully that we'll be able to put more of our families into homes and I know that with you guys continuing your service working with the staff and management that it can be possible, and all things are possible. So, thank you and you have my support.

Senator Muna Barnes: Si Yu'os ma'åse' Senator Ada. As I share a lot of the same sentiments of my colleagues up here and wanting to thank you again for your volunteer work cause, I don't know you guys are getting paid still right? Is it still \$50? But you know in these tough economic times, and just trying to make a difference, we do extend our thank you to the both of you. Based on national media and what's been going on with the sequestration and all the domino effects that will happen because that may come and take place, and I just said might, I'm praying if it didn't start already based because we are where America's day begins. Is there any of the programs that you are doing today that may be cut that you may be aware of? You two? Sure?

Martin C. Benavente: If you are not aware of it yet but I know that you are. But the rest of the committee, we have been pushing for this local housing trust fund and I think that is our answer to whatever the federal government does or does not do. It gives up a grown up approach of handling our own problems too and doing housing programs that we can afford ourselves. And I say that because with this committee's help, under your leadership senator and speaker ben, you've created the trust fund already. All that we need to do now in the next few weeks or months is fund it. And we suggested funding sources for the trust fund. 40 other states are doing it. We learned our lesson from Hawaii. We watched them and asked them how they fund their projects and we learned from that. It's not something that we invented but I think that if you can help us with that, that would kind of open the doors so that things can

happen faster. People can get their loans faster. They can build faster. The faster they build the more we stimulate the economy and that is what we are looking at. While everybody is having problems, people are coming to our offices, young couples are still saying can't help us build, so if we can help them build, then they can continue building, it's averaging something like 300 homes a year so far, if we can continue pushing for that, maybe up it a little bit by helping them. The down payment assistance program Speaker Pangelinan has been a great help. 55 people have benefited from that. And that's how we do it, because without that, people would have never met that threshold. They would just fall right below it. And then the other things that we're trying to help with is of course removing the systems development charge those are things that affect building homes. So, in the future we will be asking for your help to eliminate some of these problems and also add on some resources so that the board members can go full scale. Rest assured that we're just not out there spending everything we have. But we have done a good job in the last few years, Mary will show you records if you want to see a copy of that. But when we say do a good job that means we have been issuing loans to the people that need them. And what was pictured before as, 14million good or whatever, we've spent a lot of that already giving people loans, not necessarily feeding the Guam Housing employees with their, adding more people that we don't need. So that's where we are at and I'm hoping that you continue that support because this committee has been fantastic to your committee has been great because you have helped us remove these things a lot of these things that we've did in the last few years, senators, these are things that we didn't invent them. We didn't need a rocket scientist to figure it out. They were just properties that belonged to the people that were thrown away. The teacher's housing that was renovated with GHURA and the Sagan linayan with GHURA and many more. We want to continue trying to get more people into the Chamorro Land Trust to help our people their homes. There are a lot of things that we are on top of and I'm so glad that we have a very supportive committee and board of directors also.

Senator Muna Barnes: Any added other comments from any of you?

Speaker Ben Pangelinan: Yes, just one final comment and that is to thank Guam Housing Corporation. I think when we revamped the first time home-owners assistance program, that was one of the most efficient implementation going from policy to practice. The bill was introduced, the bill was passed, rules and regulations were set up, and loans were issued all in a matter of twelve months. I've never seen, in my time, legislation that sets up a program or revamps a program that was implemented in a timely fashion. It has to do with the cooperation of Guam Housing Corporation and I also want to give them credit and thank them.

Mr. Martin Benavente: It has a lot to do with the good staff. Just to make that clear.

I say that with a lot of concern, because in the next few months there maybe some changes that are made that will really tap into us needing to be creative and knowingly that we are going to be getting less. I just want to say Thank You and truly from my heart, Dangko'lo Na Si Yu'os Ma'åse for continuing to volunteer. I know that Guam Housing has a team that is willing to work closely with this legislative body and the administration to work as one team. To the staff out there, again based on the concerns coming our way, that we need to get more creative to find those resources without taking from the general fund. I'm gonna need that support and that expertise and brain power from all of you. We will get your packet on the March session agenda. I've asked my staff to work on this and work closely with my colleagues to get this done. We will work closely with our colleagues here to get a unanimous support for you. Again, on behalf of the 32nd Guam Legislature and this Committee, I want to thank you both for stepping up to the plate and volunteering for the next 6 years.
