- 3. Appointment packet forwarded to this Committee for public hearing on April 22, 2014.

II. SUMMARY OF TESTIMONY & DISCUSSION

(a) Summary

Acting Chairman Cruz: The Committee on Appropriations, Public Debt, Legal Affairs, Retirement, Public Parks, Recreation, Historic Preservation, and Land will now come to order. Due to the untimely passing of the chairman of this committee, I have been asked by Senator Ben last week to conduct this public hearing. He left a whole set of questions that I am supposed to ask and you'll know that they were from him when I ask them. I figured I should follow through with the instructions that were given to me to conduct this public hearing in spite of the island being in a state of mourning. With that, I would like to begin this public hearing and invite the nominees up, or would you like to speak first Joe?

(b) Testimonies & Discussion

Mr. Joe Quinata: Good morning. Buenas, Vice Chair and Senators. I have a written testimony I'd like to read. [Read verbatim from written testimony]

Acting Chairman Cruz: Thank you. Chairman Pangelinan was very aware of the fact that you had not had a quorum for a while and that the reason he wanted to make sure these nominees went through. We thank the governor for sending down this list of nominees. It was Senator ben's desire that the hearing be conducted as soon as possible. I know there was one hearing scheduled for a few months ago that was unfortunately rescheduled, but last week when I offered to assist, he very graciously insisted, but I had to the public hearings yesterday for the Chamorro Land Trust and now his other pet project, Historic Preservation. If I could just have the four nominees join, Mr. Quinata. I'm sure gentleman will not object if I ask Ms. Duenas to be the first one to address the panel. Please proceed.

Rebecca Duenas: Dear Senators, my name is Rebecca Duenas. [Read verbatim from written testimony]

Acting Chairman Cruz: First, I want to thank you for your ten years of service on the board, but more importantly, I am glad we started with you, because you have given us a great background, from which we are going to be able to do this. That was just by chance. Amongst the men, why don't I start with your current chairman, Mike.

Mr. Michael Makio: Hafa adai, members of the committee. Thank you very much for entertaining our nominations today. I would like to first start by extending your committee and

the legislature our condolences on the passing of Senator Pangelinan. He was a colleague and a friend for many years and a leader for many years. I understand and we all understand the gap the legislature and the island is facing today, so our condolences.

I have some notes that I have written out, and it is essentially in the support of the nominations for the board members that are presented to you today in addition to my own nomination. As stated, we have Rebecca Duenas, representing Culture, Joaquin Perez, representing Planning, Father Eric Forbes, representing History, and Richard Olmo representing Archaeology. I know each of these people, these potential board members, I know them all personally, I worked with them all, both on commissions and boards and community projects and educational projects as well. I am able to speak a little bit about each of them from a personal perspective.

Starting with Rebecca Duenas, what I can tell you is that she is a very strong advocate for education for historic preservation education, which is very important. She is a lifetime educator herself. I think the other strength that she brings to the Trust, frankly which you may have heard from her testimony is that she has a very strong financial intuition and financial background and that's the kind of thing we need in both the organizations because we are dealing with funds that are intended for the public benefit, so we have to make sure that those are expended well. Rebecca is a very good advocate for accountability and just making sure there are wide decisions made to any actions that our boards take that affect public funds.

Påle' Eric Forbes is one of the most respected historians on the island. I think he follows in the tradition of Tony Palomo who is probably one of my greatest idols. I am really glad to see that Påle' Eric's projects with regard to history really make history accessible. It is not just something that happens in a classroom, but it is something that there is public outreach. There are adults that are involved in the history of the island. There are Chamorros that are all over the United States and abroad who are now able to access our history through the programs that Påle' Eric is working on right now. I think he is really doing a lot to take history to the next level as making it a priority for adults and families and professionals so that they can start to incorporate Guam's history into their activities.

Joaquin Perez. His background with regard to the federal government is amazing and even right now as we are going through studies and feedback and dialogue about the Supplemental Environmental Impact Statement, and that entire activity, his guidance and input has been wonderful. He knows intuitively and instinctively how reactions are going to be presented. He understands how the strategy of how information should be passed back and forth. It has been wonderful. From a planning perspective, the man is a book. He has so much knowledge about the villages, about Hagåtña, about the history of World War II, all these histories play such a large role in historic preservation activities. I am just astounded that one person can have that much information.

And then we have Richard Olmo who is one of the most respected archeologists on the island right now. I think that, not just in the past, but right now, he is a lifelong educator. He had dedicated a lot of his time and effort to the University of Guam. He has had a lot of face-to-face interaction with a lot of students that will be historic preservationist moving forward. I think he is really helping to shape, that next generation of preservationists. Again, I think these four

nominees are wonderful examples of the kind of leadership we were hoping to take us to the next levels to both of the boards.

There are two sets of goals that I wanted to quickly run through with you by you folks. One is a set of goals that I think we as a group are hoping to accomplish over the next few months and years. For the Guam Historic Preservation Review Board, our goals include, raising awareness, raising funding and division programs for historic sites on the bases, on military installations, and on federal properties. So we really want to become as proactive we can be. We have been quite proactive, but to continue that effort and may expand it. There is really productive dialogue between the federal government and our local preservations for historic preservation. We also want to expand the support mechanisms for the historic preservation office to deal with the proposed build up impacts. I think with the circumstances and some of the outcomes that were established from the initial Programmatic Agreement and discussion that we're dealing with now, those programs are different. We need to sit back now and look at really what the benefits are that the military buildup can bring to the island under this proposed arrangement now.

We talked about this before, about having financial support, for the state historic preservation office and expertise and technical support from the National Park service to really go back and revisit all of the opportunities and to really make sure we are really getting the best deal or he best relationship out of the interaction between the two groups. We also want to make sure that Guam's preservation plan is updated. So the preservation plan, again in a moment I'll describe why it's different than the strategic preservation plan, the preservation plan is the map that the Guam Historic Preservation Review Board and the Historic Preservation Office use for their programs. There has to be a direct correlation between those projects and programs that are identified by the Guam preservation plan and the actual activities that are undertaken with the Department of Parks and Recreation, National Parks services, and the historic resources division at parks and rec.

We want to complete the establishment of the procedures for challenges to the SHPO offices and findings. This is actually a mandate by law. We had several mandates by law. We have had multiple meetings and tried to get the public feedback to rap up that process. We also want to work with the both the legislature and executive division and executive offices to fill the vacancies in this historic resource division staff. So that is the status of our preservation office. There are several vacancies up there right now and I think particularly with the activities that may be involved with the military buildup that they are fully staffed and as capable as they can be.

We also want to have expanded outreach and interaction with the historic research division. I think that because they are a government of Guam agency and because they have very specific mandates, I think that they tend to focus on the completion of that work. I think that we would like to see that there is more interaction with the public so there is a better understanding of what the State Historic Preservation Office does. Also acceleration of the listing of historic sites on the National and Guam Registrars. We have established a good pace, but quite frankly, I would like to accelerate that. There are a lot of other properties that are potentially in danger. We want to make sure that those properties are properly listed and then they get protections and the access to finances for restoration work.

Moving then to the Guam Preservation Trust goals, we want to accelerate the restoration work for the historic districts for Inarajan and Hagåtña. We did complete the historic district revitalization plan for Inarajan, which was a wonderful program. I think a lot of members of the legislature also participated and went out to our public meetings as we gathered that information. What it did was, it reinforced the Inarajan community what historic preservation could do for them. It also helps us as the Trust and the Board for the Trust too, organize the programs for restoration for the actual village itself. Since the completion of the historical revitalization program at Inarajan, I think we are up to 5 homes and we probably have 3 more on the drawing boards for restoration projects, and that activity, that historical revitalization plan is now being emulated for the village of Umatac. That is another point which was too continue the historic revitalization plans and go through the remainder of the villages. So Umatac is next.

One of our other goals is to complete the master plan for the Atantano Property, which members of the board worked to get that 162 acres to the Trust for our preservation and conservation area. It was a huge opportunity for us. Our archeological sites on that property, wetlands, which we think are great because we are in the conservation programs. Most people would hear wetlands and run away. We hear wetlands and we get excited. There are medicinal plants there. There are trails, plants, and just a lot of opportunities for preservation and conservation in that area. We are actually working with the American Institutes of Guam chapter to work through the master plan itself and get trails and start to work on how that program will be developed. We want to complete the registration of the Manenggon concentration camp to the National Registrar. This effort has been going on for quite awhile.

Mr. Vice Chair, you'll notice that task has been reassigned and was moved away Historic Preservation Office and taken to he Guam Preservation Trust, again the State Historical Preservation Office inundated with the work that they have go to do. So we saw an opportunity to move it along a lot faster and we are able to do that now by shifting that program over to the Guam Preservation Trust, we have completed all of the work for the second issuance for the five year strategic plan, this is for the Guam Preservation Trust, and again we will make a presentation to the legislature formally and then show you folks how the projects that are established in the strategic plan are linked to the programs and funds we are expending. We are very happy about this.

We are developing a preservation curriculum for secondary and post secondary schools, so again, making sure that all this information that we are gathering now is properly conveyed completely educating and arming our next generation of preservationists. There are wonderful opportunities for historical preservationists to showcase, to be showcased in economic programs, educational programs, tourism programs, and professional programs. We are working now on restoration of several buildings that can actually be repurposed for new uses and so we are keeping those historic properties in the fabric or our day-to-day lives.

Last but not least, is to complete restoration of the legislature building, which I think is very dear to a lot of people's hearts. We have been ready, the Trust has been ready with their little piece of their work, so we are told, and are very hopeful, we light candles every night, that the legislature will be able to give us the go signal on the rest of the program. I hope that background is helpful

to you folks and I have to tell you that I think this is a really wonderful group that we have gathered together. I really feel that this group is before you right now is able to take historic preservation to the next level. I mean there is a different set of skills; it's a different group of skill sets, different group of players involved, and those perspectives will all be very productive in getting us to the next level of preservation.

Acting Chairman Cruz: Thank you very much, I'm glad that we went in that order, and I was going to say that as we were going in that order that we should have a *saina* to speak next, but the *saina* at the table is in a brown robe.

Påle' Eric Forbes: Si Yu'os Ma'ase Mr. Vice Chairman. Buenas dias todus. I'll keep my remarks very short, because I think Rebecca and Mike have done an excellent job at articulating so many important things. It is a group of people with their various backgrounds and expertise that are linked in common a passion for this. As busy as we are, I think we can say that we are all very happy and thrilled to be nominated to serve on this very extremely important body. It has been awhile since I have been in the loop. My term expired in 2007 and I knew I was retiring as superior and I knew I would take a year or more, it happened to be two years off, so I didn't seek membership again, and I am very happy to accept this nomination, and to ask for your confirmation, because I believe in the work, and it is an excellent body, and excellent staff, on both sides, and members are needed, and the work needs to get done, and I am happy to be involved, and I am open to any questions.

Acting Chairman Cruz: And we are very happy that you decided to come back on because I don't know if any other person I would say is a historian currently on island, with all of the publications that you have made, and so we are very happy to have your name, and we will go down. Why don't we do it alphabetically, so I don't insult him by saying we'll go by age? We'll do Mr. Olmo. He told me he has three pages [referring to Mr. Perez].

Mr. Richard Olmo: Buenas. Hafa adai. Thank you very much for the opportunity to speak this morning. I had submitted some written testimony last night, before the prior meeting that was postponed, and I don't have much to add to that. I'll just give you a brief rundown of my background. I have been on island since 1992 and always take my civic responsibility very seriously and as a consequence was involved with the museum board back in the '90s and after that was fortunate enough to be appointed to the Historic Preservation Board and that's been really rewarding for me, I keep learning, the whole time that I have been on island, and hopefully, I am in a position to kind of return that to the community by performing on the board, I have been involved in Archaeology and that is my particular specialty. I have also been at the University and have, as mentioned previously, been engaged with many students and have tried to fire them up about their role and responsibility with respect to preserving their own culture.

I am an outsider, and I can do what I can do, but the reigns have to be taken by people who are here from the start and I believe that the initiatives that we are moving forward with in terms of trying educate, starting in the high schools and then into the university. Students who themselves will come into our chairs and also come into the position of the offices of the Historic Preservation Office and the Preservation Trust Office that these are fine initiatives and I'm glad we are doing it at this time. I'm getting along in my youth and a lot of our Archeologists are and

we need to pass the baton on. I think we cannot continue to have the outsider, which I am, coming in and grappling in and assessing with and promoting the cultural history of the island. I humbly ask you to accept my confirmation for the Board.

Acting Chairman Cruz: Though you may think you are an outsider, the 22 years of public service devoted to Guam is greatly appreciated and the education you imparted to the young people is your greatest contribution and hopefully there are going to be archeologist and if there was one thing that I would have wanted to be was an archeologist. I've been through most archeological digs throughout the world and that's my big love.

Mr. Richard Olmo: It's not too late.

Acting Chairman Cruz: I know, but I'm even longer in the youth than you are. So it'll be a waste of education. Mr. Perez?

Mr. Joaquin Perez: You know, when I was first asked to join the Trust, I was very hesitant. I really wanted to join the Cockpit Board, but then I was told that I wouldn't be able to fight my rooster. So I said, "Ok, we will go with this one." What really convinced me to want to serve on this Board was the announcement of the release of the SEIS. I really hope that the fact that it was released on Good Friday was not because it's the next Passion of the Chamorro people. Because with all the talk about all the economic benefits and the speed of light that we move with in attracting all these announcement of rosy futures and all the money that's going to come in. We seem to forget that there's a part of history that makes us who we are. If that thing disappears then nothing is worth it. I was actually asked not by the Front Office, but people directly related to the Trust, if I was interested in serving. I told them, "I would think about it."

In April of this year, I was asked to go to Sumay grounds for a mass for the Sumay residents. Påle' Eric was there. After the mass, I went around and I eavesdropped and I like to eavesdrop. I eavesdropped on a conversation of younger people, what really surprised me was how so little these people knew of the significance of where we were standing. My sisters and I went to the cemetery to visit our grandfather and uncles' graves. There were no young people there, only old people were there. They were there visiting and cleaning up the graves of all the relatives. No young people. All of a sudden it dawned on me that something is wrong with this scene.

Påle' Eric came up to me and gave the homily. The one thing that I urge you people from the relatives of the people of Sumay is to never forget the real meaning of Sumay and I don't mean putting in water and soaking something. The real meaning of Sumay was the actual formation of the real Chamorro heritage and Chamorro culture. It's all over the place, but even with the presence of the Chamorro culture the young people did not pay attention to it. I think that's the most important responsibility of this Trust.

We can rebuild and preserve the Legislative building. A lot of people don't know the significance of that building. Everybody says it's the Legislature, but it first started as Island Court and people don't know who the judges were in that court. It went from Island Court, to the Superior Court, to the Legislature. How many people know that the state funeral for Senator Gene Ramsey was held in that building and the state funeral for the late Governor Ricky

Bordallo started in that building? That's the importance and the young people don't know this and that's really a shame. Once they grow up and become older and I'm not that old, don't believe him. Once we're gone, you know, once BJ is gone, who's going to bring it back? Who's going to remind these kids where they came from, those people, those buildings is what made us really the Chamorro people. What made it beautiful.

And so that day, let me read that one paragraph. On April 5th this year I attended Mass at the site of the original Our Lady of Guadalupe Church in Sumay. A lot of people don't realize that was the first church on Guam. Not necessarily the Cathedral. And the Statue of Our Lady of Guadalupe was done in Pago Bay. But it even predates Our Lady of Camarin. That particular statue was destroyed during World War II. But how many of the young people know that? Under any other circumstances, I will not enter Naval Base. I really resent the fact that that property, a lot of that property used to belong to my grandparents. And we can discuss it here, we can discuss all day how I feel how they took it. You know, a lot of people will, you'll hear it, it was stolen. And if you look at the Organic Act and history, and we'll get into that later on, not in this setting. It is painful to visit lands which my ancestors called home and which was hijacked immediately after the reoccupation of Guam in 1945. It's even more painful that I can only visit their graves at the invitation of the base commander. You can't get on there if you don't, if you're not invited. They won't let you into the cemetery if you're not invited. And that to me is just—it's a sin!

After the mass I told you about this: eavesdropping. And it seems there was a total disinterest among the young people. They weren't interested. I walk around, I walk around that cemetery to look at the names on the headstones and the years they died and the years they were born but no young kids went in there. That was, that really bothered me. Pale Eric gave the homily that day. After giving a detailed history of the Church in Sumay, he closed by urging the congregation never to forget the real meaning of Sumay—on that day, I wondered if anyone understood the real meaning of Pale Eric's homily, and how many would remember it beyond the Naval Base gates and its brand new bright green fences. That fence never existed; only now.

Before in the 50's and 60's, I used to remember we could drive even through, all the way down through SRF, no gate. Now, it's more difficult to get in there than to get into Guam Memorial Hospital. That was the day I really decided to accept the invitation to join the Trust. I want to thank you for permitting this time before you.

ben Pangelinan was an extremely good friend of mine. And I can tell you there are very few champions of the Chamorro culture like ben: the intensity and passion. I'll miss him as a friend and as a relative. We cannot, though in my mind we cannot expect others, others that come here carpetbaggers, our colonizers, and Benjamin don't tell I said that. Not that, not those who are sent here on two-year stints of duty. We have to do it ourselves and if we don't do it, the greatest sin we will have is, you know when we say the [inaudible] in Church, "Forgive me for the sins I have committed and that which I have not committed or I fail to do." Whatever duties I failed to do, this is the sin we would commit if we don't do this. And so I've been to two meetings with these guys and everybody speaks. The knowledge vested in this board is unbelievable. And I've served on many commissions for the Government of Guam. I worked for the government—local and federal—fifty years. This is one group I really enjoy working with. Thank you.

Acting Chairman Cruz: Thank you very much, Mr. Perez. And yes, I do know the importance of the beginning of the Legislature Hall. I got run over against parental instructions to watch the court in session when I was five years old.

Joaquin Perez: You also did your confirmation there.

Acting Chairman Cruz: Yes, there's going to be a special closet that we're going to name after me at that Hall.

Joaquin Perez: [Jokes] Who encouraged you to come out of there?

Acting Chairman Cruz: We'll go forward and these are the questions that, and you'll know when I read it, it may be my voice that's saying it but you will be able to feel the passion of Senator ben. These are his questions that he wanted to ask members of the board: Did the board submit testimony in response to the SEIS. What were some of your main concerns with regard to the preservation and protection of cultural sites and landscapes? One example, in the Cultural Resources section of the Draft SEIS, it is outlined that there are potential direct adverse impacts to 20 historic properties—National Register of Historic Places eligible archaeological sites from construction and potential indirect adverse effects to three National Register of Historic Places site. The mitigation offered is to develop and implement a "Range Mitigation Plan" which will identify measures to avoid, minimize, and mitigate in and direct adverse effects to historic properties. Have there been any preliminary discussions that the Guam Preservation Trust and Guam Historic Preservation Review Board has been involved with Regarding the Range mitigation Plan and how will you ensure GPT/GHPR Board is able to fully participate in the development of this plan is required? Whoever wants to...

Mr. Michael Makio: Well, what I'll do is start sort of give a quick overview, Joe and Kin may also want to chime in as well as the other board members. We did immediately call together a committee to review the SEIS impacts on the historic properties and historic content in the areas that would be affected. We know that exactly what you just read that they, in the document itself, they state outright that there will be impacts to these historic properties. I think the overall feeling of the Committee was just that the message of how these elements would be mitigated and contained was very broad. They lack detail. So again, in our committee there was an actual, formal presentation of comments for the SEIS. It went down a week and a half ago? About a week and a half ago, you're right. So we went through the committee members, we went through several readings. Dave Lotz, who is also a board member, was also very instrumental in that review. And again we wanted to get into specific details. You don't want to, we don't want to stay broad. I think part of the purpose of having this level of expertise is to get into the nitty gritty of what is the mitigation step. Will it work? Will it happen? How will it be funded? We get into those kinds of questions. And those were contained in the response provided to the SEIS. One, of the other things that has happened is that in the initial Programmatic Agreement exercise, the Guam Preservation Trust was not, did not sign the agreement, and was not a signatory. However, in our committee meetings, we decided that we should go back and inquire. Knock on the door again, sort of paraphrasing Kin here. Knock on the door again and say this is a little different exercise. We want to come back to the table. And obviously, there was some adversarial feeling at the time of the Programmatic Agreement. We were protecting Pagat at the

time but now that we're going down a different path with the military buildup. Again, we want to become part of that signatory group. So, a formal request was sent over to the federal government. And there is ongoing discussions right now with Parks and Recreation and the State Historic Preservation Office to bring that invitation, our self-invitation, all the way to fruition and get us back into that program. Regardless, if we are allowed to become a signatory to the Agreement or not, I think, I know that we're going to continue to advocate for State Historic properties.

One of the things I alluded to earlier was, again, broad terms you find all over the SEIS. That's just you know, "We will help you folks gain funding." Well, okay now we're dealing with a more defined, a smaller program. Let's talk about funding, let's talk about, you know actual programs. Let's talk about personal expertise we need on the island in order to deal with the impacts of the military buildup. So those kinds of questions have been forwarded to them and I think we can make a copy of our formal comments available to the Legislature for their review. I think they might have been provided through Senator ben's office. I believe so but we'll verify.

Mr. Joaquin Perez: You know, I've, I'm not against the military buildup. You can put 25,000 marines on this island and we could possibly handle them. However, I don't think we as a community, as a Chamorro community have done enough to explore alternatives to what's being proposed. In 1970, and I guess this sort of dates me, in 1970, the Navy announced plans to condemn Cetti Bay and Sella Bay for an ammunition pier. And they wanted to not only do that, they wanted to close Route 2 at times, during, when they were unloading ammunition here. So, ammunition, so they can take the ammunition from Cetti Bay or Sella Bay or wherever they built the wharf into Naval Magazine with no obstructive traffic. Governor Camacho at that time, Governor Carlos Camacho didn't, in discussions with the Legislature, they said no. This can't happen. And he appointed a committee of local people to talk with the Navy. The Navy was willing to discuss and that's how, because they were going to turn over Hotel Wharf, they need to build another ammunition pier to handle bigger ships and we want Cetti Bay and Sella Bay. They appointed this Committee and we sat down with the Navy and looked at alternatives. You know instead of taking Cetti, why don't you put the ammunition pier and put it up in Tarague? Or NCS Double Reef? Or wherever but don't touch Sella and Cetti. We sat down with Navy and we gave them our ideas. And they studied and they started to study putting the ammo pier right at Naval Station, a place that we now call Kilo Wharf. And they did studies, they did wind tunnel studies in San Francisco and they hired Bechtel and Bechtel came around and yeah this is totally feasible. And we saved Sella and Cetti.

With the Firing Range the big issue in this SEIS, with the Firing Range there was no other alternative. The only alternative they are looking at is, Naval Magazine, Naval Magazine, Pagat, and Northwest Field. My question is that, why not take it completely off-island. To Tinian, which would bring economic benefits to Tinian. And leave Northwest Field alone because there are, we've identified bundles of historic sites up there. And you not only have that, you will have the environment that will totally change. There used to be a nice fruit bat colony down at Naval Station on Orote point. And there's no way to deny it, I used to go down there and shoot fruit bats. There is no longer any fruit bat down there because of the development. The fruit bats down at Andersen, they didn't disappear because of the hunters. When we go shoot fruit bats we take only what we need, what we can eat. When the B-52s and helicopters fly they, they don't,

there's not, they don't pick and choose their targets. The fruit bats, particularly, the "chamek," the small, the baby fruit bat, they lose their sense of hearing, they lose their sense of navigation. We used to go up there and find these little animals, the baby fruit bats, on the bottom of the tree because they were dead. They couldn't navigate, they couldn't eat. Development and open, a lot of noise. Fruit bats don't like people. And what I'm saying and what I'm asking. And we tried to do that. And we brought up the issue. I brought up the issue separately. But we discussed a lot of things in the Trust in reference to this thing and I'm still, I'm still not satisfied that, that the firing range has to be built on Northwest Field. The only reason, the military, the navy gives for building at Northwest Field is that to build it on Tinian is cost prohibitive. I don't think the United States government is very cost conscious on a lot of things. So, why do we, why do we put up with the [inaudible]? I'm saying we should still fight it.

Acting Chairman Cruz: And this next question again was written by Senator ben and he and I disagreed on this one issue. But I'll read the question as he posed it: It is my understanding that the existing Department of Administration (DOA) building falls within the Hagåtña Historic District, which is on both the Guam and National Register of Historic Places. I'm also aware that the effort to replicate the Palacio at the Plaza de Esplana and a new design team was solicited to assess renovations and removal of portions of the DOA building. Did this require Board action? Isn't this building now protected since it is both on local and federal registers? I raise the concern that we will be funding the destruction or removal of an already existing historical structure, Department of Administration for the replica construction of a building that was destroyed during 1944 US Military bombardment on Guam, the Palacio." Any comments?

Mr. Joe Quinata: Vice Chair, just a point of information, the Department of Administration building is not listed in the local or national register of historic places.

Acting Chairman Cruz: Ok, great. That was his question. Because as many of you may have suffered for the last 15 years, I've been asking for the rebuilding of the Palacio. I would have no problem with getting rid of that one wing if not both wings.

Mr. Michael Makio: Let me just add in for all, a part of the reason why we are doing this is exactly as you described it's a step, that we're trying to understand what's possible and what's not possible. There were no foregone conclusions about what will happen. We really want to know what's possible. I'm going to speak as an architect for a moment. I really struggle with the Department of Administration building. I've been through it quite recently. It's a scary building. I don't know how in good conscience we can have people in there. It's quite dangerous. If you went down the list of International Building Code requirements, you'll get 50% fails on almost everything in that building. I'm a preservationist at heart and wherever it's possible I would like repurpose buildings and I have a history of doing that and I won't knock a building down if we don't have to. I try to use and renovate them, rehabilitate them wherever possible, even if they're not historic in nature. With that building, I would have to look back...

What you started to talk about was the historic district. In my perspective, the Department of Administration is probably one of the biggest challenges to the historic district, because of the design on the building and it turns its back to the Plaza de Espana. It was very typical of the

design philosophy of that period of time and it really does not help the historic district. The historic district outlines right up to but excludes the Department of Administration building. We have to verify that, what we can do. From the community planning and the physical planning of the Hagåtña Master plan that I was a part of that entire process. We looked at the building in a lot of different ways.

Speaking now as a citizen, I really think that there are better things that we can consider for that space that might have longer-term benefits for the entire village. I know that this is debatable, but this is just a personal opinion of an architect.

Acting Chairman Cruz: The next question, "Is there an MOU for the Administration for the Plaza? If there is, what is the status of that MOU?"

Mr. Joe Quinata: For point of information, we don't have an MOU with the Plaza. We requested the Legislature if we can be able to assist in overseeing and maintaining the Plaza. We never had any formal MOU.

Acting Chairman Cruz: "What criteria were used when considering who or what project will be funded by GPT? Is there a different set of criteria the Board uses for grants instead of sponsorships?"

Mr. Michael Makio: In terms of the expending for grants, we have the strategic plan that's basically our guiding document. In there, there are half a dozen different categories of preservation projects that we undertake. As a group, the Board will sit down and try and find an equitable distribution. We know that some kinds of work are just by their nature more expensive. So we know that the rehabilitation work is usually more expensive than the work that's related to oral histories as an example. They just nationally fall into their own scale. With regard to the sponsorship programs, the sponsorship programs allow a little bit of flexibility. But we still have to meet the mandates that are in the formation of the trust. There's a physical mandate for facilities and there are activities related to histories and oral histories, cultural traditions and cultural properties. Those items are all outlined. In order for sponsorship to happen they still have to make that threshold and still comply with our mandates. It's essentially a different approach to the work. With sponsorship, we don't have necessarily direct control over the project. We are providing funding. Sometimes technical expertise to assist a program, but it's really being spearheaded by another entity and we're using the funding to help expedite the project.

Acting Chairman Cruz: "How does the Board decide what the most important mandates to fund are or where to concentrate funding on every year? Is there a requirement to fund a percentage of specific types of projects? If not, should there be an annual requirement to breakdown funding for the different mandates of the trust?"

Mr. Joe Quinata: I would have to say that the requirements for what gets funded and which goes first is really indicated at the strategic plan and the strategic plan itself, just the making of the strategic plan involves the different stakeholders – the community. We have over close to 100 stakeholders, individuals, organizations that take part in this strategic plan. They provide the

Trust with the ideas that would advance preservation here on Guam. Those ideas get put into a focus group meeting and it gets reviewed and it goes through the Board and the priorities are developed at the Board level. With the strategic plan that we develop this year for the next 5 years, you're going to see the priorities. You're going to see the 3 areas of concerns by the community.

Mr. Richard Olmo: I want to say that I've been involved with the last two strategic plans that we've put together. I've always been impressed with how the public has come forward. They're willing to participate and how open the Trust has been to all the voices that are out there. There's been no question in my mind that we are not really fully integrating the needs that the public determines with the importance that we ourselves as professionals place on the projects. We are really taking these two things together. When we finally decide what we're going to be putting our energies into each year.

Mr. Joe Quinata: Also I provided two documents to the Senators. One document really is almost like a snippet of what you'll be seeing at the strategic plan. It'll tell you who we are and what we've done for the last 5 years and where we are heading to for the next 5 years. This is all generated and presented by the community. The other document is a year-to-year snippet that dissects our activities and provides you with the elements that goes with what we've done for that year.

Acting Chairman Cruz: Thank you very much for both of us and Senator Duenas said they're very well balanced. I have a few more questions, "Is there a limit as to how many of the same or similar projects the Board will fund as an example, Amot related funding request has increased in the last year. Will you continue to fund more amot as oppose to something like site resurveys? Is GPT's money better spent on smaller projects like the amot project brochures vs site re-surveys?"

Mr. Joe Quinata: Again, if you refer to our strategic plan, we do have the amot preservation objectives there. That is provided for our community if they would like to partner with Guam Preservation Trust. Again, a lot of these projects are not fully funded by the Guam Preservation Trust. We seek other funds, we look for other partners to help move a lot of these projects through. Our strategic plan provides that guidance.

Acting Chairman Cruz: 1 think the Senator was trying to get across is if the money is better spent in the Site Reef surveys than on the Amot projects?

Mr. Michael Makio: We've had that exact discussion as well. There were several amot grant applications that were received and went through and we did not accept all of them. I think that the part of the interest in the amot program was that it had become a popular topic locally. So internationally we would see so many grant applications come in, but we never took our eye of the other responsibilities that were mandated by law. We tried to always maintain that distribution of funding and attention across all of the programs that we work with. We've never stopped that rehabilitation; we've never stopped surveying properties and sites. We've never stopped the ethnographies and oral histories. They were all moving and sometimes the proportions changes and it adjusts itself. Towards the end of a typical fiscal year, you'll see that

they all balance out to what we initially programmed or budgeted for. I don't think that this level of interest in the åmot programs is really going to continue. I think that we've done a lot to strengthen that program and again your attention naturally goes to the next areas that need attention.

Acting Chairman Cruz: Next question, when solicitations are sent out, what is the process the board follows? When solicitations are received, how does the Board decide which entity or firm to select? Is it based on the type of project? i.e. appraisal selections may be based on experience with historical property assessments instead of whatever other.

Mr. Michael Makio: Yes, whatever...I'll start, so yeah when those, those sort of solicitations are issued, yeah we have to look at professionalism, we have to look at history of success with a particular partner. We look at expenses as well. I mean, a lot of times that will tell us the level of detail a potential partner will give us about a program they are advocating. The level of detail will tell us how prepared they are and how much they know about their own procedures. And a lot of us have been looking at these kinds of solicitations for several years, some of us decades. So you do get an intuitive sense this group is more prepared than other groups. Or this group has history of success. Or this other group has an energy level or access to certain technical expertise that will make it more successful than others.

Acting Chairman Cruz: As it relates to archaeological site surveys, how important are site resurveys and what function do they serve for the mandate of the trust?

Mr. Michael Makio: They are, well, I'll, let me start and I'll hand it over to the archaeologist. So obviously, the archaeological programs are part of our mandate. Again, at the beginning of the year, with the strategic plan, we go back and we take a look at some times, we look at, we partner with various, at times University of Hawaii, the University of Guam programs. There's actually a program for archaeological research and survey for the Donald property which we've just received. We've also allocated a certain amount of our funding to surveys for residential programs for people that are going for homes and there may be some concern that they're on a historically relevant property. There may be historic content there so we anticipate to provide in some funding in that process as well. That is also need driven. Alright, so we have to assess the. We meet with the applicants, for example if they are a homeowner, then we'll meet with them and you know, we'll have to ask them pressing questions, like "Why is this something you need assistance with? Why is this something you can't fund in some other method?" Once it makes it past that benchmark, then again we go back and assist with that funding. There is also a mandate for archaeological surveys with the Guam Historic, with the State Historic Preservation Office and Parks and Recreation. I think that, you know again, they have a limited amount of funding in that organization that they've got to spread across several program areas as well. So, you know, so it...there's never enough money to do all the things you want to do.

Mr. Richard Olmo: Can 1 just jump in for a second?

Acting Chairman Cruz: Make sure the light is on.

Mr. Richard Olmo: Should I get closer, is that better? Okay, so the situation I've seen certainly is that it's a different level that we're working with when we're operating out of the trust. And that is, it's been more investigation of sites as opposed to a resurvey. I wasn't sure how'd you using resurvey, were the sites were known sites but then we only knew things from the surface and as a consequence of the work that the trust engaged in terms of granting monies to archaeologists we were able to see what was going on below the surface and then have a better understanding of those sites. With Atantano, the situation where it also has been surveyed but we'll be looking again at a more detailed look at the surface in that area if we're going to develop some type of long range project to both conserve the area but use it in an educational vein.

Mr. Joe Quinata: Yeah, in regards to archaeology, to me there are two types. One is directed archaeology that the trust, whoever wants to go in and do a study, a study that would give us information into Guam's past. Then you have the other archaeology that is driven by development and that's where the trust do not assist the businesses but we do assist residentials that do come in and otherwise cannot afford an archaeologist to come in and do a survey of their property before they build. That's a requirement with building permits. And we provide that assistance to them, not a full assistance. They also have to look for another partner for funding source. We provide matching funds for that assistance. But again looking at two types, we talked about Atantano, that's a directed archaeology project. We've done that before with Ritidian and the University of Guam, where that was a directed archaeology. Our goal was to locate an old church that was written and documented that it was there. And we did find that church and we documented that church. So that's a directed archaeology. Thank you.

Acting Chairman Cruz: This is getting eerie because the questions actually that he sent me last week are segueing perfectly. Is it common practice for GPT to fund or partially fund archaeological surveys for private citizens? What is the reasoning behind funding or partially funding? How often do they do these types of requests come before the board?

Mr. Joe Quinata: It is part of our program in the archaeology goal mandates. And it is, we get an average of maybe one or two a year from residents. And most of these request come in from the historic district of Inarajan because everything there is required. In archaeology, the significance and then again, the level of assistance, like I said earlier, is that we provide matching. You know, I was able to do some research work and was able to see that cost can be included in the construction cost. I've visited a couple banks to see how they can be able to incorporate that into the construction cost and their response is that they could do it, if it was in the mandates. If it was in the law, that is not identified cost. If we can be able to do that, that would be great. They can borrow money against archaeology work that can be included in construction cost.

Acting Chairman Cruz: The last question, I thank everybody for their patience but I'm trying to get through this. But I'm trying to make sure that I'm...If a grant request is received for more than \$5,000 how does the board approach approving that request? Does the board automatically dismiss any request if said request is at an amount greater than \$5,000? If not, what steps does the board take next?

Mr. Joe Quinata: Currently, there is a moratorium on the grants over \$5,000. But we've been able to help folks to overcome...we've really never turned down people coming in for grants not unless it doesn't fall within our mandates. And we do, we do breakdown these projects into different phases. That way we can look into phase one that reaches \$5,000 and they get a partner to help with that. And then phase two, we break it down into phases so that we can be able to see that project go through.

Acting Chairman Cruz: Those are all the...those are all the questions Senator ben asked that I asked. And as I've mentioned earlier, both Senator Tina and I have been approached about whether or not the Historic Preservation Trust or SHPO or somebody was watching the construction of Tiyan Highway. So I'll let her ask the question, since she was in the discussion too.

Senator Muna Barnes: Thank you Mr. Chair. I guess to follow up on that concern. There was excavations and bulldozing being done in the Tiyan parkway. And according to what was told, there was an archaeologist there based on the mandate of the law but there was a lot of findings, a lot of historic findings, even to the fact, were they were saying there were ancient, fossilized clams that were full shape, that were being taken away. And then after being taken away, they were being sold on the internet. And we did refer the constituent to several places. First Parks and Rec, and to check with you folks. But more importantly, if they could give us something in writing so that we could be able to follow it through. And my take is, based on some of the presentations and mandates you work with, if something of that nature were to come to you, how would you mitigate that, how would you work that? It was an artisan that came to us and he was very concerned because his take was if you find something, you have to, there are several things that need to be done. And then you have to return it—it belongs to the people. Well, not to anybody else but the people.

Mr. Michael Makio: Actually, so, I think the key entity in, with regards to this type of situation would actually be the State Historic Preservation Office and the Guam Historic Preservation Review Board and the Department of Parks and Recreation. By law, there's a couple of things, they carry the mandate that has to deal with the protection of historic research. They have legal authorizations and powers to enforce and to assist with the prosecution. Again, there's never enough money and resources. If we could find a way to increase that funding so that they can staff in a more healthy way, then we may have a more robust program. I know there were several archeological surveys that were prepared related to the Airport expansion. The Tiyan Parkway, I also know that there were archeological surveys done with that work. I'm not too familiar with it. Because there were federal monies involved in those they were mandated to go through the Department of Interior's Section 106. Section 106 process to make sure that any historic properties to make sure there's a good effort to try and identify those. It's disturbing that there was someone who feels there was historic content that was inappropriately handled.

Senator Muna Barnes: Sorry, it was told to us that there was not just one it was plenty.

Mr. Michael Makio: It becomes a legal matter, so if that person is able to provide any information, I believe both the Department of Park and Recreation and the Police Department and the Attorney General's Office become involved immediately. There are usually monitors

that are required by the Territorial Archeologist and the Historic Preservation office and they normally inspect when their schedules allow them to inspect and observe. Many times it requires certain reports to be submitted back to their office so they can validate that their work is going on appropriately. If there's a concern that something is being done inappropriately then we would need to turn it over to the authorities for investigation and prosecution.

Mr. Joe Quinata: Yeah, I know Vice Chair had informed me about that this morning. So I immediately go to our staff to look into it. I just got a text that the shell in question is over at MARC at the University of Guam. I will get back to you and give you photos and send you digitals.

Senator Muna Barnes: Thank you and Mr. Chair, I just want to say for the record that I guess on behalf of the Speaker that she apologizes and she was here earlier and had several presentations so that's the hard part of being Senator. You'll have to be at two or three places at one time. She shares her support and I just want to say for the record that as I look at the panel here and the volunteerism that they continue to give the labor of love from the heart. Most of you if not have come back to continue to give up your time, I just want to say Un Dangkulu Na Si Yu'os Ma'ase. Because it's not easy and I just want to say to you Uncle Kin Perez, reading your testimony and you had a statement in Chamorro saying that we should never forget and we should come together and continue to work and it all relates to the preservation and the protection and the conservation as who we are as a people. Last night I saw Father Eric and I reminded him about a hearing on July 11th and I forgot to tell him about the hearing here this morning at 9, but more importantly you guys have the passion and the love and the heart and for the record I will support you. I know that the good Chair will put your nominations out and if it could be today, I would say let's do it. But I know it takes time, but I want to say thank you and you got my support and I know there are a lot of projects that still need to be worked on. The protection and even if you know that it may not be yours, you're still concerned and you're going to help facilitate that. That makes a big difference. Thank you Mr. Chair. I support you guys, God bless you.

Senator Duenas: Thank you Mr. Chair, I don't think it's eerie. I think by the training and the faith of Påle' Eric I think that ben's spirit is here. I think that yesterday, the panel that we had before us for Land Management and the Department of Chamorro in terms of Ancestral Lands and Chamorro Land Trust, was an amazing group of appointees. Today, we have not been disappointed once again. It's a various team panel and I want to say thank you for your service. I join the retiring speaker in thanking you also. I don't have any questions, but maybe my comment may elicit comment, particularly from Tun Kin and his comment. You know for me, you're right Kin. That's why I spend a lot of time with my dad, I have so much oral history within me, because of what my father has passed down to me. I get to visit the place where I understand where you're coming from for a long time we didn't before. The story that he told me about the war time and how Tun Pepe and the other farmers... I pass by that football field up at what we call Tiyan now and all that area and sometimes when I go to a party with the Pedangs, they talk about my grandfather and all the richness and history of that place and how even the Japanese left them alone during the war, because they were the ones providing the food. They were the farmers and this is the history that was embedded to me from my dad and I continue to talk to him about the old days so that I can have that within me so that I can pass it on to my son

and our grandchildren as well. But I guess maybe what I would say is notwithstanding the fact that whatever happens in the final record of decisions and those issues. I listen to groups that have come before us and this panel embodies what their spirit is about, We Are Guahan and the others that are seeking to preserve our future and history for future generations. What I hear especially when it comes to federal properties is access and the opportunity to continue to have that to preserve our culture. But then I look at the work that you do and you're doing now and all the tremendous efforts that are put forward and maybe it's us that are leading by example with all these properties and these thousands and thousands of acres that we have right now. You know Mike when you're talking about the hundred some acres, even me a third of my property is wetlands and I celebrate that. I know I'll never build on that area, I love my property and I love my house. I know it'll always be sa'kati, jungle and I know there's catfish down there and I like it because that's what I want on my land. But you know the thing is, is that I want to continue to support this effort and this Board because the more and more properties that we develop like this and the more and more work we do it teaches. Sometimes these federal they do training because their military and sometimes we need to train them by example and by all of our historical preservation and the cultural center that's being built. My dream now for that museum when it's done is to be the repository and the place to go from that says here's the history of Guam because it's an educational center and let's go out there and feel it and see it and taste it. When we do within our community, we're the ones to tell our military, now open up our gates, you don't like you do in Hawaii and other places and bases that they have, we now will go in and teach you how to preserve those locations too so we can be a partnership here. I think it's the work that you're doing today, Pale and all you guys to the archeologist and everything else. That we shine and we show and we care about our own property that we have historically and we have a hammer if you will or a bat or whatever tool, give me a Chamorro tool, Påle'.

Påle' Eric Forbes: Fusiños.

Senator Duenas: I'm sorry to get on my soap box, but that's my passion and it's just looking at the compilation here and I'm just so proud and invigorated and that's just how I feel and I really want to see all this stuff happen for us. Because we can go there every day now, but the future is to hold those guys accountable too and say we want you to live by our standards too because we take care of our own. Thank you, Mr. Chairman.

Acting Chairman Cruz: I thank the panel for your service some of you decades and your willingness to continue to serve on this Board. We will get this nomination to the floor for confirmation at the earliest possible date. Thank you and you're excused. I understand there were other people that wished to talk and so we'll invite them up. Any other person wishing to testify? Thank you very much Mr. Blas. No? Anybody wish to speak?

Thank you very much and this hearing is adjourned.

III. FINDINGS & RECOMMENDATIONS

The Committee on Appropriations, Public Debt, Legal Affairs, Retirement, Public Parks, Recreation, Historic Preservation and Land hereby reports out the nomination of Mr. Richard K. Olmo to serve as the Archaeologist Representative to the Guam Historic Preservation Review

Some \$4.3 million in projects to protect and preserve Guam's historical and traditional heritage were completed from 2007 to 2012. About half of these funds were dedicated to saving existing historical sites and structures. About the Guam Preservation Trust

The Guam Preservation Trust (GPT) was created as a nonprofit public corporation in 1990 by Public Law 20-151, and is governed by a Board of Directors. It is dedicated to preserving Guam's historic sites and culture as well as educating the public about those issues. Although primarily tasked with restoring historic structures, which are listed in the Guam Register of Historic Places and/or the National Register of Historic Places, GPT also funds various types of cultural preservation projects. The Board of Directors consists of 10 members representing 5 fields of expertise: Archaeology, Architecture, Chamorro Culture, History and Planning. There are two members in each field (primary and alternate capacities). Board members appointed by the Governor and approved by the Legislature to the Historic Review Board of the Guam Department of Parks and Recreation, automatically sit on the Trust Board.

Its mandated purposes are:

- -To seek outside grants and donations:
- -To acquire title to threatened Guam properties for the preservation of their historical value, whether in fee simple, by leasehold, or by easement, and whether through donation, transfer, dedication or purchase;
- -To award grants for:

I. Historic Property Documentation and Register Nomination

This program assists in the documentation of the historic significance of places, objects, structures, buildings, and sites, and in the formal process for registration and, nomination for listing on the Guam and/or National Register of Historic Places.

II. Public Interpretation and Presentation

This program provides assistance in the interpretation and presentation of one or more historic properties for public appreciation and enjoyment.

III. Architectural History

This program focuses on architectural research and documentation of historic structures.

IV. Repair, Restoration or Renovation of Historic Buildings and Structures

This program assists owners of historic properties or interested community organizations in the care and treatment of deteriorating historic structures and buildings.

V. Ethnography and Oral History

This program provides assistance for research on and documentation of historic places and the traditional cultural values, and practices that give these places, values, and practices significance. The research methods used in this program are those of ethnography and oral history.

VI. Archival Research

This program provides assistance in archival research that focuses on specific historic places or broad patterns of events significant in Guam's history

VII. Archaeological Research

This program provides assistance in archaeological research, with the exception of archaeology that is required by law to complete compliance obligations imposed in development review and permitting processes.

VIII. Miscellaneous

The miscellaneous program provides for potential consideration of proposals that can be justified according to the purposes of GPT but which do not fall within the programs listed.

PROGRESS IN FY 2013

COMMUNITY PARTNERSHIPS

The Guam Preservation **Trust** has partnered with over 50 public and private organizations and individuals from the community to oversee more than 17 grants and projects to accomplish *proposed outcomes* for this year. All have been successful in their respective delivery to the community for their benefit and appreciation.

During Fiscal Year 2013, the Guam Preservation Trust Board of Directors appropriated a total of about \$473,000 to fund all grants and projects, an increase compared to last year's total of approximately \$182,365. The 17 grants and projects have contributed an estimated total of \$750,000 in kind and cash contributions as our partners' share to advance preservation on Guam.






REVENUES & EXPENDITURES

The Guam Preservation Trust receives most of its revenues from the Building Permit Fees administered by the Guam Department of Public Works. For Fiscal Year 2013, a total of \$1,181,790 was collected from building permit fees, which resulted in a slight increase of 7.9% from the 2012 total of \$1,094,760. The increase is a result of increase in construction activity on Guam for that period as well as the revamping of permit collection and control procedures as pointed out by the Public Auditor's Performance Audit of the Guam Department of Public Works Building Permits and Inspection Section conducted in 2011.

Interest income on investments increased between FY2013 and FY2012. In FY2013, \$87,735 was earned on interest income, compared to \$23,368 in FY2012. The 275,4% increase is due to the increase in cash equivalents and investment accounts. For FY2012, there was a change in the Asset Allocation Rates of the Trust Investment Policy. The new Asset Allocation rates are 80% investment on cash equivalents and 20% on equity investments. For FY2013, the Trust had an unrealized loss of \$74,381 compared to an unrealized gain of \$120,158 in FY2012.

PDS appeals termination of telecommunications contract

PACIFIC Data Systems Inc. (PDS) has filed an appeal with the Office of Public Accountability after the General Services Agency fired the company for a breach of contract.

According to documents filed with the OPA. PDS was awarded the bid to install telecommunication services to government agencies including the Guam Fire Department and the Department of Public Health and Social Services. During the delivery of those services. Teleguam Holdings LLC GTA filed a motion alleging contempt of court against PDS and GSA related to the services.

PDS wrote in its appeal that "it was decided by PDS and GSA that during the pendency of this motion, all work on the installation of the new voice services should be suspended."

The bid specified that the services be completed within 150 days after PDS received the purchase order.

The appellant, PDS, stated that on April 22, the company provided an update to GSA regarding the status of the installations for the voice services and requested GSA confinn a revised schedule of service installation. GSA had yet to reply to the request, the appellant wrote.

request, the appellant wrote.

A month later, on May 30, GSA issued default notices to PDS regarding the telecommunications services and last month, on June 10, PDS was

sent a termination memorandum. "The GSA memo stated that the PDS services were being terminated based on PDS's failure to timely deliver the voice services specified under these (purchase orders)." appeal documents said.

The next day, PDS requested that GSA reconsider the termination in a letter to the agency, including notification justifying its position that PDS had not failed to meet the deadline. Instead, PDS wrote that the deadline for delivery of the services had not lapsed because of previous excusable delays, including the motion filed by GTA regarding the services.

PDS wrote that the termination of the company's services by GSA was "invalid, without justification and an illegal act."

"The facts show that PDS was complying with the terms of the procurement related to the delivery of the voice services covered by these GSA purchase orders." documents state. "Rather than being late. PDS was actually ahead of the delivery timeline under the allowed procurement."

GSA acting Chief Procurement Officer Robert Koro sent a memo to the OPA in connection with the appeals filed by PDS on June 25. Koro wrote that an upfront hearing with the hearing office would be valuable in resolving the issue.

The OPA responded and a status hearing is scheduled for Wednesday. July 9 before the hearing office.

Class-action voting discrimination appeal to be heard

FOR the first time, the Unites States Ninth Circuit Court of Appeals will hear oral arguments on Guam in August and the historic event will be open to the public.

Chief Judge Frances
Tydingco-Gatewood of the
District Court of Guam,
announced that on Aug. 27
at 10 a.m. the Ninth Circuit
judges will hear arguments on
one criminal and two civil cases
in the fourth-floor courtroom
of the District Court of Guam
courthouse.

According to the Tydingco-Gatewood, no hearings of the Court of Appeals have ever been conducted on Guam.

The proceeding will be streamed on the Internet for viewing by the public and media will be allowed to record, broadcast and take still photographs provided they will file an application beforehand.

According to the Ninth Circuit Court calendar, each side will be given 15 minutes to present their arguments during the proceedings.

The court, however, did not disclose which circuit judges will be coming to hear the historic court proceedings.
