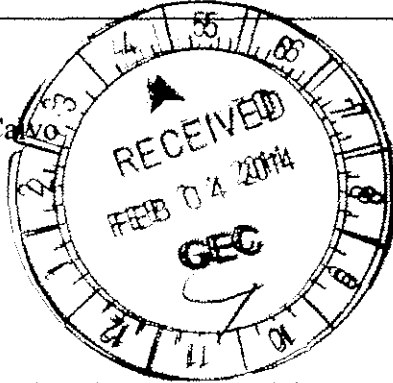



#### II. SUMMARY OF TESTIMONY & DISCUSSION

The public hearing was Called-to-Order at 4:02pm.

I like to also recognize those who have sign in or here but don't wish to provide any oral testimony but sign in support of the appointee. **Ms. Amy Sue Santos :** ( Please see attached written testimony)

**Chairman Senator Dennis Rodriguez, Jr.:** Thank you very much Ms. Amy Sue and like to my indulgence of my good colleagues, I didn't recognized them the Vice Chair Senator Tony Ada, thank you very much & Senator Chris Duenas , Thank you for joining us. So Mr. Jared and so I can call on Ms. Reyna Calvo

**Mr. Jared Ivre:** My name is Jared and here to offer my testimony in support to Ms. Hope Pangelinan appointment to the Guam Board of Social Worker. I'm currently Hope's Supervisor as the Medical Social Work Supervisor as the Medical Social Services at Medical of the Pacific so I have the daily opportunity to work with her and see her on the front lines as she serves the patients, clients and families of our hospice families as well as those with significant debilitating illness. Our profession as social work is rooted, values and ethics and I'm sure in your research you know what some are those are. You know Hope is really and all of my years of work and I been a social worker for close to 20 years and I do have a master on social work degree and I advice students and employee on a variety of social work setting. And Hope really thus bring with her a spirit energy and commitment to the values that we hold very dear and our social work profession, and service and her commitment to social justice and special the dignity of the person and the importance of human relationship which probably I would say is one of her greatest attributes and qualities and her interaction & work with families and her commitment to obtaining that very high level of competence. I have full faith of her ability to serve the island of Guam on this capacity. I'm excited as we move forward and gets very exciting and I know Hope is little nervous to be here today, we talk a little bit about it but I can't think of more appropriate appointment to this forth than Hope Pangelinan so Thank you for receiving my testimony.

**Chairman Senator Dennis G. Rodriguez, Jr.:** Thank you very much Sir. Ms. Rhina Calvo , sorry about that earlier.

**Ms. Reyna Calvo:** Hafa Adai Senators. My name is Reyna Clavo , I'm a license marriage encounter therapist on our island and I'm here to fully support Hope in this appointment. Ms. Pangelinan , I work side by side with her at the project Karinu so I witness her commitment, her strong work ethic and her generosity of heart. She's someone that's accountable and I cannot say enough good things about Hope Pangelinan. I've seen her she has modeled leadership over at project Karinu and the things she does outside she called to do and she walks the extra mile for that and for the families that she advocated and as well as the children in need so that why I'm here to fully support her and Thank you.

**Chairman Senator Dennis G. Rodriguez, Jr. :** Thank you very much Ms. Calvo. Vice Chairman, Senator Duenas anything for this panel? Okay, thank you very much and appreciate your testimony. Thank you. Now, I like to call on the appointee, Ms. Pangelinan to please come

forward as you come forward I like to recognize your mom and dad who's here in your support. Thank you very much for being here. Thank you.

**Ms. Hope Pangelinan:** Good afternoon, I like to acknowledge both Chairman and Vice Chairman for being here today and also Senator Duenas. Excuse me I'm so nervous. My name is Hope I humbly like to thank my colleague for being here who is in support of me to be a member of the Guam Social work board. I also like to thank you in considering me on this position and this capacity. I know that is going to be very honorable and full of hard work but energy and like what my colleague say my hard work. I will definitely put out what the role entails. I'd like to share with you a little bit of my background in social and like share my interest. I think I will be a appropriate member to the Guam Social work Board and in the end I hope that , that will be enough information for Senator to decide if I'm the right person to serve the people of Guam and to give justice to the social work profession . My social work career did not start with the bachelor's degree. I like to say that it started as a teenager. I was actively involve with Santa Teresita Catholic Church which is a very renowned Youth Ministry organization at that time it was only 3 ministries up it to 8. I like to say that it wasn't for my faith and my passion to create community change and make a difference for youth members then the profession will not excess today because I will not know what to do. After I graduate with my Bachelors Degree I did work at Dementia at the Family Support Elderly program and also do counseling with Health Services of the Pacific another elderly program and at Project Karinu which deal with children birth to five. I'm currently an individual therapist at American Medical Center and counseling at Health of the Pacific. I got my masters here in Guam but that was quit a journey , I did go off island a couple of times to the University of Baltimore and University of Hawaii, Manoa. In Maryland I was offered an internship with John Hopkinson University the Kennedy Career Institute which is renowned and have been featured on ABC 14 . With me being passionate about my island it did have the same value to me that's why I came back to Guam. And I ended up finishing my masters here. And as I mentioned we work got together and saw the need of licensure in Guam so together as a group we work hard into pushing this board and so I like to thank everyone for being here today. As a member of the social work board I do hope to model the social work value that our interest and ultimately that we do accomplish in the best interest of only our client that we service and costumer protection but also hope that we will advance the social work profession so that those of us here that choose to practice on Guam and those who do come to Guam practice social work will have that opportunity to transfer their licensees co'z I just don't want to hear that their degree is not measurable to those that have received it off island. So I just want to leave that with you and I hope that and hope to be appointed to this board and I hope that I be able to provide all the hard work that necessary. Thank you.

**Chairman Senator Dennis G. Rodriguez, Jr.:** Thank you very much Hope. Senator Morrison, Thank you for joining us this afternoon. First of all congratulation again for your appointment. As you know with your appointment now would allow the board with one chair to officially meet now and start the work to social work, it's very important that we moved forward and as I told you, you have my support and the work you done when you were at project Karinu. And so I thank you for that and expect that your nomination packet will be move forward in the Legislative process.

I just wanted to mention that I'm no longer employed with Project Karinu, I'm now employed with Health and Services of the Pacific and part time at American Medical Center so in terms of my commitment, there's something about me that I love is the drive and goals and determination. I think my parents for allowing me to stay up until 2 am to an event but that always been me and when I put my mind to something I drive it home. 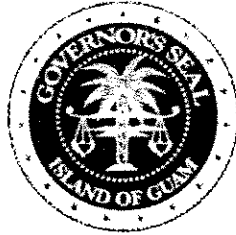

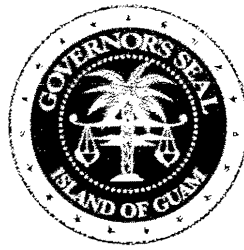
