

#### I. OVERVIEW

The Committee on Education, Public Library and Women's Affairs convened a public hearing on August 7, 2014 at 4:00 pm in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of the appointment of Ms. Denise K.L Reyes, Member, Guam Public Library System Board, the appointment history as follows:

- Appointed by the Governor of Guam on June 13, 2014, term to expire June 29, 2017.
- Appointment packet forwarded to I Liheslatura on July 16, 2014; and
- Appointment packet forwarded to the Committee for public consideration on June 17, 2014.

#### Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on July 30, 2014, (5-Day Notice) and August 4, 2014 (48-Hour Notice) via email. Copies of the hearing notices are appended to the committee report.

#### II. SUMMARY OF TESTIMONY AND DISCUSSION

- Speaker Won Pat Ed.D announced that the Committee will hear the nomination of Ms. Denise K.L Reyes for the Guam Public Library System Board.
- Ms. Reyes testified that she is a home school mother for the past 15 years and has 5 children; one about to graduate, one in middle school, one in elementary, and one has already graduated who is employed and married. She also stated that she would like to fulfill her obligations as a board member for the Guam Public Library System, because she brings a very needed and very beneficial asset to them by being a liaison for both being an avid user in all the different villages. She also has the connections with all the home school associations for being a tutor, and as an academic coach. She has an ear for what the children need at all different levels of education.

She knows the ways to use the library for its services and the different programs it has. She stated that she visits the library daily and she holds different activities so she sees where the library might slip though and where the services might excel and how they can enhance it. She stated that most of the other mothers that I do home school with that would give testimony are with our children up at a camp in Ritidian. She also mentioned that she brings a lot for the local users of the library and she will enhance the board of directors; and these are my suggestions and comments.

- Speaker Won Pat Ed.D stated that she is going to ask a few questions, then open up the discussion with her colleagues to ask questions or to provide any comment.
- Speaker Won Pat Ed.D asked the nominee how long she has been using the library, since she indicated that she was a high user of the library.
- Ms. Reyes stated that she grew up on Guam and that she went to the Academy. She has been going to the library since she was a kid. She has been going to the library for the past 15 years as a weekly user of the library.
- Speaker Won Pat Ed.D thanked the appointee for volunteering to serve in the capacity as a board member because there is no money in this and it's more of love and use of public library. Speaker asked the appointee what she has seen in the library that may have been lacking that she can bring forth to the table, to the board, and to the legislature.
- Ms. Reyes replied that there is not necessarily a lack but there is unawareness. She also responded that there are 2 basic users of the library system there are those who want to procure services that the library provide and users who just want the library for its books. It is just the awareness, the person that is at the grass root level that can bring additional input as to how they can enhance their services.
- Speaker Won Pat Ed.D mentioned if there are enough patrons that through this awareness that you want to bring out to the community through the grass roots that you can increase the patrons.
- Ms. Reyes stated that she thinks if they knew what services were provided and on a consistent basis that they be encouraged to use it more. She mentioned that she wants the library to be a safe haven for kids to go to, instead of kids going to the mall or to the park. She also want the library to be beneficial for kids where they can read, they can relax, and be in a safe environment.
- Speaker Won Pat Ed.D asked, "What do you think in your capacity as an advocate that you can enhance or improve the libraries and our community?"
- Ms. Reyes The library does cater to home school students and they are patrons of hours when other patrons are not there. The appointee mentioned that she is an academic coach, a coach for math counts, a coach for math Olympiad, and a coach for spelling bee. They have allowed me, when there are no or a few patrons there to have my sessions with them. So we use that, we use the reference materials while we are there.

- Speaker Won Pat Ed.D mentioned how she like the idea of reading programs, to expand beyond the school, is this something that you can work with the Department of Education, to coordinate programs after schools?
- Ms. Reyes stated that they do have the DEED program, which is an after-school program. Notably known down in Merizo where kids go to the library after school.
- Speaker Won Pat Ed.D asked the senators if they had any questions or comments
- Vice Chairperson Yamashita, Ph.D. thanked the appointee for making the time and effort to be a community leader throughout the public libraries. The Vice Chairperson mentioned that the appointee has a solid crew running the libraries right now who want to do even better. The Vice Chairperson mentioned about the visually impaired to make sure that all levels, all skills, all abilities need to be ensured that the facilities are open and accessible to accommodate which means that all materials are accessible and accommodations are made as well.
- Speaker Won Pat Ed.D thanked Ms. Reyes for accepting the nomination and for being here this afternoon. She also mentioned to the audience, that the audience and the public have 10 days to submit written testimonies. The Speaker concluded the public hearing for the nominee.
