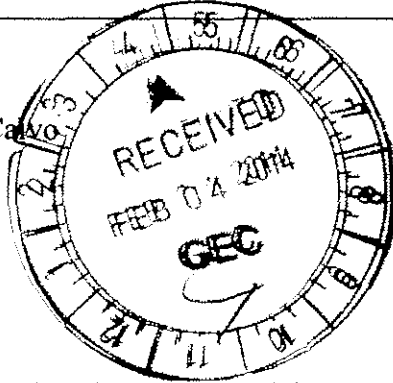





## **II. SUMMARY OF TESTIMONY & DISCUSSION**

**Chairman Pangelinan:** Before we start, ladies and gentlemen, please join me in rising for a moment of silence to honor the late General and Congressman, Guam's son and native, General Ben Blaz. [moment of silence]

Si yu'us ma'ase' todus hamyo. Good morning, ladies and gentlemen, to those of you here, present at the legislature, as well as those of you listening in on the airwaves, as this is being aired for this public hearing. This public hearing was announced pursuant to the requirements of the Open Government Law of the Government of Guam.

We have an agenda this morning that includes a confirmation hearing plus some bills that have been proposed by members of the legislature. We'll begin with the agenda as published and we'll start with the confirmation of Dr. Marilyn Salas to be the Chamorro Culture Representative for the Guam Historic Preservation Review Board. We have this morning to testify, the nominee herself, and we'd like to call her up and Mr. Joe Quinata from the Historic Preservation Trust. Please join us this morning. We'll begin with the receipt of testimony by public representatives, and that will be Mr. Joe Quinata, and then we'll close the nomination hearing, by hearing from the nominee herself. Mr. Quinata, please identify yourself for the record and proceed with the presentation of your testimony.

### **Testimonies**

**Mr. Joseph Quinata:** Senators, my name is Joseph Quinata. I am the Chief Program Officer of the Guam Preservation Trust. I would like to thank you for this opportunity to testify in favor of Dr. Marilyn Salas' appointment to the Guam Historic Preservation Review Board.

[Read written testimony verbatim, attached here.]

**Chairman Pangelinan:** Si yu'us ma'ase', Mr. Quinata. I also have signed up as members of the public, Mr. Michael Makio. Please join us here at the table, Mike, and Mr. Pete Calvo, the director of the Guam Energy Office.

**Mr. Michael Makio:** Hafa adai, Senator and members of the Committee. Thank you very much for taking time to listen to our testimony. I'm here today also in support of Dr. Salas' nomination to be a member of the Guam Historic Preservation Review Board representing Chamorro Culture. I've had the opportunity to work alongside Dr. Salas for many years now, without dating ourselves, and it's always been a privilege and a pleasure to work with her. She's a very strong advocate for Chamorro culture. She's wonderful at building advocacy and consensus, especially in culture and heritage preservation. Many times you see people butting heads. You need a diplomat, a voice of reason, and that's what Dr. Salas, many times, brings to

the table. She's able to build that consensus on a lot of projects, and programs are able to move forward. She's also always been a strong advocate of women's roles relative to historic preservation, cultural preservation and heritage. Her legacy at the University of Guam, she's been a role model for young women for decades...[jokes]...for many weeks now, she's been a role model...she's only 22 years old...no...but you talk to a lot of professional women who are involved in culture and heritage preservation on Guam right now and they will always point to her and say that she was part of building that interest and sustaining that standard of excellence for a lot of women practicing in cultural and heritage preservation. I think all of us would be very lucky to have another member on the board who brings these talents and the commitment that Dr. Salas brings to our programs. Thank you. And I am Michael Blas Makio, Chairman of the Guam Historic Preservation Review Board and Chairman of the Guam Preservation Trust.

**Chairman Pangelinan:** Thank you very much. Mr. Calvo?

**Mr. Peter S. Calvo:** Thank you, Mr. Chairman, members of the Committee. I'd like to throw my support fully behind Marilyn. She's indeed a very beneficial member of this group, having been...excuse me, my name is Pete Calvo, I'm the Guam Energy Office Director. I was a Director for Parks and Recreation and I have very good relationship with the Historic and Preservation Review Boards, and I really appreciate the services that Marilyn and others have provided for us. Indeed, their dedication and commitment to the program is beneficial not only to preserving our culture and to the people of Guam in the future for all of our future generations. I'd like to ditto everything that has been mentioned thus far, and indicate that with Marilyn's demeanor, she is indeed a force that looks to ensure that things move forward and so she's always there making things smooth over, if there's any controversy, and she's always providing that air, that distance to both sides as well as looks for avenues to move the programs forward so I appreciate the opportunity to speak on her behalf and I look forward to her continued support of the programs.

**Chairman Pangelinan:** Thank you very much, Mr. Calvo. We'll go ahead now and hear from the nominee herself, Dr. Salas?

**Dr. Marilyn Salas:** Senator Pangelinan, Committee on Appropriations, Public Debt, Legal Affairs, Retirement, Public Parks, Recreation, Historic Preservation, and Land – long title and a lot of responsibilities here. Thank you for this opportunity here, and I want to thank Mike and Joe and Pete for speaking on my behalf. I'm here to request your support of my confirmation to serve as a Chamorro Culture Representative on the Guam Historic Preservation Review Board (GHPRB). I left the Board six (6) months ago and had lots of time to reflect on all the successes, challenges and new ideas for Historic Preservation. I miss being with such wonderfully knowledgeable and committed people who focus on the mission of historic preservation. Today, I sit before you and I also serve again, this time as a wiser person who looks at preservation of historic sites and landscapes amidst all the challenges of Guam in 2014—interest by the US military for more of this precious land and economic growth and development. Our preservation goals include safeguarding the future for younger generations with our cultural, historic and natural resources, exposing and teaching our young adults the stories of our island's historic sites and landscapes, respect for our ancestors, the mountains, the valleys, the oceans, the rivers, the wells, latte sites, *nunu* trees, ancestral burial grounds, Chamorro language and all the knowledge

these sites and landscapes communicate. In time and more informed of heritage, young adults will develop greater self-esteem, leading to respect for the diversity of people who have made Guam their home. As board members, we are witnessing the eager and renewed interest in preservation through our new staff at Guam Preservation Trust, young and between the ages of 25-40. I know that the next bills coming, one has to do with land for the University of Guam, and I think that is a precious and a valuable thing to do, to be able to support what the University of Guam wants and can use. The Guam Historic Preservation Review Board serves to advise leadership about preservation of historic cultural sites and landscapes. It means advocating for legislation and working with our community to preserve and protect. The year 2014 and beyond are interesting years for historic preservation. If confirmed, I look forward to working with GHRB as Guam moves forward. Thank you for this opportunity to share my interest and excitement.

**Chairman Pangelinan:** Thank you very much, Dr. Salas. I'll go ahead and recognize members of the panel to see if they have any comments or questions. Speaker Won Pat?

**Speaker Judith Won Pat:** Thank you very much. Dr. Salas I know you've been in this commission—is there anything, as you say you're much wiser, now that you would like to see the Preservation actually undertake that hasn't been done?

**Dr. Marilyn Salas:** I think what's coming up currently in National Preservation Trust and also Guam's interest is heritage tourism. I think we're going that way, as Guam moves on, like the Plaza de España. Those ideas are coming out. Humåtak, and the Humåtak Foundation is doing something with heritage tourism. The other one is, we can protect and preserve all these historic sites, but we also have to know that there is an education to the youth about the importance. Because, you know it's easy to just take this boulder away or cut down that *nunu* tree, but what did it represent? And how do we work around these natural environments? I'm now a farmer and I have more of a love for nature and all the things that are there. So there's a lot that nature can teach human beings. How do we then use this? It's about training of youth. And as we go, our strategic plans right now show a lot of activities that will encourage the youth to participate in historic preservation.

**Speaker Judith Won Pat:** You've also stated in your testimony, of course, about some of the indigenous plants on the island. Is there anything, along the same line of interest that you have, and your return to tilling the soil, as a farmer, that you see expansion in terms of what the Preservation does? There was a conference held on-island, and someone was brought out to talk about gardens in our schools, as well, community gardens. It is unfortunate that we've come to this point to realize what we used to do as a people. Do you also see an expansion in terms of what Preservation does, but more importantly, what it can do in addition, tying it all in to our culture and heritage preservation?

**Dr. Marilyn Salas:** As you say that, I think of Agriculture and the University of Guam's CNAS, and what they can do to help guide the preservation of lands that have medicinal plants, at the coastal area, the mountain area and in valleys. How do we protect that? We can't find all the medicines in one place. So at least we protect something because Guam and its population growth is going to mean that we might destroy all these. The *suruhanas* and *suruhanus* that I've

talked to from the Northern Marianas, they come here to get some of our plants, and they're recognizing along Gun Beach, they don't see the same medicinal plants. And we're very sad about that, so how do we keep that? Bernie has a garden on the back road, on the way to Andersen, and Bernie Nelson, she's holding it, but it's not in its natural environment as much. How do we keep things in their natural environment, and work with it there?

**Speaker Judith Won Pat:** I know that Speaker Ben had introduced legislation, it passed, preserving about five (5) acres of property to be used for medicinal plants. Is this again, and it's part of our culture, part of our heritage, other than preserving buildings beyond that, is legislation needed to do that? Is this something the Board can do?

**Dr. Marilyn Salas:** I think this is within our mission and our goals; it's not only to protect the sites and the buildings, but also to look at the cultural aspects, the intangible part that could easily disappear. We have grants within there that could do that, or we have programs that will be allowable, and not a grant, but something we'd take on as a Board.

**Speaker Judith Won Pat:** Thank you very much.

**Chairman Pangelinan:** Thank you very much, Speaker Won Pat. I'm going to recognize the other lady on the panel since Mike certainly put us in that frame of perspective. Senator Yamashita?

**Senator Aline Yamashita:** Thank you very much, Speaker Ben. Dr. Salas, welcome to your legislature, thank you for all being here. Dr. Salas, thank you for your willingness to serve, and following up on some of the comments Speaker Won Pat raised, do we have a healthy working relationship with GDOE Curriculum and Instruction to infuse the curricular objectives, not only in Chamorro Studies, but also in Social Studies, Health, Language? Is that an ongoing stream on activity?

**Dr. Marilyn Salas:** We do, and in our strategic plan we do have curriculum. We are also looking at historic preservation scholarships, which will probably come through the University of Guam and GCC, so those are opportunities. The curriculum, we are always working on History Day projects that involve a social studies curriculum, so there are many ways. Ron Laguana comes to us for support of the Chamorro curriculum, and posters that are needed about the birds, the plants, the flowers, and the fruit trees, so those are coming through that way.

**Senator Aline Yamashita:** Good, because I'm sure Joe Sanchez would be very excited to ensure that there is energetic partnership. How's our working relationship with GVB in helping our visitors understand and respect and acknowledge what we are? Is there a healthy partnership there?

**Dr. Marilyn Salas:** There is a very healthy partnership and there's support from our side to them on all their activities, and vice versa, they will help us on our big things too.

**Senator Aline Yamashita:** Well, thank you and I wish you the best. Again, thank you for carving out the time. I know how busy you are with your newfound passion for farming, and so the island really appreciates you. Thank you, Speaker Ben.

**Chairman Vicente Pangelinan:** Thank you very much, Senator Yamashita. Senator Aguon?

**Senator Frank Aguon Jr.:** Thank you very much, Mr. Speaker, and Dr. Salas, thank you for once again extending yourself to the community and to the island of Guam. Just to share a perspective, when I first came in in 1997, I know that you were a very staunch proponent for cultural preservation and language out of the University of Guam. It goes back many years in terms of understanding what you have contributed to our island and our community, and seeing that you can continue to serve in this capacity and lend yourself to the community and hopefully be able to continue to highlight the culture and the aspects of Guam that many of our younger generation were not exposed to while they were growing up. I think that would be very helpful, especially as it adds to tourism. I thank you very much for extending yourself to our community. We look forward to your contribution. Thank you very much, Mr. Speaker.

**Chairman Pangelinan:** Thank you very much, Senator Aguon. Senator Limtiaco?

**Senator Michael Limtiaco:** Thank you, Speaker. Dr. Salas, thank you for your willingness to serve again. I think it's important that the Board has continuity and the fact that you've been there, and seen what's happened in the past, and you know where to go going forward is important. Portions of your testimony struck a cord with me because we recently had the honor of the ribbon cutting ceremony for the rehabilitation of Plaza de España and that area played a real important part of my childhood because, at one point in time, that was a bus depot. We used to play in those trees all the time, and I heard they were thinking of cutting down the trees because it's ruining the concrete. That would be sad if we did that, because those trees are important to a lot of us for our playground area. But I think that the fact that you'll be serving again is only going to bring more added value to the Board. You have my full support.

**Chairman Pangelinan:** Thank you very much. And they did cut down the tree. I'm very disappointed in that. I'm glad you said we should work around those things, in your testimony.

**Dr. Marilyn Salas:** I think that they had lots of discussion. Well...I was away...[laughter]

**Chairman Pangelinan:** Yes.

**Dr. Marilyn Salas:** They had lots of discussion. They had to make some critical decisions on this, recommendations from the Board.

**Chairman Pangelinan:** : Oh man, I had a recommendation.

**Dr. Marilyn Salas:** Yes, we played on those trees also.

**Chairman Pangelinan:** Yes. Senator Duenas? And then Senator Ada?



**Senator Chris Duenas:** Thank you, Mr. Chairman. I join the chorus, Dr. Salas in commending you for your willingness to serve. I'm not going to ask you for a position, but I am going to ask you to please provide, I know some of us have worked, particularly Senator Morrison, on a recently introduced bill with regard to the issue of celebrating, like I said I won't go into details, but celebrating and reinvigorating the recognition of our culture and our history. I know that some have a difference about that because of the issue surrounding what happened post-bumping into Guam for Magellan. But I would hope that you would take this up as the bill is going to be heard soon, to really address, you mention discovery, or not discovery but education of history. I think there has been some misunderstanding of what the intention of this bill is. I would ask you personally to take that upon yourself, with the rest of the Board, to work with us and educate us more on how we can make the bill better for the true intent, which is to really recognize Chamorros and their resiliency, through all those that bumped into our island and now are part of this huge Guamanian family. That would be my only request, and you certainly have my support and I thank you for your willingness to serve.

**Chairman Pangelinan:** Thank you very much. Senator Ada?

**Senator Tony Ada:** Thank you very much, Mr. Chair. Dr. Salas, thank you for your continued service to the people of Guam. I look forward to voting on your confirmation, and you have my full support, Ma'am. Thank you, Mr. Chair.

**Chairman Pangelinan:** Thank you very much. I have a couple of questions. You're coming back after taking a break—what different perspective will you bring back to the Board that you think is going to change the operation of the Board. What new perspective do you think you're going to bring back that would change some of the decision making processes, some of the review processes that you think needs to be made within the current structure now?

**Dr. Marilyn Salas:** I think it's about collaboration, the partnerships that we can have because not one agency can do it alone. I've seen that work with the Department of Chamorro Affairs, Preservation Office, Parks and Recreation, getting together, even in your term. How do we all help to make it the best that we can? Collaboration is important. The other one is really looking at the national level, what are their topics and their concerns right now? It could be different from what Guam is going through, but it could also inform us about what kinds of things we look for. We are at a level of preserving historic places and sites. But the next step is what do we do so that there is some economic growth in those places? And we've been discussing that—I went to one meeting now. We've been discussing how we can look at the economic benefits of these heritage places now.

**Chairman Pangelinan:** In the preservation statutes that have oversight and responsibility over the development of properties and the protection of these historical sites, historical artifacts and so forth, we have the Guam State Historic Preservation Review Board, which is under the Department of Parks and Recreation and then the Guam Preservation Trust Board. Now you talked about collaboration, do you think that, the fact that there are some of the same people making decisions on these issues, that there needs to be a different perspective from one board versus the other board? And what would your position be on building a little bit of a separation that still allows collaboration, but allows a little bit more clarity with regards to responsibilities,

so that we don't end up being incestuous almost with regard to the projects, authorities and the approvals on these developments?

**Dr. Marilyn Salas:** I think the Board that serves for both is okay. We have different specialties within there—we have the planner, the archaeologist, so that's already enough to inform what Guam Preservation needs and what the Historic Preservation Office needs. I believe it is how the leadership, the program officer leads those that makes the difference, because this Board doesn't have a problem of serving the Guam Preservation Trust and the Historic Preservation Office.

**Chairman Pangelinan:** Have there been conflicts in the past in terms of this preservation versus moving forward on these projects?

**Dr. Marilyn Salas:** I believe it's just about the process of how things get done, like the Historic Preservation Office needs some things done but grants need to come in. Requests need to come in from this office, the Guam Preservation Trust in order for that to happen. We need to document what we're doing. We really need to reach out to assist, as a Chief Program Officer reaches out. Lynda sits with us in our meetings, so I think we're going to see more collaboration especially as we get to the next stage in our strategic plans.

**Chairman Pangelinan:** There was a recent grant that was awarded to document the undersea garden of dumping water relics into our oceans, that's how I would put it. It was almost like we endorsed that idea, and now we should embrace the fact that we polluted our waters by dumping these relics. Were you part of that decision, in the review of that project?

**Dr. Marilyn Salas:** No, I wasn't.

**Chairman Pangelinan:** You were off the Board at that time. Again, just a different perspectives that we all have. Cutting the tree down, you know I think we should have cut the roots that were flowing over to the garden house, instead of cutting the entire tree down. Just cut the roots off; let's dig it up, by hand if necessary. That tree is just as important, in terms of our history and our culture, preservation, as the garden house almost—the fact that the solution is take it all out versus preserve the tree, preserve the garden house. My suggestion was you cut the tree on the one side; I think the tree system, root system, we should have brought in horticulturalists, and if we could have done that, the tree could be supported by the one side of the root system and cut those so that they don't continue to grow and pop up the garden house. I know that there was a lot of discussion, but it saddened me because I think that was the easy way out maybe. We wanted to do a ribbon cutting, I don't know, the tree just stood in the way instead of taking a chisel to try and solve the problem, we took a bulldozer and decided to just ram it off. I don't know if that's historical preservation. We need to preserve not only the memories but also what created those memories if at all possible. Instead of preserving what creates those memories, we just decided that we're going to preserve the memories, and people are going to forget.

**Dr. Marilyn Salas:** That tree carried a lot of history, through all those times.

**Chairman Pangelinan:** : I agree.

**Dr. Marilyn Salas:** But also when you look at plants, if you cut those roots, they grow even stronger, and move faster. So that's even why with preservation, our plants within the concrete, we have to know how to do that, to take it out because if you pull it out and there's still some root it'll damage even more. It's about looking at all those. And I am sure that my colleagues looked at the point, because some wanted to keep it, others didn't, but they had to come to a solution here, and problem solve.

**Chairman Pangelinan:** Well, thank you very much, si yu'us ma'ase and I want to thank the governor for making this appointment, and we'll certainly do what is necessary to place your nomination before this body for confirmation.

**Dr. Marilyn Salas:** And thank you, and Ansito Walter, he's been my support because he gives me another dimension, another dimension of looking at preservation. When I see where Chamorros are, and I see where the Chuukese group is with it, they're still using the clamshell to pull out the tapioca, to clean it, and I'm going, wow, that's our artifact. So thank you, everybody.

**Chairman Pangelinan:** That's culture, living.

Thank you very much, si yu'us ma'ase. Thank you very much for your testimony. This concludes the testimony on the confirmation hearing for Dr. Marilyn Salas. There being no additional individuals to present any additional testimony, this Committee will continue to remain open for the acceptance of any additional information or public testimony on the appointment of Dr. Marilyn Salas.
