

#### **COMMITTEE REPORT DIGEST**

#### I. OVERVIEW

The nomination of John Taitano II to serve as a member of the Alcoholic Beverage Control Board was made by Governor Edward J.B. Calvo on July 19, 2013. The appointment packet was received by the Office of Speaker Judith T. Won Pat, Ed.D., on July 19, 2013. The appointment of John Taitano II was subsequently referred by the Committee on Rules to the Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations on July 19, 2013.

The Committee on Aviation, Ground Transportation, Regulatory Concerns and Future Generations convened a public hearing on July 30, 2013 at 2:00 p.m. in *I Liheslatura*'s Public Hearing Room. Among the items on the hearing agenda was the nomination of John Taitano II. The hearing was adjourned at 2:23 p.m.

#### **Public Notice Requirements**

Public Hearing notices were disseminated via electronic mail to all senators and all main media broadcasting outlets on July 23, 2013, and again on July 26, 2013. Notice was also posted on the official website of *I Liheslaturan Guåhan* beginning on July 23, 2013.

#### II. TESTIMONY & DISCUSSION

**Chairman Michael F.Q. San Nicolas**: We will go ahead and begin the testimony of the nominees, starting with John Taitano II to serve as a member of the Alcohol Beverage Control Board. Before I have Mr. Taitano testify, is there anyone who wishes to offer testimony on his behalf? None present, John. Good to see you.

**Mr. John Taitano II**: Good afternoon, Chairman San Nicolas, Senator Morrison, Senator Duenas. I am here for the confirmation hearing as a member of the Alcoholic Beverage Control Board.

**Chairman San Nicolas**: Thanks, John. Is there anything you want to offer? Your desire for reconfirmation and what you would like to continue working on at the Board?

Mr. Taitano: Currently, I am the Acting Chairperson for the ABC Board. We are tasked, this year, with many challenges and we are working with the Senator and the Administration to further commerce and keep the community safe. One of the things that we have been tasked with is to confirm the amount of general liquor licenses that we do have in each municipality. Currently, the system that we are working with does not correlate or tabulate the information all that well. So, a lot of it we are trying to do by hand or manual. We feel that we should be getting close to giving a more accurate picture of what we are dealing with.

Chairman San Nicolas: Thank you. I was very pleased to see your re-nomination to the Board. You have been going through many challenges as a Board as of late, and you've been doing an excellent job of trying to work through those challenges. These challenges just didn't spring up as you were a Board member; they have actually been preexisting and have been building up over the course of multiple boards. You have done a very good job of taking the necessary leadership steps to get the Board situated properly and to begin complying with the laws that have been neglected due to lack of awareness. I'm very grateful that you have been re-nominated because you know already the many challenges that the Board has been going through. You're going to be able to help steer this ship into port and make sure everything is being done the right way because you've already gone through all these challenges and know what needs to be fixed. I'm grateful for your re-nomination and I'm glad that you also, in spite of all the challenges, are willing to continue to serve the people and are willing to work on the improvements that need to happen. Again, you've been very gracious and very dedicated in your intentions to make things better. We look forward to working with you to get the ABC Board to function the way everybody would like it to and the way the law mandates that it does. Thank you very much for stepping up to the plate and being willing to serve. Do my colleagues have anything?

Senator Christopher Duenas: Thank you, Mister Chairman. John Ray, I also join in on the appreciation for your willingness to serve once again. As he mentioned, I know that you are keenly aware of the issues that exist particularly with Hagatna and Tamuning. I wanted to glean into your thoughts on the issue in particular. I think you understand the dilemma a community has balancing business opportunities and commerce versus the community's desire to remain as wholesome and as protected, particularly when we are talking about on-sale areas — bars and clubs — and that balance. As you know, and it was mentioned on a hearing on a bill proposed by the Chairman earlier in testimony by certain individuals who have gone through and really dove into the details of the law, that establishments... in particular two, especially when we are talking about Hagatna and Tamuning, that would open their business, that have significant investment such as over \$50,000.00 or that are of a nature of being a hotel, with 50 or more rooms, or any restaurant that have on-site sales or have that significant investment... do you see that as a good balancing factor, knowing that those businesses are not affected and to, at least for now, adhere to the license issues and the quantity per population, to keep that balance? Is that your view at this point?

**Mr. Taitano**: Currently, we are sticking with that view because that is how we understand the law to be. We do have restaurants that are looking to get licensed and hotels with over 20 rooms. That does not affect the ratio as stated by law. Again, when this information was brought to our attention, we immediately went to seek advice and once we heard that advice, we took it under advisement. We agreed that this was going to be what we deemed as correct for the Board.

Senator Duenas: So, that is currently how you are lined up?

Mr. Taitano: Correct.

Senator Duenas: I think that's important because there is constantly going to be this desire for the community to strike that balance. I know that the Land Use Commission grapples with these issues all the time. The fact of the matter is, while we want to entice business, commerce and have a vibrant economy, people's comfort levels within their community and the value of their properties, their homes and their significant investments are something that we have to value as well. I would say in closing, and maybe the Chairmen is going to go in this direction and have more discussions on this issue, by creating this issue and maintaining the licenses as they are structured, you are adding a value to that license and now those who are license holders have something that, if their businesses aren't doing so well and maybe their model doesn't work anymore, they have commerce in their hand because they have a license that can be marketed. I think that while the jury is out and there should be an economic study as well as what you have to enforce, but I still think that it may to tip to that area where even your level of involvement is going to become even more important to monitor the commercial value of that license holder.

**Mr. Taitano**: You are absolutely right, Senator. This is a work in progress and the Board is always willing to work with stakeholders, community partners, the Legislature, the three branches of government because we do think it's a team approach. I do see it as a team approach.

**Senator Duenas**: I appreciate your open mindedness and that you've answered those questions. You're definitely just not a figure on that Board but you're really interested in the overall community concerns as well as the need for commerce and economic vitality. Thank you and I look forward to voting in the affirmative for your confirmation.

Senator Tommy Morrison: Thank you, Mister Chairman. I echo Senator Duenas' line of questions and I appreciate your feedback. I just want to point to thanking the Governor for renominating you to the Board. You are a trusted man and a lot of folks that know you rely on you. I appreciate that there is going to be continuity there and working with the Chairman and his Committee to ensure there is a smooth transition to many of these goals ahead of us. I appreciate that you're taking the time to really do this again and we look forward to working with you. You have my full support.

Chairman San Nicolas: Thank you to my colleagues. Again, we are having many new nominations to the ABC Board, so your institutional knowledge is going to be very valuable to making sure that those new members are able to navigate the current challenges and put into perspective with everything that you have been through thus far. I cannot overemphasize that your willingness, in spite of those challenges, is really admirable because there is very little incentive to serve on these boards, more often than not, when it gets challenging as it has under your tenure. The tendency is for board members to say, "Okay, I did my part" but you're willing to continue on. You're willing to guide and direct this improvement process and now you're going to be the institutional knowledge that a lot of these new members will be looking to. Your

track record of being a consensus builder and of trying to seek out the right answers is just stellar. Thanks for your willingness to serve.

Mr. Taitano: Thank you.

Chairman San Nicolas: This will conclude the hearing of Mister Taitano's nomination.




